ENGROSSED SENATE BILL 5953

AN ACT Relating to the disruption of traffic by pedestrians; amending RCW 46.63.020; adding a new section to chapter 46.61 RCW; prescribing penalties; and declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 46.61 RCW 6 to read as follows:

7 (1) A pedestrian may not unlawfully and intentionally impede, or 8 otherwise disrupt, the flow of traffic on a highway that has been 9 designated, in whole or in part, as a highway of statewide 10 significance.

11 (2) A violation of this section is a gross misdemeanor punishable 12 under RCW 9A.20.021.

(3) Nothing in this section prohibits the filing, at any time, of
a cause of action for damages resulting from the disruption of traffic
caused by a pedestrian or pedestrians.

16 (4) In addition to any other costs that may be imposed by the 17 court, the court shall require a defendant to reimburse the actual

1 costs incurred by a law enforcement agency or emergency personnel, as 2 a result of responding to the traffic disruption prohibited under this 3 section.

4 **Sec. 2.** RCW 46.63.020 and 2001 c 325 s 4 are each amended to read 5 as follows:

15 <u>NEW SECTION.</u> Sec. 3. This act is necessary for the immediate 16 preservation of the public peace, health, or safety, or support of the 17 state government and its existing public institutions, and takes effect 18 immediately.
