- 1 AN ACT Relating to funding and expenditures for official
- 2 legislative association conferences; amending RCW 42.52.150; and adding
- 3 a new section to chapter 42.52 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 42.52 RCW to read as follows:
- When soliciting gifts, grants, or donations to host an official
- 8 conference within the state of Washington of a national legislative
- 9 association as approved by both the chief clerk and the secretary of
- 10 the senate, designated legislative officials and designated legislative
- 11 employees are presumed not to be in violation of the solicitation and
- 12 receipt of gift provisions in this chapter. For the purposes of this
- 13 section, any legislative association must include among its membership
- 14 the Washington state legislature or individual legislators or
- 15 legislative staff.
- 16 Sec. 2. RCW 42.52.150 and 2003 c 265 (ESSB 5178) s 3 and 2003 c
- 17 153 (2SHB 1973) s 6 are each amended to read as follows:
- 18 (1) No state officer or state employee may accept gifts, other than

those specified in subsections (2) and (5) of this section, with an 1 2 aggregate value in excess of fifty dollars from a single source in a calendar year or a single gift from multiple sources with a value in 3 excess of fifty dollars. For purposes of this section, "single source" 4 5 means any person, as defined in RCW 42.52.010, whether acting directly or through any agent or other intermediary, and "single gift" includes 6 7 any event, item, or group of items used in conjunction with each other or any trip including transportation, lodging, and attendant costs, not 8 excluded from the definition of gift under RCW 42.52.010. The value of 9 gifts given to an officer's or employee's family member or guest shall 10 be attributed to the official or employee for the purpose of 11 12 determining whether the limit has been exceeded, unless an independent 13 business, family, or social relationship exists between the donor and 14 the family member or quest.

- (2) Except as provided in subsection (4) of this section, the following items are presumed not to influence under RCW 42.52.140, and may be accepted without regard to the limit established by subsection (1) of this section:
 - (a) Unsolicited flowers, plants, and floral arrangements;
- (b) Unsolicited advertising or promotional items of nominal value, such as pens and note pads;
- (c) Unsolicited tokens or awards of appreciation in the form of a plaque, trophy, desk item, wall memento, or similar item;
- (d) Unsolicited items received by a state officer or state employee for the purpose of evaluation or review, if the officer or employee has no personal beneficial interest in the eventual use or acquisition of the item by the officer's or employee's agency;
- (e) Informational material, publications, or subscriptions related to the recipient's performance of official duties;
- 30 (f) Food and beverages consumed at hosted receptions where 31 attendance is related to the state officer's or state employee's 32 official duties;
- 33 (g) Gifts, grants, conveyances, bequests, and devises of real or 34 personal property, or both, in trust or otherwise accepted and 35 solicited for deposit in the legislative international trade account 36 created in RCW 44.04.--- (section 1, chapter 265 (Engrossed Substitute 37 Senate Bill No. 5178), Laws of 2003);

(h) Gifts, grants, conveyances, bequests, and devises of real or personal property, or both, in trust or otherwise accepted and solicited for the purpose of promoting the expansion of tourism as provided for in RCW 43.330.090;

- (i) Gifts, grants, conveyances, bequests, and devises of real or personal property, or both, in trust or otherwise accepted and solicited for the purpose of hosting an official conference under the circumstances specified in section 1 of this act;
- (j) Admission to, and the cost of food and beverages consumed at, events sponsored by or in conjunction with a civic, charitable, governmental, or community organization; and
- $((\frac{1}{2}))$ (k) Unsolicited gifts from dignitaries from another state or a foreign country that are intended to be personal in nature.
- (3) The presumption in subsection (2) of this section is rebuttable and may be overcome based on the circumstances surrounding the giving and acceptance of the item.
- (4) Notwithstanding subsections (2) and (5) of this section, a state officer or state employee of a regulatory agency or of an agency that seeks to acquire goods or services who participates in those regulatory or contractual matters may receive, accept, take, or seek, directly or indirectly, only the following items from a person regulated by the agency or from a person who seeks to provide goods or services to the agency:
- (a) Unsolicited advertising or promotional items of nominal value, such as pens and note pads;
- (b) Unsolicited tokens or awards of appreciation in the form of a plaque, trophy, desk item, wall memento, or similar item;
- (c) Unsolicited items received by a state officer or state employee for the purpose of evaluation or review, if the officer or employee has no personal beneficial interest in the eventual use or acquisition of the item by the officer's or employee's agency;
- (d) Informational material, publications, or subscriptions related to the recipient's performance of official duties;

events sponsored by or in conjunction with a civic, charitable, governmental, or community organization; and

- (g) Those items excluded from the definition of gift in RCW 42.52.010 except:
- (i) Payments by a governmental or nongovernmental entity of reasonable expenses incurred in connection with a speech, presentation, appearance, or trade mission made in an official capacity;
- (ii) Payments for seminars and educational programs sponsored by a bona fide governmental or nonprofit professional, educational, trade, or charitable association or institution; and
 - (iii) Flowers, plants, and floral arrangements.

12 (5) A state officer or state employee may accept gifts in the form 13 of food and beverage on infrequent occasions in the ordinary course of 14 meals where attendance by the officer or employee is related to the 15 performance of official duties. Gifts in the form of food and beverage 16 that exceed fifty dollars on a single occasion shall be reported as 17 provided in chapter 42.17 RCW.
