1 AN ACT Relating to a qualifying primary; amending RCW 29A.04.085,
2 29A.04.127, 29A.04.310, 29A.20.020, 29A.20.120, 29A.20.140, 29A.20.150,
3 29A.20.160, 29A.20.170, 29A.20.180, 29A.20.190, 29A.24.030, 29A.24.080,

16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

17 NEW SECTION. **Sec. 1.** A new section is added to chapter 29A.52 RCW
18 to read as follows:

19 (1) This act may be known and cited as the Qualifying Primary Act.

1 (2) The purpose of any primary held in this state is to qualify
2 candidates to appear on the general election ballot. Primary elections
3 do not function as a procedure to determine the nominees of political
4 parties. The sole purpose of allowing candidates to identify a
5 political party preference is to provide to voters a brief description
6 of each candidate's political philosophy, which the voters may consider
7 when casting their votes at a primary or general election. In a
8 primary election, each voter, regardless of party affiliation, may vote
9 for any candidate listed on the ballot, and the two candidates who
10 receive the most votes, also known as the top two vote getters, and who
11 receive at least one percent of the total votes cast for that office,
12 advance to the general election. Primary election voters are not
13 choosing a party's nominee. A qualifying primary ensures more choice,
14 greater participation, increased privacy, and a sense of fairness for
15 the voters.

16 (3) The provisions of this title relating to primaries must be
17 liberally construed to further the following interests:

18 (a) The legislature finds that the process of determining which
19 candidates will appear on the general election ballot or be elected to
20 office is a public process, in which all voters must be permitted to
21 participate. The legislature further finds that it is not in the
22 public interest to expend public funds on an election procedure that
23 limits the rights of voters by restricting their ability to participate
24 based on the party affiliation, if any, of the voters or the
25 candidates, or that requires voters to publicly declare an affiliation
26 with a political party;

27 (b) All qualified registered voters of the state of Washington
28 should be permitted to participate in all meaningful stages of the
29 process for qualifying candidates to appear on the general election
30 ballot by voting for the candidates of their choice in the districts
31 and jurisdictions where they are eligible to vote; and

32 (c) No registered voter of the state of Washington should be
33 required to divulge to any public or private entity his or her party
34 affiliation, if any, as a prerequisite to voting.

35 **Sec. 2.** RCW 29A.04.085 and 2003 c 111 s 115 are each amended to
36 read as follows:

37 "Major political party" means a political party (~~of which at least~~

1 ~~one nominee for president, vice president, United States senator, or a~~
2 ~~statewide office received at least five percent of the total vote cast~~
3 ~~at the last preceding state general election in an even numbered year.~~
4 ~~A political party qualifying as a major political party under this~~
5 ~~section retains such status until the next even year election at which~~
6 ~~a candidate of that party does not achieve at least five percent of the~~
7 ~~vote for one of the previously specified offices. If none of these~~
8 ~~offices appear on the ballot in an even year general election, the~~
9 ~~major party retains its status as a major party through that election))~~
10 identified as the party best approximating his or her political
11 philosophy by at least one candidate for an office voted upon statewide
12 who also received at least five percent of the total votes cast for
13 that office at the last primary or general election in a year in which
14 the governor is elected.

15 NEW SECTION. **Sec. 3.** A new section is added to chapter 29A.04 RCW
16 to read as follows:

17 "Partisan office" means an office for which a candidate may
18 identify a political philosophy under RCW 29A.24.030(3) or section 15
19 of this act, and is limited to the following offices:

20 (1) United States senator and representative;

21 (2) All state offices except (a) judicial offices and (b) the
22 office of superintendent of public instruction;

23 (3) All county offices except (a) judicial offices and (b) those
24 offices where a county home rule charter provides otherwise.

25 **Sec. 4.** RCW 29A.04.127 and 2003 c 111 s 122 are each amended to
26 read as follows:

27 "Primary" (~~or "primary election"~~) means a statutory qualifying
28 procedure ((for nominating candidates to public office at the polls))
29 in which each registered voter eligible to vote in the district or
30 jurisdiction is permitted to cast a vote for his or her preferred
31 candidate for each office appearing on the ballot, without any
32 limitation based on party preference or affiliation on the part of the
33 voter or the candidate, with the result that not more than two
34 candidates for each office qualify to appear on the general election
35 ballot.

1 **Sec. 5.** RCW 29A.04.310 and 2003 c 111 s 143 are each amended to
2 read as follows:

3 (~~Nominating~~) Qualifying primaries for general elections to be
4 held in November must be held on the third Tuesday of the preceding
5 September or on the seventh Tuesday immediately preceding such general
6 election, whichever occurs first.

7 **Sec. 6.** RCW 29A.20.020 and 2003 c 111 s 502 are each amended to
8 read as follows:

9 (1) A person filing a declaration of candidacy for an office shall,
10 at the time of filing, be a registered voter and possess the
11 qualifications specified by law for persons who may be elected to the
12 office.

13 (2) Excluding the office of precinct committee officer or a
14 temporary elected position such as a charter review board member or
15 freeholder, no person may file for more than one office.

16 (3) The name of a candidate for an office shall not appear on a
17 ballot for that office unless, except as provided in RCW 3.46.067 and
18 3.50.057, the candidate is, at the time the candidate's declaration of
19 candidacy is filed, properly registered to vote in the geographic area
20 represented by the office. For the purposes of this section, each
21 geographic area in which registered voters may cast ballots for an
22 office is represented by that office. If a person elected to an office
23 must be (~~nominated~~) elected from a district or similar division of
24 the geographic area represented by the office, the name of a candidate
25 for the office shall not appear on a primary ballot for that office
26 unless the candidate is, at the time the candidate's declaration of
27 candidacy is filed, properly registered to vote in that district or
28 division. The officer with whom declarations of candidacy must be
29 filed under this title shall review each such declaration filed
30 regarding compliance with this subsection.

31 (4) (~~This section does not apply to the office of a member of the~~
32 ~~United States Congress.~~) The requirements of voter registration and
33 residence within the geographic area of a district do not apply to
34 candidates for congressional office. Qualifications for United States
35 Congress are specified in the United States Constitution.

1 **Sec. 7.** RCW 29A.20.120 and 2003 c 111 s 506 are each amended to
2 read as follows:

3 ~~((1) Any nomination of a candidate for partisan public office by
4 other than a major political party may be made only: (a) In a
5 convention held not earlier than the last Saturday in June and not
6 later than the first Saturday in July or during any of the seven days
7 immediately preceding the first day for filing declarations of
8 candidacy as fixed in accordance with RCW 29A.28.040; (b) as provided
9 by RCW 29A.60.020; or (c) as otherwise provided in this section.~~

10 ~~(2))~~ Nominations of candidates for president and vice president of
11 the United States other than by a major political party ~~((may))~~ must be
12 made ~~((either at a convention conducted under subsection (1) of this
13 section, or))~~ at a ~~((similar))~~ convention ~~((taking place))~~ to be held
14 not earlier than the first Sunday in July and not later than seventy
15 days before the general election. ~~((Conventions held during this time
16 period may not nominate candidates for any public office other than
17 president and vice president of the United States, except as provided
18 in subsection (3) of this section.~~

19 ~~(3) If a special filing period for a partisan office is opened
20 under RCW 29A.24.210, candidates of minor political parties and
21 independent candidates may file for office during that special filing
22 period. The names of those candidates may not appear on the ballot
23 unless they are nominated by convention held no later than five days
24 after the close of the special filing period and a certificate of
25 nomination is filed with the filing officer no later than three days
26 after the convention. The requirements of RCW 29A.20.130 do not apply
27 to such a convention. If primary ballots or a voters' pamphlet are
28 ordered to be printed before the deadline for submitting the
29 certificate of nomination and the certificate has not been filed, then
30 the candidate's name will be included but may not appear on the general
31 election ballot unless the certificate is timely filed and the
32 candidate otherwise qualifies to appear on that ballot.~~

33 ~~(4) A minor political party may hold more than one convention but
34 in no case shall any such party nominate more than one candidate for
35 any one partisan public office or position. For the purpose of
36 nominating candidates for the offices of president and vice president,
37 United States senator, or a statewide office, a minor party or
38 independent candidate holding multiple conventions may add together the~~

1 ~~number of signatures of different individuals from each convention~~
2 ~~obtained in support of the candidate or candidates in order to obtain~~
3 ~~the number required by RCW 29A.20.140. For all other offices for which~~
4 ~~nominations are made, signatures of the requisite number of registered~~
5 ~~voters must be obtained at a single convention.))~~

6 **Sec. 8.** RCW 29A.20.140 and 2003 c 111 s 508 are each amended to
7 read as follows:

8 ~~((1) To be valid, a convention must be attended by at least~~
9 ~~twenty five registered voters.~~

10 (2)) In order to nominate candidates for the offices of president
11 and vice president of the United States, ~~((United States senator, or~~
12 ~~any statewide office,))~~ a nominating convention shall obtain and submit
13 to the filing officer the signatures of at least two hundred registered
14 voters of the state of Washington. ~~((In order to nominate candidates~~
15 ~~for any other office, a nominating convention shall obtain and submit~~
16 ~~to the filing officer the signatures of twenty five persons who are~~
17 ~~registered to vote in the jurisdiction of the office for which the~~
18 ~~nominations are made.))~~

19 **Sec. 9.** RCW 29A.20.150 and 2003 c 111 s 509 are each amended to
20 read as follows:

21 A nominating petition submitted under this chapter shall clearly
22 identify the name of the minor party or independent candidate
23 ~~((convention as it appears on the certificate of nomination as required~~
24 ~~by RCW 29A.20.160(3))).~~ The petition shall also contain a statement
25 that the person signing the petition is a registered voter of the state
26 of Washington and shall have a space for the voter to sign his or her
27 name and to print his or her name and address. ~~((No person may sign~~
28 ~~more than one nominating petition under this chapter for an office for~~
29 ~~a primary or election.))~~ The nominating petition must be submitted to
30 the secretary of state not later than ten days after adjournment of the
31 convention.

32 **Sec. 10.** RCW 29A.20.160 and 2003 c 111 s 510 are each amended to
33 read as follows:

34 A certificate evidencing nominations of candidates for the offices
35 of president and vice president made at a convention must:

- 1 (1) Be in writing;
- 2 (2) Contain the name of each person nominated(~~(, his or her~~
3 ~~residence, and the office for which he or she is named, and if the~~
4 ~~nomination is~~)) for the offices of president and vice president of the
5 United States, their addresses, and a sworn statement from both
6 nominees giving their consent to the nomination;
- 7 (3) Identify the minor political party or the independent candidate
8 on whose behalf the convention was held;
- 9 (4) Be verified by the oath of the presiding officer and secretary;
- 10 (5) Be accompanied by a nominating petition or petitions bearing
11 the signatures and addresses of registered voters equal in number to
12 that required by RCW 29A.20.140;
- 13 (6) Contain proof of publication of the notice of calling the
14 convention; and
- 15 (7) Be submitted to the (~~appropriate filing officer~~) secretary of
16 state not later than one week following the adjournment of the
17 convention at which the nominations were made. (~~If the nominations~~
18 ~~are made only for offices whose jurisdiction is entirely within one~~
19 ~~county, the certificate and nominating petitions must be filed with the~~
20 ~~county auditor. If a minor party or independent candidate convention~~
21 ~~nominates any candidates for offices whose jurisdiction encompasses~~
22 ~~more than one county, all nominating petitions and the convention~~
23 ~~certificates must be filed with the secretary of state.~~)

24 **Sec. 11.** RCW 29A.20.170 and 2003 c 111 s 511 are each amended to
25 read as follows:

- 26 (1) If two or more valid certificates of nomination are filed
27 purporting to nominate different candidates for (~~the same position~~)
28 president and vice president using the same party name, the filing
29 officer must give effect to both certificates. If conflicting claims
30 to the party name are not resolved either by mutual agreement or by a
31 judicial determination of the right to the name, the candidates must be
32 treated as independent candidates. Disputes over the right to the name
33 must not be permitted to delay the printing of either ballots or a
34 voters' pamphlet. (~~Other candidates nominated by the same conventions~~
35 ~~may continue to use the partisan affiliation unless a court of~~
36 ~~competent jurisdiction directs otherwise.~~)

1 (2) A person affected may petition the superior court of ~~((the))~~
2 Thurston county ~~((in which the filing officer is located))~~ for a
3 judicial determination of the right to the name of a minor political
4 party, either before or after documents are filed with the ~~((filing~~
5 ~~officer))~~ secretary of state. The court shall resolve the conflict
6 between competing claims to the use of the same party name according to
7 the following principles: (a) The prior established public use of the
8 name during previous elections by a party composed of or led by the
9 same individuals or individuals in documented succession; (b) prior
10 established public use of the name earlier in the same election cycle;
11 (c) ~~((the nomination of a more complete slate of candidates for a~~
12 ~~number of offices or in a number of different regions of the state;~~
13 ~~(d))~~ documented affiliation with a national or statewide party
14 organization with an established use of the name; ~~((e))~~ (d) the first
15 date of filing of a certificate of nomination; and ~~((f))~~ (e) such
16 other indicia of an established right to use of the name as the court
17 may deem relevant. ~~((If more than one filing officer is involved, and~~
18 ~~one of them is the secretary of state, the petition must be filed in~~
19 ~~the superior court for Thurston county.))~~ Upon resolving the conflict
20 between competing claims, the court may also address any ballot
21 designation for the candidate who does not prevail.

22 **Sec. 12.** RCW 29A.20.180 and 2003 c 111 s 512 are each amended to
23 read as follows:

24 A minor political party or independent candidate convention
25 nominating candidates for the offices of president and vice president
26 of the United States shall, not later than ten days after the
27 adjournment of the convention, submit a list of presidential electors
28 to the office of the secretary of state. The list shall contain the
29 names and the mailing addresses of the persons selected and shall be
30 verified by the ~~((presiding officer of the convention))~~ candidates
31 named on the nominating petition.

32 **Sec. 13.** RCW 29A.20.190 and 2003 c 111 s 513 are each amended to
33 read as follows:

34 Upon the receipt of the ~~((certificate of nomination))~~ nominating
35 petition, the ~~((officer with whom it is filed shall check the~~
36 ~~certificate and))~~ secretary of state shall canvass the signatures ~~((on~~

1 ~~the accompanying nominating petitions to determine if the requirements~~
2 ~~of RCW 29A.20.140 have been met)).~~ Once the determination of the
3 sufficiency of the petitions has been made, the filing officer shall
4 notify the (~~presiding officer of the convention~~) candidates and any
5 other persons requesting the notification(~~, of his or her decision~~
6 ~~regarding the sufficiency of the certificate or the nominating~~
7 ~~petitions)).~~ Any appeal regarding the filing officer's determination
8 must be filed with the superior court of (~~the~~) Thurston county (~~in~~
9 ~~which the certificate or petitions were filed~~) not later than five
10 days from the date the determination is made, and shall be heard and
11 finally disposed of by the court within five days of the filing.
12 Nominating petitions shall not be available for public inspection or
13 copying.

14 **Sec. 14.** RCW 29A.24.030 and 2003 c 111 s 603 are each amended to
15 read as follows:

16 A candidate who desires to have his or her name printed on the
17 ballot for election to an office other than president of the United
18 States, vice president of the United States, or an office for which
19 ownership of property is a prerequisite to voting shall complete and
20 file a declaration of candidacy. The secretary of state shall adopt,
21 by rule, a declaration of candidacy form for the office of precinct
22 committee officer and a separate standard form for candidates for all
23 other offices filing under this chapter. Included on the standard form
24 shall be:

25 (1) A place for the candidate to declare that he or she is a
26 registered voter within the jurisdiction of the office for which he or
27 she is filing, and the address at which he or she is registered;

28 (2) A place for the candidate to indicate the position for which he
29 or she is filing;

30 (3) For those offices defined in section 3 of this act only, a
31 place for the candidate to (~~indicate a party designation, if~~
32 applicable)) identify a major or minor political party, if any, the
33 candidate regards as best approximating his or her own political
34 philosophy. No candidate may list more than one political party.
35 Nothing in this indication of political philosophy may be construed as
36 denoting an endorsement or nomination by that party. The sole purpose
37 of allowing candidates to identify a political party preference is to

1 provide to voters a brief description of each candidate's political
2 philosophy, which the voters may consider when casting their votes at
3 a primary or general election. If a court of competent jurisdiction
4 holds that a political party has a right to control the use of the name
5 in a manner inconsistent with this subsection, this subsection is
6 inoperative and section 15 of this act applies;

7 (4) A place for the candidate to indicate the amount of the filing
8 fee accompanying the declaration of candidacy or for the candidate to
9 indicate that he or she is filing a (~~nominating~~) petition in lieu of
10 the filing fee under RCW 29A.24.090;

11 (5) A place for the candidate to sign the declaration of candidacy,
12 stating that the information provided on the form is true and swearing
13 or affirming that he or she will support the Constitution and laws of
14 the United States and the Constitution and laws of the state of
15 Washington.

16 In the case of a declaration of candidacy filed electronically,
17 submission of the form constitutes agreement that the information
18 provided with the filing is true, that he or she will support the
19 Constitutions and laws of the United States and the state of
20 Washington, and that he or she agrees to electronic payment of the
21 filing fee established in RCW 29A.24.090.

22 The secretary of state may require any other information on the
23 form he or she deems appropriate to facilitate the filing process.

24 NEW SECTION. Sec. 15. A new section is added to chapter 29A.24
25 RCW to read as follows:

26 If, as provided in RCW 29A.24.030(3), a court of competent
27 jurisdiction holds that a political party has the right to control the
28 use of its name in a manner inconsistent with the provisions of that
29 subsection, then the following process applies:

30 For those offices defined in section 3 of this act, a place for the
31 candidate to submit a description of up to three words that the
32 candidate regards as best approximating his or her own political
33 philosophy. The sole purpose of allowing a candidate to submit a
34 three-word description is to provide to voters information about each
35 candidate's political philosophy, which the voters may consider when
36 casting their votes at a primary or general election. The secretary of

1 state shall adopt rules as necessary for the implementation of this
2 section.

3 **Sec. 16.** RCW 29A.24.080 and 2003 c 111 s 608 are each amended to
4 read as follows:

5 Any candidate may mail his or her declaration of candidacy for an
6 office to the filing officer. Such declarations of candidacy shall be
7 processed by the filing officer in the following manner:

8 (1) Any declaration received by the filing officer by mail before
9 the tenth business day immediately preceding the first day for
10 candidates to file for office shall be returned to the candidate
11 submitting it, together with a notification that the declaration of
12 candidacy was received too early to be processed. The candidate shall
13 then be permitted to resubmit his or her declaration of candidacy
14 during the filing period.

15 (2) Any properly executed declaration of candidacy received by mail
16 on or after the tenth business day immediately preceding the first day
17 for candidates to file for office and before the close of business on
18 the last day of the filing period shall be included with filings made
19 in person during the filing period. In primaries for partisan office
20 and judicial (~~elections~~) offices the filing officer shall determine
21 by lot the order in which the names of those candidates shall appear
22 upon sample and absentee primary ballots.

23 (3) Any declaration of candidacy received by the filing officer
24 after the close of business on the last day for candidates to file for
25 office shall be rejected and returned to the candidate attempting to
26 file it.

27 **Sec. 17.** RCW 29A.24.090 and 2003 c 111 s 609 are each amended to
28 read as follows:

29 A filing fee of one dollar shall accompany each declaration of
30 candidacy for precinct committee officer; a filing fee of ten dollars
31 shall accompany the declaration of candidacy for any office with a
32 fixed annual salary of one thousand dollars or less; a filing fee equal
33 to one percent of the annual salary of the office at the time of filing
34 shall accompany the declaration of candidacy for any office with a
35 fixed annual salary of more than one thousand dollars per annum. No

1 filing fee need accompany a declaration of candidacy for any office for
2 which compensation is on a per diem or per meeting attended basis.

3 A candidate who lacks sufficient assets or income at the time of
4 filing to pay the filing fee required by this section shall submit with
5 his or her declaration of candidacy a (~~nominating~~) filing petition.
6 The petition shall contain not less than a number of signatures of
7 registered voters equal to the number of dollars of the filing fee.
8 The signatures shall be of voters registered to vote within the
9 jurisdiction of the office for which the candidate is filing.

10 When the candidacy is for:

11 (1) A legislative or judicial office that includes territory from
12 more than one county, the fee shall be paid to the secretary of state
13 for equal division between the treasuries of the counties comprising
14 the district.

15 (2) A city or town office, the fee shall be paid to the county
16 auditor who shall transmit it to the city or town clerk for deposit in
17 the city or town treasury.

18 **Sec. 18.** RCW 29A.24.100 and 2003 c 111 s 610 are each amended to
19 read as follows:

20 The (~~nominating~~) filing petition authorized by RCW 29A.24.090
21 shall be printed on sheets of uniform color and size, shall contain no
22 more than twenty numbered lines, and must be in substantially the
23 following form:

24 The warning prescribed by RCW 29A.72.140; followed by:

25 We, the undersigned registered voters of . . .(the state of
26 Washington or the political subdivision for which the (~~nomination~~)
27 filing is made). . ., hereby petition that the name of
28 . . .(candidate's name). . . be printed on the official primary ballot
29 for the office of . . .(insert name of office). . .

30 If the candidate listed a political party on the declaration of
31 candidacy, then the name of that party must appear on the filing
32 petition.

33 The petition must include a place for each individual to sign and
34 print his or her name, and the address, city, and county at which he or
35 she is registered to vote.

1 **Sec. 19.** RCW 29A.24.110 and 2003 c 111 s 611 are each amended to
2 read as follows:

3 (~~Nominating~~) Petitions may be rejected for the following reasons:

- 4 (1) The petition is not in the proper form;
5 (2) The petition clearly bears insufficient signatures;
6 (3) The petition is not accompanied by a declaration of candidacy;
7 (4) The time within which the petition and the declaration of
8 candidacy could have been filed has expired.

9 If the petition is accepted, the officer with whom it is filed
10 shall canvass the signatures contained on it and shall reject the
11 signatures of those persons who are not registered voters and the
12 signatures of those persons who are not registered to vote within the
13 jurisdiction of the office for which the (~~nominating~~) petition is
14 filed. He or she shall additionally reject any signature that appears
15 on the (~~nominating~~) petitions of two or more candidates for the same
16 office and shall also reject, each time it appears, the name of any
17 person who signs the same petition more than once.

18 If the officer with whom the petition is filed refuses to accept
19 the petition or refuses to certify the petition as bearing sufficient
20 valid signatures, the person filing the petition may appeal that action
21 to the superior court. The application for judicial review shall take
22 precedence over other cases and matters and shall be speedily heard and
23 determined.

24 **Sec. 20.** RCW 29A.24.140 and 2003 c 111 s 614 are each amended to
25 read as follows:

26 A void in candidacy for (~~a nonpartisan~~) an office occurs when an
27 election for such office, except for the short term, has been scheduled
28 and no valid declaration of candidacy has been filed for the position
29 or all persons filing such valid declarations of candidacy have died or
30 been disqualified.

31 **Sec. 21.** RCW 29A.24.150 and 2003 c 111 s 615 are each amended to
32 read as follows:

33 The election officer with whom declarations of candidacy are filed

35 (1) If the requisite number of any federal, state, county, city, or
36 district offices have not (~~been nominated~~) qualified to appear on the

1 having an equal and requisite number of votes for being placed on the
2 general election ballot, the official empowered by state law to certify
3 candidates for the general election ballot shall give notice to the
4 several persons so having the equal and requisite number of votes to
5 attend at the appropriate office at the time designated by that

8 placed on the general election ballot.

9 (2) If the requisite number of any federal, state, county, city,
10 district, or precinct officers have not been elected by reason of two

12 the same office, the official empowered by state law to issue the
13 original certificate of election shall give notice to the several
14 persons so having the highest and equal number of votes to attend at
15 the appropriate office at the time to be appointed by that official,
16 who shall then and there proceed publicly to decide by lot which of
17 those persons will be declared duly elected, and the official shall
18 make out and deliver to the person thus duly declared elected a
19 certificate of election.

20 **Sec. 45.** RCW 29A.64.010 and 2003 c 111 s 1601 are each amended to
21 read as follows:

22 An officer of a political party or any person for whom votes were
23 cast in a primary who was not declared (~~nominated~~) qualified to
24 appear on the general election ballot may file a written application
25 for a recount of the votes or a portion of the votes cast at that
26 primary for all persons for whom votes were cast for (~~nomination to~~)
27 that office.

28 An officer of a political party or any person for whom votes were
29 cast at any election may file a written application for a recount of
30 the votes or a portion of the votes cast at that election for all
31 candidates for election to that office.

32 Any group of five or more registered voters may file a written
33 application for a recount of the votes or a portion of the votes cast
34 upon any question or issue. They shall designate one of the members of

9 election official for the office. The recount shall be conducted using
10 the alternative method if: It is suited to the balloting system that
11 was used for casting the votes for the office; it involves the use of
12 a vote tallying system that is approved for use in this state by the

15 balloting system was used in casting votes for the office, an
16 alternative to a manual recount may be selected for each system.

31 the costs of the recount exceed the deposit, the applicant shall pay
32 the difference. No charges may be deducted by the canvassing board

24 (b) The governing body of the state organization of a major
25 political party, as defined in RCW (~~((29.01.090))~~) 29A.04.085, that is
26 the body authorized by the charter or bylaws of the party to exercise
27 authority on behalf of the state party; or

28 (c) The county central committee or legislative district committee
29 of a major political party. There may be only one legislative district
30 committee for each party in each legislative district.

31 (6) "Depository" means a bank designated by a candidate or
32 political committee pursuant to RCW 42.17.050.

33 (7) "Treasurer" and "deputy treasurer" mean the individuals
34 appointed by a candidate or political committee, pursuant to RCW
35 42.17.050, to perform the duties specified in that section.

36 (8) "Candidate" means any individual who seeks nomination for
37 election or election to public office. An individual seeks nomination
38 or election when he or she first:

1 (a) Receives contributions or makes expenditures or reserves space
2 or facilities with intent to promote his or her candidacy for office;

3 (b) Announces publicly or files for office;

4 (c) Purchases commercial advertising space or broadcast time to
5 promote his or her candidacy; or

6 (d) Gives his or her consent to another person to take on behalf of
7 the individual any of the actions in (a) or (c) of this subsection.

8 (9) "Caucus political committee" means a political committee
9 organized and maintained by the members of a major political party in
10 the state senate or state house of representatives.

11 (10) "Commercial advertiser" means any person who sells the service
12 of communicating messages or producing printed material for broadcast
13 or distribution to the general public or segments of the general public
14 whether through the use of newspapers, magazines, television and radio
15 stations, billboard companies, direct mail advertising companies,
16 printing companies, or otherwise.

17 (11) "Commission" means the agency established under RCW 42.17.350.

18 (12) "Compensation" unless the context requires a narrower meaning,
19 includes payment in any form for real or personal property or services
20 of any kind: PROVIDED, That for the purpose of compliance with RCW
21 42.17.241, the term "compensation" shall not include per diem
22 allowances or other payments made by a governmental entity to reimburse
23 a public official for expenses incurred while the official is engaged
24 in the official business of the governmental entity.

25 (13) "Continuing political committee" means a political committee
26 that is an organization of continuing existence not established in
27 anticipation of any particular election campaign.

28 (14)(a) "Contribution" includes:

29 (i) A loan, gift, deposit, subscription, forgiveness of
30 indebtedness, donation, advance, pledge, payment, transfer of funds
31 between political committees, or anything of value, including personal
32 and professional services for less than full consideration;

33 (ii) An expenditure made by a person in cooperation, consultation,
34 or concert with, or at the request or suggestion of, a candidate, a
35 political committee, or their agents;

36 (iii) The financing by a person of the dissemination, distribution,
37 or republication, in whole or in part, of broadcast, written, graphic,

1 or other form of political advertising prepared by a candidate, a
2 political committee, or its authorized agent;

3 (iv) Sums paid for tickets to fund-raising events such as dinners
4 and parties, except for the actual cost of the consumables furnished at
5 the event.

6 (b) "Contribution" does not include:

7 (i) Standard interest on money deposited in a political committee's
8 account;

9 (ii) Ordinary home hospitality;

10 (iii) A contribution received by a candidate or political committee
11 that is returned to the contributor within five business days of the
12 date on which it is received by the candidate or political committee;

13 (iv) A news item, feature, commentary, or editorial in a regularly
14 scheduled news medium that is of primary interest to the general
15 public, that is in a news medium controlled by a person whose business
16 is that news medium, and that is not controlled by a candidate or a
17 political committee;

18 (v) An internal political communication primarily limited to the
19 members of or contributors to a political party organization or
20 political committee, or to the officers, management staff, or
21 stockholders of a corporation or similar enterprise, or to the members
22 of a labor organization or other membership organization;

23 (vi) The rendering of personal services of the sort commonly
24 performed by volunteer campaign workers, or incidental expenses
25 personally incurred by volunteer campaign workers not in excess of
26 fifty dollars personally paid for by the worker. "Volunteer services,"
27 for the purposes of this section, means services or labor for which the
28 individual is not compensated by any person;

29 (vii) Messages in the form of reader boards, banners, or yard or
30 window signs displayed on a person's own property or property occupied
31 by a person. However, a facility used for such political advertising
32 for which a rental charge is normally made must be reported as an in-
33 kind contribution and counts towards any applicable contribution limit
34 of the person providing the facility;

35 (viii) Legal or accounting services rendered to or on behalf of:

36 (A) A political party or caucus political committee if the person
37 paying for the services is the regular employer of the person rendering
38 such services; or

1 (B) A candidate or an authorized committee if the person paying for
2 the services is the regular employer of the individual rendering the
3 services and if the services are solely for the purpose of ensuring
4 compliance with state election or public disclosure laws.

5 (c) Contributions other than money or its equivalent are deemed to
6 have a monetary value equivalent to the fair market value of the
7 contribution. Services or property or rights furnished at less than
8 their fair market value for the purpose of assisting any candidate or
9 political committee are deemed a contribution. Such a contribution
10 must be reported as an in-kind contribution at its fair market value
11 and counts towards any applicable contribution limit of the provider.

12 (15) "Elected official" means any person elected at a general or
13 special election to any public office, and any person appointed to fill
14 a vacancy in any such office.

15 (16) "Election" includes any primary, general, or special election
16 for public office and any election in which a ballot proposition is
17 submitted to the voters: PROVIDED, That an election in which the
18 qualifications for voting include other than those requirements set
19 forth in Article VI, section 1 (Amendment 63) of the Constitution of
20 the state of Washington shall not be considered an election for
21 purposes of this chapter.

22 (17) "Election campaign" means any campaign in support of or in
23 opposition to a candidate for election to public office and any
24 campaign in support of, or in opposition to, a ballot proposition.

25 (18) "Election cycle" means the period beginning on the first day
26 of December after the date of the last previous general election for
27 the office that the candidate seeks and ending on November 30th after
28 the next election for the office. In the case of a special election to
29 fill a vacancy in an office, "election cycle" means the period
30 beginning on the day the vacancy occurs and ending on November 30th
31 after the special election.

32 (19) "Expenditure" includes a payment, contribution, subscription,
33 distribution, loan, advance, deposit, or gift of money or anything of
34 value, and includes a contract, promise, or agreement, whether or not
35 legally enforceable, to make an expenditure. The term "expenditure"
36 also includes a promise to pay, a payment, or a transfer of anything of
37 value in exchange for goods, services, property, facilities, or
38 anything of value for the purpose of assisting, benefiting, or honoring

8 (20) "Final report" means the report described as a final report in
9 RCW 42.17.080(2).

10 (21) "General election" for the purposes of RCW 42.17.640 means the
11 election that results in the election of a person to a state office.
12 It does not include a primary.

13 (22) "Gift," is as defined in RCW 42.52.010.

14 (23) "Immediate family" includes the spouse, dependent children,
15 and other dependent relatives, if living in the household. For the
16 purposes of RCW 42.17.640 through 42.17.790, "immediate family" means
17 an individual's spouse, and child, stepchild, grandchild, parent,
18 stepparent, grandparent, brother, half brother, sister, or half sister
19 of the individual and the spouse of any such person and a child,
20 stepchild, grandchild, parent, stepparent, grandparent, brother, half
21 brother, sister, or half sister of the individual's spouse and the
22 spouse of any such person.

23 (24) "Independent expenditure" means an expenditure that has each
24 of the following elements:

25 (a) It is made in support of or in opposition to a candidate for
26 office by a person who is not (i) a candidate for that office, (ii) an
27 authorized committee of that candidate for that office, (iii) a person
28 who has received the candidate's encouragement or approval to make the
29 expenditure, if the expenditure pays in whole or in part for political
30 advertising supporting that candidate or promoting the defeat of any
31 other candidate or candidates for that office, or (iv) a person with
32 whom the candidate has collaborated for the purpose of making the
33 expenditure, if the expenditure pays in whole or in part for political
34 advertising supporting that candidate or promoting the defeat of any
35 other candidate or candidates for that office;

36 (b) The expenditure pays in whole or in part for political
37 advertising that either specifically names the candidate supported or

1 opposed, or clearly and beyond any doubt identifies the candidate
2 without using the candidate's name; and

3 (c) The expenditure, alone or in conjunction with another
4 expenditure or other expenditures of the same person in support of or
5 opposition to that candidate, has a value of five hundred dollars or
6 more. A series of expenditures, each of which is under five hundred
7 dollars, constitutes one independent expenditure if their cumulative
8 value is five hundred dollars or more.

9 (25)(a) "Intermediary" means an individual who transmits a
10 contribution to a candidate or committee from another person unless the
11 contribution is from the individual's employer, immediate family as
12 defined for purposes of RCW 42.17.640 through 42.17.790, or an
13 association to which the individual belongs.

14 (b) A treasurer or a candidate is not an intermediary for purposes
15 of the committee that the treasurer or candidate serves.

16 (c) A professional fund-raiser is not an intermediary if the fund-
17 raiser is compensated for fund-raising services at the usual and
18 customary rate.

19 (d) A volunteer hosting a fund-raising event at the individual's
20 home is not an intermediary for purposes of that event.

21 (26) "Legislation" means bills, resolutions, motions, amendments,
22 nominations, and other matters pending or proposed in either house of
23 the state legislature, and includes any other matter that may be the
24 subject of action by either house or any committee of the legislature
25 and all bills and resolutions that, having passed both houses, are
26 pending approval by the governor.

27 (27) "Lobby" and "lobbying" each mean attempting to influence the
28 passage or defeat of any legislation by the legislature of the state of
29 Washington, or the adoption or rejection of any rule, standard, rate,
30 or other legislative enactment of any state agency under the state
31 Administrative Procedure Act, chapter 34.05 RCW. Neither "lobby" nor
32 "lobbying" includes an association's or other organization's act of
33 communicating with the members of that association or organization.

34 (28) "Lobbyist" includes any person who lobbies either in his or
35 her own or another's behalf.

36 (29) "Lobbyist's employer" means the person or persons by whom a
37 lobbyist is employed and all persons by whom he or she is compensated
38 for acting as a lobbyist.

1 (30) "Person" includes an individual, partnership, joint venture,
2 public or private corporation, association, federal, state, or local
3 governmental entity or agency however constituted, candidate,
4 committee, political committee, political party, executive committee
5 thereof, or any other organization or group of persons, however
6 organized.

7 (31) "Person in interest" means the person who is the subject of a
8 record or any representative designated by that person, except that if
9 that person is under a legal disability, the term "person in interest"
10 means and includes the parent or duly appointed legal representative.

11 (32) "Political advertising" includes any advertising displays,
12 newspaper ads, billboards, signs, brochures, articles, tabloids,
13 flyers, letters, radio or television presentations, or other means of
14 mass communication, used for the purpose of appealing, directly or
15 indirectly, for votes or for financial or other support in any election
16 campaign.

17 (33) "Political committee" means any person (except a candidate or
18 an individual dealing with his or her own funds or property) having the
19 expectation of receiving contributions or making expenditures in
20 support of, or opposition to, any candidate or any ballot proposition.

21 (34) "Primary" for the purposes of RCW 42.17.640 means the
22 procedure for ~~((nominating))~~ qualifying a candidate to state office
23 under chapter ~~((29.18 or 29.21 RCW or any other primary for an election
24 that uses, in large measure, the procedures established in chapter
25 29.18 or 29.21))~~ 29A.52 RCW.

26 (35) "Public office" means any federal, state, county, city, town,
27 school district, port district, special district, or other state
28 political subdivision elective office.

29 (36) "Public record" includes any writing containing information
30 relating to the conduct of government or the performance of any
31 governmental or proprietary function prepared, owned, used, or retained
32 by any state or local agency regardless of physical form or
33 characteristics. For the office of the secretary of the senate and the
34 office of the chief clerk of the house of representatives, public

36 means the following: All budget and financial records; personnel
37 leave, travel, and payroll records; records of legislative sessions;

1 reports submitted to the legislature; and any other record designated
2 a public record by any official action of the senate or the house of
3 representatives.

4 (37) "Recall campaign" means the period of time beginning on the
5 date of the filing of recall charges under RCW (~~(29.82.015)~~) 29A.56.120
6 and ending thirty days after the recall election.

7 (38) "State legislative office" means the office of a member of the
8 state house of representatives or the office of a member of the state
9 senate.

10 (39) "State office" means state legislative office or the office of
11 governor, lieutenant governor, secretary of state, attorney general,
12 commissioner of public lands, insurance commissioner, superintendent of
13 public instruction, state auditor, or state treasurer.

14 (40) "State official" means a person who holds a state office.

15 (41) "Surplus funds" mean, in the case of a political committee or
16 candidate, the balance of contributions that remain in the possession
17 or control of that committee or candidate subsequent to the election
18 for which the contributions were received, and that are in excess of
19 the amount necessary to pay remaining debts incurred by the committee
20 or candidate prior to that election. In the case of a continuing
21 political committee, "surplus funds" mean those contributions remaining
22 in the possession or control of the committee that are in excess of the
23 amount necessary to pay all remaining debts when it makes its final
24 report under RCW 42.17.065.

25 (42) "Writing" means handwriting, typewriting, printing,
26 photostating, photographing, and every other means of recording any
27 form of communication or representation, including, but not limited to,
28 letters, words, pictures, sounds, or symbols, or combination thereof,
29 and all papers, maps, magnetic or paper tapes, photographic films and
30 prints, motion picture, film and video recordings, magnetic or punched
31 cards, discs, drums, diskettes, sound recordings, and other documents
32 including existing data compilations from which information may be
33 obtained or translated.

34 As used in this chapter, the singular shall take the plural and any
35 gender, the other, as the context requires.

11 state government and its existing public institutions, and takes effect
12 immediately.
