31 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

32 <u>NEW SECTION.</u> Sec. 1. The legislature intends by this act to 33 reorganize criminal provisions throughout the Revised Code of 34 Washington to clarify and simplify the identification and referencing 35 of crimes. It is not intended that this act effectuate any substantive 36 change to any criminal provision in the Revised Code of Washington.

1 Sec. 2. RCW 2.48.180 and 2001 c 310 s 2 are each amended to read 2 as follows:

(1) As used in this section:

4 (a) "Legal provider" means an active member in good standing of the
5 state bar, and any other person authorized by the Washington state
6 supreme court to engage in full or limited practice of law;

7 (b) "Nonlawyer" means a person to whom the Washington supreme court 8 has granted a limited authorization to practice law but who practices 9 law outside that authorization, and a person who is not an active 10 member in good standing of the state bar, including persons who are 11 disbarred or suspended from membership;

(c) "Ownership interest" means the right to control the affairs of a business, or the right to share in the profits of a business, and includes a loan to the business when the interest on the loan is based upon the income of the business or the loan carries more than a commercially reasonable rate of interest.

(2) The following constitutes unlawful practice of law:

(a) A nonlawyer practices law, or holds himself or herself out asentitled to practice law;

(b) A legal provider holds an investment or ownership interest in
a business primarily engaged in the practice of law, knowing that a
nonlawyer holds an investment or ownership interest in the business;

(c) A nonlawyer knowingly holds an investment or ownership interestin a business primarily engaged in the practice of law;

(d) A legal provider works for a business that is primarily engaged in the practice of law, knowing that a nonlawyer holds an investment or ownership interest in the business; or

(e) A nonlawyer shares legal fees with a legal provider.

(3)(a) Unlawful practice of law is a crime. A single violation of
 this section is a gross misdemeanor.

31 (b) Each subsequent violation <u>of this section</u>, whether alleged in 32 the same or in subsequent prosecutions, is a class C felony <u>punishable</u> 33 <u>according to chapter 9A.20 RCW</u>.

34 (4) Nothing contained in this section affects the power of the
 35 courts to grant injunctive or other equitable relief or to punish as
 36 for contempt.

37 (5) Whenever a legal provider or a person licensed by the state in38 a business or profession is convicted, enjoined, or found liable for

1 damages or a civil penalty or other equitable relief under this 2 section, the plaintiff's attorney shall provide written notification of 3 the judgment to the appropriate regulatory or disciplinary body or 4 agency.

5 (6) A violation of this section is cause for discipline and 6 constitutes unprofessional conduct that could result in any regulatory 7 penalty provided by law, including refusal, revocation, or suspension 8 of a business or professional license, or right or admission to 9 practice. Conduct that constitutes a violation of this section is 10 unprofessional conduct in violation of RCW 18.130.180.

(7) In a proceeding under this section it is a defense if proven by the defendant by a preponderance of the evidence that, at the time of the offense, the conduct alleged was authorized by the rules of professional conduct or the admission to practice rules, or Washington business and professions licensing statutes or rules.

(8) Independent of authority granted to the attorney general, the 16 17 prosecuting attorney may petition the superior court for an injunction against a person who has violated this chapter. Remedies in an 18 injunctive action brought by a prosecuting attorney are limited to an 19 order enjoining, restraining, or preventing the doing of any act or 20 21 practice that constitutes a violation of this chapter and imposing a 22 civil penalty of up to five thousand dollars for each violation. The prevailing party in the action may, in the discretion of the court, 23 24 recover its reasonable investigative costs and the costs of the action 25 including a reasonable attorney's fee. The degree of proof required in 26 an action brought under this subsection is a preponderance of the 27 evidence. An action under this subsection must be brought within three 28 years after the violation of this chapter occurred.

Every person convicted by the municipal court of a violation of the criminal provisions of an ordinance for which no punishment is specifically prescribed in the ordinance <u>is quilty of a gross</u> <u>misdemeanor and</u> shall be punished by a fine of not more than five thousand dollars or imprisonment in the city jail for a period not to exceed one year, or both such fine and imprisonment.

36 or prevent the continuance or recurrence of the violation of RCW

1 declaratory relief, mandatory orders, or any other relief deemed 2 necessary to accomplish the purposes of the injunction. The court may 3 retain jurisdiction of the case for the purpose of enforcing its 4 orders.

(5) If it is shown to the satisfaction of the court, either by 5 verified complaint or affidavit, that a person is engaged in or is б 7 about to engage in any act that constitutes a violation of RCW 9.26A.110, section 21 of this act, or 9.26A.090, the court may issue an 8 9 order which shall be promptly served upon the person in whose name the 10 telecommunications device is listed, requiring the party, within a reasonable time, to be fixed by the court, from the time of service of 11 12 the petition on ((said)) the party, to show cause before the judge why 13 telephone service should not promptly be discontinued. At the hearing 14 the burden of proof shall be on the complainant.

(6) Upon a finding by the court that the telecommunications device 15 is being used or has been used in violation of RCW 9.26A.110 or section 16 17 21 of this act, the court may issue an order requiring the telephone company which is rendering service over the device to disconnect such 18 service. Upon receipt of such order, which shall be served upon an 19 officer of the telephone company by the sheriff or deputy of the county 20 21 in which the telecommunications device is installed, the telephone 22 company shall proceed promptly to disconnect and remove such device and discontinue all telephone service until further order of the court, 23 24 provided that the telephone company may do so without breach of the 25 peace or trespass.

(7) The telecommunications company that petitions the court for the removal of any telecommunications device under this section shall be a necessary party to any proceeding or action arising out of or under RCW 9.26A.110 or section 21 of this act.

(8) No telephone company shall be liable for any damages, penalty,
 or forfeiture, whether civil or criminal, for any legal act performed
 in compliance with any order issued by the court.

(9) Property seized pursuant to the direction of the court that the court has determined to have been used in violation of RCW 9.26A.110 or section 21 of this act shall be forfeited after notice and hearing. The court may remit or mitigate the forfeiture upon terms and conditions as the court deems reasonable if it finds that such forfeiture was incurred without gross negligence or without any intent

of the petitioner to violate the law, or it finds the existence of such mitigating circumstances as to justify the remission or the mitigation of the forfeiture. In determining whether to remit or mitigate forfeiture, the court shall consider losses that may have been suffered by victims as the result of the use of the forfeited property.

Whenever any inmate of a correctional institution shall hold, or participate in holding, any person as a hostage, by force or violence, or the threat thereof, or shall prevent, or participate in preventing an officer of such institution from carrying out his or her duties, by force or violence, or the threat thereof, he or she shall be guilty of a <u>class B</u> felony and upon conviction shall be punished by imprisonment in a state correctional institution for not less than one year nor more
 than ten years.

For offenders placed on community 27 custody for crimes committed on or after July 1, 2000, the department 28 shall assess the offender's risk of reoffense and may establish and 29 modify conditions of community custody, in addition to those imposed by 30 31 the court, based upon the risk to community safety.

32 (6) "Community custody range" means the minimum and maximum period
33 of community custody included as part of a sentence under RCW
34 9.94A.715, as established by the commission or the legislature under
35 RCW 9.94A.850, for crimes committed on or after July 1, 2000.

36 (7) "Community placement" means that period during which the 37 offender is subject to the conditions of community custody and/or postrelease supervision, which begins either upon completion of the term of confinement (postrelease supervision) or at such time as the offender is transferred to community custody in lieu of earned release. Community placement may consist of entirely community custody, entirely postrelease supervision, or a combination of the two.

6 (8) "Community restitution" means compulsory service, without 7 compensation, performed for the benefit of the community by the 8 offender.

(9) "Community supervision" means a period of time during which a 9 convicted offender is subject to crime-related prohibitions and other 10 sentence conditions imposed by a court pursuant to this chapter or RCW 11 16.52.200(6) or 46.61.524. Where the court finds that any offender has 12 13 a chemical dependency that has contributed to his or her offense, the 14 conditions of supervision may, subject to available resources, include treatment. For purposes of the interstate compact for out-of-state 15 supervision of parolees and probationers, RCW 9.95.270, community 16 17 supervision is the functional equivalent of probation and should be considered the same as probation by other states. 18

(10) "Confinement" means total or partial confinement.

(11) "Conviction" means an adjudication of guilt pursuant to Titles
10 or 13 RCW and includes a verdict of guilty, a finding of guilty, and
acceptance of a plea of guilty.

(12) "Crime-related prohibition" means an order of a court prohibiting conduct that directly relates to the circumstances of the crime for which the offender has been convicted, and shall not be construed to mean orders directing an offender affirmatively to participate in rehabilitative programs or to otherwise perform affirmative conduct. However, affirmative acts necessary to monitor compliance with the order of a court may be required by the department.

30 (13) "Criminal history" means the list of a defendant's prior 31 convictions and juvenile adjudications, whether in this state, in 32 federal court, or elsewhere.

33 (a) The history shall include, where known, for each conviction (i) 34 whether the defendant has been placed on probation and the length and 35 terms thereof; and (ii) whether the defendant has been incarcerated and 36 the length of incarceration.

(b) A conviction may be removed from a defendant's criminal history

a controlled substance (((RCW 69.50.401(d))) section 334 of this act)

9A.76.120), willful failure to return from furlough (RCW 72.66.060),
willful failure to return from work release (RCW 72.65.070), or willful
failure to be available for supervision by the department while in
community custody (RCW 72.09.310); or

(b) Any federal or out-of-state conviction for an offense that

The 25 home detention program may also be made available to offenders whose charges and convictions do not otherwise disqualify them if medical or 26 27 health-related conditions, concerns or treatment would be better addressed under the home detention program, or where the health and 28 welfare of the offender, other inmates, or staff would be jeopardized 29 by the offender's incarceration. Participation in the home detention 30 31 program for medical or health-related reasons is conditioned on the 32 offender abiding by the rules of the home detention program and complying with court-ordered restitution. 33



9 (ii) The bona fide gift of a controlled substance, legend drug, or 10 imitation controlled substance shall not result in the forfeiture of 11 real property;

(iii) The possession of marijuana shall not result in the 12 13 forfeiture of real property unless the marijuana is possessed for commercial purposes, the amount possessed is five or more plants or one 14 pound or more of marijuana, and a substantial nexus exists between the 15 16 possession of marijuana and the real property. In such a case, the 17 intent of the offender shall be determined by the preponderance of the evidence, including the offender's prior criminal history, the amount 18 of marijuana possessed by the offender, the sophistication of the 19 activity or equipment used by the offender, and other evidence which 20 21 demonstrates the offender's intent to engage in commercial activity;

(iv) The unlawful sale of marijuana or a legend drug shall not result in the forfeiture of real property unless the sale was forty grams or more in the case of marijuana or one hundred dollars or more in the case of a legend drug, and a substantial nexus exists between the unlawful sale and the real property; and

(v) A forfeiture of real property encumbered by a bona fide security interest is subject to the interest of the secured party if the secured party, at the time the security interest was created, neither had knowledge of nor consented to the act or omission.

31 (((b))) (2) Real or personal property subject to forfeiture under 32 this chapter may be seized by any board inspector or law enforcement 33 officer of this state upon process issued by any superior court having jurisdiction over the property. Seizure of real property shall include 34 the filing of a lis pendens by the seizing agency. Real property 35 seized under this section shall not be transferred or otherwise 36 conveyed until ninety days after seizure or until a judgment of 37 38 forfeiture is entered, whichever is later: PROVIDED, That real

property seized under this section may be transferred or conveyed to any person or entity who acquires title by foreclosure or deed in lieu of foreclosure of a security interest. Seizure of personal property without process may be made if:

5 (((1))) <u>(a)</u> The seizure is incident to an arrest or a search under 6 a search warrant or an inspection under an administrative inspection 7 warrant;

17 (((c))) <u>(3)</u> In the event of seizure pursuant to subsection (((b)))(2) of this section, proceedings for forfeiture shall be deemed 18 The law enforcement agency under whose 19 commenced by the seizure. authority the seizure was made shall cause notice to be served within 20 21 fifteen days following the seizure on the owner of the property seized 22 and the person in charge thereof and any person having any known right or interest therein, including any community property interest, of the 23 24 seizure and intended forfeiture of the seized property. Service of 25 notice of seizure of real property shall be made according to the rules of civil procedure. (((d))) <u>(4)</u> If no person notifies the seizing law enforcement 4 agency in writing of the person's claim of ownership or right to 5 possession of items specified in subsection $\left(\left(\frac{a}{a}\right), \frac{a}{a}\right)$, or 6 (a)(8))) (1)(d), (q), or (h) of this section within forty-five days of 7 the seizure in the case of personal property and ninety days in the 8 case of real property, the item seized shall be deemed forfeited. 9 The 10 community property interest in real property of a person whose spouse committed a violation giving rise to seizure of the real property may 11 12 not be forfeited if the person did not participate in the violation.

13 (((+))) (5) If any person notifies the seizing law enforcement 14 agency in writing of the person's claim of ownership or right to 15 possession of items specified in subsection $\left(\left(\frac{a}{2}, \frac{a}{3}, \frac{a}{4}\right)\right)$ (a)(5), (a)(6), (a)(7), or (a)(8)) (1)(b), (c), (d), (e), (f), (g), or16 (h) of this section within forty-five days of the seizure in the case 17 of personal property and ninety days in the case of real property, the 18 person or persons shall be afforded a reasonable opportunity to be 19 heard as to the claim or right. The hearing shall be before the chief 20 21 law enforcement officer of the seizing agency or the chief law 22 enforcement officer's designee, except where the seizing agency is a state agency as defined in RCW 34.12.020(4), the hearing shall be 23 24 before the chief law enforcement officer of the seizing agency or an 25 administrative law judge appointed under chapter 34.12 RCW, except that any person asserting a claim or right may remove the matter to a court 26 27 of competent jurisdiction. Removal of any matter involving personal property may only be accomplished according to the rules of civil 28 procedure. The person seeking removal of the matter must serve process 29 against the state, county, political subdivision, or municipality that 30 31 operates the seizing agency, and any other party of interest, in 32 accordance with RCW 4.28.080 or 4.92.020, within forty-five days after the person seeking removal has notified the seizing law enforcement 33 agency of the person's claim of ownership or right to possession. 34 The court to which the matter is to be removed shall be the district court 35 36 when the aggregate value of personal property is within the 37 jurisdictional limit set forth in RCW 3.66.020. In all cases, the burden of proof is upon the law enforcement agency to establish, by a preponderance of the evidence, that the property is subject to forfeiture.

The seizing law enforcement agency shall promptly return the article or articles to the claimant upon a determination by the administrative law judge or court that the claimant is the present lawful owner or is lawfully entitled to possession thereof of items specified in subsection (((a)(2), (a)(3), (a)(4), (a)(5), (a)(6),(a)(7), or (a)(8))) (1)(b), (c), (d), (e), (f), (g), or (h) of this section.

11 (((f))) (6) In any proceeding to forfeit property under this title, 12 where the claimant substantially prevails, the claimant is entitled to 13 reasonable attorneys' fees reasonably incurred by the claimant. In 14 addition, in a court hearing between two or more claimants to the 15 article or articles involved, the prevailing party is entitled to a 16 judgment for costs and reasonable attorneys' fees.

17 (((+g))) (7) When property is forfeited under this chapter the board 18 or seizing law enforcement agency may:

19 (((1))) (a) Retain it for official use or upon application by any 20 law enforcement agency of this state release such property to such 21 agency for the exclusive use of enforcing the provisions of this 22 chapter;

23 (((2))) (b) Sell that which is not required to be destroyed by law 24 and which is not harmful to the public;

Money retained 34 under this section may not be used to supplant preexisting funding 35 sources.

36 (((+))) (11) Controlled substances listed in Schedule I, II, III, 37 IV, and V that are possessed, transferred, sold, or offered for sale in 38 violation of this chapter are contraband and shall be seized and 1 summarily forfeited to the state. Controlled substances listed in 2 Schedule I, II, III, IV, and V, which are seized or come into the 3 possession of the board, the owners of which are unknown, are 4 contraband and shall be summarily forfeited to the board.

(2)(a) Except as provided in (b) of this subsection, a person who 20 violates any rule adopted, promulgated, or issued by the commission 21 22 pursuant to the provisions of this chapter((; shall be)) is guilty of 23 a misdemeanor ((unless)).

24 (b) The commission ((has specified)) may specify by rule, when not 25 inconsistent with applicable statutes, that violation of the rule is an infraction under chapter 7.84 RCW. 26

Sec. 383. RCW 80.28.190 and 1971 c 81 s 141 are each amended to 27 read as follows: 28

3 (4) The amount of tax, until paid by the buyer to the seller or to 4 the department, shall constitute a debt from the buyer to the seller 5 and any seller who fails or refuses to collect the tax as required with 6 intent to violate the provisions of this chapter or to gain some 7 advantage or benefit, either direct or indirect, and any buyer who 8 refuses to pay any tax due under this chapter ((shall be)) is guilty of 9 a misdemeanor.

(5) The tax required by this chapter to be collected by the seller 10 shall be stated separately from the selling price in any sales invoice 11 12 or other instrument of sale. On all retail sales through vending 13 machines, the tax need not be stated separately from the selling price or collected separately from the buyer. For purposes of determining 14 the tax due from the buyer to the seller and from the seller to the 15 16 department it shall be conclusively presumed that the selling price 17 quoted in any price list, sales document, contract or other agreement between the parties does not include the tax imposed by this chapter, 18 19 but if the seller advertises the price as including the tax or that the 20 seller is paying the tax, the advertised price shall not be considered 21 the selling price.
