- 8 s 1 & 1989 c 260 s 3 are each repealed.
- 9 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 43.70 RCW
- 10 to read as follows:
- 11 (1) "Human immunodeficiency virus insurance program," as used in
- 12 this section, means a program that provides health insurance coverage
- 13 for individuals with human immunodeficiency virus, as defined in RCW
- 14 70.24.017(7), who are not eligible for medical assistance programs from
- 15 the department of social and health services as defined in RCW
- 16 74.09.010(8) and meet eligibility requirements established by the
- 17 department of health.

- (2) The department of health may pay for health insurance coverage 1 2 on behalf of persons with human immunodeficiency virus, who meet department eligibility requirements, and who are eligible 3 "continuation coverage" as provided by the federal consolidated omnibus 4 budget reconciliation act of 1985, group health insurance policies, or 5 individual policies. The number of insurance policies supported by 6 7 this program in the Washington state health insurance pool as defined in RCW 48.41.030(18) shall not grow beyond the July 1, 2003, level. 8
- 9 <u>NEW SECTION.</u> **Sec. 3.** The department of health shall adopt rules to implement this act.
- NEW SECTION. Sec. 4. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect July 1, 2003.
