1 AN ACT Relating to exempting from taxation certain property
2 belonging to any federally recognized Indian tribe located in the
3 state; and amending RCW 84.36.010.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 84.36.010 and 1998 c 179 s 8 are each amended to read
6 as follows:

7 (1) All property belonging exclusively to the United States, the
8 state, ~~or~~ any county or municipal corporation((~~r~~)); ~~all property~~
9 belonging exclusively to any federally recognized Indian tribe located
10 in the state, if that property is used exclusively for essential
11 government services; all state route number 16 corridor transportation
12 systems and facilities constructed under chapter 47.46 RCW((~~r~~)); and
13 all property under a financing contract pursuant to chapter 39.94 RCW
14 or recorded agreement granting immediate possession and use to ((~~said~~))
15 the public bodies listed in this section or under an order of immediate
16 possession and use pursuant to RCW 8.04.090((~~r shall be~~)); is exempt
17 from taxation. All property belonging exclusively to a foreign
18 national government ((~~shall be~~)) is exempt from taxation if ((~~such~~))
19 that property is used exclusively as an office or residence for a

1 consul or other official representative of (~~such~~) the foreign
2 national government, and if the consul or other official representative
3 is a citizen of (~~such~~) that foreign nation.

4 (2) For the purposes of this section, "essential government
5 services" means services such as tribal administration, public
6 facilities, fire, police, public health, education, sewer, water,
7 environmental and land use, transportation, and utility services.
