- January 1, 2003, that changes the major lines of instruction exclusive to the University of Washington or Washington State University, including the amendments in chapter . . ., Laws of 2003 (this act).
 - (2) If a four-year institution requests approval under RCW 28B.80.340 of a new degree program that is the result of legislation enacted to change the terms of RCW 28B.10.115, the higher education coordinating board shall conduct an independent analysis using information from a variety of sources as part of the board's review of the proposed program, including but not limited to information submitted by the institution. Such information shall include:
 - (a) Detailed evidence of why the program is justified, including the size and scope of student, employer, and community demand for the program;
 - (b) The feasibility of using existing public or private capacity for the program and comparisons of the state cost of providing existing and proposed capacity. Any institution that offers programs under this section shall comply with all applicable state rules and regulations;
 - (c) Projected future enrollment in the program and substantiation of the enrollment estimates; and
 - (d) Additional information as requested by the board regarding demand, need, and cost-effectiveness of the program.
 - (3) The higher education coordinating board shall submit a complete analysis of a proposed program under this section to the higher education committees of the legislature before making a final determination regarding approval of the program.

Note: Governor's explanation of partial veto is as follows:

"I am returning herewith, without my approval, as to section 2, Engrossed House Bill No. 1808 entitled:

"An Act relating to establishing standards of review in order to change lines of instruction at research universities;"

This legislation allows any public university to apply to the Higher Education Coordinating Board to offer an electrical engineering degree.

Section 2 requires the Higher Education Coordinating Board to conduct an analysis of any proposed electrical engineering program using a variety of sources of information. Information reviewed must include: detailed evidence of student, employer and community demand for the program; the feasibility of using existing public or

private program capacity rather than opening a new program; and projected future enrollment. This section also requires that the Higher Education Coordinating Board submit its analysis to the higher education committees of the legislature before making a final decision regarding program approval.

I encourage the Higher Education Coordinating Board to follow the criteria set forth in section 2 of this bill. However, current statute already requires the Higher Education Coordinating Board to review and approve all proposals for new degree programs. Therefore, section 2 is not necessary.

For these reasons, I have vetoed section 2 of Engrossed House Bill No. 1808.

With the exception of section 2, Engrossed House Bill No. 1808 is approved."
