3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 Sec. 1. RCW 79.92.030 and 1989 c 79 s 1 are each amended to read 5 as follows:

The commission on harbor lines is hereby authorized to change, 6 7 relocate, or reestablish harbor lines in Guemes Channel and Fidalgo Bay 8 in front of the city of Anacortes, Skagit county; in Grays Harbor in front of the cities of Aberdeen, Hoquiam, and Cosmopolis, Grays Harbor 9 10 county; Bellingham Bay in front of the city of Bellingham and in Drayton Harbor in front of the city of Blaine, Whatcom county; in 11 12 Elliott Bay, Puget Sound and Lake Union within, and in front of the city of Seattle, King county, and within one mile of the limits of such 13 city; Port Angeles harbor in front of the city of Port Angeles, Clallam 14 county; in Lake Washington in front of the cities of Renton and Lake 15 Forest Park, King county; Commencement Bay in front of the city of 16 Tacoma, Pierce county; and within one mile of the limits of such city; 17 Budd Inlet in front of the city of Olympia, Thurston county; the 18 19 Columbia river in front of the city of Kalama, Cowlitz county; Port

Washington Narrows and Sinclair Inlet in front of the city of 1 2 Bremerton, Kitsap county; Sinclair Inlet in front of the city of Port Orchard, Kitsap county; in Liberty Bay in front of the city of Poulsbo, 3 ((King)) Kitsap county; the Columbia river in front of the city of 4 Vancouver, Clark county; Port Townsend Bay in front of the city of Port 5 Townsend, Jefferson county; the Swinomish Channel in front of the city 6 of La Conner, Skagit county; and Port Gardner Bay in front of the city 7 of Everett, ((Snohomish county,)) except no harbor lines shall be 8 established in Port Gardener Bay west of the easterly shoreline of 9 Jetty Island as presently situated or west of a line extending S 37° 10 09' 38" W from the Snohomish River Light (5), and in front of the city 11 of Edmonds, Snohomish county; in Oakland Bay in front of the city of 12 13 Shelton, Mason county; and within one mile of the limits of such city; in Gig Harbor in front of the city of Gig Harbor, Pierce county; and 14 within one mile of the limits of such city, at the entrance to the 15 Columbia river in front of the city of Ilwaco, Pacific county; in the 16 Columbia river in front of the city of Pasco, Franklin county; and in 17 the Columbia river in front of the city of Kennewick, Benton county. 18 Passed by the Senate February 3, 2004.
