AN ACT Relating to the rural Washington loan fund; amending RCW 43.84.092; reenacting and amending RCW 43.84.092; providing effective dates; providing an expiration date; and declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 43.84.092 and 2003 c 361 s 602, 2003 c 324 s 1, 2003
6 c 150 s 2, and 2003 c 48 s 2 are each reenacted and amended to read as
7 follows:

8 (1) All earnings of investments of surplus balances in the state 9 treasury shall be deposited to the treasury income account, which 10 account is hereby established in the state treasury.

(2) The treasury income account shall be utilized to pay or receive 11 12 funds associated with federal programs as required by the federal cash management improvement act of 1990. The treasury income account is 13 14 subject in all respects to chapter 43.88 RCW, but no appropriation is 15 required for refunds or allocations of interest earnings required by the cash management improvement act. Refunds of interest to the 16 federal treasury required under the cash management improvement act 17 fall under RCW 43.88.180 and shall not require appropriation. 18 The 19 office of financial management shall determine the amounts due to or

1 from the federal government pursuant to the cash management improvement 2 act. The office of financial management may direct transfers of funds 3 between accounts as deemed necessary to implement the provisions of the 4 cash management improvement act, and this subsection. Refunds or 5 allocations shall occur prior to the distributions of earnings set 6 forth in subsection (4) of this section.

7 (3) Except for the provisions of RCW 43.84.160, the treasury income account may be utilized for the payment of purchased banking services 8 on behalf of treasury funds including, but not limited to, depository, 9 10 safekeeping, and disbursement functions for the state treasury and affected state agencies. The treasury income account is subject in all 11 12 respects to chapter 43.88 RCW, but no appropriation is required for 13 payments to financial institutions. Payments shall occur prior to 14 distribution of earnings set forth in subsection (4) of this section.

15 (4) Monthly, the state treasurer shall distribute the earnings 16 credited to the treasury income account. The state treasurer shall 17 credit the general fund with all the earnings credited to the treasury 18 income account except:

Western Washington University capital projects account. Earnings 1 derived from investing balances of the agricultural permanent fund, the 2 normal school permanent fund, the permanent common school fund, the 3 scientific permanent fund, and the state university permanent fund 4 5 shall be allocated to their respective beneficiary accounts. All earnings to be distributed under this subsection (4)(a) shall first be 6 7 reduced by the allocation to the state treasurer's service fund pursuant to RCW 43.08.190. 8

(b) The following accounts and funds shall receive eighty percent 9 of their proportionate share of earnings based upon each account's or 10 fund's average daily balance for the period: The aeronautics account, 11 12 aircraft search and rescue account, the county arterial the 13 preservation account, the department of licensing services account, the 14 essential rail assistance account, the ferry bond retirement fund, the grade crossing protective fund, the high capacity transportation 15 account, the highway bond retirement fund, the highway safety account, 16 17 the motor vehicle fund, the motorcycle safety education account, the pilotage account, the public transportation systems account, the Puget 18 Sound capital construction account, the Puget Sound ferry operations 19 account, the recreational vehicle account, the rural arterial trust 20 21 account, the safety and education account, the special category C account, the state patrol highway account, the transportation 2003 22 23 account (nickel account), the transportation equipment fund, the 24 transportation fund, the transportation improvement account, the 25 transportation improvement board bond retirement account, and the urban arterial trust account. 26

(5) In conformance with Article II, section 37 of the state
Constitution, no treasury accounts or funds shall be allocated earnings
without the specific affirmative directive of this section.

 without the specific affirmative directive of this section.

NEW SECTION. Sec. 3. (1) Section 1 of this act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect July 1, 2005.

5 (2) Section 2 of this act takes effect July 1, 2006.

6 <u>NEW SECTION.</u> Sec. 4. Section 1 of this act expires July 1, 2006.
