- 1 AN ACT Relating to tax exemptions for comprehensive cancer centers;
- 2 adding a new section to chapter 82.04 RCW; adding a new section to

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 82.04 RCW 6 to read as follows:
- 7 (1) This chapter does not apply to amounts received by a 8 comprehensive cancer center to the extent the amounts are exempt from 9 federal income tax.
- 10 (2) For the purposes of this section, "comprehensive cancer center"
 11 means a cancer center that has written confirmation that it is
 12 recognized by the national cancer institute as a comprehensive cancer
 13 center and that qualifies as an exempt organization under 26 U.S.C.
 14 Sec. 501(c)(3) as existing on the effective date of this section.
- NEW SECTION. **Sec. 2.** A new section is added to chapter 82.08 RCW to read as follows:
- 17 (1) The tax levied by RCW 82.08.020 does not apply to the sale of 18 medical supplies, chemicals, or materials to a comprehensive cancer

center. The exemption in this section does not apply to the sale of construction materials, office equipment, building equipment, administrative supplies, or vehicles.

- (2) For the purposes of this section, the following definitions apply:
- 6 (a) "Comprehensive cancer center" has the meaning provided in section 1 of this act.
- 8 (b) "Chemical" means any catalyst, solvent, water, acid, oil, or 9 other additive that physically or chemically interacts with blood, 10 bone, or tissue.
- 11 (c) "Materials" means any item of tangible personal property, 12 including, but not limited to, bags, packs, collecting sets, filtering 13 materials, testing reagents, antisera, and refrigerants used or 14 consumed in performing research on, procuring, testing, processing, 15 storing, packaging, distributing, or using blood, bone, or tissue.
 - (d) "Research" means basic and applied research that has as its objective the design, development, refinement, testing, marketing, or commercialization of a product, service, or process.
 - (e) "Medical supplies" means any item of tangible personal property, including any repair and replacement parts for such tangible personal property, used by a comprehensive cancer center for the purpose of performing research on, procuring, testing, processing, storing, packaging, distributing, or using blood, bone, or tissue. The term includes tangible personal property used to:
 - (i) Provide preparatory treatment of blood, bone, or tissue;
- 26 (ii) Control, guide, measure, tune, verify, align, regulate, test, 27 or physically support blood, bone, or tissue; and
- (iii) Protect the health and safety of employees or others present during research on, procuring, testing, processing, storing, packaging, distributing, or using blood, bone, or tissue.
- NEW SECTION. Sec. 3. A new section is added to chapter 82.12 RCW to read as follows:
- 33 (1) The provisions of this chapter do not apply in respect to the 34 use of medical supplies, chemicals, or materials by a comprehensive 35 cancer center. The exemption in this section does not apply to the use 36 of construction materials, office equipment, building equipment,
