- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 69.43 RCW 6 to read as follows:
  - (1) It is unlawful for any person to possess more than one hundred grams of ephedrine or any of its salts or isomers or salts of isomers, pseudoephedrine or any of its salts or isomers or salts of isomers, or phenylpropanolamine or any of its salts or isomers or salts of isomers, or a combination of any of those substances.
- 12 (2) Any person who violates this section is guilty of a class B felony.
  - (3) This section does not apply to any of the following:
- 15 (a) A pharmacist or other authorized person who sells or furnishes 16 ephedrine, pseudoephedrine, or phenylpropanolamine, their salts, 17 isomers, or salts of isomers upon the prescription of a practitioner,

- (c) A pharmacy, manufacturer, or wholesaler licensed by, or shopkeeper or itinerant vendor registered with, the department of health under chapter 18.64 RCW; or
- (d) A person in the course of his or her business of selling, transporting, or storing ephedrine, pseudoephedrine, or phenylpropanolamine, their salts, isomers, or salts of isomers, for a person described in (a), (b), or (c) of this subsection.
