- 5 **Sec. 1.** RCW 29A.84.110 and 2003 c 111 s 2105 are each amended to read as follows:
- 7 If <u>the secretary of state or</u> any county auditor or registration 8 assistant:
 - (1) Willfully neglects or refuses to perform any duty required by law in connection with the registration of voters; or
- 11 (2) Willfully neglects or refuses to perform such duty in the 12 manner required by voter registration law; or
- 13 (3) Enters or causes or permits to be entered on the voter 14 registration records the name of any person in any other manner or at 15 any other time than as prescribed by voter registration law or enters 16 or causes or permits to be entered on such records the name of any 17 person not entitled to be thereon; or
- 18 (4) Destroys, mutilates, conceals, changes, or alters any

- 1 registration record in connection therewith except as authorized by
