
SUBSTITUTE HOUSE BILL 2420

1 AN ACT Relating to the office of lieutenant governor; adding a new
2 chapter to Title 43 RCW; creating a new section; and recodifying RCW
3 44.04.270, 44.52.010, 44.52.020, 44.52.030, 44.52.040, 44.52.050,
4 44.52.060, 44.52.070, 44.52.900, 44.52.901, 43.342.010, and 43.342.020.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** The legislature finds that as the duties and
7 responsibilities of the office of lieutenant governor have continued to
8 incrementally increase, they have been distributed among various
9 noncorresponding chapters in statute. The legislature further finds
10 that by consolidating the duties and responsibilities of the office of
11 lieutenant governor under one chapter, it keeps our statutes consistent
12 among the different statewide elected offices and greater facilitates
13 the understanding of the role of the office of lieutenant governor and
14 its many statutorily defined duties and responsibilities.

15 NEW SECTION. **Sec. 2.** A new chapter is added to Title 43 RCW to be
16 named the "Office of Lieutenant Governor" and consisting of sections 3
17 through 5 of this act.

1 NEW SECTION. **Sec. 3.** The lieutenant governor has the following
2 duties:

3 (1) The lieutenant governor serves as president of the senate.

4 (2) In addition to the events prescribed under the state
5 Constitution, the lieutenant governor performs the duties of the
6 governor when the governor is out of the state pursuant to RCW
7 43.06.040 and 43.06.050. When the lieutenant governor is called to
8 perform the duties of the governor, he or she is compensated according
9 to RCW 43.03.027.

10 NEW SECTION. **Sec. 4.** The lieutenant governor serves as president
11 of the senate and is responsible for making appointments to, and
12 serving on, the committees and boards as set forth in this section.

13 (1) The lieutenant governor serves on the following boards and
14 committees:
