- 1 AN ACT Relating to home visits by mental health professionals;
- 2 adding new sections to chapter 71.05 RCW; and creating new sections.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. Sec. 1. The legislature finds that designated mental 4 5 health professionals go out into the community to evaluate people for potential detention under the state's involuntary treatment act. Also, 6 mental health professionals do 7 crisis outreach work 8 communities throughout Washington state. The presence of a second mental health professional on outreach to a person's private home or 9 10 other private location will enhance safety, will provide for a second 11 mental health expert to help evaluate the person's needs, and will 12 advance the legislature's interest in quality mental health care 13 services.
- NEW SECTION. Sec. 2. A new section is added to chapter 71.05 RCW to read as follows:
- 16 If a designated mental health professional or other mental health 17 crisis outreach worker visits a client in the client's private home or

- 1 in any other nonpublic setting, he or she shall be accompanied by
- 2 another mental health worker who has received training under section 5
- 3 of this act.
- 4 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 71.05 RCW
- 5 to read as follows:
- 6 Any mental health professional who engages in home visits to
- 7 clients shall be provided by their employer with a wireless telephone
- 8 or comparable device for the purpose of emergency communication.
- 9 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 71.05 RCW
- 10 to read as follows:
- 11 Any mental health professional that is dispatched on a crisis
- 12 outreach visit shall have prompt access to existing case files, if any
- 13 exist, on the client they are being sent to evaluate.
- 14 <u>NEW SECTION.</u> **Sec. 5.** A new section is added to chapter 71.05 RCW
- 15 to read as follows:
- Annually, all community mental health employees who work directly
- 17 with clients shall be provided with training on safety and violence
- 18 prevention. The curriculum for the training shall be developed
- 19 collaboratively among the department of social and health services,
- 20 contracted mental health providers, and employee organizations that
- 21 represent community mental health workers.
- 22 <u>NEW SECTION.</u> **Sec. 6.** This act shall be known as the Marty Smith
- 23 Law.
- 24 NEW SECTION. Sec. 7. If specific funding for the purposes of this
- 25 act, referencing this act by bill or chapter number, is not provided by
- 26 June 30, 2006, in the omnibus appropriations act, this act is null and
- 27 void.
