## SENATE BILL 5068

State of Washington 59th Legislature 2005 Regular Session

1 AN ACT Relating to health information for youth; adding a new 2 section to chapter 70.24 RCW; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

MEW SECTION. Sec. 1. (1) The legislature finds that it is a public health priority for young people to acquire the knowledge and skills necessary for healthy development. Sexually transmitted diseases, HIV infection, and unintended pregnancy do not contribute to the healthy development of young people in Washington state. Yet, rates of teen pregnancy, sexually transmitted diseases, and HIV infection among young people in this state are unacceptably high.

11 (2) Over twelve thousand girls nineteen years of age and younger 12 become pregnant in Washington every year. Girls fifteen through nineteen years of age have the highest chlamydia and the second-highest 13 14 gonorrhea infection rates among all age groups in this state. Levels of chlamydia infection are likely equally high among Washington's teen 15 boys, who experience a disparity in screening. It is also estimated 16 that one-half of all new HIV infections in this country now occur among 17 people aged twenty-five and younger. 18

1 (3) Washington's adolescent health issues, like teen pregnancy and 2 sexually transmitted diseases, must be addressed with comprehensive 3 prevention efforts. The legislature intends to enhance the healthy 4 development of young people in Washington state by taking opportunities 5 to provide them with information needed to help reduce rates of teen 6 pregnancy, sexually transmitted diseases, and HIV infection.

7 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 70.24 RCW 8 to read as follows:

9 (1) Students receiving health instruction paid for in whole or in 10 part with public funds may receive health information and disease 11 prevention instruction.

12 (2) "Health information and disease prevention instruction" means 13 medically and scientifically accurate curricula and information related 14 to sexual activity that:

15 (a) Is age appropriate;

16

(b) Encourages communication with parents and other trusted adults;

17 (c) Is respectful of the needs, attitudes, and perspectives of 18 individuals and communities;

19 (d) Encourages young people to develop and apply health-promoting 20 behaviors including disease prevention and detection and accessing 21 accurate health information;

(e) Teaches that abstinence from sexual activity is the only sure
way to avoid pregnancy and reduce the risk of sexually transmitted
diseases;

25 (f) Stresses the value of abstinence while addressing the health 26 needs of youth who are sexually active;

(g) Provides information about the health benefits and side effects
of contraceptives and barrier methods as a means to prevent pregnancy
and reduce the risk of sexually transmitted diseases and HIV/AIDS;

30 (h) Provides information about the stages, patterns, and 31 responsibilities associated with growth and development;

(i) Promotes the development of interpersonal skills including a
 sense of dignity and self-worth and the communication, decision-making,
 assertiveness, and refusal skills necessary to reduce health risks and
 choose healthy behaviors; and

36 (j) Helps young people develop and maintain healthy, respectful, 37 and meaningful relationships.

1 (3) The department of health shall work in consultation with the 2 office of the superintendent of public instruction to develop 3 guidelines for health information and disease prevention instruction 4 under this section.
