1 AN ACT Relating to a department of early learning; amending RCW  
2 43.17.010, 42.17.2401, 41.04.385, 74.13.085, 74.13.0902, 74.13.0903,  
3 74.13.098, 74.13.099, 74.15.350, 74.12.340, 28A.215.110, 28A.215.120,  
4 43.63A.066, 74.15.030, 74.15.100, and 74.15.130; reenacting and  
5 amending RCW 43.17.020 and 74.15.020; adding a new section to chapter  
6 41.06 RCW; adding a new chapter to Title 43 RCW; creating new sections;  
7 recodifying RCW 74.13.097, 74.13.098, 74.13.099, 74.15.063, 74.15.310,  
8 74.15.320, 74.15.330, 74.15.340, 74.15.350, 28A.215.100, 28A.215.110,  
9 28A.215.120, 28A.215.130, 28A.215.140, 28A.215.150, 28A.215.160,  
10 28A.215.170, 28A.215.180, 28A.215.190, 28A.215.200, 28A.215.900,  
11 28A.215.904, 28A.215.906, and 28A.215.908; prescribing penalties; and

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

14 **PART 1**

15 **DEPARTMENT OF EARLY LEARNING CREATED**

16 NEW SECTION. **Sec. 101.** (1) The legislature recognizes that:

17 (a) Parents are their children's first and most important teachers  
18 and decision makers;

1 (b) Research across disciplines now demonstrates that what happens  
2 in the earliest years makes a critical difference in children's  
3 readiness to succeed in school and life;

4 (c) Washington's competitiveness in the global economy requires a  
5 world-class education system that starts early and supports life-long  
6 learning;

7 (d) Washington state currently makes substantial investments in  
8 voluntary child care and early learning services and supports, but  
9 because services are fragmented across multiple state agencies, and  
10 early learning providers lack the supports and incentives needed to  
11 improve the quality of services they provide, many parents have  
12 difficulty accessing high quality early learning services;

13 (e) A more cohesive and integrated voluntary early learning system  
14 would result in greater efficiencies for the state, increased  
15 partnership between the state and the private sector, improved access  
16 to high quality early learning services, and better employment and  
17 early learning outcomes for families and all children.

18 (2) The legislature finds that the early years of a child's life  
19 are critical to the child's healthy brain development and that the  
20 quality of caregiving during the early years can significantly impact  
21 the child's intellectual, social, and emotional development.

22 (3) The purpose of this chapter is:

23 (a) To establish the department of early learning, the purpose of  
24 which is to coordinate and consolidate child care and early learning  
25 programs;

26 (b) To safeguard the health, safety, and well-being of children  
27 receiving child care and early learning services, which is paramount  
28 over the right of any person to provide care;

29 (c) To promote the development of a sufficient number and variety  
30 of adequate child care and early learning facilities, both public and  
31 private; and

32 (d) To license agencies and to assure the users of such agencies,  
33 their parents, the community at large and the agencies themselves that  
34 adequate minimum standards are maintained by all child care and early  
35 learning facilities.

36 NEW SECTION. **Sec. 102.** The definitions in this section apply  
37 throughout this chapter unless the context clearly requires otherwise.

1 (1) "Agency" means any person, firm, partnership, association,  
2 corporation, or facility that provides child care and early learning  
3 services outside a child's own home and includes the following  
4 irrespective of whether there is compensation to the agency:

5 (a) "Child day care center" means an agency that regularly provides  
6 child day care and early learning services for a group of children for  
7 periods of less than twenty-four hours;

8 (b) "Family day care provider" means a child day care provider who  
9 regularly provides child day care and early learning services for not  
10 more than twelve children in the provider's home in the family living  
11 quarters;

12 (c) "Service provider" means the entity that operates a community  
13 facility.

14 (2) "Agency" does not include the following:

15 (a) Persons related to the child in the following ways:

16 (i) Any blood relative, including those of half-blood, and  
17 including first cousins, nephews or nieces, and persons of preceding  
18 generations as denoted by prefixes of grand, great, or great-great;

19 (ii) Stepfather, stepmother, stepbrother, and stepsister;

20 (iii) A person who legally adopts a child or the child's parent as  
21 well as the natural and other legally adopted children of such persons,  
22 and other relatives of the adoptive parents in accordance with state  
23 law; or

24 (iv) Spouses of any persons named in (i), (ii), or (iii) of this  
25 subsection (2)(a), even after the marriage is terminated;

26 (b) Persons who are legal guardians of the child;

27 (c) Persons who care for a neighbor's or friend's child or  
28 children, with or without compensation, where the person providing care  
29 for periods of less than twenty-four hours does not conduct such  
30 activity on an ongoing, regularly scheduled basis for the purpose of  
31 engaging in business, which includes, but is not limited to,  
32 advertising such care;

33 (d) Parents on a mutually cooperative basis exchange care of one  
34 another's children;

35 (e) Nursery schools or kindergartens that are engaged primarily in  
36 educational work with preschool children and in which no child is  
37 enrolled on a regular basis for more than four hours per day;

1 (f) Schools, including boarding schools, that are engaged primarily  
2 in education, operate on a definite school year schedule, follow a  
3 stated academic curriculum, accept only school-age children, and do not  
4 accept custody of children;

5 (g) Seasonal camps of three months' or less duration engaged  
6 primarily in recreational or educational activities;

7 (h) Facilities providing care to children for periods of less than  
8 twenty-four hours whose parents remain on the premises to participate  
9 in activities other than employment;

10 (i) Any agency having been in operation in this state ten years  
11 before June 8, 1967, and not seeking or accepting moneys or assistance  
12 from any state or federal agency, and is supported in part by an  
13 endowment or trust fund;

14 (j) An agency operated by any unit of local, state, or federal  
15 government or an agency, located within the boundaries of a federally  
16 recognized Indian reservation, licensed by the Indian tribe;

17 (k) An agency located on a federal military reservation, except  
18 where the military authorities request that such agency be subject to  
19 the licensing requirements of this chapter.

20 (3) "Department" means the department of early learning.

21 (4) "Director" means the director of the department.

22 (5) "Enforcement action" means denial, suspension, revocation,  
23 modification, or nonrenewal of a license pursuant to section 311(1) of  
24 this act or assessment of civil monetary penalties pursuant to section  
25 311(3) of this act.

26 (6) "Probationary license" means a license issued as a disciplinary  
27 measure to an agency that has previously been issued a full license but  
28 is out of compliance with licensing standards.

29 (7) "Requirement" means any rule, regulation, or standard of care  
30 to be maintained by an agency.

31 NEW SECTION. **Sec. 103.** (1) The department of early learning is  
32 created as an executive branch agency. The department is vested with  
33 all powers and duties transferred to it under this chapter and such  
34 other powers and duties as may be authorized by law.

35 (2) The primary duties of the department are to set state early  
36 learning policy and to coordinate, consolidate, and integrate child

1 care and early learning programs in order to administer programs and  
2 funding as efficiently as possible. The department's duties include,  
3 but are not limited to, the following:

4 (a) To have lead responsibility for the state's early learning  
5 policy;

6 (b) To improve parent education and support;

7 (c) To carry out activities to improve the quality of early  
8 learning opportunities for young children including activities in  
9 cooperation with the public-private partnership;

10 (d) To administer child care and early learning programs;

11 (e) To standardize internal financial audits, oversight visits,  
12 performance benchmarks, and licensing criteria, so that programs can  
13 function in an integrated fashion;

14 (f) To assist in the formation of a public-private partnership and  
15 cooperate with that partnership in pursuing its goals; and

16 (g) To work cooperatively and in coordination with the early  
17 learning council.

18 NEW SECTION. **Sec. 104.** (1) The executive head and appointing  
19 authority of the department is the director. The director shall be  
20 appointed by the governor and shall serve at the pleasure of the  
21 governor. The appointment made by the governor is subject to  
22 confirmation by the senate. The director shall be paid a salary to be  
23 fixed by the governor in accordance with RCW 43.03.040. If a vacancy  
24 occurs, it shall be filled by appointment by the governor.

25 (2) The director may employ staff members, who shall be exempt from  
26 chapter 41.06 RCW, and any additional staff members as are necessary to  
27 administer this chapter. The director may delegate any power or duty  
28 vested in him or her by this chapter, including authority to make final  
29 decisions and enter final orders in hearings conducted under chapter  
30 34.05 RCW.

31 NEW SECTION. **Sec. 105.** It is the intent of the legislature  
32 wherever possible to place the internal affairs of the department under  
33 the control of the director in order that the director may institute  
34 therein the flexible, alert, and intelligent management of its business  
35 that changing contemporary circumstances require. Therefore, whenever  
36 the director's authority is not specifically limited by law, the

1 director has complete charge and supervisory powers over the  
2 department. The director may create such administrative structures as  
3 the director considers appropriate, except as otherwise specified by  
4 law. The director may employ such assistants and personnel as  
5 necessary for the general administration of the department. This  
6 employment shall be in accordance with the state civil service law,  
7 chapter 41.06 RCW, except as otherwise provided.

8 NEW SECTION. **Sec. 106.** The director may appoint such advisory  
9 committees or councils as may be required by any federal legislation as  
10 a condition to the receipt of federal funds by the department. The  
11 director may also appoint statewide committees or councils on such  
12 subject matters as are or come within the department's  
13 responsibilities. The committees or councils shall be constituted as  
14 required by federal law or as the director may determine.

15 Members of such state advisory committees or councils may be paid  
16 their travel expenses in accordance with RCW 43.03.050 and 43.03.060.

17 NEW SECTION. **Sec. 107.** In furtherance of the policy of the state  
18 to cooperate with the federal government in all of the programs under  
19 the jurisdiction of the department, such rules as may become necessary  
20 to entitle the state to participate in federal funds may be adopted,  
21 unless expressly prohibited by law. Any internal reorganization  
22 carried out under the terms of this chapter shall meet federal  
23 requirements that are a necessary condition to state receipt of federal  
24 funds. Any section or provision of law dealing with the department  
25 that may be susceptible to more than one construction shall be  
26 interpreted in favor of the construction most likely to comply with  
27 federal laws entitling this state to receive federal funds for the  
28 various programs of the department.

29 NEW SECTION. **Sec. 108.** (1) In addition to other duties under this  
30 chapter, the director shall provide leadership and active participation  
31 in the creation and governance of a nongovernmental public-private  
32 partnership focused on supporting government's investments in early  
33 learning and ensuring that every child in the state is prepared to  
34 succeed in school and in life.

1 (2) In addition to other powers granted to the director, the  
2 director may:

3 (a) Enter into contracts on behalf of the department to carry out  
4 the purposes of this chapter;

5 (b) Accept gifts, grants, or other funds for the purposes of this  
6 chapter; and

7 (c) Adopt, in accordance with chapter 34.05 RCW, rules necessary to  
8 implement this chapter, including rules governing child day care and  
9 early learning programs under this chapter.

10 NEW SECTION. **Sec. 109.** A new section is added to chapter 41.06  
11 RCW to read as follows:

12 In addition to the exemptions under RCW 41.06.070, the provisions  
13 of this chapter shall not apply in the department of early learning to  
14 the director, the director's personal secretary, and any other exempt  
15 staff members provided for in section 104(2) of this act.

16 **Sec. 110.** RCW 43.17.010 and 2005 c 333 s 10 are each amended to  
17 read as follows:

18 There shall be departments of the state government which shall be  
19 known as (1) the department of social and health services, (2) the  
20 department of ecology, (3) the department of labor and industries, (4)  
21 the department of agriculture, (5) the department of fish and wildlife,  
22 (6) the department of transportation, (7) the department of licensing,  
23 (8) the department of general administration, (9) the department of  
24 community, trade, and economic development, (10) the department of  
25 veterans affairs, (11) the department of revenue, (12) the department  
26 of retirement systems, (13) the department of corrections, (14) the  
27 department of health, (15) the department of financial institutions,  
28 (~~and~~) (16) the department of archaeology and historic preservation,  
29 and (17) the department of early learning, which shall be charged with  
30 the execution, enforcement, and administration of such laws, and  
31 invested with such powers and required to perform such duties, as the  
32 legislature may provide.

33 **Sec. 111.** RCW 43.17.020 and 2005 c 333 s 11 and 2005 c 319 s 2 are  
34 each reenacted and amended to read as follows:

35 There shall be a chief executive officer of each department to be

1 known as: (1) The secretary of social and health services, (2) the  
2 director of ecology, (3) the director of labor and industries, (4) the  
3 director of agriculture, (5) the director of fish and wildlife, (6) the  
4 secretary of transportation, (7) the director of licensing, (8) the  
5 director of general administration, (9) the director of community,  
6 trade, and economic development, (10) the director of veterans affairs,  
7 (11) the director of revenue, (12) the director of retirement systems,  
8 (13) the secretary of corrections, (14) the secretary of health, (15)  
9 the director of financial institutions, (~~and~~) (16) the director of  
10 the department of archaeology and historic preservation, and (17) the  
11 director of early learning.

12 Such officers, except the director of fish and wildlife, shall be  
13 appointed by the governor, with the consent of the senate, and hold  
14 office at the pleasure of the governor. The director of fish and  
15 wildlife shall be appointed by the fish and wildlife commission as  
16 prescribed by RCW 77.04.055.

17 **Sec. 112.** RCW 42.17.2401 and 2005 c 424 s 17 are each amended to  
18 read as follows:

19 For the purposes of RCW 42.17.240, the term "executive state  
20 officer" includes:

21 (1) The chief administrative law judge, the director of  
22 agriculture, the administrator of the Washington basic health plan, the  
23 director of the department of services for the blind, the director of  
24 the state system of community and technical colleges, the director of  
25 community, trade, and economic development, the secretary of  
26 corrections, the director of early learning, the director of ecology,  
27 the commissioner of employment security, the chair of the energy  
28 facility site evaluation council, the secretary of the state finance  
29 committee, the director of financial management, the director of fish  
30 and wildlife, the executive secretary of the forest practices appeals  
31 board, the director of the gambling commission, the director of general  
32 administration, the secretary of health, the administrator of the  
33 Washington state health care authority, the executive secretary of the  
34 health care facilities authority, the executive secretary of the higher  
35 education facilities authority, the executive secretary of the horse  
36 racing commission, the executive secretary of the human rights  
37 commission, the executive secretary of the indeterminate sentence



1 review board, the director of the department of information services,  
2 the director of the interagency committee for outdoor recreation, the  
3 executive director of the state investment board, the director of labor  
4 and industries, the director of licensing, the director of the lottery  
5 commission, the director of the office of minority and women's business  
6 enterprises, the director of parks and recreation, the director of  
7 personnel, the executive director of the public disclosure commission,  
8 the director of retirement systems, the director of revenue, the  
9 secretary of social and health services, the chief of the Washington  
10 state patrol, the executive secretary of the board of tax appeals, the  
11 secretary of transportation, the secretary of the utilities and  
12 transportation commission, the director of veterans affairs, the  
13 president of each of the regional and state universities and the  
14 president of The Evergreen State College, each district and each campus  
15 president of each state community college;

16 (2) Each professional staff member of the office of the governor;

17 (3) Each professional staff member of the legislature; and

18 (4) Central Washington University board of trustees, board of  
19 trustees of each community college, each member of the state board for  
20 community and technical colleges, state convention and trade center  
21 board of directors, committee for deferred compensation, Eastern  
22 Washington University board of trustees, Washington economic  
23 development finance authority, The Evergreen State College board of  
24 trustees, executive ethics board, forest practices appeals board,  
25 forest practices board, gambling commission, life sciences discovery  
26 fund authority board of trustees, Washington health care facilities  
27 authority, each member of the Washington health services commission,  
28 higher education coordinating board, higher education facilities  
29 authority, horse racing commission, state housing finance commission,  
30 human rights commission, indeterminate sentence review board, board of  
31 industrial insurance appeals, information services board, interagency  
32 committee for outdoor recreation, state investment board, commission on  
33 judicial conduct, legislative ethics board, liquor control board,  
34 lottery commission, marine oversight board, Pacific Northwest electric  
35 power and conservation planning council, parks and recreation  
36 commission, personnel appeals board, board of pilotage commissioners,  
37 pollution control hearings board, public disclosure commission, public  
38 pension commission, shorelines hearing board, public employees'

1 benefits board, salmon recovery funding board, board of tax appeals,  
2 transportation commission, University of Washington board of regents,  
3 utilities and transportation commission, Washington state maritime  
4 commission, Washington personnel resources board, Washington public  
5 power supply system executive board, Washington State University board  
6 of regents, Western Washington University board of trustees, and fish  
7 and wildlife commission.

8 **PART 2**

9 **POLICIES AND PROGRAMS TRANSFERRED**

10 **Sec. 201.** RCW 41.04.385 and 2005 c 490 s 9 are each amended to  
11 read as follows:

12 The legislature finds that (1) demographic, economic, and social  
13 trends underlie a critical and increasing demand for child care in the  
14 state of Washington; (2) working parents and their children benefit  
15 when the employees' child care needs have been resolved; (3) the state  
16 of Washington should serve as a model employer by creating a supportive  
17 atmosphere, to the extent feasible, in which its employees may meet  
18 their child care needs; and (4) the state of Washington should  
19 encourage the development of partnerships between state agencies, state  
20 employees, state employee labor organizations, and private employers to  
21 expand the availability of affordable quality child care. The  
22 legislature finds further that resolving employee child care concerns  
23 not only benefits the employees and their children, but may benefit the  
24 employer by reducing absenteeism, increasing employee productivity,  
25 improving morale, and enhancing the employer's position in recruiting  
26 and retaining employees. Therefore, the legislature declares that it  
27 is the policy of the state of Washington to assist state employees by  
28 creating a supportive atmosphere in which they may meet their child  
29 care needs. Policies and procedures for state agencies to address  
30 employee child care needs will be the responsibility of the director of  
31 personnel in consultation with the director of the department of early  
32 learning and state employee representatives.

33 **Sec. 202.** RCW 74.13.085 and 1989 c 381 s 2 are each amended to  
34 read as follows:

35 It shall be the policy of the state of Washington to:

1 (1) Recognize the family as the most important social and economic  
2 unit of society and support the central role parents play in child  
3 rearing. All parents are encouraged to care for and nurture their  
4 children through the traditional methods of parental care at home.  
5 However, there has been a dramatic increase in participation of women  
6 in the workforce which has made the availability of quality, affordable  
7 child care a critical concern for the state and its citizens. There  
8 are not enough child care services and facilities to meet the needs of  
9 working parents, the costs of care are often beyond the resources of  
10 working parents, and child care facilities are not located conveniently  
11 to work places and neighborhoods. Parents are encouraged to  
12 participate fully in the effort to improve the quality of child care  
13 services.

14 (2) Promote a variety of culturally and developmentally appropriate  
15 child care settings and services of the highest possible quality in  
16 accordance with the basic principle of continuity of care. These  
17 settings shall include, but not be limited to, family day care homes,  
18 mini-centers, centers and schools.

19 (3) Promote the growth, development and safety of children by  
20 working with community groups including providers and parents to  
21 establish standards for quality service, training of child care  
22 providers, fair and equitable monitoring, and salary levels  
23 commensurate with provider responsibilities and support services.

24 (4) Promote equal access to quality, affordable, socio-economically  
25 integrated child care for all children and families.

26 (5) Facilitate broad community and private sector involvement in  
27 the provision of quality child care services to foster economic  
28 development and assist industry through the department of early  
29 learning.

30 **Sec. 203.** RCW 74.13.0902 and 1989 c 381 s 6 are each amended to  
31 read as follows:

32 An employer liaison position is established in the department of  
33 (~~social and health services to be colocated at the business assistance~~  
34 ~~center established under RCW 43.31.083)) early learning to be colocated  
35 with the department of community, trade, and economic development. The  
36 employer liaison shall, within appropriated funds:~~

1 (1) Staff and assist the child care partnership in the  
2 implementation of its duties (~~((under RCW 74.13.0901))~~);

3 (2) Provide technical assistance to employers regarding child care  
4 services, working with and through local resource and referral  
5 organizations whenever possible. Such technical assistance shall  
6 include at a minimum:

7 (a) Assessing the child care needs of employees and prospective  
8 employees;

9 (b) Reviewing options available to employers interested in  
10 increasing access to child care for their employees;

11 (c) Developing techniques to permit small businesses to increase  
12 access to child care for their employees;

13 (d) Reviewing methods of evaluating the impact of child care  
14 activities on employers; and

15 (e) Preparing, collecting, and distributing current information for  
16 employers on options for increasing involvement in child care; and

17 (3) Provide assistance to local child care resource and referral  
18 organizations to increase their capacity to provide quality technical  
19 assistance to employers in their community.

20 **Sec. 204.** RCW 74.13.0903 and 2005 c 490 s 10 are each amended to  
21 read as follows:

22 ~~The ((office of child care policy is established to operate under~~  
23 ~~the authority of the department of social and health services. The~~  
24 ~~duties and responsibilities of the office include, but are not limited~~  
25 ~~to, the following, within appropriated funds)) department of early~~  
26 ~~learning shall:~~

27 (1) Work in conjunction with the statewide child care resource and  
28 referral network as well as local governments, nonprofit organizations,  
29 businesses, and community child care advocates to create local child  
30 care resource and referral organizations. These organizations may  
31 carry out needs assessments, resource development, provider training,  
32 technical assistance, and parent information and training;

33 (2) Actively seek public and private money for distribution as  
34 grants to the statewide child care resource and referral network and to  
35 existing or potential local child care resource and referral  
36 organizations;

1 (3) Adopt rules regarding the application for and distribution of  
2 grants to local child care resource and referral organizations. The  
3 rules shall, at a minimum, require an applicant to submit a plan for  
4 achieving the following objectives:

5 (a) Provide parents with information about child care resources,  
6 including location of services and subsidies;

7 (b) Carry out child care provider recruitment and training  
8 programs, including training under RCW 74.25.040;

9 (c) Offer support services, such as parent and provider seminars,  
10 toy-lending libraries, and substitute banks;

11 (d) Provide information for businesses regarding child care supply  
12 and demand;

13 (e) Advocate for increased public and private sector resources  
14 devoted to child care;

15 (f) Provide technical assistance to employers regarding employee  
16 child care services; and

17 (g) Serve recipients of temporary assistance for needy families and  
18 working parents with incomes at or below household incomes of one  
19 hundred seventy-five percent of the federal poverty line;

20 (4) Provide staff support and technical assistance to the statewide  
21 child care resource and referral network and local child care resource  
22 and referral organizations;

23 (5) Maintain a statewide child care licensing data bank and work  
24 with department (~~(of social and health services)~~) licensors to provide  
25 information to local child care resource and referral organizations  
26 about licensed child care providers in the state;

27 (6) Through the statewide child care resource and referral network  
28 and local resource and referral organizations, compile data about local  
29 child care needs and availability for future planning and development;

30 (7) Coordinate with the statewide child care resource and referral  
31 network and local child care resource and referral organizations for  
32 the provision of training and technical assistance to child care  
33 providers; and

34 (8) Collect and assemble information regarding the availability of  
35 insurance and of federal and other child care funding to assist state  
36 and local agencies, businesses, and other child care providers in  
37 offering child care services.

1           **Sec. 205.** RCW 74.13.098 and 2005 c 507 s 2 are each amended to  
2 read as follows:

3           (1) Subject to the availability of funds appropriated for this  
4 specific purpose, the (~~division of child care and early learning in~~  
5 ~~the~~) department (~~of social and health services~~) shall establish a  
6 child care career and wage ladder in licensed child care centers that  
7 meet the following criteria: (a) At least ten percent of child care  
8 slots are dedicated to children whose care is subsidized by the state  
9 or any political subdivision thereof or any local government; (b) the  
10 center agrees to adopt the child care career and wage ladder, which, at  
11 a minimum, shall be at the same pay schedule as existed in the previous  
12 child care career and wage ladder pilot project; and (c) the center  
13 meets further program standards as established by rule pursuant to  
14 section 4 (~~of this act~~), chapter 507, Laws of 2005.

15           The child care career and wage ladder shall include wage increments  
16 for levels of education, years of relevant experience, levels of work  
17 responsibility, relevant early childhood education credits, and  
18 relevant requirements in the state training and registry system.

19           (2) The (~~division~~) department shall establish procedures for the  
20 allocation of funds to implement the child care career and wage ladder  
21 among child care centers meeting the criteria identified in subsection

## 30 PART 5

### 31 TRANSFER OF POWERS, DUTIES, AND FUNCTIONS

32 NEW SECTION. **Sec. 501.** (1) All powers, duties, and functions of  
33 the office of the superintendent of public instruction and the  
34 department of community, trade, and economic development pertaining to  
35 the early childhood education and assistance (ECEAP) program and the  
36 early reading initiative are transferred to the department of early

1 learning. All references to the director or the department of  
2 community, trade, and economic development in the Revised Code of  
3 Washington shall be construed to mean the director or the department of  
4 early learning when referring to the functions transferred in this  
5 section.

6 (2) All powers, duties, and functions of the division of child care  
7 and early learning in the department of social and health services  
8 pertaining to the working connections child care program, child care  
9 licensing, child care quality activities, and the head start  
10 collaboration office are transferred to the department of early  
11 learning. However, eligibility staffing and eligibility payment  
12 functions for the working connections child care program shall not be  
13 transferred to the department of early learning. All references to the  
14 secretary or the department of social and health services in the  
15 Revised Code of Washington shall be construed to mean the director or  
16 the department of early learning when referring to the functions  
17 transferred in this section.

18 NEW SECTION. **Sec. 502.** All reports, documents, surveys, books,  
19 records, files, papers, or written material in the possession of the  
20 office of the superintendent of public instruction, the department of  
21 social and health services, and the department of community, trade, and  
22 economic development pertaining to the powers, functions, and duties  
23 transferred in section 501 of this act shall be delivered to the  
24 custody of the department of early learning. All cabinets, furniture,  
25 office equipment, motor vehicles, and other tangible property employed  
26 by the office of the superintendent of public instruction, the  
27 department of social and health services, and the department of  
28 community, trade, and economic development in carrying out the powers,  
29 functions, and duties transferred shall be made available to the  
30 department of early learning. All funds, credits, or other assets held  
31 in connection with the powers, functions, and duties transferred shall  
32 be assigned to the department of early learning.

33 NEW SECTION. **Sec. 503.** (1) Any appropriations made to the office  
34 of the superintendent of public instruction or the department of  
35 community, trade, and economic development for carrying out the powers,

1 functions, and duties transferred in section 501 of this act shall, on  
2 the effective date of this section, be transferred and credited to the  
3 department of early learning;

4 (2) Any appropriations made to the department of social and health  
5 services for carrying out the powers, functions, and duties transferred  
6 shall, on the effective date of this section, be transferred to the  
7 department of early learning through an interagency agreement.

8 NEW SECTION. **Sec. 504.** (1) All employees of the office of the  
9 superintendent of public instruction, the department of social and  
10 health services, and the department of community, trade, and economic  
11 development engaged in performing the powers, functions, and duties  
12 transferred in section 501 of this act are transferred to the  
13 jurisdiction of the department of early learning. All employees  
14 classified under chapter 41.06 RCW, the state civil service law, are  
15 assigned to the department of early learning to perform their usual  
16 duties upon the same terms as formerly, without any loss of rights,  
17 subject to any action that may be appropriate thereafter in accordance  
18 with the laws and rules governing state civil service.

19 (2) Nothing contained in this section may be construed to alter any  
20 existing collective bargaining unit or the provisions of any existing  
21 collective bargaining agreement until the agreement has expired or

24 NEW SECTION. **Sec. 505.** (1) All rules and all pending business  
25 before the office of the superintendent of public instruction, the  
26 department of social and health services, and the department of  
27 community, trade, and economic development pertaining to the powers,  
28 functions, and duties transferred in section 501 of this act shall be  
29 continued and acted upon by the department of early learning. All  
30 existing contracts and obligations shall remain in full force and shall  
31 be performed by the department of early learning.

32 (2) The transfer of the powers, duties, functions, and personnel of  
33 the office of the superintendent of public instruction, the department  
34 of social and health services, and the department of community, trade,  
35 and economic development shall not affect the validity of any act  
36 performed before the effective date of this section.

1 (3) Whenever any question arises as to the transfer of any  
2 personnel, funds, books, documents, records, papers, files, equipment,  
3 or other tangible property used or held in the exercise of the powers  
4 and the performance of the duties and functions transferred, the  
5 director of financial management shall make a determination as to the  
6 proper allocation and certify the same to the state agencies concerned.

7 (4) If apportionments of budgeted funds are required because of the  
8 transfers directed by this section and sections 501 through 504 of this  
9 act, the director of financial management shall certify the  
10 apportionments to the agencies affected, the state auditor, and the  
11 state treasurer. Each of these shall make the appropriate transfer and  
12 adjustments in funds and appropriation accounts and equipment records  
13 in accordance with the certification.

14 NEW SECTION. **Sec. 506.** By November 15, 2006, the department of  
15 early learning, in collaboration with the early learning council, shall  
16 prepare a report and make recommendations to the governor and  
17 appropriate committees of the legislature detailing:

18 (1) Coordination and collaboration between the department and the  
19 K-12 system at the state and local levels to ensure appropriate  
20 connections and smooth transitions between early learning and K-12;

21 (2) Ongoing coordination and collaboration between the department  
22 and other programs not included in the department;

23 (3) Ways the department will support local communities in  
24 encouraging public-private partnerships, innovative solutions to local  
25 issues, coordination of early learning services, and improved  
26 transitions from early learning to kindergarten;

27 (4) The relationship between the department and the public-private  
28 partnership;

29 (5) Internal governance of the department, to be implemented July  
30 1, 2007, upon termination of the early learning council; and

31 (6) Transition of any additional early learning programs and  
32 responsibilities, including administration of federal child care funds  
33 and subsidy eligibility and payment functions.
