- AN ACT Relating to false academic credentials; adding a new section to chapter 28B.85 RCW; adding a new section to chapter 9A.60 RCW;
- 3 adding a new section to chapter 28A.405 RCW; adding a new section to
- 4 chapter 28B.50 RCW; adding a new section to chapter 41.06 RCW;
- 5 repealing RCW 28B.85.030; and prescribing penalties.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. Sec. 1. A new section is added to chapter 28B.85 RCW to read as follows:
- 9 (1) It is unlawful for a person to:
- 10 (a) Grant or award a false academic credential or offer to grant or 11 award a false academic credential in violation of this section;
- 12 (b) Represent that a credit earned or granted by the person, in 13 violation of this section, can be applied toward a credential offered
- 14 by another person; or
- 15 (c) Solicit another person to seek a credential or to earn a credit 16 that is offered in violation of this section.
- 17 (2) "False academic credential" has the same definition as in section 2 of this act.

- 1 (3) A violation of this section constitutes an unfair or deceptive 2 act or practice in the conduct of trade or commerce under chapter 19.86 3 RCW.
- 4 (4) In addition to any other venue authorized by law, venue for the 5 prosecution of an offense under this section is in the county in which 6 an element of the offense occurs.
- NEW SECTION. Sec. 2. A new section is added to chapter 9A.60 RCW to read as follows:
- 9 (1) A person is guilty of issuing a false academic credential if 10 the person knowingly:
- 11 (a) Grants or awards a false academic credential or offers to grant 12 or award a false academic credential in violation of this section;
 - (b) Represents that a credit earned or granted by the person in violation of this section can be applied toward a credential offered by another person;
 - (c) Grants or offers to grant a credit for which a representation as described in (b) of this subsection is made; or
 - (d) Solicits another person to seek a credential or to earn a credit the person knows is offered in violation of this section.
 - (2) A person is guilty of knowingly using a false academic credential if the person knowingly uses a false academic credential or falsely claims to have a credential issued by an institution of higher education that is accredited by an accrediting association recognized as such by rule of the higher education coordinating board:
- 25 (a) In a written or oral advertisement or other promotion of a 26 business; or
 - (b) With the intent to:
 - (i) Obtain employment;

- 29 (ii) Obtain a license or certificate to practice a trade, 30 profession, or occupation;
 - (iii) Obtain a promotion, compensation or other benefit, or an increase in compensation or other benefit, in employment or in the practice of a trade, profession, or occupation;
- 34 (iv) Obtain admission to an educational program in this state; or
- (v) Gain a position in government with authority over another person, regardless of whether the person receives compensation for the position.

- (3) "False academic credential" means a document that provides 1 2 evidence or demonstrates completion of a course of instruction or coursework, that results in the attainment of a rank or level of 3 associate or higher, and that is issued by a person or institution that 4 5 is not accredited by an accrediting association recognized as such by rule of the higher education coordinating board. Such documents 6 7 include, but are not limited to, degrees, coursework, degree credits, transcripts, or certification of completion of a degree. 8
- 9 (4) Issuing a false academic credential is a class C felony.
- 10 (5) Knowingly using a false academic credential is a class C 11 felony.
- NEW SECTION. Sec. 3. A new section is added to chapter 28A.405 RCW to read as follows:
- A person who issues or uses a false academic credential is subject to sections 1 and 2 of this act.
- NEW SECTION. Sec. 4. A new section is added to chapter 28B.50 RCW to read as follows:
- A person who issues or uses a false academic credential is subject to sections 1 and 2 of this act.
- NEW SECTION. Sec. 5. A new section is added to chapter 41.06 RCW to read as follows:
- A person who issues or uses a false academic credential is subject to sections 1 and 2 of this act.
- NEW SECTION. Sec. 6. RCW 28B.85.030 (Current authorization required to offer or grant degree--Penalty for violation) and 2003 c 53 s 175 & 1986 c 136 s 3 are each repealed.
