1 AN ACT Relating to the definition of sick leave under the family 2 care act; and amending RCW 49.12.265.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 49.12.265 and 2002 c 243 s 2 are each amended to read 5 as follows:

6 The definitions in this section apply throughout RCW 49.12.270 7 through 49.12.295 unless the context clearly requires otherwise.

8 (1) "Child" means a biological, adopted, or foster child, a 9 stepchild, a legal ward, or a child of a person standing in loco 10 parentis who is: (a) Under eighteen years of age; or (b) eighteen 11 years of age or older and incapable of self-care because of a mental or 12 physical disability.

3 (2) "Grandparent" means a parent of a parent of an employee.

(3) "Parent" means a biological <u>or adoptive</u> parent of an employee
or an individual who stood in loco parentis to an employee when the
employee was a child.

17 (4) "Parent-in-law" means a parent of the spouse of an employee.

18 (5) "Sick leave or other paid time off" means time allowed under 19 the terms of an appropriate <u>state law</u>, collective bargaining agreement,

or employer policy, as applicable, to an employee for illness, 1 vacation, and personal holiday. If paid time is not allowed to an 2 employee for illness, "sick leave or other paid time off" also means 3 time allowed under the terms of an appropriate state law, collective 4 bargaining agreement, or employer policy, as applicable, to an employee 5 for disability under a plan, fund, program, or practice that is: (a) 6 Not covered by the employee retirement income security act of 1974, 29 7 U.S.C. Sec 1001 et seq.; and (b) not established or maintained through 8 the purchase of insurance. 9

(6) "Spouse" means a husband or wife, as the case may be.
