- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 41.26.048 and 1996 c 226 s 1 are each amended to read 6 as follows:
- 7 (1) A one hundred fifty thousand dollar death benefit shall be paid 8 to the member's estate, or such person or persons, trust or
- 9 organization as the member shall have nominated by written designation
- 10 duly executed and filed with the department. If there be no such
- 11 designated person or persons still living at the time of the member's
- 12 death, such member's death benefit shall be paid to the member's
- 13 surviving spouse as if in fact such spouse had been nominated by
- 14 written designation, or if there be no such surviving spouse, then to
- 15 such member's legal representatives.
- 16 (2) The benefit under this section shall be paid only ((where))
- 17 <u>when</u> death occurs: (a) As a result of injuries sustained in the course
- 18 of employment; or (b) to a member of plan 2 as a result of an
- 19 <u>occupational disease or infection that arises naturally and proximately</u>

- 1 <u>out of employment covered under this chapter</u>. The determination of
- 2 eligibility for the benefit shall be made consistent with Title 51 RCW
- 3 by the department of labor and industries. The department of labor and
- 4 industries shall notify the department of retirement systems by order
- 5 under RCW 51.52.050.
