1 AN ACT Relating to maintenance and repair of electrical appliances
2 by a public utility district; adding new sections to chapter 54.16 RCW;
3 and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** It is the intent of the legislature to avoid
6 unnecessary hardships on the citizens of a community by recognizing the
7 traditional appliance repair services that have been offered for many
8 years by any public utility district described in section 2 of this
9 act.

10 The legislature understands that some of these services improve the
11 energy efficiency of the appliance repaired, which helps citizens save
12 money and energy as well as extending the life of the appliance.

13 The legislature recognizes these historic services coexist with the
14 private sector without creating aggressive competition between public
15 and private enterprises.

16 It is the intent of the legislature to have these services be
17 financially self-supporting and not be subsidized by any other customer
18 rate structures.

1 Public utility districts affected by this act are encouraged to
2 continue to work collaboratively with the private sector in providing
3 these services.

4 NEW SECTION. **Sec. 2.** A new section is added to chapter 54.16 RCW
5 to read as follows:

6 Any public utility district that has operated an electrical
7 appliance repair service for at least ten years prior to the effective
8 date of this act, may continue to operate an electrical appliance
9 repair service within its service territory.

10 NEW SECTION. **Sec. 3.** A new section is added to chapter 54.16 RCW
11 to read as follows:

12 When a public utility district provides electrical appliance repair
13 services under section 2 of this act, the public utility district
14 shall:

- 15 (1) Charge customers the true and fair cost for the services;
- 16 (2) Keep records documenting the revenues and expenditures for the
17 services and make those records available to the public; and
- 18 (3) Develop measures or benchmarks to track and evaluate the
19 performance of the services.
