1 AN ACT Relating to improving teachers' skills in teaching children 2 with learning differences; and amending RCW 28A.415.023.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 Sec. 1. RCW 28A.415.023 and 1997 c 90 s 1 are each amended to read 5 as follows:

6 (1) Credits earned by certificated instructional staff after 7 September 1, 1995, shall be eligible for application to the salary 8 schedule developed by the legislative evaluation and accountability 9 program committee only if the course content:

10 (a) Is consistent with a school-based plan for mastery of student 11 learning goals as referenced in RCW ((28A.320.205)) 28A.655.110, the 12 annual school performance report, for the school in which the 13 individual is assigned;

14 (b) Pertains to the individual's current assignment or expected 15 assignment for the subsequent school year;

16 (c) Is necessary to obtain an endorsement as prescribed by the 17 state board of education;

18 (d) Is specifically required to obtain advanced levels of 19 certification; ((<del>or</del>))

1 (e) Is included in a college or university degree program that 2 pertains to the individual's current assignment, or potential future 3 assignment, as a certified instructional staff<u>; or</u>

4 (f) Addresses research-based assessment and instructional
5 strategies for students with dyslexia, dysgraphia, and language
6 disabilities when addressing learning goal one under RCW 28A.150.210,
7 as applicable and appropriate for individual certificated instructional
8 staff.

9 (2) For the purpose of this section, "credits" mean college quarter 10 hour credits and equivalent credits for approved in-service, approved 11 continuing education, or approved internship hours computed in 12 accordance with RCW 28A.415.020.

13 (3) The superintendent of public instruction shall adopt rules and 14 standards consistent with the limits established by this section for 15 certificated instructional staff.
