- 1 AN ACT Relating to inspections and sampling of fish, wildlife, and
- 2 shellfish by department of fish and wildlife employees; amending RCW
- 3 77.15.360; adding a new section to chapter 77.12 RCW; creating a new
- 4 section; and prescribing penalties.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** The legislature intends that inspections of

facilities and vessels and sampling of fish, wildlife, and shellfish by

- 8 department of fish and wildlife employees will ensure the conservation
- 9 and management of fish, shellfish, and wildlife. Because the harvest
- 10 of fish and wildlife is regulated by the department of fish and
- 11 wildlife, the legislature finds that inspections and sampling by
- 12 departmental employees will benefit the resource. The legislature
- 13 further finds that inspection and sampling will further the department
- 14 of fish and wildlife's research related to fish, wildlife, and
- 15 shellfish.

- 16 NEW SECTION. Sec. 2. A new section is added to chapter 77.12 RCW
- 17 to read as follows:

p. 1 HB 1075

- Department employees, in carrying out their duties under this title, may:
- 3 (1) Inspect all fish, wildlife, and shellfish taken or possessed in 4 the field or state waters;
- 5 (2) Inspect at a reasonable time and in a reasonable manner fish, 6 wildlife, and shellfish stored at a processing plant or locker plant or 7 other facility open for commercial purposes;
- 8 (3) Collect samples of tissue, fluids, or other bodily parts of 9 fish, wildlife, or shellfish;
- 10 (4) Board vessels in state waters engaged in commercial harvest 11 activities to inspect fish or shellfish, harvesting gear or devices, or 12 harvest record data; or
- 13 (5) Board and remain for a reasonable time as observers on board 14 vessels that are engaged in commercial harvest operations of fish or 15 shellfish.
- 16 **Sec. 3.** RCW 77.15.360 and 2000 c 107 s 243 are each amended to read as follows:
- 18 (1) A person is guilty of unlawful interfering in department 19 operations if the person prevents department employees from carrying 20 out duties authorized by this title, including but not limited to 21 interfering:
- 22 (a) In the operation of department vehicles, vessels, or aircraft:
- 23 (b) With the inspection of fish, wildlife, and shellfish taken or 24 possessed in the field or stored at a facility open for commercial 25 purposes:
- 25 <u>purposes;</u>
- 26 (c) With the collection of samples of tissue, fluids, or other
 27 bodily parts of fish, wildlife, and shellfish;
- 28 <u>(d) In the boarding of vessels engaged in recreational or</u> 29 <u>commercial harvest of fish or shellfish.</u>
- 30 (2) Unlawful interfering in department operations is a gross 31 misdemeanor.
