SUBSTITUTE HOUSE BILL 1076

State of Washington 60th Legislature 2007 Regular Session

By House Committee on Agriculture & Natural Resources (originally sponsored by Representatives Blake, Takko, B. Sullivan and Moeller)

AN ACT Relating to rockfish research; amending RCW 77.65.150, 77.65.210, and 77.32.470; adding a new section to chapter 77.12 RCW; creating a new section; providing an effective date; and providing an expiration date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 <u>NEW SECTION.</u> Sec. 1. (1) The legislature finds that:

7 (a) Seven rockfish stocks, including canary and yelloweye rockfish,
8 have been designated under federal law by the national marine fisheries
9 services as overfished on the west coast.

10 (b) The department of fish and wildlife has classified certain 11 rockfish species within Puget Sound as critically depressed. These 12 common species of rockfish have undergone dramatic declines in Puget 13 Sound and the coast during the past three decades.

(c) The Pacific fishery management council and the department of
fish and wildlife have eliminated the directed commercial fisheries and
greatly reduced the recreational fishing opportunity for these species.
(d) Due to the interactions of these depleted stocks with the
healthier ones, commercial and recreational fisheries have been
severely constrained in recent years in order to rebuild the

populations of these overfished rockfish. For many of these stocks there have been no recent stock assessments, or the current assessments are based on poor data. Improved survey information is essential for assessing abundance and to monitor progress toward rebuilding efforts on the coast and in Puget Sound.

(e) Department of fish and wildlife staff have been developing 6 7 underwater robot technology or remote operated vehicles to scientifically estimate the abundance of rockfish populations in both 8 the nearshore and in deep waters. These new assessment techniques, 9 coupled with existing bottom trawl surveys, will be used to estimate 10 current abundance and future recovery of rockfish populations along the 11 12 coast of Washington and in Puget Sound.

13 (2) Therefore, the legislature intends to implement a targeted, 14 short-term surcharge on commercial licenses issued by the department of fish and wildlife in 2008 through 2010 that provide for the retention 15 or landing of groundfish, and a targeted, short-term surcharge on 2008 16 17 through 2010 recreational saltwater fishing licenses. Funds derived from the surcharge will be used by the department of fish and wildlife 18 solely for the purpose of conducting rockfish research and stock 19 20 assessments.

21 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 77.12 RCW 22 to read as follows:

(1) The department is directed to develop and implement a rockfish research and stock assessment program. Using funds from the rockfish research account created in subsection (2) of this section, the department must conduct Puget Sound basin and coastal surveys with new and existing technology to estimate the current abundance and future recovery of rockfish populations and other groundfish species.

(2) The rockfish research account is created in the custody of the 29 30 state treasurer. All receipts from surcharges assessed on commercial 31 and recreational fishing licenses for the purposes of rockfish research must be deposited into the account. Expenditures from the account may 32 be used only for rockfish research, including stock assessments. Only 33 the director of the department or the director's designee may authorize 34 expenditures from the account. The account is subject to allotment 35 36 procedures under chapter 43.88 RCW, but an appropriation is not 37 required for expenditures.

1 **Sec. 3.** RCW 77.65.150 and 2006 c 186 s 1 are each amended to read 2 as follows:

3 (1) The director shall issue the charter licenses and angler 4 permits listed in this section according to the requirements of this 5 title. The licenses and permits and their annual fees and surcharges 6 are:

(2) A salmon charter license designating a vessel is required to operate a charter boat from which persons may, for a fee, fish for salmon, other food fish, and shellfish. The director may issue a salmon charter license only to a person who meets the qualifications of RCW 77.70.050.

(3) A nonsalmon charter license designating a vessel is required to
operate a charter boat from which persons may, for a fee, fish for food
fish other than salmon and shellfish.

(4)(a) "Charter boat" means a vessel from which persons may, for a fee, fish for food fish or shellfish for personal use in those state waters set forth in (b) of this subsection. "Charter boat" also means a vessel from which persons may, for a fee, fish for food fish or shellfish for personal use in offshore waters or in the waters of other states. The director may specify by rule when a vessel is a "charter boat" within this definition.

35 (b) A person may not operate a vessel from which persons may, for36 a fee, fish for food fish or shellfish in Puget Sound, Grays Harbor,

Willapa Bay, Pacific Ocean waters, Lake Washington, or the Columbia
 river below the bridge at Longview unless the vessel is designated on
 a charter boat license.

(5) A charter boat licensed in Oregon may fish without a Washington 4 5 charter license under the same rules as Washington charter boat operators in ocean waters within the jurisdiction of Washington state б 7 from the southern border of the state of Washington to Leadbetter Point, as long as the Oregon vessel does not take on or discharge 8 passengers for any purpose from any Washington port, the Washington 9 10 shore, or a dock, landing, or other point in Washington. The provisions of this subsection shall be in effect as long as the state 11 12 of Oregon has reciprocal laws and regulations.

(6) A salmon charter license under subsection (1)(b) of this 13 section may be renewed if the license holder notifies the department by 14 May 1st of that year that he or she will not participate in the fishery 15 during that calendar year. The license holder must pay the one 16 17 hundred-dollar enhancement surcharge and a thirty-five dollar surcharge to be deposited in the rockfish research account created in section 2 18 of this act, plus a fifteen-dollar handling charge, in order to be 19 considered a valid renewal and eligible to renew the license the 20 21 following year.

22 **Sec. 4.** RCW 77.65.210 and 2005 c 20 s 4 are each amended to read 23 as follows:

(1) Except as provided in subsection (2) of this section, a person 24 may not use a commercial fishing vessel to deliver food fish or 25 26 shellfish taken for commercial purposes in offshore waters to a port in 27 the state without a nonlimited entry delivery license. As used in this section, "deliver" and "delivery" mean arrival at a place or port, and 28 include arrivals from offshore waters to waters within the state and 29 arrivals ashore from offshore waters. As used in this section, "food 30 31 fish" does not include salmon. As used in this section, "shellfish" does not include ocean pink shrimp, coastal crab, or fish or shellfish 32 taken under an emerging commercial fisheries license if taken from off-33 34 shore waters. The annual license fee for a nonlimited entry delivery 35 license is one hundred ten dollars for residents and two hundred 36 dollars for nonresidents, and an additional thirty-five dollar

surcharge for both residents and nonresidents to be deposited in the
 rockfish research account created in section 2 of this act.

(2) Holders of salmon troll fishery licenses issued under RCW 3 77.65.160, salmon delivery licenses issued under RCW 77.65.170, crab 4 pot fishery licenses issued under RCW 77.65.220, food fish trawl--Non-5 Puget Sound fishery licenses, and emerging commercial fishery licenses 6 7 issued under RCW 77.65.200, Dungeness crab--coastal fishery licenses, ocean pink shrimp delivery licenses, shrimp trawl--Non-Puget Sound 8 fishery licenses, and emerging commercial fishery licenses issued under 9 RCW 77.65.220 may deliver food fish or shellfish taken in offshore 10 waters without a nonlimited entry delivery license. 11

12 (3) A nonlimited entry delivery license authorizes no taking of13 food fish or shellfish from state waters.

14 **Sec. 5.** RCW 77.32.470 and 2005 c 192 s 1 are each amended to read 15 as follows:

16 (1) A personal use saltwater, freshwater, combination, temporary, 17 or family fishing weekend license is required for all persons fifteen 18 years of age or older to fish for or possess fish taken for personal 19 use from state waters or offshore waters.

20 (2) The fees for annual personal use saltwater, freshwater, or 21 combination licenses are as follows:

(a) A combination license allows the holder to fish for or possess
fish, shellfish, and seaweed from state waters or offshore waters. The
fee for this license is thirty-six dollars for residents, seventy-two
dollars for nonresidents, and five dollars for youth. There is an
additional fifty-cent surcharge for this license, to be deposited in
the rockfish research account created section 2 of this act.

(b) A saltwater license allows the holder to fish for or possess fish taken from saltwater areas. The fee for this license is eighteen dollars for residents, thirty-six dollars for nonresidents, and five dollars for resident seniors. <u>There is an additional fifty-cent</u> <u>surcharge for this license, to be deposited in the rockfish research</u> <u>account created section 2 of this act.</u>

34 (c) A freshwater license allows the holder to fish for, take, or
 35 possess food fish or game fish species in all freshwater areas. The
 36 fee for this license is twenty dollars for residents, forty dollars for
 37 nonresidents, and five dollars for resident seniors.

(3)(a) A temporary combination fishing license is valid for one to
 five consecutive days and allows the holder to fish for or possess
 fish, shellfish, and seaweed taken from state waters or offshore
 waters. The fee for this temporary fishing license is:

5 (i) One day - Seven dollars for residents and fourteen dollars for
6 nonresidents;

7 (ii) Two days - Ten dollars for residents and twenty dollars for 8 nonresidents;

9 (iii) Three days - Thirteen dollars for residents and twenty-six 10 dollars for nonresidents;

11 (iv) Four days - Fifteen dollars for residents and thirty dollars 12 for nonresidents; and

(v) Five days - Seventeen dollars for residents and thirty-fourdollars for nonresidents.

(b) The fee for a charter stamp is seven dollars for a one-day temporary combination fishing license for residents and nonresidents for use on a charter boat as defined in RCW 77.65.150.

18 (c) A transaction fee to support the automated licensing system 19 will be taken from the amounts set forth in this subsection for 20 temporary licenses.

(d) Except for active duty military personnel serving in any branch of the United States armed forces, the temporary combination fishing license is not valid on game fish species for an eight-consecutive-day period beginning on the opening day of the lowland lake fishing season.

25 (e) There is an additional fifty-cent surcharge on the temporary 26 combination fishing license and the associated charter stamp, to be 27 deposited in the rockfish research account created in section 2 of this 28 act.

(4) A family fishing weekend license allows for a maximum of six anglers: One resident and five youth; two residents and four youth; or one resident, one nonresident, and four youth. This license allows the holders to fish for or possess fish taken from state waters or offshore waters. The fee for this license is twenty dollars. This license is only valid during periods as specified by rule of the department.

35 (5) The commission may adopt rules to create and sell combination 36 licenses for all hunting and fishing activities at or below a fee equal 37 to the total cost of the individual license contained within any 38 combination.
