1 AN ACT Relating to prioritizing tuition waivers for war veterans;
2 and amending RCW 28B.15.910.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 28B.15.910 and 2006 c 229 s 2 are each amended to read
5 as follows:

6 (1) For the purpose of providing state general fund support to
7 public institutions of higher education, except for revenue waived
8 under programs listed in subsections (3) and (4) of this section, and
9 unless otherwise expressly provided in the omnibus state appropriations
10 act, the total amount of operating fees revenue waived, exempted, or
11 reduced by a state university, a regional university, The Evergreen
12 State College, or the community colleges as a whole, shall not exceed
13 the percentage of total gross authorized operating fees revenue in this
14 subsection. As used in this section, "gross authorized operating fees
15 revenue" means the estimated gross operating fees revenue as estimated
16 under RCW 82.33.020 or as revised by the office of financial
17 management, before granting any waivers. This limitation applies to
18 all tuition waiver programs established before or after July 1, 1992.

7 (5) The institutions of higher education will participate in
8 outreach activities to increase the number of veterans who receive
9 tuition waivers. Colleges and universities shall revise the
10 application for admissions so that all applicants shall have the
11 opportunity to advise the institution that they are veterans (~~who need~~
12 ~~assistance. If a person indicates on the application for admissions~~
13 ~~that the person is a veteran who is in need of assistance, then the~~
14 ~~institution of higher education shall ask the person whether they have~~
15 ~~any funds disbursed in accordance with the Montgomery GI Bill available~~
16 ~~to them. Each institution shall encourage veterans to utilize funds~~
17 ~~available to them in accordance with the Montgomery GI Bill prior to~~
18 ~~providing the veteran a tuition waiver)). The legislature intends to
19 make available to all eligible admitted veterans a waiver of operating
20 fees by a state university, a regional university, The Evergreen State
21 College, or the community colleges as a whole to veterans who qualify
22 under RCW 28B.15.621.~~
