
SUBSTITUTE HOUSE BILL 2262

State of Washington 60th Legislature 2007 Regular Session

1 AN ACT Relating to salary bonuses for individuals certified by the
2 national board for professional teaching standards; adding a new
3 section to chapter 28A.405 RCW; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The legislature finds and declares:

6 (1) The national board for professional teaching standards has
7 established high and rigorous standards for what highly accomplished
8 teachers should know and be able to do in order to increase student
9 learning results;

10 (2) The national board certifies teachers who meet these standards
11 through a rigorous, performance-based assessment process;

12 (3) A certificate awarded by the national board attests that a
13 teacher has met high and rigorous standards and has demonstrated the
14 ability to make sound professional judgments about how to best meet
15 students' learning needs and effectively help students meet challenging
16 academic standards; and

17 (4) Teachers who attain national board certification should be
18 acknowledged and rewarded in order to encourage more teachers to pursue
19 certification for the benefit of Washington students.

1 NEW SECTION. **Sec. 2.** A new section is added to chapter 28A.405
2 RCW to read as follows:

3 (1) Certificated instructional staff who have attained
4 certification from the national board for professional teaching
5 standards shall receive a bonus each year in which they maintain the
6 certification. The bonus shall be calculated as follows:

7 (a) The annual bonus shall be five thousand two hundred fifty
8 dollars for fiscal year 2008 and five thousand four hundred dollars for
9 fiscal year 2009. Thereafter, the annual bonus shall be an amount
10 established in the omnibus appropriations act, or a pro rata share of
11 that amount subject to the conditions of (b) of this subsection; and

12 (b) State appropriations for this bonus may be limited to the
13 amount of funding required to provide the full amount of the bonus to
14 five percent of the certificated instructional staff who are eligible
15 to receive certification from the national board for professional
16 teaching standards. If the percentage of certificated instructional
17 staff who attain certification from the national board for professional
18 teaching standards exceeds five percent of those eligible to attain
19 such certification, and if providing a full bonus to all eligible
20 certificated instructional staff will exceed the amount of funding
21 appropriated by the legislature for the bonuses, each eligible
22 certificated instructional staff shall receive a pro rata share of the
23 amount provided.

24 (2) Certificated instructional staff who have attained
25 certification from the national board for professional teaching
26 standards shall be eligible for one or more bonuses in addition to that
27 provided by subsection (1) of this section if the individual:

28 (a) Is in an instructional assignment in a school in which at least
29 seventy percent of the students qualify for the free and reduced-price
30 lunch program; and

31 (b) Has attained certification from the national board for
32 professional teaching standards in middle level and/or high school
33 level mathematics and/or science and is in a mathematics and/or science
34 instructional assignment in a school in which at least seventy percent
35 of the students qualify for the free and reduced-price lunch program.

36 (3) The amount of the additional bonus under subsection (2) of this
37 section for those meeting the qualifications of subsection (2)(a) of

1 this section is five thousand dollars. The amount of the additional
2 bonus for those meeting the qualifications of subsection (2)(a) and (b)
3 of this section is ten thousand dollars.

4 (4) The bonuses provided under this section are in addition to
5 compensation received under a district's salary schedule adopted in
6 accordance with RCW 28A.405.200 and shall not be included in
7 calculations of a district's average salary and associated salary
8 limitations under RCW 28A.400.200.
