- AN ACT Relating to the application of chapter 39.12 RCW to 1 2 construction projects that involve tax incentives, loans, or public 3 land or property that is sold or leased; and amending RCW 39.12.020.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 39.12.020 and 2007 c 169 s 1 are each amended to read as follows: 6

The hourly wages to be paid to laborers, workers, or mechanics, upon all public works and under all public building service maintenance contracts of the state or any county, municipality or political subdivision created by its laws, shall be not less than the prevailing rate of wage for an hour's work in the same trade or occupation in the locality within the state where such labor is performed. Projects covered by this chapter include, but are not limited to, any work, construction, alteration, repair, or improvement other than ordinary maintenance that involves tax incentives established by the state or any county, municipality, or political subdivision created by its laws; loans provided by the state or any county, municipality, or political subdivision created by its laws; sales of public land or property to a private entity for less than fair market value by the state or any

county, municipality, or political subdivision created by its laws; or 1 2 leases of public land or property to a private entity by the state or any county, municipality, or political subdivision created by its laws. 3 For a contract in excess of ten thousand dollars, a contractor required 4 5 to pay the prevailing rate of wage shall post in a location readily visible to workers at the job site: PROVIDED, That on road 6 construction, sewer line, pipeline, transmission line, street, or alley 7 improvement projects for which no field office is needed or 8 established, a contractor may post the prevailing rate of wage 9 10 statement at the contractor's local office, gravel crushing, concrete, or asphalt batch plant as long as the contractor provides a copy of the 11 12 wage statement to any employee on request:

- (1) A copy of a statement of intent to pay prevailing wages approved by the industrial statistician of the department of labor and industries under RCW 39.12.040; and
- (2) The address and telephone number of the industrial statistician of the department of labor and industries where a complaint or inquiry concerning prevailing wages may be made.

This chapter shall not apply to workers or other persons regularly employed by the state, or any county, municipality, or political subdivision created by its laws.
