- 1 AN ACT Relating to the practice of dentistry; amending RCW
- 2 18.32.215; adding a new section to chapter 18.32 RCW; and providing an
- 3 expiration date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 Sec. 1. RCW 18.32.215 and 2003 c 57 s 2 are each amended to read 6 as follows:
- 7 (1) An applicant holding a valid license and currently engaged in 8 practice in another state may be granted a license without examination 9 required by this chapter, on the payment of any required fees, if the
- 10 applicant:
- 11 (a) Is a graduate of a dental college, school, or dental department
- of an institution approved by the commission under RCW 18.32.040(1); or
- 13 (b)(i) Has practiced in another state for at least four years; and
- 14 (ii) Has completed a one-year postdoctoral residency approved by
- 15 <u>the commission</u>. The residency may have been completed outside
- 16 Washington.
- 17 (2) The commission may also require the applicant to:  $((\frac{1}{1}))$  (a)
- 18 File with the commission documentation certifying the applicant is
- 19 licensed to practice in another state; and  $((\frac{2}{2}))$  provide

- 1 information as the commission deems necessary pertaining to the
- 2 conditions and criteria of the Uniform Disciplinary Act, chapter 18.130
- 3 RCW, and to demonstrate to the commission a knowledge of Washington law
- 4 pertaining to the practice of dentistry.
- 5 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 18.32 RCW 6 to read as follows:
- By November 15, 2009, the commission shall report to the governor and the legislature with recommendations for appropriate standards for
- 9 issuing a license to a foreign-trained dentist. The recommendations
- 10 shall consider the balance between maintaining assurances that
- 11 Washington's dental professionals are well-qualified and planning for
- 12 an adequate supply of dentists to meet the future needs of Washington's
- 13 diverse urban and rural communities. In addition to considering the
- 14 use of standards established by accreditation organizations, the
- 15 recommendations shall consider other options to reduce barriers to
- 16 licensure.
- 17 <u>NEW SECTION.</u> **Sec. 3.** This act expires July 1, 2010.
