- AN ACT Relating to exempting biodiesel fuel used for farm use from

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 82.08.865 and 2006 c 7 s 1 are each amended to read as follows:
- 7 (1) The tax levied by RCW 82.08.020 does not apply to sales of 8 diesel fuel, biodiesel fuel, or aircraft fuel as defined in RCW 82.42.010(5), to a farm fuel user for nonhighway use. This exemption 10 is available only if the buyer provides the seller with an exemption
- 11 certificate in a form and manner prescribed by the department. Fuel
- Il certificate in a form and manner prescribed by the department. Fuel
- 12 used for space or water heating for human habitation is not exempt
- 13 under this section.
- 14 (2) The definitions in RCW 82.04.213 and this subsection apply to this section.
- 16 (a) "Biodiesel fuel" is defined as provided in RCW 19.112.010.
- 17 <u>(b)</u> "Diesel fuel" is defined as provided in 26 U.S.C. 4083, as 18 amended or renumbered as of January 1, 2006.

- (((b))) (c) "Farm fuel user" means: (i) A farmer; or (ii) a person
 who provides horticultural services for farmers, such as soil
 preparation services, crop cultivation services, and crop harvesting
 services.
- 5 **Sec. 2.** RCW 82.12.865 and 2006 c 7 s 2 are each amended to read as 6 follows:
 - (1) The provisions of this chapter do not apply with respect to the nonhighway use of diesel fuel, nonhighway use of biodiesel fuel as defined in RCW 19.112.010, or aircraft fuel as defined in RCW 82.42.010(5), by a farm fuel user. Fuel used for space or water heating for human habitation is not exempt under this section.
- 12 (2) The definitions in RCW 82.08.865 apply to this section.
