AN ACT Relating to protecting persons with veteran or military status from discrimination; and amending RCW 49.60.010, 49.60.020, 49.60.030, 49.60.040, 49.60.120, 49.60.130, 49.60.175, 49.60.176, 49.60.180, 49.60.190, 49.60.200, 49.60.215, 49.60.222, 49.60.223, 5 49.60.224, and 49.60.225.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 **Sec. 1.** RCW 49.60.010 and 2006 c 4 s 1 are each amended to read as 8 follows:

This chapter shall be known as the "law against discrimination." 9 It is an exercise of the police power of the state for the protection 10 11 of the public welfare, health, and peace of the people of this state, 12 and in fulfillment of the provisions of the Constitution of this state concerning civil rights. The legislature hereby finds and declares 13 14 that practices of discrimination against any of its inhabitants because of race, creed, color, national origin, families with children, sex, 15 marital status, sexual orientation, age, honorably discharged veteran 16 17 or military status, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a 18 19 ((disabled)) person with a disability are a matter of state concern,

that such discrimination threatens not only the rights and proper 1 2 privileges of its inhabitants but menaces the institutions and foundation of a free democratic state. A state agency is herein 3 created with powers with respect to elimination and prevention of 4 5 discrimination in employment, in credit and insurance transactions, in places of public resort, accommodation, or amusement, and in real 6 7 property transactions because of race, creed, color, national origin, families with children, sex, marital status, sexual orientation, age, 8 honorably discharged veteran or military status, or the presence of any 9 10 sensory, mental, or physical disability or the use of a trained dog guide or service animal by a ((disabled)) person with a disability; and 11 12 the commission established hereunder is hereby given general 13 jurisdiction and power for such purposes.

14 **Sec. 2.** RCW 49.60.020 and 2006 c 4 s 2 are each amended to read as 15 follows:

16 The provisions of this chapter shall be construed liberally for the 17 accomplishment of the purposes thereof. Nothing contained in this chapter shall be deemed to repeal any of the provisions of any other 18 19 law of this state relating to discrimination because of race, color, 20 creed, national origin, sex, marital status, sexual orientation, age, 21 honorably discharged veteran or military status, or the presence of any sensory, mental, or physical disability, other than a law which 22 23 purports to require or permit doing any act which is an unfair practice 24 under this chapter. Nor shall anything herein contained be construed to deny the right to any person to institute any action or pursue any 25 26 civil or criminal remedy based upon an alleged violation of his or her civil rights. This chapter shall not be construed to endorse any 27 specific belief, practice, behavior, or orientation. Inclusion of 28 29 sexual orientation in this chapter shall not be construed to modify or 30 supersede state law relating to marriage.

31 **Sec. 3.** RCW 49.60.030 and 2006 c 4 s 3 are each amended to read as 32 follows:

(1) The right to be free from discrimination because of race,
 creed, color, national origin, sex, <u>honorably discharged veteran or</u>
 <u>military status</u>, sexual orientation, or the presence of any sensory,
 mental, or physical disability or the use of a trained dog guide or

service animal by a ((disabled)) person with a disability is recognized as and declared to be a civil right. This right shall include, but not be limited to:

4 (a) The right to obtain and hold employment without discrimination;
5 (b) The right to the full enjoyment of any of the accommodations,
6 advantages, facilities, or privileges of any place of public resort,
7 accommodation, assemblage, or amusement;

8 (c) The right to engage in real estate transactions without 9 discrimination, including discrimination against families with 10 children;

11 (d) The right to engage in credit transactions without 12 discrimination;

(e) The right to engage in insurance transactions or transactions
with health maintenance organizations without discrimination:
PROVIDED, That a practice which is not unlawful under RCW 48.30.300,
48.44.220, or 48.46.370 does not constitute an unfair practice for the
purposes of this subparagraph; and

18 (f) The right to engage in commerce free from any discriminatory boycotts or blacklists. Discriminatory boycotts or blacklists for 19 purposes of this section shall be defined as the formation or execution 20 21 of any express or implied agreement, understanding, policy or 22 contractual arrangement for economic benefit between any persons which is not specifically authorized by the laws of the United States and 23 24 which is required or imposed, either directly or indirectly, overtly or 25 covertly, by a foreign government or foreign person in order to restrict, condition, prohibit, or interfere with or in order to exclude 26 27 any person or persons from any business relationship on the basis of race, color, creed, religion, sex, <u>honorably discharged veteran or</u> 28 military status, sexual orientation, the presence of any sensory, 29 mental, or physical disability, or the use of a trained dog guide or 30 service animal by a ((disabled)) person with a disability, or national 31 32 origin or lawful business relationship: PROVIDED HOWEVER, That nothing herein contained shall prohibit the use of boycotts as authorized by 33 law pertaining to labor disputes and unfair labor practices. 34

35 (2) Any person deeming himself or herself injured by any act in 36 violation of this chapter shall have a civil action in a court of 37 competent jurisdiction to enjoin further violations, or to recover the 38 actual damages sustained by the person, or both, together with the cost

of suit including reasonable attorneys' fees or any other appropriate remedy authorized by this chapter or the United States Civil Rights Act of 1964 as amended, or the Federal Fair Housing Amendments Act of 1988 (42 U.S.C. Sec. 3601 et seq.).

(3) Except for any unfair practice committed by an employer against 5 an employee or a prospective employee, or any unfair practice in a real 6 7 estate transaction which is the basis for relief specified in the amendments to RCW 49.60.225 contained in chapter 69, Laws of 1993, any 8 9 unfair practice prohibited by this chapter which is committed in the 10 course of trade or commerce as defined in the Consumer Protection Act, chapter 19.86 RCW, is, for the purpose of applying that chapter, a 11 12 matter affecting the public interest, is not reasonable in relation to 13 the development and preservation of business, and is an unfair or 14 deceptive act in trade or commerce.

15 Sec. 4. RCW 49.60.040 and 2006 c 4 s 4 are each amended to read as 16 follows:

17 The definitions in this section apply throughout this chapter 18 unless the context clearly requires otherwise.

19 (1) "Person" includes one or more individuals, partnerships, 20 associations, organizations, corporations, cooperatives, legal 21 representatives, trustees and receivers, or any group of persons; it 22 includes any owner, lessee, proprietor, manager, agent, or employee, 23 whether one or more natural persons; and further includes any political 24 or civil subdivisions of the state and any agency or instrumentality of 25 the state or of any political or civil subdivision thereof((\div)).

26 (2) "Commission" means the Washington state human rights 27 commission((\div)).

(3) "Employer" includes any person acting in the interest of an employer, directly or indirectly, who employs eight or more persons, and does not include any religious or sectarian organization not organized for private profit((+)).

32 (4) "Employee" does not include any individual employed by his or 33 her parents, spouse, or child, or in the domestic service of any 34 $person((\div))$.

35 (5) "Labor organization" includes any organization which exists for 36 the purpose, in whole or in part, of dealing with employers concerning

1 grievances or terms or conditions of employment, or for other mutual 2 aid or protection in connection with $employment((\div))$.

3 (6) "Employment agency" includes any person undertaking with or 4 without compensation to recruit, procure, refer, or place employees for 5 an employer((*i*)).

6 (7) "Marital status" means the legal status of being married,
7 single, separated, divorced, or widowed((+)).

8

(8) "National origin" includes "ancestry"((+)).

(9) "Full enjoyment of" includes the right to purchase any service, 9 commodity, or article of personal property offered or sold on, or by, 10 any establishment to the public, and the admission of any person to 11 12 accommodations, advantages, facilities, or privileges of any place of public resort, accommodation, assemblage, or amusement, without acts 13 directly or indirectly causing persons of any particular race, creed, 14 color, sex, sexual orientation, national origin, or with any sensory, 15 16 mental, or physical disability, or the use of a trained dog guide or 17 service animal by a ((disabled)) person with a disability, to be treated as not welcome, accepted, desired, or solicited((\div)). 18

(10) "Any place of public resort, accommodation, assemblage, or 19 20 amusement" includes, but is not limited to, any place, licensed or 21 unlicensed, kept for gain, hire, or reward, or where charges are made for admission, service, occupancy, or use of any property 22 or facilities, whether conducted for the entertainment, housing, 23 or 24 lodging of transient guests, or for the benefit, use, or accommodation 25 of those seeking health, recreation, or rest, or for the burial or other disposition of human remains, or for the sale of goods, 26 27 merchandise, services, or personal property, or for the rendering of personal services, or for public conveyance or transportation on land, 28 water, or in the air, including the stations and terminals thereof and 29 the garaging of vehicles, or where food or beverages of any kind are 30 31 sold for consumption on the premises, or where public amusement, 32 entertainment, sports, or recreation of any kind is offered with or without charge, or where medical service or care is made available, or 33 where the public gathers, congregates, or assembles for amusement, 34 recreation, or public purposes, or public halls, public elevators, and 35 public washrooms of buildings and structures occupied by two or more 36 37 tenants, or by the owner and one or more tenants, or any public library 38 or educational institution, or schools of special instruction, or

nursery schools, or day care centers or children's camps: PROVIDED, 1 2 That nothing contained in this definition shall be construed to include or apply to any institute, bona fide club, or place of accommodation, 3 which is by its nature distinctly private, including fraternal 4 5 organizations, though where public use is permitted that use shall be covered by this chapter; nor shall anything contained in this 6 7 definition apply to any educational facility, columbarium, crematory, mausoleum, or cemetery operated or maintained by a bona fide religious 8 9 or sectarian institution($(\dot{\tau})$).

10 (11) "Real property" includes buildings, structures, dwellings, 11 real estate, lands, tenements, leaseholds, interests in real estate 12 cooperatives, condominiums, and hereditaments, corporeal and 13 incorporeal, or any interest therein((*i*)).

14 (12) "Real estate transaction" includes the sale, appraisal, 15 brokering, exchange, purchase, rental, or lease of real property, 16 transacting or applying for a real estate loan, or the provision of 17 brokerage services((*i*)).

18 (13) "Dwelling" means any building, structure, or portion thereof 19 that is occupied as, or designed or intended for occupancy as, a 20 residence by one or more families, and any vacant land that is offered 21 for sale or lease for the construction or location thereon of any such 22 building, structure, or portion thereof((+)).

23

(14) "Sex" means gender($(\dot{\tau})$).

24 (15) "Sexual orientation" means heterosexuality, homosexuality, 25 bisexuality, and gender expression or identity. As used in this definition, "gender expression or identity" means having or being 26 27 perceived as having a gender identity, self-image, appearance, behavior, or expression, whether or not that gender identity, self-28 image, appearance, behavior, or expression is different from that 29 traditionally associated with the sex assigned to that person at 30 31 $birth((\dot{\tau}))$.

32 (16) "Aggrieved person" means any person who: (a) Claims to have 33 been injured by an unfair practice in a real estate transaction; or (b) 34 believes that he or she will be injured by an unfair practice in a real 35 estate transaction that is about to $occur((\div))$.

36 (17) "Complainant" means the person who files a complaint in a real 37 estate transaction((\div)).

1 (18) "Respondent" means any person accused in a complaint or 2 amended complaint of an unfair practice in a real estate 3 transaction((\div)).

(19) "Credit transaction" includes any open or closed end credit 4 transaction, whether in the nature of a loan, retail installment 5 transaction, credit card issue or charge, or otherwise, and whether for 6 7 personal or for business purposes, in which a service, finance, or interest charge is imposed, or which provides for repayment 8 in scheduled payments, when such credit is extended in the regular course 9 10 of any trade or commerce, including but not limited to transactions by savings and loan associations or other financial 11 banks, lending 12 institutions of whatever nature, stock brokers, or by a merchant or 13 mercantile establishment which as part of its ordinary business permits 14 or provides that payment for purchases of property or service therefrom 15 may be deferred((\div)).

(20) "Families with children status" means one or more individuals 16 17 who have not attained the age of eighteen years being domiciled with a parent or another person having legal custody of such individual or 18 individuals, or with the designee of such parent or other person having 19 such legal custody, with the written permission of such parent or other 20 21 person. Families with children status also applies to any person who 22 is pregnant or is in the process of securing legal custody of any 23 individual who has not attained the age of eighteen years $((\dot{\tau}))$.

(21) "Covered multifamily dwelling" means: (a) Buildings consisting of four or more dwelling units if such buildings have one or more elevators; and (b) ground floor dwelling units in other buildings consisting of four or more dwelling units((*÷*)).

28 (22) "Premises" means the interior or exterior spaces, parts, 29 components, or elements of a building, including individual dwelling 30 units and the public and common use areas of a building($(\div$)).

31 (23) "Dog guide" means a dog that is trained for the purpose of 32 guiding blind persons or a dog that is trained for the purpose of 33 assisting hearing impaired $persons((\div))$.

34 (24) "Service animal" means an animal that is trained for the
 35 purpose of assisting or accommodating a ((disabled person's)) person
 36 with a disability's sensory, mental, or physical disability.

37 (25) "Honorably discharged veteran or military status" means a 38 person who is:

- 1(a) A veteran, as defined in RCW 41.04.007; or2(b) An active or reserve member in any branch of the armed forces3of the United States, including the national guard, coast guard, and
- 4 <u>armed forces reserves.</u>

5 Sec. 5. RCW 49.60.120 and 2006 c 4 s 5 are each amended to read as 6 follows:

7

The commission shall have the functions, powers, and duties:

8 (1) To appoint an executive director and chief examiner, and such 9 investigators, examiners, clerks, and other employees and agents as it 10 may deem necessary, fix their compensation within the limitations 11 provided by law, and prescribe their duties.

12 (2) To obtain upon request and utilize the services of all13 governmental departments and agencies.

14 (3) To adopt, amend, and rescind suitable rules to carry out the 15 provisions of this chapter, and the policies and practices of the 16 commission in connection therewith.

17 (4) To receive, impartially investigate, and pass upon complaints18 alleging unfair practices as defined in this chapter.

(5) To issue such publications and results of investigations and 19 20 research as in its judgment will tend to promote good will and minimize 21 or eliminate discrimination because of sex, sexual orientation, race, color, national origin, marital status, age, 22 creed, honorably discharged veteran or military status, or the presence of any sensory, 23 24 mental, or physical disability, or the use of a trained dog guide or service animal by a ((disabled)) person with a disability. 25

(6) To make such technical studies as are appropriate to effectuate
the purposes and policies of this chapter and to publish and distribute
the reports of such studies.

(7) To cooperate and act jointly or by division of labor with the 29 30 United States or other states, with other Washington state agencies, 31 commissions, and other government entities, and with political subdivisions of the state of Washington and their respective human 32 rights agencies to carry out the purposes of this chapter. However, 33 the powers which may be exercised by the commission under this 34 subsection permit investigations and complaint dispositions only if the 35 36 investigations are designed to reveal, or the complaint deals only with, allegations which, if proven, would constitute unfair practices
 under this chapter. The commission may perform such services for these
 agencies and be reimbursed therefor.

4 (8) To foster good relations between minority and majority
5 population groups of the state through seminars, conferences,
6 educational programs, and other intergroup relations activities.

7 **Sec. 6.** RCW 49.60.130 and 2006 c 4 s 6 are each amended to read as 8 follows:

9 The commission has power to create such advisory agencies and conciliation councils, local, regional, or statewide, as in its 10 11 judgment will aid in effectuating the purposes of this chapter. The 12 commission may empower them to study the problems of discrimination in all or specific fields of human relationships or in specific instances 13 of discrimination because of sex, race, creed, color, national origin, 14 marital status, sexual orientation, age, honorably discharged veteran 15 16 or military status, or the presence of any sensory, mental, or physical 17 disability or the use of a trained dog guide or service animal by a ((disabled)) person with a disability; to foster through community 18 19 effort or otherwise good will, cooperation, and conciliation among the 20 groups and elements of the population of the state, and to make 21 recommendations to the commission for the development of policies and procedures in general and in specific instances, and for programs of 22 23 formal and informal education which the commission may recommend to the 24 appropriate state agency.

Such advisory agencies and conciliation councils shall be composed 25 26 of representative citizens, serving without pay, but with reimbursement 27 for travel expenses in accordance with RCW 43.03.050 and 43.03.060 as now existing or hereafter amended, and the commission may make 28 provision for technical and clerical assistance to such agencies and 29 30 councils and for the expenses of such assistance. The commission may 31 use organizations specifically experienced in dealing with questions of discrimination. 32

33 **Sec. 7.** RCW 49.60.175 and 2006 c 4 s 7 are each amended to read as 34 follows:

35 It shall be an unfair practice to use the sex, race, creed, color, 36 national origin, marital status, <u>honorably discharged veteran or</u>

1 <u>military status</u>, sexual orientation, or the presence of any sensory, 2 mental, or physical disability of any person, or the use of a trained 3 dog guide or service animal by a ((disabled)) person with a disability, 4 concerning an application for credit in any credit transaction to 5 determine the credit worthiness of an applicant.

6 **Sec. 8.** RCW 49.60.176 and 2006 c 4 s 8 are each amended to read as 7 follows:

8 (1) It is an unfair practice for any person whether acting for 9 himself, herself, or another in connection with any credit transaction 10 because of race, creed, color, national origin, sex, marital status, 11 <u>honorably discharged veteran or military status</u>, sexual orientation, or 12 the presence of any sensory, mental, or physical disability or the use 13 of a trained dog guide or service animal by a ((disabled)) person with 14 <u>a disability</u>:

15

(a) To deny credit to any person;

16 (b) To increase the charges or fees for or collateral required to 17 secure any credit extended to any person;

18 (c) To restrict the amount or use of credit extended or to impose 19 different terms or conditions with respect to the credit extended to 20 any person or any item or service related thereto;

21 (d) To attempt to do any of the unfair practices defined in this 22 section.

(2) Nothing in this section shall prohibit any party to a credit
 transaction from considering the credit history of any individual
 applicant.

(3) Further, nothing in this section shall prohibit any party to a
 credit transaction from considering the application of the community
 property law to the individual case or from taking reasonable action
 thereon.

30 **Sec. 9.** RCW 49.60.180 and 2006 c 4 s 10 are each amended to read 31 as follows:

32 It is an unfair practice for any employer:

(1) To refuse to hire any person because of age, sex, marital status, sexual orientation, race, creed, color, national origin, <u>honorably discharged veteran or military status</u>, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a ((disabled)) person with a disability, unless based upon a bona fide occupational qualification: PROVIDED, That the prohibition against discrimination because of such disability shall not apply if the particular disability prevents the proper performance of the particular worker involved: PROVIDED, That this section shall not be construed to require an employer to establish employment goals or quotas based on sexual orientation.

8 (2) To discharge or bar any person from employment because of age, 9 sex, marital status, sexual orientation, race, creed, color, national 10 origin, <u>honorably discharged veteran or military status</u>, or the 11 presence of any sensory, mental, or physical disability or the use of 12 a trained dog guide or service animal by a ((disabled)) person <u>with a</u> 13 <u>disability</u>.

14 (3) To discriminate against any person in compensation or in other terms or conditions of employment because of age, sex, marital status, 15 sexual orientation, race, creed, color, national origin, honorably 16 17 discharged veteran or military status, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or 18 service animal by a ((disabled)) person with a disability: 19 PROVIDED, That it shall not be an unfair practice for an employer to segregate 20 21 washrooms or locker facilities on the basis of sex, or to base other 22 terms and conditions of employment on the sex of employees where the commission by regulation or ruling in a particular instance has found 23 24 the employment practice to be appropriate for the practical realization 25 of equality of opportunity between the sexes.

(4) To print, or circulate, or cause to be printed or circulated 26 27 any statement, advertisement, or publication, or to use any form of application for employment, or to make any inquiry in connection with 28 prospective employment, which expresses any limitation, specification, 29 or discrimination as to age, sex, marital status, sexual orientation, 30 race, creed, color, national origin, honorably discharged veteran or 31 32 military status, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a 33 ((disabled)) person with a disability, or any intent to make any such 34 limitation, specification, or discrimination, unless based upon a bona 35 36 fide occupational qualification: PROVIDED, Nothing contained herein 37 shall prohibit advertising in a foreign language.

1 Sec. 10. RCW 49.60.190 and 2006 c 4 s 11 are each amended to read
2 as follows:

3 It is an unfair practice for any labor union or labor organization: 4 (1) To deny membership and full membership rights and privileges to 5 any person because of age, sex, marital status, sexual orientation, 6 race, creed, color, national origin, <u>honorably discharged veteran or</u> 7 <u>military status</u>, or the presence of any sensory, mental, or physical 8 disability or the use of a trained dog guide or service animal by a 9 ((<u>disabled</u>)) person <u>with a disability</u>.

10 (2) To expel from membership any person because of age, sex, 11 marital status, sexual orientation, race, creed, color, national 12 origin, <u>honorably discharged veteran or military status</u>, or the 13 presence of any sensory, mental, or physical disability or the use of 14 a trained dog guide or service animal by a ((disabled)) person <u>with a</u> 15 <u>disability</u>.

16 (3) To discriminate against any member, employer, employee, or 17 other person to whom a duty of representation is owed because of age, 18 sex, marital status, sexual orientation, race, creed, color, national 19 origin, <u>honorably discharged veteran or military status</u>, or the 20 presence of any sensory, mental, or physical disability or the use of 21 a trained dog guide or service animal by a ((disabled)) person <u>with a</u> 22 <u>disability</u>.

23 **Sec. 11.** RCW 49.60.200 and 2006 c 4 s 12 are each amended to read 24 as follows:

It is an unfair practice for any employment agency to fail or 25 26 refuse to classify properly or refer for employment, or otherwise to discriminate against, an individual because of age, sex, marital 27 28 status, sexual orientation, race, creed, color, national origin, honorably discharged veteran or military status, or the presence of any 29 30 sensory, mental, or physical disability or the use of a trained dog 31 guide or service animal by a ((disabled)) person with a disability, or to print or circulate, or cause to be printed or circulated any 32 statement, advertisement, or publication, or to use any form of 33 application for employment, or to make any inquiry in connection with 34 prospective employment, which expresses any limitation, specification 35 36 or discrimination as to age, sex, race, sexual orientation, creed, 37 color, or national origin, honorably discharged veteran or military

status, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a ((disabled)) person with a disability, or any intent to make any such limitation, specification, or discrimination, unless based upon a bona fide occupational qualification: PROVIDED, Nothing contained herein shall prohibit advertising in a foreign language.

7 **Sec. 12.** RCW 49.60.215 and 2006 c 4 s 13 are each amended to read 8 as follows:

It shall be an unfair practice for any person or the person's agent 9 10 or employee to commit an act which directly or indirectly results in any distinction, restriction, or discrimination, or the requiring of 11 any person to pay a larger sum than the uniform rates charged other 12 persons, or the refusing or withholding from any person the admission, 13 patronage, custom, presence, frequenting, dwelling, staying, or lodging 14 15 in any place of public resort, accommodation, assemblage, or amusement, 16 except for conditions and limitations established by law and applicable 17 to all persons, regardless of race, creed, color, national origin, sexual orientation, sex, honorably discharged veteran or military 18 19 status, the presence of any sensory, mental, or physical disability, or 20 the use of a trained dog guide or service animal by a ((disabled)) 21 person with a disability: PROVIDED, That this section shall not be construed to require structural changes, modifications, or additions to 22 make any place accessible to a ((disabled)) person with a disability 23 except as otherwise required by law: PROVIDED, That behavior or 24 actions constituting a risk to property or other persons can be grounds 25 26 for refusal and shall not constitute an unfair practice.

27 **Sec. 13.** RCW 49.60.222 and 2006 c 4 s 14 are each amended to read 28 as follows:

(1) It is an unfair practice for any person, whether acting for himself, herself, or another, because of sex, marital status, sexual orientation, race, creed, color, national origin, families with children status, <u>honorably discharged veteran or military status</u>, the presence of any sensory, mental, or physical disability, or the use of a trained dog guide or service animal by a ((disabled)) person with a <u>disability</u>:

(a) To refuse to engage in a real estate transaction with a person;

(b) To discriminate against a person in the terms, conditions, or privileges of a real estate transaction or in the furnishing of facilities or services in connection therewith;

4 (c) To refuse to receive or to fail to transmit a bona fide offer 5 to engage in a real estate transaction from a person;

6 (d) To refuse to negotiate for a real estate transaction with a 7 person;

8 (e) To represent to a person that real property is not available 9 for inspection, sale, rental, or lease when in fact it is so available, 10 or to fail to bring a property listing to his or her attention, or to 11 refuse to permit the person to inspect real property;

(f) To discriminate in the sale or rental, or to otherwise make unavailable or deny a dwelling, to any person; or to a person residing in or intending to reside in that dwelling after it is sold, rented, or made available; or to any person associated with the person buying or renting;

(g) To make, print, circulate, post, or mail, or cause to be so made or published a statement, advertisement, or sign, or to use a form of application for a real estate transaction, or to make a record or inquiry in connection with a prospective real estate transaction, which indicates, directly or indirectly, an intent to make a limitation, specification, or discrimination with respect thereto;

(h) To offer, solicit, accept, use, or retain a listing of real property with the understanding that a person may be discriminated against in a real estate transaction or in the furnishing of facilities or services in connection therewith;

(i) To expel a person from occupancy of real property;

(j) To discriminate in the course of negotiating, executing, or 28 financing a real estate transaction whether by mortgage, deed of trust, 29 30 contract, or other instrument imposing a lien or other security in real 31 property, or in negotiating or executing any item or service related 32 thereto including issuance of title insurance, mortgage insurance, loan guarantee, or other aspect of the transaction. Nothing in this section 33 shall limit the effect of RCW 49.60.176 relating to unfair practices in 34 credit transactions; or 35

36 (k) To attempt to do any of the unfair practices defined in this 37 section. 1 (2) For the purposes of this chapter discrimination based on the 2 presence of any sensory, mental, or physical disability or the use of 3 a trained dog guide or service animal by a <u>person who is</u> blind, deaf, 4 or physically disabled ((person)) includes:

5 (a) A refusal to permit, at the expense of the ((disabled)) person with a disability, reasonable modifications of existing premises 6 7 occupied or to be occupied by such person if such modifications may be necessary to afford such person full enjoyment of the dwelling, except 8 9 that, in the case of a rental, the landlord may, where it is reasonable 10 to do so, condition permission for a modification on the renter agreeing to restore the interior of the dwelling to the condition that 11 12 existed before the modification, reasonable wear and tear excepted;

(b) To refuse to make reasonable accommodation in rules, policies, practices, or services when such accommodations may be necessary to afford a person with the presence of any sensory, mental, or physical disability and/or the use of a trained dog guide or service animal by a person who is blind, deaf, or physically disabled ((person)) equal opportunity to use and enjoy a dwelling; or

(c) To fail to design and construct covered multifamily dwellings 19 and premises in conformance with the federal fair housing amendments 20 21 act of 1988 (42 U.S.C. Sec. 3601 et seq.) and all other applicable laws 22 or regulations pertaining to access by persons with any sensory, mental, or physical disability or use of a trained dog guide or service 23 24 animal. Whenever the requirements of applicable laws or regulations 25 differ, the requirements which require greater accessibility for 26 persons with any sensory, mental, or physical disability shall govern. 27 Nothing in (a) or (b) of this subsection shall apply to: (i) A single-family house rented or leased by the owner if the owner does not 28 own or have an interest in the proceeds of the rental or lease of more 29 than three such single-family houses at one time, the rental or lease 30 occurred without the use of a real estate broker or salesperson, as 31 32 defined in RCW 18.85.010, and the rental or lease occurred without the

publication, posting, or mailing of any advertisement, sign, or statement in violation of subsection (1)(g) of this section; or (ii) rooms or units in dwellings containing living quarters occupied or intended to be occupied by no more than four families living independently of each other if the owner maintains and occupies one of the rooms or units as his or her residence. 1 (3) Notwithstanding any other provision of this chapter, it shall 2 not be an unfair practice or a denial of civil rights for any public or 3 private educational institution to separate the sexes or give 4 preference to or limit use of dormitories, residence halls, or other 5 student housing to persons of one sex or to make distinctions on the 6 basis of marital or families with children status.

7 (4) Except pursuant to subsection (2)(a) of this section, this section shall not be construed to require structural changes, 8 modifications, or additions to make facilities accessible to a 9 ((disabled)) person with a disability except as otherwise required by 10 law. Nothing in this section affects the rights, responsibilities, and 11 remedies of landlords and tenants pursuant to chapter 59.18 or 59.20 12 13 RCW, including the right to post and enforce reasonable rules of conduct and safety for all tenants and their quests, provided that 14 chapters 59.18 and 59.20 RCW are only affected to the extent they are 15 16 inconsistent with the nondiscrimination requirements of this chapter. 17 Nothing in this section limits the applicability of any reasonable federal, state, or local restrictions regarding the maximum number of 18 19 occupants permitted to occupy a dwelling.

(5) Notwithstanding any other provision of this chapter, it shall not be an unfair practice for any public establishment providing for accommodations offered for the full enjoyment of transient guests as defined by RCW 9.91.010(1)(c) to make distinctions on the basis of families with children status. Nothing in this section shall limit the effect of RCW 49.60.215 relating to unfair practices in places of public accommodation.

27 (6) Nothing in this chapter prohibiting discrimination based on families with children status applies to housing for older persons as 28 defined by the federal fair housing amendments act of 1988, 42 U.S.C. 29 Sec. 3607(b)(1) through (3), as amended by the housing for older 30 persons act of 1995, P.L. 104-76, as enacted on December 28, 1995. 31 32 Nothing in this chapter authorizes requirements for housing for older persons different than the requirements in the federal fair housing 33 amendments act of 1988, 42 U.S.C. Sec. 3607(b)(1) through (3), as 34 amended by the housing for older persons act of 1995, P.L. 104-76, as 35 enacted on December 28, 1995. 36

37 (7) Nothing in this chapter shall apply to real estate transactions38 involving the sharing of a dwelling unit, or rental or sublease of a

portion of a dwelling unit, when the dwelling unit is to be occupied by the owner or subleasor. For purposes of this section, "dwelling unit" has the same meaning as in RCW 59.18.030.

(1) When a reasonable cause determination has been made under RCW 3 49.60.240 that an unfair practice in a real estate transaction has been 4 5 committed and a finding has been made that the respondent has engaged in any unfair practice under RCW 49.60.250, the administrative law 6 7 judge shall promptly issue an order for such relief suffered by the aggrieved person as may be appropriate, which may include actual 8 damages as provided by the federal fair housing amendments act of 1988 9 (42 U.S.C. Sec. 3601 et seq.), and injunctive or other equitable 10 relief. Such order may, to further the public interest, assess a civil 11 penalty against the respondent: 12

(a) In an amount up to ten thousand dollars if the respondent has

(b) In an amount up to twenty-five thousand dollars if the respondent has been determined to have committed one other unfair practice in a real estate transaction during the five-year period ending on the date of the filing of this charge; or

(c) In an amount up to fifty thousand dollars if the respondent has 20 21 been determined to have committed two or more unfair practices in a 22 real estate transaction during the seven-year period ending on the date of the filing of this charge, for loss of the right secured by RCW 23 24 49.60.010, 49.60.030, 49.60.040, and 49.60.222 through 49.60.224, as 25 now or hereafter amended, to be free from discrimination in real property transactions because of sex, marital status, race, creed, 26 27 color, national origin, sexual orientation, families with children status, honorably discharged veteran or military status, or the 28 presence of any sensory, mental, or physical disability or the use of 29 a trained dog guide or service animal by a person who is blind, deaf, 30 31 or physically disabled ((person)). Enforcement of the order and appeal 32 therefrom by the complainant or respondent may be made as provided in RCW 49.60.260 and 49.60.270. If acts constituting the unfair practice 33 in a real estate transaction that is the object of the charge are 34 determined to have been committed by the same natural person who has 35 been previously determined to have committed acts constituting an 36 37 unfair practice in a real estate transaction, then the civil penalty of 38 up to fifty thousand dollars may be imposed without regard to the

1 period of time within which any subsequent unfair practice in a real 2 estate transaction occurred. All civil penalties assessed under this 3 section shall be paid into the state treasury and credited to the 4 general fund.

5 (2) Such order shall not affect any contract, sale, conveyance, 6 encumbrance, or lease consummated before the issuance of an order that 7 involves a bona fide purchaser, encumbrancer, or tenant who does not 8 have actual notice of the charge filed under this chapter.

9 (3) Notwithstanding any other provision of this chapter, persons 10 awarded damages under this section may not receive additional damages 11 pursuant to RCW 49.60.250.
