- (a) The broad discretionary power to determine and adopt written policies not in conflict with other law that provide for the development and implementation of programs, activities, services, or practices that the board determines will:

- 13 (ii) Promote the effective, efficient, or safe management and operation of the school district;
 - (b) Such powers as are expressly authorized by law; and

- (2) Before adopting a policy under subsection (1)(a) of this 18 section, the school district board of directors shall comply with the 19 20 notice requirements of the open public meetings act, chapter 42.30 RCW, 21 and shall in addition include in that notice a statement that sets forth or reasonably describes the proposed policy. 22 directors shall provide a reasonable opportunity for public written and 23 24 oral comment and consideration of the comment by the board of directors. 25
- NEW SECTION. Sec. 4. Interested stakeholders are encouraged to inform the legislature as to any additional legislation that needs to be enacted before December 1, 2010, to enable school districts to be efficient and effective in teaching the public school students of Washington state when the other statutes are repealed in 2011.
- NEW SECTION. Sec. 5. Section 3 of this act takes effect May 1, 2011.
