1 AN ACT Relating to donation of unclaimed personal property to
2 nonprofit charitable organizations; amending RCW 63.32.050 and
3 63.40.060; and adding a new section to chapter 63.35 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 63.32.050 and 1987 c 182 s 1 are each amended to read
6 as follows:

7 In addition to any other method of disposition of unclaimed
8 property provided under this chapter, the police authorities of a city
9 or town may donate unclaimed (~~((bicyeles, trieyeles, and toys))~~) personal
10 property to nonprofit charitable organizations (~~((for use by))~~). A
11 nonprofit charitable organization receiving personal property donated
12 under this section must use the property, or its proceeds, to benefit
13 needy persons. Such organization must qualify for tax-exempt status
14 under 26 U.S.C. Sec. 501(c)(3) of the federal internal revenue code.

15 NEW SECTION. **Sec. 2.** A new section is added to chapter 63.35 RCW
16 to read as follows:

17 In addition to any other method of disposition of unclaimed
18 property provided under this chapter, the state patrol may donate

1 unclaimed personal property to nonprofit charitable organizations. A
2 nonprofit charitable organization receiving personal property donated
3 under this section must use the property, or its proceeds, to benefit
4 needy persons. Such organization must qualify for tax-exempt status
5 under 26 U.S.C. Sec. 501(c)(3) of the federal internal revenue code.

6 **Sec. 3.** RCW 63.40.060 and 1987 c 182 s 2 are each amended to read
7 as follows:

8 In addition to any other method of disposition of unclaimed
9 property provided under this chapter, the county sheriff may donate
10 unclaimed (~~bicycles, tricycles, and toys~~) personal property to
11 nonprofit charitable organizations (~~for use by~~). A nonprofit
12 charitable organization receiving personal property donated under this
13 section must use the property, or its proceeds, to benefit needy
14 persons. Such organization must qualify for tax-exempt status under 26
15 U.S.C. Sec. 501(c)(3) of the federal internal revenue code.
