1 AN ACT Relating to work performed by institutions of higher 2 education; and amending RCW 28B.10.350 and 28B.50.330.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 Sec. 1. RCW 28B.10.350 and 2001 c 38 s 1 are each amended to read 5 as follows:

(1) When the cost to The Evergreen State $College((\tau))$ or any 6 7 regional $((university_{\tau}))$ or state university $((\tau))$ of any building, 8 construction, renovation, remodeling, or demolition, other than maintenance or repairs, will equal or exceed the sum of ((thirty-five)) 9 10 fifty-five thousand dollars, or thirty-five thousand dollars if the work involves one trade or craft area, complete 11 plans and 12 specifications for ((such)) the work shall be prepared ((and such)), the work shall be put out for public $bid((s))_{\perp}$ and the contract shall 13 be awarded to the ((lowest)) responsible bidder ((if in accordance with 14 15 the bid specifications: PROVIDED, That when the estimated cost of such building, construction, removation, remodeling, or demolition equals or 16 exceeds the sum of twenty five thousand dollars, such project shall be 17 deemed a public works and "the prevailing rate of wage," under chapter 18 19 39.12 RCW shall be applicable thereto: PROVIDED FURTHER, That when

such building, construction, renovation, remodeling, or demolition 1 2 involves one trade or craft area and the estimated cost exceeds fifteen 3 thousand dollars, complete plans and specifications for such work shall be prepared and such work shall be put out for public bids, and the 4 5 contract shall be awarded to the lowest responsible bidder if in accordance with the bid specifications. This subsection shall not 6 7 apply when a contract is awarded by the small works roster procedure 8 authorized in RCW 39.04.155 or under any other procedure authorized for an institution of higher education)) who submits the lowest responsive 9 bid. 10

11 (2) Any building, construction, renovation, remodeling, or 12 demolition project that exceeds the dollar amounts in subsection (1) of 13 this section is subject to the provisions of chapter 39.12 RCW.

14 Evergreen State College((-))or (3) The any regional ((university,)) or state university may require a project to be put to 15 public bid even when it is not required to do so under subsection (1) 16 17 of this section. Any project publicly bid under this subsection is subject to the provisions of chapter 39.12 RCW. 18

19 (((3))) (4) Where the estimated cost ((to The Evergreen State 20 College, any regional university, or state university)) of any 21 building, construction, renovation, remodeling, or demolition is less 22 than ((twenty-five)) fifty-five thousand dollars or the contract is 23 awarded by the small works roster procedure authorized in RCW 24 39.04.155, the publication requirements of RCW 39.04.020 ((shall be inapplicable)) do not apply.

(((4))) (5) In the event of any emergency when the public interest 26 27 or property of The Evergreen State College((7)) or a regional ((university,)) or state university would suffer material injury or 28 damage by delay, the president of such college or university may 29 declare the existence of ((such)) an emergency and, reciting the facts 30 31 constituting the same, may waive the requirements of this section with 32 reference to any contract in order to correct the condition causing the emergency((+ PROVIDED, That an "emergency,")). For the purposes of 33 this section, <u>"emergency"</u> means a condition likely to result in 34 35 immediate physical injury to persons or to property of ((such)) the college or university in the absence of prompt remedial action or a 36 37 condition which immediately impairs the institution's ability to 38 perform its educational obligations.

1 (6) This section does not apply when a contract is awarded by the 2 small works roster procedure authorized in RCW 39.04.155 or under any

small works roster procedure authorized in RCW 39.04.155 or under any other procedure authorized for an institution of higher education.

4 **Sec. 2.** RCW 28B.50.330 and 1993 c 379 s 108 are each amended to 5 read as follows:

6 (1) The boards of trustees of college districts are empowered in 7 accordance with the provisions of this chapter to provide for the construction, reconstruction, erection, equipping, demolition, and 8 major alterations of buildings and other capital assets, and the 9 10 acquisition of sites, rights-of-way, easements, improvements, or 11 appurtenances for the use of the aforementioned colleges as authorized 12 by the college board in accordance with RCW 28B.50.140; to be financed by bonds payable out of special funds from revenues hereafter derived 13 from income received from such facilities, gifts, bequests, or grants, 14 and such additional funds as the legislature may provide, and payable 15 16 out of a bond retirement fund to be established by the respective 17 district boards in accordance with rules and regulations of the state board. With respect to building, improvements, or repairs, or other 18 work, where the estimated cost exceeds ((twenty-five)) fifty-five 19 20 thousand dollars, or thirty-five thousand dollars if the work involves 21 one trade or craft area, complete plans and specifications for ((such)) the work shall be prepared ((and such)), the work shall be put out for 22 23 <u>a</u> public bid((s)), and the contract shall be awarded to the ((lowest))) 24 responsible bidder ((if in accordance with the bid specifications: PROVIDED, That when such building, construction, removation, remodel-25 26 ing, or demolition involves one trade or craft area and the estimated 27 cost exceeds ten thousand dollars, complete plans and specifications for such work shall be prepared and such work shall be put out for 28 public bids, and the contract shall be awarded to the lowest 29 responsible bidder if in accordance with the bid specifications)) who 30 submits the lowest responsive bid. Any project regardless of dollar 31 amount may be put to public bid. 32

33 (2) This ((subsection shall)) section does not apply when a 34 contract is awarded by the small works <u>roster</u> procedure authorized in 35 RCW ((39.04.150: PROVIDED FURTHER, That any project regardless of 36 dollar amount may be put to public bid)) <u>39.04.155</u>. 1 (3) Where the estimated cost to any college of any building, 2 improvements, or repairs, or other work, is less than ((twenty-five 3 thousand dollars)) fifty-five thousand dollars, or thirty-five thousand 4 dollars if the work involves one trade or craft area, the publication 5 requirements of RCW 39.04.020 ((shall be inapplicable)) do not apply.
