- 6 Sec. 1. RCW 84.33.088 and 2003 c 315 s 1 are each amended to read 7 as follows:
 - (1) A purchaser of privately owned timber in an amount in excess of two hundred thousand board feet in a voluntary sale made in the ordinary course of business shall, on or before the last day of the month following the purchase of the timber, report the particulars of the purchase to the department as required in subsection (2) of this section.
- (2) The report required in subsection (1) of this section ((shall)) 14 must contain all information relevant to the value of the timber 15 purchased including, but not limited to, the following, as applicable: Purchaser's name and address, sale date, termination date in sale 17 agreement, total sale price, total acreage involved in the sale, net 18 19 volume of timber purchased, legal description of the area involved in
