1 AN ACT Relating to contribution rates in the Washington state
2 patrol retirement system; amending RCW 41.45.0631; creating a new
3 section; providing an effective date; and declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 41.45.0631 and 2006 c 94 s 2 are each amended to read
6 as follows:

7 (1) The allocation of costs between the employer and members of the
8 Washington state patrol retirement system shall be made only after the
9 application of any minimum total contribution rate that may be in
10 effect for the system under subsection (4) of this section. For
11 benefit improvements effective on or after July 1, 2007, costs shall be
12 shared equally by members and the employer, and any cap on member
13 contributions shall be adjusted accordingly. The member contribution
14 rate shall be based on the adjusted total contribution rate described
15 in subsection (2) of this section. Beginning July 1, ((2001)) 2007,
16 the required member contribution rate for members of the Washington
17 state patrol retirement system shall be ((two percent or equal to the
18 employer rate adopted under RCW 41.45.060 and 41.45.070 for the
19 Washington state patrol retirement system, whichever is greater. The

1 ~~employee contribution rate shall not, however, include any increase as~~
2 ~~a result of))~~ the lesser of the following: (a) One-half of the
3 adjusted total contribution rate for the system; or (b) seven percent,
4 plus fifty percent of the contribution rate increase caused by any
5 benefit improvements effective on or after July 1, 2007.

6 (2) The employer shall continue to pay for all costs attributable
7 to distributions under RCW 43.43.270(2) for survivors of members who
8 became disabled under RCW 43.43.040(2) prior to July 1, 2006, until
9 such costs are fully paid. In order to avoid charging members for
10 these costs, the total required contribution rate shall be adjusted to
11 exclude these costs. The result of the adjustment shall be the
12 adjusted total contribution rate that is to be used to calculate the
13 required member contribution rate.

14 (3) The employer rate shall be the contribution rate required to
15 cover all total system costs that are not covered by the member
16 contribution rate.

17 (4) Beginning July 1, 2009, a minimum total contribution rate is
18 established for the Washington state patrol retirement system. The
19 total Washington state patrol retirement system contribution rate as
20 adopted by the pension funding council and subject to revision by the
21 legislature may exceed, but may not drop below, the established minimum
22 total contribution rate. The minimum total contribution rate shall
23 equal the total contribution rate required to fund seventy percent of
24 the Washington state patrol retirement system's normal cost as
25 calculated under the entry age normal cost method. Upon completion of
26 each biennial actuarial valuation, the state actuary shall review the
27 appropriateness of this minimum total contribution rate and recommend
28 to the legislature any adjustments as may be needed.

29 NEW SECTION. Sec. 2. If both Senate Bill No. 6129 and Substitute
30 Senate Bill No. 5937 are not enacted by June 30, 2007, this act is null
31 and void.

32 NEW SECTION. Sec. 3. This act is necessary for the immediate
33 preservation of the public peace, health, or safety, or support of the
34 state government and its existing public institutions, and takes effect

1 July 1, 2007.
