1 AN ACT Relating to dental assistant education and training
2 programs; and amending RCW 18.260.110.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 18.260.110 and 2007 c 269 s 11 are each amended to
5 read as follows:

6 Nothing in this chapter may be construed to prohibit or restrict:

7 (1) The practice of a dental assistant in the discharge of official
8 duties by dental assistants in the United States federal services on
9 federal reservations, including but not limited to the armed services,
10 coast guard, public health service, veterans' bureau, or bureau of
11 Indian affairs; (~~or~~)

12 (2) Expanded function dental auxiliary education and training
13 programs approved by the commission and the practice as an expanded
14 function dental auxiliary by students in expanded function dental
15 auxiliary education and training programs approved by the commission,
16 when acting under the direction and supervision of persons licensed
17 under chapter 18.29 or 18.32 RCW;

18 (3) Dental assistant education and training programs, and the
19 practice of dental assisting by students in dental assistant education

1 and training programs approved by the commission or offered at a school
2 approved or licensed by the workforce training and education
3 coordinating board, higher education coordinating board, state board
4 for community and technical colleges, or Washington state skill centers
5 certified by the office of the superintendent of public instruction,
6 when acting under the direction and supervision of persons registered
7 or licensed under this chapter or chapter 18.29 or 18.32 RCW; or
8 (4) The practice of a volunteer dental assistant providing services
9 under the supervision of a licensed dentist in a charitable dental
10 clinic, as approved by the commission in rule.
