## EFFECT:

- Adds a representative of Indian tribes to the work group that is directed to engage federal representatives and agencies in an analysis of various federal requirements.
  - Establishes that the work group directed to consider the 2009 special needs transportation study recommendations may consult with other agencies if funding is available, and may propose alternative coordination models to the Joint Transportation Committee than those recommended in the study.
  - Clarifies that the pilot project designed to demonstrate cost sharing opportunities is not limited to opportunities involving public paratransit and Medicaid nonemergency medical trips, but instead may include other opportunities that demonstrate cost sharing opportunities.
  - Directs the Department of Social and Health Services to track transportation purchased for its clients, and to report that

data on a quarterly basis to the Agency Council on Coordinated Transportation.
