1       Strike everything after the enacting clause and insert the  
2 following:

3       "NEW SECTION. **Sec. 1.** INTENT. (1) The legislature finds that:

4       (a) Low-income families and individuals often face significant  
5 barriers to receiving the services and benefits that they are qualified  
6 to receive. These services are essential to meeting individuals' basic  
7 needs, and provide critical support to low-income individuals who are  
8 working or who have disabilities that prevent them from working;

9       (b) Each year millions of federal dollars go unclaimed due to  
10 underutilization of benefits such as tax credits, health care coverage,  
11 and food support;

12       (c) State agencies have been engaged in an effort to implement an  
13 online benefit portal to simplify and streamline access to state,  
14 federal, and local benefits that include a broad array of public  
15 benefits;

16       (d) Access to education and training gives low-income individuals  
17 and families the opportunity to acquire the skills they need to become  
18 successfully employed and attain self-sufficiency; and

19       (e) Agencies have been engaged in efforts to increase access to  
20 training and education for recipients of federal food assistance.

21       (2) The legislature therefore intends to strengthen existing  
22 efforts by providing enhanced structure and direction to ensure that a  
23 strong partnership among colleges, state agencies, community partners,  
24 and philanthropy be established. The legislature also intends to  
25 provide an efficient, effective, integrated approach to the delivery of  
26 basic support services and education and training programs. The  
27 integrated approach should include the creation of a one-stop-shop,  
28 online benefits portal where individuals can apply for a broad array of  
29 services, including public benefits and education and training support,  
30 and the expansion of the food stamp employment and training program.

1 (3) The legislature further finds that:

2 (a) The general assistance program can be reformed to better  
3 support the ability of persons who are unable to work due to physical  
4 or mental health impairments to either return to work, or transition to  
5 federal supplemental security income benefits; and

6 (b) Persons who are homeless and suffering from mental illness or  
7 chemical dependency are particularly vulnerable, because homelessness  
8 is a substantial barrier to successful participation in, and completion  
9 of, needed treatment services.

10 (4) Through the reforms included in this act, the legislature  
11 intends to end the general assistance program and establish the  
12 disability lifeline program, and to implement multiple strategies  
13 designed to improve the employment and basic support outcomes of  
14 persons receiving disability lifeline benefits. The legislature  
15 further intends to focus services on persons who are homeless and have  
16 a mental illness or chemical dependency by providing housing vouchers  
17 as an alternative to a cash grant so that these persons can be in  
18 stable housing and thus have a greater opportunity to succeed in  
19 treatment.

20 NEW SECTION. **Sec. 2.** A new section is added to chapter 74.04 RCW  
21 to read as follows:

22 OPPORTUNITY PORTAL. (1) An online opportunity portal shall be  
23 established to provide the public with more effective access to  
24 available state, federal, and local services. The secretary of the  
25 department of social and health services shall act as the executive  
26 branch sponsor of the portal planning process. Under the leadership of  
27 the secretary, the department shall:

28 (a) Identify and select an appropriate solution and acquisition  
29 approach to integrate technology systems to create a user-friendly  
30 electronic tool for Washington residents to apply for benefits;

31 (b) Facilitate the adaptation of state information technology  
32 systems to allow applications generated through the opportunity portal  
33 and other compatible electronic application systems to seamlessly link  
34 to appropriate state information systems;

35 (c) Ensure that the portal provides access to a broad array of  
36 state, federal, and local services, including but not limited to:  
37 Health care services, higher education financial aid, tax credits,

1 civic engagement, nutrition assistance, energy assistance, family  
2 support, and disability lifeline benefits as defined in sections 4  
3 through 12 of this act;

4 (d) Design an implementation strategy for the portal that maximizes  
5 collaboration with community-based organizations to facilitate its use  
6 by low-income individuals and families;

7 (e) Provide access to the portal at a wide array of locations  
8 including but not limited to: Community or technical colleges,  
9 community college campuses where community service offices are  
10 colocated, community-based organizations, libraries, churches, food  
11 banks, state agencies, early childhood education sites, and labor  
12 unions;

13 (f) Ensure project resources maximize available federal and private  
14 funds for development and initial operation of the opportunity portal.  
15 Any incidental costs to state agencies shall be derived from existing  
16 resources. This subsection does not obligate or preclude the  
17 appropriation of future state funding for the opportunity portal;

18 (g) Determine the solution and acquisition approach by June 1,  
19 2010.

20 (2) By December 1, 2011, and annually thereafter, the department of  
21 social and health services shall report to the legislature and  
22 governor. The report shall include data and information on  
23 implementation and outcomes of the opportunity portal, including any  
24 increases in the use of public benefits and increases in federal  
25 funding.

26 (3) The department shall develop a plan for implementing paperless  
27 application processes for the services included in the opportunity  
28 portal for which the electronic exchange of application information is  
29 possible. The plan should include a goal of achieving, to the extent  
30 possible, the transition of these services to paperless application  
31 processes by July 1, 2012. The plan must comply with federal statutes  
32 and regulations and must allow applicants to submit applications by  
33 alternative means to ensure that access to benefits will not be  
34 restricted.

35 (4) To the extent that the department enters into a contractual  
36 relationship to accomplish the purposes of this section, such contract  
37 or contracts shall be performance-based.

1        NEW SECTION.    **Sec. 3.**    A new section is added to chapter 74.04 RCW  
2 to read as follows:

3        BASIC FOOD EMPLOYMENT AND TRAINING PROGRAM.    (1) The department,  
4 the employment security department, and the state board for community  
5 and technical colleges shall work in partnership to expand the food  
6 stamp employment and training program.    Subject to federal approval,  
7 the program shall be expanded to three additional community colleges or  
8 other community-based locations in 2010 and shall expand capacity at  
9 participating colleges.    To the greatest extent possible, expansion  
10 shall be geographically diverse.    The agencies shall:

11        (a) Identify and seek out partnerships with community-based  
12 organizations that can provide support services and case management to  
13 participants through performance-based contracts in the food stamp  
14 employment and training program, and do not replace the positions or  
15 work of department employees;

16        (b) Identify eligible nonfederal matching funds to draw down the  
17 federal match for food stamp employment and training services.  
18 Matching funds may include: Local funds, foundation grants, employer-  
19 paid costs, and the state allocation to community and technical  
20 colleges.

21        (2) Employment and training funds may be allocated for:  
22 Educational programs to develop skills for employability, vocational  
23 education, English as a second language courses, adult basic education,  
24 GED courses, remedial programs, job readiness training, case  
25 management, intake, assessment, evaluation, and barrier removal and  
26 support services such as tuition, books, child care, transportation,  
27 housing, and counseling services.

28        (3) The department shall annually track and report outcomes  
29 including those achieved through performance-based contracts as  
30 follows: Federal funding received, the number of participants served,  
31 achievement points, the number of participants who enter employment  
32 during or after participation in the food stamp employment and training  
33 program, and the average wage of jobs attained.    The report shall be  
34 submitted to the governor and appropriate committees of the legislature  
35 on November 1st of each year, beginning in 2010.

36        (4) For purposes of this section, "food stamp employment and  
37 training program" refers to a program established and administered

1 through the employment security department and the department of social  
2 and health services.

3 **Sec. 4.** RCW 74.04.005 and 2003 1st sp.s. c 10 s 1 are each amended  
4 to read as follows:

5 For the purposes of this title, unless the context indicates  
6 otherwise, the following definitions shall apply:

7 (1) "Public assistance" or "assistance"--Public aid to persons in  
8 need thereof for any cause, including services, medical care,  
9 assistance grants, disbursing orders, work relief, (~~general~~  
10 ~~assistance~~) disability lifeline benefits and federal aid assistance.

11 (2) "Department"--The department of social and health services.

12 (3) "County or local office"--The administrative office for one or  
13 more counties or designated service areas.

14 (4) "Director" or "secretary" means the secretary of social and  
15 health services.

16 (5) "Disability lifeline program" means a program that provides aid  
17 and support in accordance with the conditions set out in this  
18 subsection.

19 (a) Aid and assistance shall be provided to persons who are not  
20 eligible to receive federal aid assistance, other than basic food  
21 benefits transferred electronically and medical assistance and meet one  
22 of the following conditions:

23 (i) Are pregnant and in need, based upon the current income and  
24 resource requirements of the federal temporary assistance for needy  
25 families program; or

26 (ii) Are incapacitated from gainful employment by reason of bodily  
27 or mental infirmity that will likely continue for a minimum of ninety  
28 days as determined by the department; and

29 (A) Are citizens or aliens lawfully admitted for permanent  
30 residence or otherwise residing in the United States under color of  
31 law;

32 (B) Have furnished the department their social security number. If  
33 the social security number cannot be furnished because it has not been  
34 issued or is not known, an application for a number shall be made prior  
35 to authorization of benefits, and the social security number shall be  
36 provided to the department upon receipt;

1       (C) Have not refused or failed without good cause to participate in  
2 drug or alcohol treatment if an assessment by a certified chemical  
3 dependency counselor indicates a need for such treatment. Good cause  
4 must be found to exist when a person's physical or mental condition, as  
5 determined by the department, prevents the person from participating in  
6 drug or alcohol dependency treatment, or when drug or alcohol treatment  
7 is not available to the person in the county of his or her residence;  
8 and

9       (D) Have not refused or failed without good cause to participate in  
10 vocational rehabilitation services, if an assessment conducted under  
11 section 5 of this act indicates that the person might benefit from such  
12 services. Good cause must be found to exist when a person's physical  
13 or mental condition, as determined by the department, prevents the  
14 person from participating in vocational rehabilitation services, or  
15 when vocational rehabilitation services are not available to the person  
16 in the county of his or her residence.

17       (b)(i) Persons who initially apply and are found eligible for  
18 disability lifeline benefits based upon incapacity from gainful  
19 employment under (a) of this subsection on or after September 2, 2010,  
20 who are homeless and have been assessed as needing chemical dependency  
21 or mental health treatment or both, must agree, as a condition of  
22 eligibility for the disability lifeline program, to accept a housing  
23 voucher in lieu of a cash grant if a voucher is available. The  
24 department shall establish the dollar value of the housing voucher.  
25 The dollar value of the housing voucher may differ from the value of  
26 the cash grant. Persons receiving a housing voucher under this  
27 subsection also shall receive a cash stipend of fifty dollars per  
28 month.

29       (ii) If the department of commerce has determined under section 8  
30 of this act that sufficient housing is not available, persons described  
31 in this subsection who apply for disability lifeline benefits during  
32 the time period that housing is not available shall receive a cash  
33 grant in lieu of a cash stipend and housing voucher.

34       (iii) Persons who refuse to accept a housing voucher under this  
35 subsection but otherwise meet the eligibility requirements of (a) of  
36 this subsection are eligible for medical care services benefits under  
37 RCW 74.09.035, subject to the time limits in (h) of this subsection.

1 (c) The following persons are not eligible for the disability  
2 lifeline program:

3 (i) Persons who are unemployable due primarily to alcohol or drug  
4 addiction. These persons shall be referred to appropriate assessment,  
5 treatment, shelter, or supplemental security income referral services  
6 as authorized under chapter 74.50 RCW. Referrals shall be made at the  
7 time of application or at the time of eligibility review. This  
8 subsection shall not be construed to prohibit the department from  
9 granting disability lifeline benefits to alcoholics and drug addicts  
10 who are incapacitated due to other physical or mental conditions that  
11 meet the eligibility criteria for the disability lifeline program;

12 (ii) Persons who refuse or fail to cooperate in obtaining federal  
13 aid assistance, without good cause.

14 (d) Disability lifeline benefits shall be provided only to persons  
15 who are not members of assistance units receiving federal aid  
16 assistance, except as provided in (a) of this subsection, and who will  
17 accept available services that can reasonably be expected to enable the  
18 person to work or reduce the need for assistance unless there is good  
19 cause to refuse. Failure to accept such services shall result in  
20 termination until the person agrees to cooperate in accepting such  
21 services and subject to the following maximum periods of ineligibility  
22 after reapplication:

23 (i) First failure: One week;

24 (ii) Second failure within six months: One month;

25 (iii) Third and subsequent failure within one year: Two months.

26 (e) Persons who are likely eligible for federal supplemental  
27 security income benefits shall be moved into the disability lifeline  
28 expedited component of the disability lifeline program. Persons placed  
29 in the expedited component of the program may, if otherwise eligible,  
30 receive disability lifeline benefits pending application for federal  
31 supplemental security income benefits. The monetary value of any  
32 disability lifeline benefit that is subsequently duplicated by the  
33 person's receipt of supplemental security income for the same period  
34 shall be considered a debt due the state and shall by operation of law  
35 be subject to recovery through all available legal remedies.

36 (f) For purposes of determining whether a person is incapacitated  
37 from gainful employment under (a) of this subsection:

1       (i) The department shall adopt by rule medical criteria for  
2 disability lifeline incapacity determinations to ensure that  
3 eligibility decisions are consistent with statutory requirements and  
4 are based on clear, objective medical information; and

5       (ii) The process implementing the medical criteria shall involve  
6 consideration of opinions of the treating or consulting physicians or  
7 health care professionals regarding incapacity, and any eligibility  
8 decision which rejects uncontroverted medical opinion must set forth  
9 clear and convincing reasons for doing so.

10       (g) Persons receiving disability lifeline benefits based upon a  
11 finding of incapacity from gainful employment who remain otherwise  
12 eligible shall have their benefits discontinued unless the recipient  
13 demonstrates no material improvement in their medical or mental health  
14 condition. The department may discontinue benefits when there was  
15 specific error in the prior determination that found the person  
16 eligible by reason of incapacitation.

17       (h)(i) Between September 1, 2010, and June 30, 2012, no person who  
18 is currently receiving or becomes eligible for disability lifeline  
19 program benefits shall be eligible to receive benefits under the  
20 program for more than eighteen months in a thirty-six month period.  
21 For purposes of this subsection, months of receipt of general  
22 assistance-unemployable benefits count toward the eighteen month limit.  
23 Months during which a person received benefits under the expedited  
24 component of the disability lifeline program or under the aged, blind,  
25 or disabled component of the disability lifeline program shall not be  
26 included when determining whether a person has been receiving benefits  
27 for more than eighteen months. On or before July 1, 2010, the  
28 department must review the cases of all persons who have received  
29 disability lifeline benefits or general assistance unemployable  
30 benefits for at least twelve months as of that date. The review should  
31 identify services needed to transition the individual to employment or,  
32 if sufficiently disabled, to supplemental security income benefits.

33       (ii) The department shall monitor the experience of persons  
34 receiving disability lifeline benefits who are terminated from the  
35 program pursuant to this subsection and provide an initial report to  
36 the governor and relevant policy and fiscal committees of the  
37 legislature no later than November 30, 2011, containing the following  
38 information:



1 (A) The number of persons terminated from the program who  
2 transition to supplemental security income benefits;

3 (B) The number of persons who become employed;

4 (C) The rate at which the affected persons use hospital emergency  
5 room services;

6 (D) The number of persons involuntarily committed under chapter  
7 71.05 RCW;

8 (E) The number of persons arrested or convicted of criminal  
9 offenses; and

10 (F) The mortality rate of the affected persons.

11 (i) No person may be considered an eligible individual for  
12 disability lifeline benefits with respect to any month if during that  
13 month the person:

14 (i) Is fleeing to avoid prosecution of, or to avoid custody or  
15 confinement for conviction of, a felony, or an attempt to commit a  
16 felony, under the laws of the state of Washington or the place from  
17 which the person flees; or

18 (ii) Is violating a condition of probation, community supervision,  
19 or parole imposed under federal or state law for a felony or gross  
20 misdemeanor conviction.

21 (6) "Federal aid assistance"--The specific categories of assistance  
22 for which provision is made in any federal law existing or hereafter  
23 passed by which payments are made from the federal government to the  
24 state in aid or in respect to payment by the state for public  
25 assistance rendered to any category of needy persons for which  
26 provision for federal funds or aid may from time to time be made, or a  
27 federally administered needs-based program.

28 ~~((6)(a) "General assistance"--Aid to persons in need who:~~

29 ~~(i) Are not eligible to receive federal aid assistance, other than~~  
30 ~~food stamps or food stamp benefits transferred electronically and~~  
31 ~~medical assistance; however, an individual who refuses or fails to~~  
32 ~~cooperate in obtaining federal aid assistance, without good cause, is~~

33       ~~(i) Recipients of supplemental security income whose need, as~~  
34 ~~defined in this section, is not met by such supplemental security~~

37 ~~appropriations act, to recipients of temporary assistance for needy~~

1 in monthly income below the entitled benefit payment level caused by  
2 loss or reduction of wages or unemployment compensation benefits or  
3 some other unforeseen circumstances. The amount of general assistance  
4 authorized shall not exceed the difference between the entitled benefit  
5 payment level and the amount of income actually received.

6 (c) General assistance shall be provided only to persons who are  
7 not members of assistance units receiving federal aid assistance,  
8 except as provided in subsection (6)(a)(ii)(A) and (b) of this section,  
9 and will accept available services which can reasonably be expected to  
10 enable the person to work or reduce the need for assistance unless  
11 there is good cause to refuse. Failure to accept such services shall  
12 result in termination until the person agrees to cooperate in accepting  
13 such services and subject to the following maximum periods of  
14 ineligibility after reapplication:

15 (i) First failure: One week;

16 (ii) Second failure within six months: One month;

17 (iii) Third and subsequent failure within one year: Two months.

18 (d) Persons found eligible for general assistance based on  
19 incapacity from gainful employment may, if otherwise eligible, receive  
20 general assistance pending application for federal supplemental  
21 security income benefits. Any general assistance that is subsequently  
22 duplicated by the person's receipt of supplemental security income for  
23 the same period shall be considered a debt due the state and shall by  
24 operation of law be subject to recovery through all available legal  
25 remedies.

26 (e) The department shall adopt by rule medical criteria for general  
27 assistance eligibility to ensure that eligibility decisions are  
28 consistent with statutory requirements and are based on clear,  
29 objective medical information.

30 (f) The process implementing the medical criteria shall involve  
31 consideration of opinions of the treating or consulting physicians or  
32 health care professionals regarding incapacity, and any eligibility  
33 decision which rejects uncontroverted medical opinion must set forth  
34 clear and convincing reasons for doing so.

35 (g) Recipients of general assistance based upon a finding of  
36 incapacity from gainful employment who remain otherwise eligible shall  
37 have their benefits discontinued unless the recipient demonstrates no  
38 material improvement in their medical or mental condition. The

1 department may discontinue benefits when there was specific error in  
2 the prior determination that found the recipient eligible by reason of  
3 incapacitation. Recipients of general assistance based upon pregnancy  
4 who relinquish their child for adoption, remain otherwise eligible, and  
5 are not eligible to receive benefits under the federal temporary  
6 assistance for needy families program shall not have their benefits  
7 terminated until the end of the month in which the period of six weeks  
8 following the birth of the recipient's child falls. Recipients of the  
9 federal temporary assistance for needy families program who lose their  
10 eligibility solely because of the birth and relinquishment of the  
11 qualifying child may receive general assistance through the end of the  
12 month in which the period of six weeks following the birth of the child  
13 falls.

14 (h) No person may be considered an eligible individual for general  
15 assistance with respect to any month if during that month the person:

16 (i) Is fleeing to avoid prosecution of, or to avoid custody or  
17 confinement for conviction of, a felony, or an attempt to commit a  
18 felony, under the laws of the state of Washington or the place from  
19 which the person flees; or

20 (ii) Is violating a condition of probation, community supervision,  
21 or parole imposed under federal or state law for a felony or gross  
22 misdemeanor conviction.)

23 (7) "Applicant"--Any person who has made a request, or on behalf of  
24 whom a request has been made, to any county or local office for  
25 assistance.

26 (8) "Recipient"--Any person receiving assistance and in addition  
27 those dependents whose needs are included in the recipient's  
28 assistance.

29 (9) "Standards of assistance"--The level of income required by an  
30 applicant or recipient to maintain a level of living specified by the  
31 department.

32 (10) "Resource"--Any asset, tangible or intangible, owned by or  
33 available to the applicant at the time of application, which can be  
34 applied toward meeting the applicant's need, either directly or by  
35 conversion into money or its equivalent. The department may by rule  
36 designate resources that an applicant may retain and not be ineligible  
37 for public assistance because of such resources. Exempt resources  
38 shall include, but are not limited to:

1 (a) A home that an applicant, recipient, or their dependents is  
2 living in, including the surrounding property;

3 (b) Household furnishings and personal effects;

4 (c) A motor vehicle, other than a motor home, used and useful  
5 having an equity value not to exceed five thousand dollars;

6 (d) A motor vehicle necessary to transport a (~~physically~~  
7 ~~disabled~~) household member with a physical disability. This exclusion  
8 is limited to one vehicle per (~~physically disabled~~) person with a  
9 physical disability;

10 (e) All other resources, including any excess of values exempted,  
11 not to exceed one thousand dollars or other limit as set by the  
12 department, to be consistent with limitations on resources and  
13 exemptions necessary for federal aid assistance. The department shall  
14 also allow recipients of temporary assistance for needy families to  
15 exempt savings accounts with combined balances of up to an additional  
16 three thousand dollars;

17 (f) Applicants for or recipients of (~~general assistance~~)  
18 disability lifeline benefits shall have their eligibility based on  
19 resource limitations consistent with the temporary assistance for needy  
20 families program rules adopted by the department; and

21 (g) If an applicant for or recipient of public assistance possesses  
22 property and belongings in excess of the ceiling value, such value  
23 shall be used in determining the need of the applicant or recipient,  
24 except that: (i) The department may exempt resources or income when  
25 the income and resources are determined necessary to the applicant's or  
26 recipient's restoration to independence, to decrease the need for  
27 public assistance, or to aid in rehabilitating the applicant or  
28 recipient or a dependent of the applicant or recipient; and (ii) the  
29 department may provide grant assistance for a period not to exceed nine  
30 months from the date the agreement is signed pursuant to this section  
31 to persons who are otherwise ineligible because of excess real property  
32 owned by such persons when they are making a good faith effort to  
33 dispose of that property: PROVIDED, That:

34 (A) The applicant or recipient signs an agreement to repay the  
35 lesser of the amount of aid received or the net proceeds of such sale;

36 (B) If the owner of the excess property ceases to make good faith  
37 efforts to sell the property, the entire amount of assistance may

1 become an overpayment and a debt due the state and may be recovered  
2 pursuant to RCW 43.20B.630;

3 (C) Applicants and recipients are advised of their right to a fair  
4 hearing and afforded the opportunity to challenge a decision that good  
5 faith efforts to sell have ceased, prior to assessment of an  
6 overpayment under this section; and

7 (D) At the time assistance is authorized, the department files a  
8 lien without a sum certain on the specific property.

9 (11) "Income"--(a) All appreciable gains in real or personal  
10 property (cash or kind) or other assets, which are received by or  
11 become available for use and enjoyment by an applicant or recipient  
12 during the month of application or after applying for or receiving  
13 public assistance. The department may by rule and regulation exempt  
14 income received by an applicant for or recipient of public assistance  
15 which can be used by him or her to decrease his or her need for public  
16 assistance or to aid in rehabilitating him or her or his or her  
17 dependents, but such exemption shall not, unless otherwise provided in  
18 this title, exceed the exemptions of resources granted under this

27 (12) "Need"--The difference between the applicant's or recipient's  
28 standards of assistance for himself or herself and the dependent  
29 members of his or her family, as measured by the standards of the  
30 department, and value of all nonexempt resources and nonexempt income  
31 received by or available to the applicant or recipient and the  
32 dependent members of his or her family.

33 (13) For purposes of determining eligibility for public assistance  
34 and participation levels in the cost of medical care, the department  
35 shall exempt restitution payments made to people of Japanese and Aleut  
36 ancestry pursuant to the Civil Liberties Act of 1988 and the Aleutian  
37 and Pribilof Island Restitution Act passed by congress, P.L. 100-383,  
38 including all income and resources derived therefrom.

1 (14) In the construction of words and phrases used in this title,  
2 the singular number shall include the plural, the masculine gender  
3 shall include both the feminine and neuter genders and the present  
4 tense shall include the past and future tenses, unless the context  
5 thereof shall clearly indicate to the contrary.

6 NEW SECTION. **Sec. 5.** A new section is added to chapter 74.04 RCW  
7 to read as follows:

8 REFERRAL TO THE DIVISION OF VOCATIONAL REHABILITATION. (1) The  
9 economic services administration shall work jointly with the division  
10 of vocational rehabilitation to develop an assessment tool that must be  
11 used to determine whether the programs offered by the division of  
12 vocational rehabilitation could assist persons receiving disability  
13 lifeline benefits in returning to the work force. The assessment tool  
14 shall be completed no later than December 1, 2010. The economic  
15 services administration shall begin using the tool no later than  
16 January 1, 2011. No later than December 30, 2011, the department shall  
17 report on the use of the tool and to what extent the programs offered  
18 by the division of vocational rehabilitation have been successful in  
19 returning persons receiving disability lifeline benefits to the work  
20 force.

21 (2) After January 1, 2011, all persons receiving disability  
22 lifeline benefits shall be assessed to determine whether they would  
23 likely benefit from a program offered by the division of vocational  
24 rehabilitation. If the assessment indicates that the person might  
25 benefit, the economic services administration shall make a referral to  
26 the division of vocational rehabilitation. If the person is found  
27 eligible for a program with the division of vocational rehabilitation,  
28 he or she must participate in that program to remain eligible for the  
29 monthly stipend and housing voucher or a cash grant. If the person  
30 refuses to participate or does not complete the program, the department  
31 shall terminate the cash stipend and housing voucher or cash grant but  
32 may not terminate medical coverage and food benefits.

33 NEW SECTION. **Sec. 6.** A new section is added to chapter 74.04 RCW  
34 to read as follows:

35 REFERRAL TO THE DEPARTMENT OF VETERANS AFFAIRS. During the  
36 application process for disability lifeline benefits, the department

1 shall inquire of each applicant whether he or she has ever served in  
2 the United States military service. If the applicant answers in the  
3 affirmative, the department shall confer with a veterans benefit  
4 specialist with the Washington state department of veterans affairs or  
5 a contracted veterans service officer in the community to determine  
6 whether the applicant is eligible for any benefits or programs offered  
7 to veterans by either the state or the federal government.

8 NEW SECTION. **Sec. 7.** A new section is added to chapter 74.04 RCW  
9 to read as follows:

10 EARLY SSI TRANSITION PROJECT. (1) To ensure that persons who are  
11 likely eligible for supplemental security income benefits are  
12 transitioned from disability lifeline benefits to disability lifeline  
13 expedited and the medicaid program, and then to the supplemental  
14 security income program as quickly as practicable, the department shall  
15 implement the early supplemental security income transition project  
16 starting in King, Pierce, and Spokane counties no later than July 1,  
17 2010, and extending statewide no later than October 1, 2011. The  
18 program shall be implemented through performance-based contracts with  
19 managed health care systems providing medical care services under RCW  
20 74.09.035 or other qualified entities. The participants shall have the  
21 following responsibilities and duties under this program:

22 (a) The entities with whom the department contracts to provide the  
23 program shall be responsible for:

24 (i) Systematically screening persons receiving disability lifeline  
25 benefits at the point of eligibility determination or shortly  
26 thereafter to determine if the persons are likely eligible for  
27 supplemental security income;

28 (ii) Immediately sharing the results of the disability screening  
29 with the department;

30 (iii) Managing disability lifeline incapacity evaluation  
31 examinations to provide timely access to needed medical and behavioral  
32 health evaluations and standardizing health care providers' conduct of  
33 incapacity evaluations. To maximize the timeliness and efficiency of  
34 incapacity evaluation examinations, the department must strongly  
35 consider contracting with a managed health care system with a network  
36 of health care providers that are trained and have agreed to conduct  
37 disability lifeline medical and psychological incapacity and



1 recertification exams. The department may obtain medical evidence and  
2 other relevant information from sources other than the contracted  
3 entity if such evidence is available at the time of a person's  
4 application for disability lifeline benefits and is sufficient to  
5 support a determination that the person is incapacitated;

6 (iv) Maintaining a centralized appointment and clinical data  
7 system; and

8 (v) Assisting persons receiving disability lifeline benefits with  
9 obtaining additional medical or behavioral health examinations needed  
10 to meet the disability standard for federal supplemental security  
11 income benefits and with submission of applications for supplemental  
12 security income benefits.

13 (b) The department shall be responsible for:

14 (i) Determining incapacity and eligibility for disability lifeline  
15 benefits;

16 (ii) Making timely determinations that a person receiving  
17 disability lifeline benefits is likely eligible for supplemental  
18 security income based on medical evidence and other relevant  
19 information provided by a contracted entity, and immediately referring  
20 such persons to a contracted entity for services;

21 (iii) Developing standardized procedures for sharing data and  
22 information with the contracted entities to ensure timely  
23 identification of clients who have not been transferred to the  
24 disability lifeline expedited program within four months of their date  
25 of application, but who may, upon further review, be appropriately  
26 transferred to that program;

27 (iv) Providing case management, in partnership with the managed  
28 health care system or contracted entity, to support persons' transition  
29 to federal supplemental security income and medicaid benefits; and

30 (v) Identifying a savings determination methodology, in  
31 consultation with the contracted entities, the office of financial  
32 management, and the legislature, on or before implementation of the  
33 project.

34 (2) Early supplemental security income transition project contracts  
35 shall include the following performance goals:

36 (a) Persons receiving disability lifeline benefits should be  
37 screened within thirty days of entering the program to determine the

1 propriety of their transfer to the disability lifeline expedited  
2 program; and

3 (b) Seventy-five percent of persons receiving disability lifeline  
4 benefits that are likely to qualify for supplemental security income  
5 benefits shall be transferred to the disability lifeline expedited  
6 program within four months of their application for disability lifeline  
7 benefits.

8 (3) The initial focus of the efforts of the early supplemental  
9 security income transition project shall be on persons who have been  
10 receiving disability lifeline or general assistance unemployable  
11 benefits for twelve or more months as of September 1, 2010.

12 (4) No later than December 1, 2011, the department shall report to  
13 the governor and appropriate policy and fiscal committees on whether  
14 the early supplemental security income transition project performance  
15 goals in subsection (2) of this section were met, including the reasons  
16 those goals were or were not met.

17 (5) Pursuant to RCW 41.06.142(3), performance-based contracting  
18 under this section is expressly mandated by the legislature and is not  
19 subject to the processes set forth in RCW 41.06.142 (1), (4), and (5).

20 The statewide expansion of the program under this section shall be  
21 considered expressly mandated by the legislature and not be subject to  
22 the provisions of RCW 41.06.142 (1), (4), and (5).

23 NEW SECTION. **Sec. 8.** A new section is added to chapter 43.330 RCW  
24 to read as follows:

25 **DISABILITY LIFELINE HOUSING VOUCHER PROGRAM.** (1) To address the  
26 housing issues faced by the disability lifeline applicants in RCW  
27 74.04.005(5)(b), the department of commerce and the department of  
28 social and health services shall jointly develop a housing voucher  
29 program. The departments also shall develop housing resources to be  
30 used by the applicants in RCW 74.04.005(5)(b). To the greatest extent  
31 possible, the housing resources shall follow the supportive housing  
32 model. The department of commerce shall administer the housing voucher  
33 program and shall:

34 (a) Identify the current supply of private and public housing  
35 including acquisition and rental of existing housing stock;

36 (b) Develop funding strategies for the development of housing  
37 resources; and

1 (c) Design the voucher program to maximize the ability of the  
2 department of social and health services to recover federal funding.

3 (2) If the department of commerce determines that the housing  
4 supply is inadequate to meet the need for those applicants qualifying  
5 for housing vouchers under RCW 74.04.005(5)(b), those applicants shall  
6 instead receive a cash grant administered by the department of social  
7 and health services. Upon the department of commerce's determination  
8 that the housing supply is adequate to meet the needs of the applicants  
9 in RCW 74.04.005(5)(b), housing vouchers rather than cash grants shall  
10 be issued to these applicants who apply on or after the department's

12 (3) The department of commerce and the department of social and  
13 health services shall evaluate the impact of the use of housing  
14 vouchers under this section and report to the governor and relevant  
15 policy and fiscal committees of the legislature by November 30, 2012,

17 (a) The supply, affordability, appropriateness, and use of stable  
18 housing;

19 (b) The following outcomes for persons receiving disability  
20 lifeline housing vouchers:

21 (i) Participation in and completion of chemical dependency or  
22 mental health treatment;

23 (ii) Contact with law enforcement, including arrest and conviction  
24 data;

25 (iii) Use of emergency room services; and

26 (iv) Involuntary commitment under chapter 71.05 RCW.

27 NEW SECTION. **Sec. 9.** A new section is added to chapter 70.47 RCW  
28 to read as follows:

29 BASIC HEALTH PLAN ENROLLMENT. In order to ensure continuity of  
30 health care coverage and avoid deterioration in health status, persons  
31 who have lost eligibility for disability lifeline benefits under RCW  
32 74.04.005(5) due to improvement in their health status and who are  
33 eligible for subsidized basic health coverage shall be given priority  
34 for enrollment in the basic health plan. If the administrator closes  
35 or limits subsidized enrollment, to the extent funding is available,  
36 the basic health plan must continue to accept and process applications  
37 for subsidized enrollment from persons described in this section.

1        NEW SECTION.    **Sec. 10.**    A new section is added to chapter 70.96A  
2    RCW to read as follows:

3        ACCESS TO CHEMICAL DEPENDENCY TREATMENT.    If an assessment by a  
4    certified chemical dependency counselor indicates a need for drug or  
5    alcohol treatment, in order to enable a person receiving disability  
6    lifeline benefits to improve his or her health status and transition  
7    from disability lifeline benefits to employment, or transition to  
8    federal disability benefits, the person must be given high priority for  
9    enrollment in treatment, within funds appropriated for that treatment.  
10    However, first priority for receipt of treatment services must be given  
11    to pregnant women and parents of young children.    This section expires  
12    June 30, 2013.

13        **Sec. 11.**    RCW 10.101.010 and 1998 c 79 s 2 are each amended to read  
14    as follows:

15        The following definitions shall be applied in connection with this  
16    chapter:

17        (1) "Indigent" means a person who, at any stage of a court  
18    proceeding, is:

19        (a) Receiving one of the following types of public assistance:  
20    Temporary assistance for needy families, (~~general assistance~~)  
21    disability lifeline benefits, poverty-related veterans' benefits, food  
22    stamps or food stamp benefits transferred electronically, refugee  
23    resettlement benefits, medicaid, or supplemental security income; or

24        (b) Involuntarily committed to a public mental health facility; or

25        (c) Receiving an annual income, after taxes, of one hundred twenty-

29 custodian has expressed, either by statement or conduct, an intent to  
30 forego, for an extended period, parental rights or responsibilities  
31 despite an ability to exercise such rights and responsibilities. If  
32 the court finds that the petitioner has exercised due diligence in  
33 attempting to locate the parent, no contact between the child and the

28 stamps or food stamp benefits transferred electronically, refugee

36 (13) "Out-of-home care" means placement in a foster family home or

2 custodian, not required to be licensed pursuant to chapter 74.15 RCW.

3 (14) "Preventive services" means preservation services, as defined  
4 in chapter 74.14C RCW, and other reasonably available services,  
5 including housing assistance, capable of preventing the need for out-  
6 of-home placement while protecting the child.

7 (15) "Shelter care" means temporary physical care in a facility  
8 licensed pursuant to RCW 74.15.030 or in a home not required to be  
9 licensed pursuant to RCW 74.15.030.

10 (16) "Sibling" means a child's birth brother, birth sister,  
11 adoptive brother, adoptive sister, half-brother, or half-sister, or as  
12 defined by the law or custom of the Indian child's tribe for an Indian  
13 child as defined in 25 U.S.C. Sec. 1903(4).

14 (17) "Social study" means a written evaluation of matters relevant  
15 to the disposition of the case and shall contain the following  
16 information:

17 (a) A statement of the specific harm or harms to the child that  
18 intervention is designed to alleviate;

19 (b) A description of the specific services and activities, for both  
20 the parents and child, that are needed in order to prevent serious harm

6 (18) "Supervising agency" means an agency licensed by the state  
7 under RCW 74.15.090 or an Indian tribe under RCW 74.15.190 with whom  
8 the department has entered into a performance-based contract to provide  
9 child welfare services as defined in RCW 74.13.020.

10 **Sec. 13.** RCW 26.19.071 and 2009 c 84 s 3 are each amended to read  
11 as follows:

12 (1) **Consideration of all income.** All income and resources of each  
13 parent's household shall be disclosed and considered by the court when  
14 the court determines the child support obligation of each parent. Only

30 Receipt of income and resources from temporary assistance for needy

32 incarcerated in a correctional institution, as defined in RCW 9.94.049,  
33 or admitted to an institute for mental disease, as defined in 42 C.F.R.  
34 part 435, Sec. 1009 on July 24, 2005.

35 (5) For purposes of this section, "likely to be eligible" means  
36 that a person:

37 (a) Was enrolled in medicaid or supplemental security income or

1 ((~~general assistance~~)) the disability lifeline program immediately  
2 before he or she was confined and his or her enrollment was terminated  
3 during his or her confinement; or

4 (b) Was enrolled in medicaid or supplemental security income or  
5 ((~~general assistance~~)) the disability lifeline program at any time  
6 during the five years before his or her confinement, and medical or  
7 psychiatric examinations during the person's confinement indicate that  
8 the person continues to be disabled and the disability is likely to  
9 last at least twelve months following release.

10 (6) The economic services administration shall adopt standardized  
11 statewide screening and application practices and forms designed to  
12 facilitate the application of a confined person who is likely to be  
13 eligible for medicaid.

14 **Sec. 30.** RCW 74.50.060 and 1989 1st ex.s. c 18 s 3 are each  
15 amended to read as follows:

16 (1) The department shall establish a shelter assistance program to  
17 provide, within available funds, shelter for persons eligible under  
18 this chapter. "Shelter," "shelter support," or "shelter assistance"  
19 means a facility under contract to the department providing room and  
20 board in a supervised living arrangement, normally in a group or  
21 dormitory setting, to eligible recipients under this chapter. This may  
22 include supervised domiciliary facilities operated under the auspices  
23 of public or private agencies. No facility under contract to the  
24 department shall allow the consumption of alcoholic beverages on the  
25 premises. The department may contract with counties and cities for  
26 such shelter services. To the extent possible, the department shall  
27 not displace existing emergency shelter beds for use as shelter under  
28 this chapter. In areas of the state in which it is not feasible to  
29 develop shelters, due to low numbers of people needing shelter  
30 services, or in which sufficient numbers of shelter beds are not  
31 available, the department may provide shelter through an intensive  
32 protective payee program, unless the department grants an exception on  
33 an individual basis for less intense supervision.

34 (2) Persons continuously eligible for the ((~~general assistance~~—  
35 ~~unemployable program~~)) disability lifeline program since July 25, 1987,  
36 who transfer to the program established by this chapter, have the



1 option to continue their present living situation, but only through a  
2 protective payee.

3 NEW SECTION. **Sec. 31.** A new section is added to chapter 74.08A  
4 RCW to read as follows:

5 Recipients exempted from active work search activities due to  
6 incapacity or a disability shall receive disability lifeline benefits  
7 as they relate to the facilitation of enrollment in the federal  
8 supplemental security income program, access to chemical dependency  
9 treatment, referrals to vocational rehabilitation, and other services  
10 needed to assist the recipient in becoming employable. Disability  
11 lifeline benefits shall not supplant cash assistance and other services  
12 provided through the temporary assistance for needy families program.  
13 To the greatest extent possible, services shall be funded through the  
14 temporary assistance for needy families appropriations.

15 NEW SECTION. **Sec. 32.** This act shall be known and cited as the  
16 security lifeline act.

17 NEW SECTION. **Sec. 33.** Except for section 10 of this act, this act  
18 is necessary for the immediate preservation of the public peace,  
19 health, or safety, or support of the state government and its existing  
20 public institutions, and takes effect immediately.

21 NEW SECTION. **Sec. 34.** Section 10 of this act takes effect July 1,  
22 2010.

23 NEW SECTION. **Sec. 35.** If private funding sufficient to implement  
24 and operate the portal authorized under section 2 of this act is not  
25 secured by December 31, 2010, section 2 of this act is null and void.

26 NEW SECTION. **Sec. 36.** Sections 1 through 10 and 28 of this act  
27 shall be implemented within the amounts appropriated specifically for  
28 these purposes in the omnibus operating appropriations act."
