- "NEW SECTION. Sec. 402. (1) The legislature finds that:
- 12 (a) To further the goals of high quality public education 13 throughout the state, each school district board of directors should 14 have the authority to grant public schools of the district the maximum 15 degree of flexibility possible to meet the needs of individual
- 16 students and the communities in which they live; and
- 17 (b) Particularly in schools and communities that are struggling 18 to improve student academic outcomes and close the achievement gap
- 19 among groups of students, there is a critical need for innovative
- 20 models of public education that are tailored to the unique
- 21 circumstances and needs of the students in those schools and
- 22 communities and implement evidence-based practices proven to be
- 23 effective in reducing demographic disparities in student achievement.
- 24 (2) Therefore, the legislature intends to:
- 25 (a) Grant school districts and public schools greater ability to
- 26 meet the educational needs of a diverse student population;

- 1 (b) Improve educational performance through greater individual 2 school autonomy and managerial flexibility;
- 3 (c) Encourage innovation in education by providing local school 4 communities and principals with greater control over levels of 5 staffing, personnel selection and evaluation, scheduling, and 6 educational programming with the goal of improving student achievement 7 and closing the achievement gap; and
- 8 (d) Hold public schools that receive greater autonomy under this 9 chapter accountable for student academic achievement as measured by 10 the statewide assessments of student learning and other accountability 11 measures.
- 12 (3) The legislature encourages school districts identified for 13 required action under section 103 of this act to establish innovation 14 schools as an intervention model under section 105 of this act in any 15 persistently lowest-performing schools identified in the district.

- NEW SECTION. Sec. 403. Any school district board of directors 18 may establish one or more innovation schools or innovation school 2 zones within the district as provided in this section.
- (1)(a) Any public school within a school district may submit to the board of directors of the district an innovation school plan as 22 described under section 404 of this act. A group of public schools within a school district that share common interests, such as 24 geographical location or educational focus, or that sequentially serve classes of students as they progress through elementary and secondary education may jointly submit to the board of directors of the district a plan to create an innovation school zone as described under section 404 of this act. An innovation school zone may include all public 29 schools within a school district.
- 30 (b) A school district board of directors that receives an 31 innovation school plan or innovation school zone plan shall either 32 approve or disapprove the plan within sixty days of receiving the 33 plan. If the board of directors rejects the plan, the board must 34 provide a written explanation of the reasons for the rejection. The

- 1 public school or group of public schools may resubmit an amended plan 2 any time after a plan is rejected.
- 3 (2) Any school district board of directors may initiate and 4 collaborate with one or more public schools in the district to create 5 one or more innovation schools through an innovation school plan or 6 one or more innovation school zones through an innovation school zone 7 plan. In creating an innovation school plan or an innovation school 8 zone plan, the board of directors must ensure that each public school 9 affected by the plan has substantial opportunity to participate in
- 11 (3) If a school district board of directors approves or creates an 12 innovation school or an innovation school zone within the district, 13 the board of directors may seek designation of the district as an 14 innovation school district under section 406 of this act.

- NEW SECTION. Sec. 404. (1) An innovation school plan shall 17 include the following information:
- 18 (a) A statement of the mission of the public school and why 19 designation as an innovation school would enhance the ability of the 20 school to achieve its mission;
- (b) A description of the innovations to be implemented by the public school, which may include but are not limited to innovations in school staffing, curriculum and assessment, class scheduling, use of financial and other resources, and recruitment, employment, evaluation, and compensation of school employees;
- 26 (c) A listing of the programs, policies, or other operational 27 aspects of the public school that would be affected by the innovations 28 identified in the plan and the manner in which they would be affected, 29 including but not limited to:
- 30 (i) The research-based educational program to be implemented by 31 the school;
- (ii) Unique learning opportunities for students to be implemented
 33 by the school;

- 1 (iii) The student promotion and graduation policies to be
- 2 implemented at the school;
- 3 (iv) The student assessment plan at the school;
- 4 (v) The length of school day and school year at the school;
- 5 (vi) The proposed budget for the school; and
- 6 (vii) The proposed staffing plan for the school;
- 7 (d) Identification of the improvements in academic performance
- 8 that the public school expects to achieve in implementing the
- 9 innovations;
- 10 (e) A statement of the level of support for designation as an
- 11 innovation school demonstrated by the personnel employed at the
- 12 school, the students and parents of students enrolled in the school,
- 13 and the community surrounding the school;
- 14 (f) An estimate of the cost savings and increased efficiencies, if
- 15 any, the public school expects to achieve in implementing the
- 16 identified innovations;
- 17 (g) A listing and description of any waivers of state rules or
- 18 laws and state or school district policies that are necessary for the
- 19 public school to implement the identified innovations and why the
- 20 waivers are necessary; and
- 21 (h) Any additional information required by the school district
- 22 board of directors to be included in an innovation school plan.
- 23 (2) An innovation school zone plan must include all of the
- 24 information under subsection (1) of this section, plus the following
- 25 additional information:
- 26 (a) A description of how innovations in the public schools within
- 27 the innovation school zone would be integrated to achieve results that
- 28 would be less likely to be accomplished by each school working alone;
- 29 (b) An estimate of any economies of scale that would be achieved
- 30 by innovations implemented jointly by the public schools within the
- 31 innovation school zone; and
- 32 (c) A statement of the level of support for creating an innovation
- 33 school zone demonstrated by the personnel employed at each public
- 34 school that would be included in the zone, the students and parents of

- 1 students enrolled in each of the schools, and the community
- 2 surrounding the innovation school zone. In determining the level of
- 3 support, each public school shall specifically solicit input
- 4 concerning the selection of schools included in the innovation school
- 5 zone and the strategies and procedures that would be used in
- 6 implementing and integrating the innovations within the schools in the 7 zone.
- 8 (3) In considering or creating an innovation school plan or an
- 9 innovation school zone plan, each public school involved in the plan
- 10 and each school district board of directors is strongly encouraged to
- 11 consider innovations in the following areas:
- 12 (a) Curriculum and assessments;
- 13 (b) Expanded accountability measures, including the use of a
- 14 variety of accountability measures to more accurately present a
- 15 complete measure of student learning and accomplishment, such as:
- 16 (i) Use of graduation or exit examinations, end-of-course
- 17 examinations, student portfolio reviews, or national and international
- 18 accountability measures;
- 19 (ii) Measuring the percentage of students continuing on to
- 20 postsecondary education; and
- 21 (iii) Measuring the percentage of students concurrently obtaining
- 22 a high school diploma and an associate degree or career and technical
- 23 education certificate;
- 24 (c) Provision of services, including special education services,
- 25 services for highly capable students, services for English language
- 26 learner students, and educational and support services for students at
- 27 risk of academic failure, suspension, or expulsion;
- 28 (d) Implementation of programs, services, and strategies
- 29 specifically intended to close the achievement gap and increase
- 30 graduation rates across all groups of students in the school;
- 31 (e) Teacher recruitment, training, and professional development;
- 32 (f) Employment and assignment policies;
- 33 (q) Performance expectations and evaluation procedures for
- 34 teachers and principals;

- 1 (h) Compensation for teachers, principals, and other school 2 building personnel, including but not limited to performance-based 3 pay, total compensation plans, and other innovations;
- 4 (i) School governance and the roles, responsibilities, and 5 expectations of principals in innovation schools or schools in an 6 innovation school zone;
- 7 (j) School-based budgeting, hiring and assignment of school staff, 8 and other management responsibilities; and
- 9 (k) Preparation and counseling of students for transition to 10 postsecondary education and employment.

NEW SECTION. Sec. 405. Each school district board of directors is authorized and encouraged to seek and accept public and private quifts, grants, and donations to offset the costs of developing and implementing innovation school plans and innovation school zone plans.

- NEW SECTION. Sec. 406. A school district board of directors that 18 has approved or created an innovation school or an innovation school 20 zone under section 403 of this act may seek designation by the state 20 board of education as an innovation school district under this 21 section.
- (1) A school district board of directors that seeks designation as 22 23 an innovation school district shall submit its innovation school plans 24 or innovation school zone plans to the state board of education and 25 the superintendent of public instruction for review and comment. 26 Within sixty days after receiving such a plan, the state board of 27 education and the superintendent of public instruction shall respond 28 to the school district board of directors with any suggested changes plan, including 29 or additions to the suggestions for further 30 innovations or measures to increase the likelihood that the 31 innovations will result in greater academic achievement within the 32 innovation schools or innovation school zones. Based on the comments 33 of the state board of education and the superintendent of public

- 1 instruction, a school district board of directors may withdraw and 2 resubmit the innovation school plan or innovation school zone plan.
- 3 (2) Within ten days of providing comment on an innovation school 4 plan or innovation school zone plan under subsection (1) of this 5 section, unless the school district board of directors withdraws the 6 plan for purposes of revision, the state board of education shall 7 designate the school district as an innovation school district unless 8 the state board concludes that the plan:
- 9 (a) Is likely to result in a decrease in academic achievement in 10 the innovation school or innovation school zone;
- 11 (b) Is not financially feasible to implement; or
- 12 (c) Would violate state or federal laws or rules that are not 13 authorized to be waived under section 407 or 408 of this act.
- 14 (3) If the state board of education does not designate a school 15 district as an innovation school district, the board shall provide a 16 written explanation of the basis for the rejection to the school 17 district board of directors. The school district board of directors 18 may resubmit a revised innovation school plan or innovation school 20 zone plan and seek designation as an innovation school district at any 20 time after the designation is rejected.

NEW SECTION. Sec. 407. The superintendent of public instruction and the state board of education, within the scope of their statutory authority, shall waive the application of rules, policies, and procedures for an innovation school district designated under section 406 of this act to the extent the waiver of the rules, policies, and procedures are included in an approved innovation school plan or innovation school zone plan. The superintendent of public instruction and the state board of education shall not waive rules, policies, and procedures that jeopardize the receipt of state or federal funds that the innovation school district would otherwise be eligible to receive unless the innovation school district submits a written authorization for the waiver acknowledging that receipt of these funds could be jeopardized. A waiver of rules, policies, and procedures under this

- 2 school zones in the designated innovation school district and only as
- 3 specified in the approved plan.

If any part of this act is found to be in conflict with federal requirements that are a prescribed condition to the allocation of federal funds to the state, the conflicting part of this act is inoperative solely to the extent of the conflict and with respect to the agencies directly affected, and this finding does not affect the operation of the remainder of this act in its application to the agencies concerned. Rules adopted under this act must meet federal requirements that are a necessary condition to the receipt of federal funds by the state.

NEW SECTION. Sec. 1106. If any provision of this act or its application to any person or circumstance is held invalid, the remainder of the act or the application of the provision to other 17 persons or circumstances is not affected.

- EFFECT: Establishes a process for a local school board to create Innovation Schools or groups of schools called an Innovation School Zone. Encourages Required Action districts to implement Innovation Schools in their persistently lowest-performing schools, as long as the Innovation School Plan meets the requirements of a federal innovation model for receipt of federal school improvement funds.
- Outlines various elements of an Innovation School or School Zone plan, which include a list of any state laws or rules that the school wants to have waived in order to implement the plan.
- Once a plan is approved by the school board, authorizes the board to request designation by the State Board of Education as an Innovation School District.

- If the SBE approves the designation, requires the SPI and the SBE, within their statutory authority, to waive any rules or procedures that are included in an approved plan.
- Requires the SPI to waive any of a series of specified laws that are included in an approved plan, as long as the waivers only apply to the schools in the plan, and only to the extent the waiver is a part of the plan.
- Allows most of the key laws in the school code to be waived, including teacher evaluation and hiring laws, salaries, requirements to hire only certified staff, minimum hours of instruction and length of the school year, and others.
- Prohibits waiver of a number of laws: those pertaining to civil rights, health and safety; statewide assessments and accountability; allocations of state funding; school district budgeting and accounting; legal and financial audits; laws pertaining to school construction and bonds.

Provides that future collective bargaining agreements must contain a provision allowing the employees of an Innovation School or an Innovation School Zone to opt out of the collective bargaining agreement by a majority vote.
