- 6 **Sec. 2.** RCW 82.12.865 and 2007 c 443 s 2 are each amended to read 7 as follows:
 - (1) The provisions of this chapter do not apply with respect to the nonhighway use of diesel fuel, biodiesel fuel, ((or)) aircraft fuel, or propane fuel by a farm fuel user. This exemption applies to a fuel blend if all of the component fuels of the blend would otherwise be exempt under this subsection if the component fuels were acquired as separate products. Fuel used for space or water heating for human habitation is not exempt under this section.
- 15 (2) The definitions in RCW 82.08.865 apply to this section.
- 16 NEW SECTION. Sec. 3. This act takes effect August 1, 2009.
- 17 <u>NEW SECTION.</u> **Sec. 4.** This act expires July 1, 2019.
