17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

18 NEW SECTION. **Sec. 1.** It is the intent of the legislature to
19 reduce and consolidate the number of state boards that conduct

1 administrative review of environmental and land use decisions and to
2 make more uniform the timelines for filing appeals with such boards.
3 The legislature intends to eliminate the hydraulics appeals board and
4 the forest practices appeals board by transferring their duties to the
5 pollution control hearings board. The legislature further intends to
6 eliminate certain preliminary informal appeals heard internally by
7 agencies. The legislature also intends to consolidate administratively
8 and physically collocate the growth management hearings boards into the
9 environmental and land use hearings office by July 1, 2011.

10 **Sec. 2.** RCW 43.21B.001 and 2004 c 204 s 1 are each amended to read
11 as follows:

12 The definitions in this section apply throughout this chapter
13 unless the context clearly requires otherwise.

14 (1) "Business days" means Monday through Friday exclusive of any
15 state or federal holiday.

16 (2) "Date of receipt" means:

17 (a) Five business days after the date of mailing; or

18 (b) The date of actual receipt, when the actual receipt date can be
19 proven by a preponderance of the evidence. The recipient's sworn
20 affidavit or declaration indicating the date of receipt, which is
21 unchallenged by the agency, shall constitute sufficient evidence of
22 actual receipt. The date of actual receipt, however, may not exceed
23 forty-five days from the date of mailing.

24 (3) "Department" means the department of ecology.

25 (4) "Director" means the director of ecology.

26 (5) "Environmental boards" means the pollution control hearings
27 board created in RCW 43.21B.010 and the shorelines hearings board
28 created in RCW 90.58.170.

29 (6) "Land use board" means the growth management hearings board
30 created in RCW 36.70A.250.

31 **Sec. 3.** RCW 43.21B.005 and 2003 c 393 s 18 and 2003 c 39 s 22 are
32 each reenacted and amended to read as follows:

33 (1) There is created an environmental hearings office of the state
34 of Washington. The environmental hearings office (~~shall~~) consists
35 of the pollution control hearings board created in RCW 43.21B.010, (~~the~~
36 ~~forest practices appeals board created in RCW 76.09.210,~~) the

1 shorelines hearings board created in RCW 90.58.170, and the
2 environmental and land use hearings board created in chapter 43.21L
3 RCW(~~(, and the hydraulic appeals board created in RCW 77.55.170)~~). The
4 chair of the pollution control hearings board shall be the chief
5 executive officer of the environmental hearings office. Membership,
6 powers, functions, and duties of the pollution control hearings

18 Administrative appeals judges shall not be subject to chapter 41.06
19 RCW.

20 (3) The administrative appeals judges appointed under subsection
21 (2) of this section are subject to discipline and termination, for
22 cause, by the chief executive officer. Upon written request by the
23 person so disciplined or terminated, the chief executive officer shall
24 state the reasons for such action in writing. The person affected has
25 a right of review by the superior court of Thurston county on petition
26 for reinstatement or other remedy filed within thirty days of receipt
27 of such written reasons.

28 (4) The chief executive officer may appoint, discharge, and fix the
29 compensation of such administrative or clerical staff as may be
30 necessary.

31 (5) The chief executive officer may also contract for required
32 services.

28 to read as follows:

29 In all appeals, upon request of one or more parties and with the
30 consent of all parties, the environmental hearings boards may schedule
31 a conference for the purpose of attempting to mediate the case.
32 Mediation must be conducted by an administrative appeals judge or other
33 duly authorized agent of the board who has received training in dispute
34 resolution techniques or has a demonstrated history of successfully
35 resolving disputes, as determined by the board. A person who mediates
36 in a particular appeal may not participate in a hearing on that appeal
37 and may not write the decision and order in the appeal. The mediator

1 may not communicate with board members regarding the mediation other
2 than to inform them of the pendency of the mediation and whether the
3 case settled. Mediation provided by the environmental hearings boards
4 must be conducted pursuant to the provisions of the uniform mediation
5 act, chapter 7.07 RCW.

12 (1) Any civil penalty provided in RCW 18.104.155, 70.94.431,
13 70.95.315, 70.105.080, 70.107.050, 88.46.090, 90.03.600, 90.46.270,
14 90.48.144, 90.56.310, and 90.56.330 and chapter 90.76 RCW shall be
15 imposed by a notice in writing, either by certified mail with return
16 receipt requested or by personal service, to the person incurring the
17 penalty from the department or the local air authority, describing the
18 violation with reasonable particularity. For penalties issued by local
19 air authorities, within thirty days after the notice is received, the
20 person incurring the penalty may apply in writing to ((the department
21 or)) the authority for the remission or mitigation of the penalty.
22 Upon receipt of the application, the ((department or)) authority may
23 remit or mitigate the penalty upon whatever terms ((the department or))
24 the authority in its discretion deems proper. The ((department or
25 the)) authority may ascertain the facts regarding all such applications
26 in such reasonable manner and under such rules as it may deem proper
27 and shall remit or mitigate the penalty only upon a demonstration of
28 extraordinary circumstances such as the presence of information or
29 factors not considered in setting the original penalty.

30 (2) Any penalty imposed under this section may be appealed to the
31 pollution control hearings board in accordance with this chapter if the
32 appeal is filed with the hearings board and served on the department or
33 authority thirty days after the date of receipt by the person penalized
34 of the notice imposing the penalty or thirty days after the date of
35 receipt of the notice of disposition by a local air authority of the
36 application for relief from penalty.

37 (3) A penalty shall become due and payable on the later of:

1 (a) Thirty days after receipt of the notice imposing the penalty;

2 (b) Thirty days after receipt of the notice of disposition by a
3 local air authority on application for relief from penalty, if such an
4 application is made; or

5 (c) Thirty days after receipt of the notice of decision of the
6 hearings board if the penalty is appealed.

7 (4) If the amount of any penalty is not paid to the department
8 within thirty days after it becomes due and payable, the attorney
9 general, upon request of the department, shall bring an action in the
10 name of the state of Washington in the superior court of Thurston
11 county, or of any county in which the violator does business, to
12 recover the penalty. If the amount of the penalty is not paid to the
13 authority within thirty days after it becomes due and payable, the
14 authority may bring an action to recover the penalty in the superior
15 court of the county of the authority's main office or of any county in
16 which the violator does business. In these actions, the procedures and
17 rules of evidence shall be the same as in an ordinary civil action.

18 (5) All penalties recovered shall be paid into the state treasury
19 and credited to the general fund except those penalties imposed
20 pursuant to RCW 18.104.155, which shall be credited to the reclamation
21 account as provided in RCW 18.104.155(7), RCW 70.94.431, the
22 disposition of which shall be governed by that provision, RCW
23 70.105.080, which shall be credited to the hazardous waste control and
24 elimination account created by RCW 70.105.180, RCW 90.56.330, which
25 shall be credited to the coastal protection fund created by RCW

18 Class IV: Forest practices other than those contained in Class I
19 or II: (a) On lands platted after January 1, 1960, as provided in
20 chapter 58.17 RCW, (b) on lands that have or are being converted to
21 another use, (c) on lands which, pursuant to RCW 76.09.070 as now or
22 hereafter amended, are not to be reforested because of the likelihood
23 of future conversion to urban development, (d) involving timber
24 harvesting or road construction on lands that are contained within
25 "urban growth areas," designated pursuant to chapter 36.70A RCW, except
26 where the forest landowner provides: (i) A written statement of intent
27 signed by the forest landowner not to convert to a use other than
28 commercial forest product operations for ten years, accompanied by
29 either a written forest management plan acceptable to the department or
30 documentation that the land is enrolled under the provisions of chapter
31 84.33 RCW; or (ii) a conversion option harvest plan approved by the
32 local governmental entity and submitted to the department as part of
33 the application, and/or (e) which have a potential for a substantial
34 impact on the environment and therefore require an evaluation by the
35 department as to whether or not a detailed statement must be prepared
36 pursuant to the state environmental policy act, chapter 43.21C RCW.
37 Such evaluation shall be made within ten days from the date the
38 department receives the application: PROVIDED, That nothing herein

1 shall be construed to prevent any local or regional governmental entity
2 from determining that a detailed statement must be prepared for an
3 action pursuant to a Class IV forest practice taken by that
4 governmental entity concerning the land on which forest practices will
5 be conducted. A Class IV application must be approved or disapproved
6 by the department within thirty calendar days from the date the
7 department receives the application, unless the department determines
8 that a detailed statement must be made, in which case the application
9 must be approved or disapproved by the department within sixty calendar
10 days from the date the department receives the application, unless the
11 commissioner of public lands, through the promulgation of a formal
12 order, determines that the process cannot be completed within such
13 period. However, the applicant may not begin work on that forest
14 practice until all forest practice fees required under RCW 76.09.065
15 have been received by the department.

16 Forest practices under Classes I, II, and III are exempt from the
17 requirements for preparation of a detailed statement under the state
18 environmental policy act.

19 (2) Except for those forest practices being regulated by local
20 governmental entities as provided elsewhere in this chapter, no Class
21 II, Class III, or Class IV forest practice shall be commenced or
22 continued after January 1, 1975, unless the department has received a
23 notification with regard to a Class II forest practice or approved an
24 application with regard to a Class III or Class IV forest practice
25 containing all information required by RCW 76.09.060 as now or
26 hereafter amended. However, in the event forest practices regulations
27 necessary for the scheduled implementation of this chapter and RCW
28 90.48.420 have not been adopted in time to meet such schedules, the
29 department shall have the authority to regulate forest practices and
30 approve applications on such terms and conditions consistent with this
31 chapter and RCW 90.48.420 and the purposes and policies of RCW
32 76.09.010 until applicable forest practices regulations are in effect.

33 (3) Except for those forest practices being regulated by local
34 governmental entities as provided elsewhere in this chapter, if a
35 notification or application is delivered in person to the department by
36 the operator or the operator's agent, the department shall immediately
37 provide a dated receipt thereof. In all other cases, the department
38 shall immediately mail a dated receipt to the operator.

1 (4) Except for those forest practices being regulated by local
2 governmental entities as provided elsewhere in this chapter, forest
3 practices shall be conducted in accordance with the forest practices
4 regulations, orders and directives as authorized by this chapter or the
5 forest practices regulations, and the terms and conditions of any
6 approved applications.

7 (5) Except for those forest practices being regulated by local
8 governmental entities as provided elsewhere in this chapter, the
9 department of natural resources shall notify the applicant in writing
10 of either its approval of the application or its disapproval of the
11 application and the specific manner in which the application fails to
12 comply with the provisions of this section or with the forest practices
13 regulations. Except as provided otherwise in this section, if the
14 department fails to either approve or disapprove an application or any
15 portion thereof within the applicable time limit, the application shall
16 be deemed approved and the operation may be commenced: PROVIDED, That
17 this provision shall not apply to applications which are neither
18 approved nor disapproved pursuant to the provisions of subsection (7)
19 of this section: PROVIDED, FURTHER, That if seasonal field conditions
20 prevent the department from being able to properly evaluate the
21 application, the department may issue an approval conditional upon
22 further review within sixty days: PROVIDED, FURTHER, That the
23 department shall have until April 1, 1975, to approve or disapprove an
24 application involving forest practices allowed to continue to April 1,
25 1975, under the provisions of subsection (2) of this section. Upon
26 receipt of any notification or any satisfactorily completed application
27 the department shall in any event no later than two business days after
28 such receipt transmit a copy to the departments of ecology and fish and
29 wildlife, and to the county, city, or town in whose jurisdiction the
30 forest practice is to be commenced. Any comments by such agencies
31 shall be directed to the department of natural resources.

32 (6) For those forest practices regulated by the board and the
33 department, if the county, city, or town believes that an application
34 is inconsistent with this chapter, the forest practices regulations, or
35 any local authority consistent with RCW 76.09.240 as now or hereafter
36 amended, it may so notify the department and the applicant, specifying
37 its objections.

1 (7) For those forest practices regulated by the board and the
2 department, the department shall not approve portions of applications
3 to which a county, city, or town objects if:

4 (a) The department receives written notice from the county, city,
5 or town of such objections within fourteen business days from the time
6 of transmittal of the application to the county, city, or town, or one
7 day before the department acts on the application, whichever is later;
8 and

9 (b) The objections relate to lands either:

10 (i) Platted after January 1, 1960, as provided in chapter 58.17
11 RCW; or

12 (ii) On lands that have or are being converted to another use.

13 The department shall either disapprove those portions of such
14 application or appeal the county, city, or town objections to the
15 appeals board. If the objections related to subparagraphs (b)(i) and
16 (ii) of this subsection are based on local authority consistent with
17 RCW 76.09.240 as now or hereafter amended, the department shall
18 disapprove the application until such time as the county, city, or town
19 consents to its approval or such disapproval is reversed on appeal.
20 The applicant shall be a party to all department appeals of county,
21 city, or town objections. Unless the county, city, or town either
22 consents or has waived its rights under this subsection, the department
23 shall not approve portions of an application affecting such lands until
24 the minimum time for county, city, or town objections has expired.

25 (8) For those forest practices regulated by the board and the
26 department, in addition to any rights under the above paragraph, the
27 county, city, or town may appeal any department approval of an
28 application with respect to any lands within its jurisdiction. The
29 appeals board may suspend the department's approval in whole or in part
30 pending such appeal where there exists potential for immediate and
31 material damage to a public resource.

32 (9) For those forest practices regulated by the board and the
33 department, appeals under this section shall be made to the appeals
34 board in the manner and time provided in (~~RCW 76.09.220(8)~~) section
35 24 of this act. In such appeals there shall be no presumption of
36 correctness of either the county, city, or town or the department
37 position.

1 (10) For those forest practices regulated by the board and the
2 department, the department shall, within four business days notify the
3 county, city, or town of all notifications, approvals, and disapprovals
4 of an application affecting lands within the county, city, or town,
5 except to the extent the county, city, or town has waived its right to
6 such notice.

7 (11) For those forest practices regulated by the board and the
8 department, a county, city, or town may waive in whole or in part its
9 rights under this section, and may withdraw or modify any such waiver,
10 at any time by written notice to the department.

11 (12) Notwithstanding subsections (2) through (5) of this section,
12 forest practices applications or notifications are not required for
13 exotic insect and disease control operations conducted in accordance
14 with RCW 76.09.060(8) where eradication can reasonably be expected.

15 **Sec. 21.** RCW 76.09.080 and 1989 c 175 s 163 are each amended to
16 read as follows:

17 (1) The department shall have the authority to serve upon an
18 operator a stop work order which shall be a final order of the
19 department if:

20 (a) There is any violation of the provisions of this chapter or the
21 forest practices regulations; or

22 (b) There is a deviation from the approved application; or

23 (c) Immediate action is necessary to prevent continuation of or to
24 avoid material damage to a public resource.

25 (2) The stop work order shall set forth:

26 (a) The specific nature, extent, and time of the violation,

28 (b) An order to stop all work connected with the violation,
29 deviation, damage, or potential damage;

30 (c) The specific course of action needed to correct such violation
31 or deviation or to prevent damage and to correct and/or compensate for

35 (1) Every person who violates any provision of RCW 76.09.010
36 through 76.09.280 or of the forest practices rules, or who converts

2 of the county, city, or town, shall be subject to a penalty in an
3 amount of not more than ten thousand dollars for every such violation.

29 except where they exist in a natural watercourse that has been altered

33 (3) "Commission" means the state fish and wildlife commission.

34 (4) "Department" means the department of fish and wildlife.

35 (5) "Director" means the director of the department of fish and

1 (6) "Emergency" means an immediate threat to life, the public,
2 property, or of environmental degradation.

3 (7) "Hydraulic project" means the construction or performance of
4 work that will use, divert, obstruct, or change the natural flow or bed
5 of any of the salt or freshwaters of the state.

6 (8) "Imminent danger" means a threat by weather, water flow, or
7 other natural conditions that is likely to occur within sixty days of
8 a request for a permit application.

9 (9) "Marina" means a public or private facility providing boat
10 moorage space, fuel, or commercial services. Commercial services
11 include but are not limited to overnight or live-aboard boating
12 accommodations.

13 (10) "Marine terminal" means a public or private commercial wharf
14 located in the navigable water of the state and used, or intended to be
15 used, as a port or facility for the storing, handling, transferring, or
16 transporting of goods to and from vessels.

17 (11) "Ordinary high water line" means the mark on the shores of all
18 water that will be found by examining the bed and banks and
19 ascertaining where the presence and action of waters are so common and
20 usual, and so long continued in ordinary years as to mark upon the soil
21 or vegetation a character distinct from the abutting upland. Provided,
22 that in any area where the ordinary high water line cannot be found,
23 the ordinary high water line adjoining saltwater is the line of mean
24 higher high water and the ordinary high water line adjoining fresh
25 water is the elevation of the mean annual flood.

26 (12) "Permit" means a hydraulic project approval permit issued
27 under this chapter.

28 (13) "Sandbars" includes, but is not limited to, sand, gravel,
29 rock, silt, and sediments.

30 (14) "Small scale prospecting and mining" means the use of only the
31 following methods: Pans; nonmotorized sluice boxes; concentrators; and
32 minirocker boxes for the discovery and recovery of minerals.

33 (15) "Spartina," "purple loosestrife," and "aquatic noxious weeds"
34 have the same meanings as defined in RCW 17.26.020.

35 (16) "Streambank stabilization" means those projects that prevent
36 or limit erosion, slippage, and mass wasting. These projects include,
37 but are not limited to, bank resloping, log and debris relocation or

1 removal, planting of woody vegetation, bank protection using rock or
2 woody material or placement of jetties or groins, gravel removal, or
3 erosion control.

4 (17) "Tide gate" means a one-way check valve that prevents the
5 backflow of tidal water.

6 (18) "Waters of the state" and "state waters" means all salt and
7 fresh waters waterward of the ordinary high water line and within the
8 territorial boundary of the state.

9 (19) "Date of receipt" has the same meaning as defined in RCW
10 43.21B.001.

11 **Sec. 27.** RCW 77.55.021 and 2008 c 272 s 1 are each amended to read
12 as follows:

13 (1) Except as provided in RCW 77.55.031, 77.55.051, and 77.55.041,
14 in the event that any person or government agency desires to undertake
15 a hydraulic project, the person or government agency shall, before
16 commencing work thereon, secure the approval of the department in the
17 form of a permit as to the adequacy of the means proposed for the
18 protection of fish life.

19 (2) A complete written application for a permit may be submitted in
20 person or by registered mail and must contain the following:

21 (a) General plans for the overall project;

22 (b) Complete plans and specifications of the proposed construction
23 or work within the mean higher high water line in saltwater or within
24 the ordinary high water line in freshwater;

25 (c) Complete plans and specifications for the proper protection of

27 (d) Notice of compliance with any applicable requirements of the

35 receipt of a complete application to grant or deny approval of a
36 permit. The forty-five day requirement is suspended if:

4 (ii) The site is physically inaccessible for inspection;

5 (iii) The applicant requests a delay; or

6 (iv) The department is issuing a permit for a storm water discharge
7 and is complying with the requirements of RCW 77.55.161(3)(b).

8 (b) Immediately upon determination that the forty-five day period
9 is suspended, the department shall notify the applicant in writing of
10 the reasons for the delay.

11 (c) The period of forty-five calendar days may be extended if the
12 permit is part of a multiagency permit streamlining effort and all
13 participating permitting agencies and the permit applicant agree to an
14 extended timeline longer than forty-five calendar days.

15 (4) If the department denies approval of a permit, the department
16 shall provide the applicant a written statement of the specific reasons
17 why and how the proposed project would adversely affect fish life.

18 (a) Except as provided in (b) of this subsection, issuance, denial,
19 conditioning, or modification of a permit shall be appealable to ((the

14 public of all applications for permits governed by any permit system
15 established pursuant to subsection (3) of this section by ensuring that

20 three hundred feet of the boundary of the property upon which the
