## SENATE BILL 6288

State of Washington 61st Legislature 2010 Regular Session

By Senators Pridemore, Fairley, Kohl-Welles, and Kline

Read first time 01/11/10. Referred to Committee on Government Operations & Elections.

AN ACT Relating to the authority of counties, cities, and towns to request criminal background checks from the Washington state patrol; adding a new section to chapter 36.01 RCW; adding a new section to chapter 35.21 RCW; and adding a new section to chapter 35A.21 RCW.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 36.01 RCW 7 to read as follows:

Counties may, by ordinance, require a state and federal background 8 9 investigation of license applicants or licensees in occupations specified by ordinance for the purpose of receiving criminal history 10 11 record information by county officials. The investigation shall consist of a background check as allowed through the Washington state 12 criminal records privacy act under RCW 10.97.050, the Washington state 13 14 patrol criminal identification system under RCW 43.43.832 through 15 43.43.834, and the federal bureau of investigation. These background 16 checks must be done through the Washington state patrol identification and criminal history section and may include a national check from the 17 18 federal bureau of investigation, which shall be through the submission 19 of fingerprints. The Washington state patrol shall serve as the sole

1 source for receipt of fingerprint submissions and the responses to the 2 submissions from the federal bureau of investigation, which must be 3 disseminated to the county. The county shall transmit appropriate fees 4 for a state and national criminal history check to the Washington state 5 patrol, unless alternately arranged.

6 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 35.21 RCW 7 to read as follows:

Cities or towns may, by ordinance, require a state and federal 8 9 background investigation of license applicants or licensees in 10 occupations specified by ordinance for the purpose of receiving 11 criminal history record information by city or town officials. The 12 investigation shall consist of a background check as allowed through the Washington state criminal records privacy act under RCW 10.97.050, 13 the Washington state patrol criminal identification system under RCW 14 43.43.832 through 43.43.834, and the federal bureau of investigation. 15 16 These background checks must be done through the Washington state patrol identification and criminal history section and may include a 17 18 national check from the federal bureau of investigation, which shall be through the submission of fingerprints. The Washington state patrol 19 20 shall serve as the sole source for receipt of fingerprint submissions 21 and the responses to the submissions from the federal bureau of 22 investigation, which must be disseminated to the city or town. The 23 city or town shall transmit appropriate fees for a state and national 24 criminal history check to the Washington state patrol, unless 25 alternately arranged.

26 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 35A.21 RCW 27 to read as follows:

28 Code cities may, by ordinance, require a state and federal 29 background investigation of license applicants or licensees in 30 occupations specified by ordinance for the purpose of receiving criminal history record information by code city officials. 31 The investigation shall consist of a background check as allowed through 32 33 the Washington state criminal records privacy act under RCW 10.97.050, 34 the Washington state patrol criminal identification system under RCW 35 43.43.832 through 43.43.834, and the federal bureau of investigation. 36 These background checks must be done through the Washington state

patrol identification and criminal history section and may include a 1 2 national check from the federal bureau of investigation, which shall be through the submission of fingerprints. The Washington state patrol 3 shall serve as the sole source for receipt of fingerprint submissions 4 5 and the responses to the submissions from the federal bureau of 6 investigation, which must be disseminated to the code city. The code city shall transmit appropriate fees for a state and national criminal 7 history check to the Washington state patrol, unless alternately 8 9 arranged.
