1            AN ACT Relating to persons selling, soliciting, or negotiating  
2 insurance; amending RCW 48.03.020, 48.14.010, 48.15.070, 48.15.073,  
3 48.15.100, 48.15.140, 48.17.010, 48.17.060, 48.17.090, 48.17.110,  
4 48.17.150, 48.17.160, 48.17.170, 48.17.173, 48.17.250, 48.17.270,

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

11            **Sec. 1.** RCW 48.03.020 and 2008 c 217 s 1 are each amended to read  
12 as follows:

13            For the purpose of ascertaining its condition, or compliance with  
14 this code, the commissioner may as often as he or she deems advisable  
15 examine the accounts, records, documents, and transactions of:

16            (1) Any insurance producer, surplus line broker, adjuster, or title  
17 insurance agent.

18            (2) Any person having a contract under which he or she enjoys in

1 fact the exclusive or dominant right to manage or control a stock or  
2 mutual insurer.

3 (3) Any person holding the shares of capital stock or policyholder  
4 proxies of a domestic insurer for the purpose of control of its  
5 management either as voting trustee or otherwise.

6 (4) Any person engaged in or proposing to be engaged in or  
7 assisting in the promotion or formation of a domestic insurer, or an  
8 insurance holding corporation, or a stock corporation to finance a  
9 domestic mutual insurer or the production of its business, or a  
10 corporation to be attorney-in-fact for a domestic reciprocal insurer.

11 **Sec. 2.** RCW 48.14.010 and 2007 c 117 s 37 are each amended to read  
12 as follows:

22 as follows:

23 Any individual while a resident of this state, or any firm or any  
24 corporation that has in its employ a qualified individual who is a  
25 resident of this state and who is authorized to exercise the powers of  
26 the firm or corporation, deemed by the commissioner to be competent and  
27 trustworthy, and while maintaining an office at a designated location  
28 in this state, may be licensed as a surplus line broker in accordance  
29 with this section.

30 (1) Application to the commissioner for the license shall be made  
31 on forms furnished by the commissioner. As part of, or in connection  
32 with, this application, the applicant shall furnish information  
33 concerning his or her identity, including fingerprints for submission  
34 to the Washington state patrol, the federal bureau of investigation,  
35 and any governmental agency or entity authorized to receive this  
36 information for a state and national criminal history background check;  
37 personal history; experience; business records; purposes; and other

1 pertinent information, as the commissioner may reasonably require. If  
2 in the process of verifying fingerprints, business records, or other  
3 information, the commissioner's office incurs fees or charges from

27 Every surplus line broker licensed under this chapter must maintain in  
28 force while so licensed a bond in favor of the people of the state of  
29 Washington or a named insured such that the people of the state are  
30 covered by the bond, executed by an authorized corporate surety  
31 approved by the commissioner, in the amount of two thousand five  
32 hundred dollars, or five percent of the premiums from placement of  
33 coverage with surplus line insurers in the previous calendar year,  
34 whichever is greater, but not to exceed one hundred thousand dollars  
35 total aggregate liability. The bond may be continuous in form, and  
36 total aggregate liability on the bond may be limited to the required  
37 amount ~~((stated in))~~ of the bond. The bond shall be contingent on the  
38 accounting by the surplus line broker to any person requesting ~~((such))~~

1 the broker to obtain insurance, for moneys or premiums collected in  
2 connection therewith. A bond issued in accordance with RCW 48.17.250  
3 or with this subsection will satisfy the requirements of both RCW  
4 48.17.250 and this subsection if the limit of liability is not less  
5 than the greater of the requirement of RCW 48.17.250 or the requirement  
6 of this subsection.

7 ~~((5) Any bond issued pursuant to subsection (3) or (4) of this~~  
8 ~~section shall remain in force until the surety is released from~~  
9 ~~liability by the commissioner, or until the bond is canceled by the~~  
10 ~~surety. Without prejudice to any liability accrued prior to such~~  
11 ~~cancellation, the surety may cancel the bond upon thirty days' advance~~  
12 ~~notice in writing filed with the commissioner.~~

23 with a bond in the name of an association. The association must have  
24 been in existence for five years, have common membership, and have been  
25 formed for a purpose other than obtaining a bond. An individual  
26 surplus line broker remains responsible for assuring that a bond is in  
27 effect and is for the correct amount.

28 (6) Members of an association may meet the requirements of  
29 subsection (3) of this section with a bond in the name of the  
30 association that is continuous in form and in the amounts set forth in  
31 subsection (3) of this section for each participating member.

32 (7) The surety may cancel the bond and be released from further  
33 liability thereunder upon thirty days' written notice in advance to the  
34 principal. The cancellation does not affect any liability incurred or  
35 accrued under the bond before the termination of the thirty-day period.

36 (8) Failure to have and maintain the bonds required under  
37 subsections (2) and (3) of this section is grounds for revocation of a  
38 license under RCW 48.15.140.

1       (9) If a party injured under the terms of the bond required under  
2 subsection (3) of this section requests the surplus line broker to  
3 provide the name of the surety and the bond number, the surplus line  
4 broker must provide the information within three working days after  
5 receiving the request.

6       (10) All records relating to the bonds required by this section  
7 must be kept available and open to the inspection of the commissioner  
8 at any business time.

9       (11) A surplus line broker's license expires if not timely renewed.  
10 Surplus line broker licenses are valid for the time period established  
11 by the commissioner unless suspended or revoked at an earlier date.

12       (12) Subject to the right of the commissioner to suspend, revoke,  
13 or refuse to renew any surplus line broker's license as provided in  
14 this title, the license may be renewed into another like period by  
15 filing with the commissioner by any means acceptable to the  
16 commissioner on or before the expiration date a request, by or on  
17 behalf of the licensee, for the renewal accompanied by payment of the  
18 renewal fee as specified in RCW 48.14.010.

19       (13) If the request and fee for renewal of a surplus line broker's  
20 license are filed with the commissioner prior to expiration of the  
21 existing license, the licensee may continue to act under the license,  
22 unless sooner revoked or suspended, until the issuance of a renewal  
23 license, or until the expiration of fifteen days after the commissioner  
24 has refused to renew the license and has mailed notification of the  
25 refusal to the licensee. If the request and fee for the license are  
26 not received by the expiration date, the authority conferred by the  
27 license ends on the expiration date.

28       (14) If the request for renewal of a surplus line broker's license  
29 and payment of the fee are not received by the commissioner prior to  
30 the expiration date, the applicant for renewal shall pay to the  
31 commissioner in addition to the renewal fee, a surcharge as follows:

32       (a) For the first thirty days or part thereof of delinquency, the  
33 surcharge is fifty percent of the renewal fee; and

34       (b) For the next thirty days or part thereof of delinquency, the  
35 surcharge is one hundred percent of the renewal fee.

36       (15) If the request for renewal of a surplus line broker's license  
37 and payment of the renewal fee are not received by the commissioner  
38 after sixty days but prior to twelve months after the expiration date,



1 the application shall be for reinstatement of the license and the  
2 applicant for reinstatement shall pay to the commissioner the license  
3 fee and a surcharge of two hundred percent of the license fee.

4 (16) Subsections (14) and (15) of this section do not exempt any  
5 person from any penalty provided by law for transacting business  
6 without a valid and subsisting license.

7 (17) An individual surplus line broker who allows his or her  
8 license to lapse may, within twelve months after the expiration date,  
9 reinstate the same license without the necessity of passing a written  
10 examination.

11 (18) For the purposes of this section, a "qualified individual" is  
12 a natural person who has met all the requirements that must be met by  
13 an individual surplus line broker.

14 (19) The commissioner may require any documents reasonably  
15 necessary to verify the information contained in an application and  
16 may, from time to time, require any licensed surplus line broker to  
17 produce the information called for in an application for license.

18 **Sec. 4.** RCW 48.15.073 and 2001 c 91 s 1 are each amended to read  
19 as follows:

20 (1) The commissioner may license as a surplus line broker a person  
21 who is otherwise qualified under this code but who is not a resident of  
22 this state, if by the laws of the state or province of his or her  
23 residence or domicile a similar privilege is extended to residents of  
24 this state.

25 (2) A person under subsection (1) of this section must meet the  
26 same qualifications, other than residency, as any other person seeking  
27 to be licensed as a surplus line broker under this chapter. A person  
28 granted a nonresident surplus line broker's license must have all the  
29 same responsibilities as any other surplus line broker and is subject  
30 to the (a) commissioner's supervision as though resident in this state  
31 and (b) rules adopted under this chapter.

32 (3) A nonresident surplus line broker's license: (a) Expires and  
33 (b) is subject to the same renewal and fee requirements for renewal as  
34 a resident surplus line broker licensed under RCW 48.15.070.

35 (4) Each licensed nonresident surplus line broker shall appoint the  
36 commissioner as the surplus line broker's attorney to receive service  
37 of legal process issued against the surplus line broker in this state

1 upon causes of action arising within this state. Service upon the  
2 commissioner as attorney constitutes effective legal service upon the  
3 surplus line broker.

4 (a) The appointment is irrevocable for as long as there could be  
5 any cause of action against the surplus line broker arising out of the  
6 surplus line broker's insurance transactions in this state.

7 (b) Duplicate copies of legal process against a surplus line broker  
8 shall be served upon the commissioner either by a person competent to  
9 serve a summons, or through registered mail. At the time of service  
10 the plaintiff shall pay to the commissioner ten dollars, taxable as  
11 costs in the action.

12 (c) Upon receiving service, the commissioner shall immediately send  
13 one of the copies of the process, by registered mail with return  
14 receipt requested, to the defendant surplus line broker at the surplus  
15 line broker's last address of record with the commissioner.

16 (d) The commissioner shall keep a record of the day and hour of  
17 service upon the commissioner of all legal process. Proceedings may  
18 not be had against the defendant surplus line broker and the defendant  
19 is not required to appear, plead, or answer until the expiration of  
20 forty days after the date of service upon the commissioner.

21 **Sec. 5.** RCW 48.15.100 and 1955 c 303 s 6 are each amended to read  
22 as follows:

23 (1) Each licensed surplus line broker shall keep a full and true  
24 record of each surplus line contract procured by him or her including  
25 a copy of the daily report, if any, showing such of the following items  
26 as may be applicable:

27 (a) Amount of the insurance;

28 (b) Gross premiums charged;

29 (c) Return premium paid, if any;

30 (d) Rate of premium charged upon the several items of property;

31 (e) Effective date of the contract, and the terms thereof;

32 (f) Name and address of the insurer;

33 (g) Name and address of the insured;

34 (h) Brief general description of property insured and where  
35 located;

36 (i) Other information as may be required by the commissioner.

1 (2) All such records as to any particular transaction shall be kept  
2 available and open to the inspection of the commissioner at any  
3 business time during the five years next following the date of  
4 completion of such transaction.

5 (3) For the purpose of ascertaining its condition, or compliance  
6 with this title, the commissioner may as often as he or she deems  
7 advisable, examine the accounts, records, documents, and transactions  
8 of any surplus line broker as set forth in chapter 48.03 RCW.

9 NEW SECTION. Sec. 6. A new section is added to chapter 48.15 RCW  
10 to read as follows:

11 (1) A surplus line broker doing business under any name other than  
12 the surplus line broker's legal name is required to register the name  
13 in accordance with chapter 19.80 RCW and notify the commissioner before  
14 using the assumed name.

15 (2) Every licensed surplus line broker shall have and maintain in  
16 this state, or, if a nonresident surplus line broker, in this state or  
17 in the state of the licensee's domicile, a place of business accessible  
18 to the public. The place of business is where the surplus line broker  
19 principally conducts transactions under that person's license. A  
20 licensee maintaining more than one place of business in this state  
21 shall obtain a duplicate license or licenses for each additional place,  
22 and shall pay the full fee therefor.

23 (3) Any notice, order, or written communication from the  
24 commissioner to a person licensed under this chapter which directly  
25 affects the person's license shall be sent by mail to the person's last  
26 address of record with the commissioner.

27 (4) The license or licenses of each surplus line broker shall be  
28 displayed in a conspicuous place in that part of the place of business  
29 which is customarily open to the public.

30 (5) If a surplus line broker is dealing directly with the insured  
31 in any capacity, the surplus line broker must comply with the  
32 disclosure requirements contained in RCW 48.17.270.

33 (6) Every surplus line broker or other person licensed under this  
34 chapter shall promptly reply in writing to an inquiry of the  
35 commissioner relative to the business of insurance. A timely response  
36 is one that is received by the commissioner within fifteen business

1 days from receipt of the inquiry. Failure to make a timely response  
2 constitutes a violation of this section.

3 (7) A surplus line broker shall report to the commissioner any  
4 administrative action taken against the surplus line broker in another  
5 jurisdiction or by another governmental agency in this state within  
6 thirty days of the final disposition of the matter. This report must  
7 include a copy of the order, consent to order, or other relevant legal  
8 documents.

9 (8) Within thirty days of the initial pretrial hearing date, a  
10 surplus line broker shall report to the commissioner any criminal  
11 prosecution of the surplus line broker taken in any jurisdiction. The  
12 report must include a copy of the initial complaint filed, the order  
13 resulting from the hearing, and any other relevant legal documents.

14 **Sec. 7.** RCW 48.15.140 and 2008 c 217 s 10 are each amended to read  
15 as follows:

16 (1) The commissioner may place on probation, revoke, suspend, or  
17 refuse to renew any surplus line broker's license, or may levy a civil  
18 penalty in accordance with RCW 48.17.560 or any combination of actions,  
19 for any one or more of the following causes:

20 (a) If the surplus line broker fails to file the licensee's annual  
21 statement or to remit the tax as required by this chapter; or

22 (b) If the surplus line broker fails to maintain an office in this  
23 state, or to keep the records, or to allow the commissioner to examine  
24 the licensee's records as required by this chapter; or

25 (c) For any of the causes for which an insurance producer's license  
26 may be revoked under chapter 48.17 RCW.

27 (2) The commissioner may suspend or revoke any such license  
28 whenever he or she deems suspension or revocation to be for the best  
29 interests of the people of this state.

30 (3) The procedures provided by this code for the suspension or  
31 revocation of insurance producers' licenses shall be applicable to  
32 suspension or revocation of a surplus line broker's license.

33 (4) A surplus line broker whose license has been so revoked shall  
34 not again be so licensed within one year thereafter, nor until any  
35 fines or delinquent taxes owing by the formal licensee have been paid.

1        NEW SECTION.    **Sec. 8.**    A new section is added to chapter 48.15 RCW  
2 to read as follows:

3        (1) A surplus line broker shall not engage in any act prohibited by  
4 RCW 48.05.465(2), 48.43.335(2), and chapter 48.30 RCW.

5        (2) A surplus line broker is entitled to the immunities granted  
6 under RCW 48.43.105 and 48.50.070.

7        (3) The rights and prohibitions applicable to insurance producers  
8 contained in RCW 48.30.260, 48.30.270, and 48.62.121 also apply to  
9 surplus line brokers.

10       (4) The exemption for taxes and fees in RCW 48.62.151 does not  
11 apply to surplus line brokers.

12       NEW SECTION.    **Sec. 9.**    A new section is added to chapter 48.15 RCW  
13 to read as follows:

14       (1) A surplus line broker, its representative, or any person  
15 licensed under this chapter involved in the procuring or issuance of an  
16 insurance contract and who receives any funds representing premiums or  
17 return premiums which belong to or should be paid to another person as  
18 a result of or in connection with an insurance transaction is deemed to  
19 have been received in the surplus line broker's fiduciary capacity and  
20 shall:

21       (a) Report to the insurer the exact amount of consideration charged  
22 as premium for the contract, and the amount shall likewise be shown in  
23 the contract and in the records of the surplus line broker;

24       (b) Be promptly accounted for and paid to the insured, insurer, or  
25 person entitled to the funds;

26       (c) Be accounted for and maintained in a separate account from all  
27 other business and personal funds and not commingle or otherwise  
28 combine premiums with any other moneys, except a surplus line broker  
29 may commingle with premium funds any additional funds as the surplus  
30 line broker may deem prudent for the purpose of advancing premiums,  
31 establishing reserves for the paying of return premiums, or for any  
32 contingencies as may arise in the surplus line broker's business of  
33 receiving and transmitting premium or return premium funds.

34       (2) Each willful violation of this section constitutes a  
35 misdemeanor.

36       (3) Any surplus line broker or other person licensed under this  
37 chapter who, not being lawfully entitled thereto, diverts or

1 appropriates funds received in a fiduciary capacity or any portion  
2 thereof to his or her own use, is guilty of theft under chapter 9A.56  
3 RCW.

4 NEW SECTION. **Sec. 10.** A new section is added to chapter 48.15 RCW  
5 to read as follows:

6 The commissioner shall immediately suspend the license or  
7 certificate of a person issued under this chapter who has been

16 practicable, liquidate from their respective securities those special  
17 deposit claims and secured claims which are proved and allowed in the  
18 ancillary proceedings in this state, and shall pay the necessary  
19 expenses of the proceedings. All remaining assets shall promptly  
20 transfer to the domiciliary receiver. Subject to the foregoing  
21 provisions the ancillary receiver and his or her deputies shall have  
22 the same powers and be subject to the same duties with respect to the  
23 administration of such assets, as a receiver of an insurer domiciled in  
24 this state.

25 (3) The domiciliary receiver of an insurer domiciled in a  
26 reciprocal state may sue in this state to recover any assets of such  
27 insurer to which he or she may be entitled under the laws of this  
28 state.

19 The definition of insurance fraud is for illustrative purposes only  
20 under this chapter to describe the nature of the behavior to be  
21 reported and investigated, and is not intended in any manner to create  
22 or modify the definition of any existing criminal acts nor to create or  
23 modify the burdens of proof in any criminal prosecution brought as a  
24 result of an investigation under this chapter.

25 (2) "Insurer" means an insurance company authorized under chapter  
26 48.05 RCW, a health care service contractor registered under chapter  
27 48.44 RCW, and a health care maintenance organization registered under  
28 chapter 48.46 RCW.

29 **Sec. 33.** RCW 51.12.020 and 2008 c 217 s 98 are each amended to

31 The following are the only employments which shall not be included  
32 within the mandatory coverage of this title:

33 (1) Any person employed as a domestic servant in a private home by

36 (A) Logs, wood chips, sawdust, wood waste, and similar products

1 (B) Pulp, including market pulp and pulp derived from recovered  
2 paper or paper products; and

3 (C) Recycled paper, but only when used in the manufacture of

5 (vi) "Wood products" means paper and paper products; dimensional  
6 lumber; engineered wood products such as particleboard, oriented strand  
7 board, medium density fiberboard, and plywood; wood doors; wood  
8 windows; and biocomposite surface products.

9 (13) Upon every person engaging within this state in inspecting,  
10 testing, labeling, and storing canned salmon owned by another person,  
11 as to such persons, the amount of tax with respect to such activities  
12 shall be equal to the gross income derived from such activities  
13 multiplied by the rate of 0.484 percent.

14 NEW SECTION. **Sec. 35.** If any provision of this act or its  
15 application to any person or circumstance is held invalid, the  
16 remainder of the act or the application of the provision to other  
17 persons or circumstances is not affected.

18 NEW SECTION. **Sec. 36.** This act is necessary for the immediate  
19 preservation of the public peace, health, or safety, or support of the  
20 state government and its existing public institutions, and takes effect  
21 July 1, 2009.
