1 AN ACT Relating to persons with intellectual disabilities; amending 2 RCW 44.04.280, 10.95.030, 10.95.070, 10.95.130, 26.26.220, 28B.20.410, 28B.20.414, 39.32.010, 41.05.095, 43.20B.080, 43.190.020, 48.01.035, 3 70.10.010, 70.10.030, 70.41.020, 70.83.020, 70.83.040, 71.34.020, 4 5 71A.10.020, 74.09.035, 74.09.120, 74.09.510, 74.09.700, 74.29.010, 74.42.010, 74.42.490, 74.46.020, 82.65A.020, 82.65A.030, and 72.29.010; 6 7 amending 1965 c 11 s 1 (uncodified); reenacting and amending RCW 13.34.030; and creating a new section. 8

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

10 NEW SECTION. Sec. 1. The purpose of this act is to move toward fulfillment of the goals stated in RCW 44.04.280, to remove demeaning 11 language from the Revised Code of Washington and to use respectful 12 13 language when referring to individuals with disabilities. It is not the intent of the legislature to expand or contract the scope or 14 15 application of any provision of this code. Nothing in this act may be 16 construed to change the application of any provision of this code to 17 any person.

1 Sec. 2. RCW 44.04.280 and 2009 c 377 s 1 are each amended to read
2 as follows:

(1) The legislature recognizes that language used in reference to 3 individuals with disabilities shapes and reflects society's attitudes 4 towards people with disabilities. Many of the terms currently used 5 diminish the humanity and natural condition of having a disability. 6 7 Certain terms are demeaning and create an invisible barrier to inclusion as equal community members. The legislature finds 8 it 9 necessary to clarify preferred language for new and revised laws by requiring the use of terminology that puts the person before the 10 disability. 11

(2)(a) The code reviser is directed to avoid all references to: Disabled, developmentally disabled, mentally disabled, mentally ill, mentally retarded, handicapped, cripple, and crippled, in any new statute, memorial, or resolution, and to change such references in any existing statute, memorial, or resolution as sections including these references are otherwise amended by law.

(b) The code reviser is directed to replace terms referenced in (a) of this subsection as appropriate with the following revised terminology: "Individuals with disabilities," "individuals with developmental disabilities," "individuals with mental illness," and "individuals with intellectual disabilities."

(3) No statute, memorial, or resolution is invalid because it doesnot comply with this section.

25 (4) The replacement of outmoded terminology with more appropriate 26 references may not be construed as changing the application of any 27 provision of this code to any person.

28 **Sec. 3.** RCW 10.95.030 and 1993 c 479 s 1 are each amended to read 29 as follows:

(1) Except as provided in subsection (2) of this section, any 30 31 person convicted of the crime of aggravated first degree murder shall be sentenced to life imprisonment without possibility of release or 32 parole. A person sentenced to life imprisonment under this section 33 shall not have that sentence suspended, deferred, or commuted by any 34 judicial officer and the indeterminate sentence review board or its 35 36 successor may not parole such prisoner nor reduce the period of 37 confinement in any manner whatsoever including but not limited to any

sort of good-time calculation. The department of social and health
 services or its successor or any executive official may not permit such
 prisoner to participate in any sort of release or furlough program.

(2) If, pursuant to a special sentencing proceeding held under RCW 4 10.95.050, the trier of fact finds that there are not sufficient 5 mitigating circumstances to merit leniency, the sentence shall be б 7 death. In no case, however, shall a person be sentenced to death if the person ((was mentally retarded)) had an intellectual disability at 8 the time the crime was committed, under the definition of ((mental 9 retardation)) intellectual disability set forth in (a) of this 10 subsection. A diagnosis of ((mental-retardation)) intellectual 11 disability shall be documented by a licensed psychiatrist or licensed 12 13 psychologist designated by the court, who is an expert in the diagnosis 14 and evaluation of ((mental-retardation)) intellectual disabilities. The defense must establish ((mental-retardation)) an intellectual 15 disability by a preponderance of the evidence and the court must make 16 17 a finding as to the existence of ((mental retardation)) an intellectual disability. 18

(a) (("Mentally-retarded")) "Intellectual disability" means the individual has: (i) Significantly subaverage general intellectual functioning; (ii) existing concurrently with deficits in adaptive behavior; and (iii) both significantly subaverage general intellectual functioning and deficits in adaptive behavior were manifested during the developmental period.

(b) "General intellectual functioning" means the results obtained by assessment with one or more of the individually administered general intelligence tests developed for the purpose of assessing intellectual functioning.

29 (c) "Significantly subaverage general intellectual functioning" 30 means intelligence quotient seventy or below.

31 (d) "Adaptive behavior" means the effectiveness or degree with 32 which individuals meet the standards of personal independence and 33 social responsibility expected for his or her age.

34 (e) "Developmental period" means the period of time between35 conception and the eighteenth birthday.

36 **Sec. 4.** RCW 10.95.070 and 1993 c 479 s 2 are each amended to read 37 as follows:

In deciding the question posed by RCW 10.95.060(4), the jury, or the court if a jury is waived, may consider any relevant factors, including but not limited to the following:

4 (1) Whether the defendant has or does not have a significant 5 history, either as a juvenile or an adult, of prior criminal activity;

6 (2) Whether the murder was committed while the defendant was under
7 the influence of extreme mental disturbance;

8

(3) Whether the victim consented to the act of murder;

9 (4) Whether the defendant was an accomplice to a murder committed 10 by another person where the defendant's participation in the murder was 11 relatively minor;

12 (5) Whether the defendant acted under duress or domination of13 another person;

14 (6) Whether, at the time of the murder, the capacity of the 15 defendant to appreciate the wrongfulness of his or her conduct or to 16 conform his or her conduct to the requirements of law was substantially 17 impaired as a result of mental disease or defect. However, a person 18 found to ((be mentally retarded)) have an intellectual disability under 19 RCW 10.95.030(2) may in no case be sentenced to death;

(7) Whether the age of the defendant at the time of the crime callsfor leniency; and

(8) Whether there is a likelihood that the defendant will pose adanger to others in the future.

24 **Sec. 5.** RCW 10.95.130 and 1993 c 479 s 3 are each amended to read 25 as follows:

(1) The sentence review required by RCW 10.95.100 shall be in addition to any appeal. The sentence review and an appeal shall be consolidated for consideration. The defendant and the prosecuting attorney may submit briefs within the time prescribed by the court and present oral argument to the court.

(2) With regard to the sentence review required by chapter 138,
 Laws of 1981, the supreme court of Washington shall determine:

(a) Whether there was sufficient evidence to justify the
 affirmative finding to the question posed by RCW 10.95.060(4); and

35 (b) Whether the sentence of death is excessive or disproportionate 36 to the penalty imposed in similar cases, considering both the crime and 37 the defendant. For the purposes of this subsection, "similar cases"

means cases reported in the Washington Reports or Washington Appellate Reports since January 1, 1965, in which the judge or jury considered the imposition of capital punishment regardless of whether it was imposed or executed, and cases in which reports have been filed with the supreme court under RCW 10.95.120;

6 (c) Whether the sentence of death was brought about through passion 7 or prejudice; and

8 (d) Whether the defendant ((was - mentally - retarded)) had an
 9 intellectual disability within the meaning of RCW 10.95.030(2).

10 Sec. 6. RCW 13.34.030 and 2009 c 520 s 21 and 2009 c 397 s 1 are 11 each reenacted and amended to read as follows:

12

For purposes of this chapter:

(1) "Abandoned" means when the child's parent, guardian, or other 13 custodian has expressed, either by statement or conduct, an intent to 14 15 forego, for an extended period, parental rights or responsibilities 16 despite an ability to exercise such rights and responsibilities. Ιf 17 the court finds that the petitioner has exercised due diligence in 18 attempting to locate the parent, no contact between the child and the 19 child's parent, guardian, or other custodian for a period of three months creates a rebuttable presumption of abandonment, even if there 20 21 is no expressed intent to abandon.

(2) "Child" and "juvenile" means any individual under the age ofeighteen years.

(3) "Current placement episode" means the period of time that begins with the most recent date that the child was removed from the home of the parent, guardian, or legal custodian for purposes of placement in out-of-home care and continues until: (a) The child returns home; (b) an adoption decree, a permanent custody order, or guardianship order is entered; or (c) the dependency is dismissed, whichever occurs first.

31 (4) "Department" means the department of social and health 32 services.

33 (5) "Dependency guardian" means the person, nonprofit corporation, 34 or Indian tribe appointed by the court pursuant to this chapter for the 35 limited purpose of assisting the court in the supervision of the 36 dependency.

37 (6) "Dependent child" means any child who:

1

(a) Has been abandoned;

2 (b) Is abused or neglected as defined in chapter 26.44 RCW by a 3 person legally responsible for the care of the child; or

4 (c) Has no parent, guardian, or custodian capable of adequately
5 caring for the child, such that the child is in circumstances which
6 constitute a danger of substantial damage to the child's psychological
7 or physical development.

(7) "Developmental disability" means a disability attributable to 8 ((mental - retardation)) intellectual _ disability, cerebral palsy, 9 epilepsy, autism, or another neurological or other condition of an 10 individual found by the secretary to be closely related to ((mental 11 retardation)) an intellectual disability or to require treatment 12 13 similar to that required for individuals with ((mental retardation)) intellectual disabilities, which disability originates before the 14 individual attains age eighteen, which has continued or can be expected 15 which constitutes a 16 to continue indefinitely, and substantial 17 ((handicap)) <u>limitation</u> to the individual.

18 (8) "Guardian" means the person or agency that: (a) Has been 19 appointed as the guardian of a child in a legal proceeding other than 20 a proceeding under this chapter; and (b) has the legal right to custody 21 of the child pursuant to such appointment. The term "guardian" shall 22 not include a "dependency guardian" appointed pursuant to a proceeding 23 under this chapter.

24 (9) "Guardian ad litem" means a person, appointed by the court to 25 represent the best interests of a child in a proceeding under this chapter, or in any matter which may be consolidated with a proceeding 26 under this chapter. A "court-appointed special advocate" appointed by 27 the court to be the guardian ad litem for the child, or to perform 28 substantially the same duties and functions as a guardian ad litem, 29 shall be deemed to be guardian ad litem for all purposes and uses of 30 31 this chapter.

(10) "Guardian ad litem program" means a court-authorized volunteer program, which is or may be established by the superior court of the county in which such proceeding is filed, to manage all aspects of volunteer guardian ad litem representation for children alleged or found to be dependent. Such management shall include but is not limited to: Recruitment, screening, training, supervision, assignment, and discharge of volunteers.

1 (11) "Housing assistance" means appropriate referrals by the 2 department or other supervising agencies to federal, state, local, or 3 private agencies or organizations, assistance with forms, applications, 4 or financial subsidies or other monetary assistance for housing. For 5 purposes of this chapter, "housing assistance" is not a remedial 6 service or time-limited family reunification service as described in 7 RCW 13.34.025(2).

8 (12) "Indigent" means a person who, at any stage of a court 9 proceeding, is:

10 (a) Receiving one of the following types of public assistance: 11 Temporary assistance for needy families, general assistance, poverty-12 related veterans' benefits, food stamps or food stamp benefits 13 transferred electronically, refugee resettlement benefits, medicaid, or 14 supplemental security income; or

15

(b) Involuntarily committed to a public mental health facility; or

16 (c) Receiving an annual income, after taxes, of one hundred twenty-17 five percent or less of the federally established poverty level; or

(d) Unable to pay the anticipated cost of counsel for the matter
before the court because his or her available funds are insufficient to
pay any amount for the retention of counsel.

(13) "Out-of-home care" means placement in a foster family home or group care facility licensed pursuant to chapter 74.15 RCW or placement in a home, other than that of the child's parent, guardian, or legal custodian, not required to be licensed pursuant to chapter 74.15 RCW.

(14) "Preventive services" means preservation services, as defined in chapter 74.14C RCW, and other reasonably available services, including housing assistance, capable of preventing the need for outof-home placement while protecting the child.

(15) "Shelter care" means temporary physical care in a facility licensed pursuant to RCW 74.15.030 or in a home not required to be licensed pursuant to RCW 74.15.030.

32 (16) "Sibling" means a child's birth brother, birth sister, 33 adoptive brother, adoptive sister, half-brother, or half-sister, or as 34 defined by the law or custom of the Indian child's tribe for an Indian 35 child as defined in 25 U.S.C. Sec. 1903(4).

36 (17) "Social study" means a written evaluation of matters relevant 37 to the disposition of the case and shall contain the following 38 information: (a) A statement of the specific harm or harms to the child that
 intervention is designed to alleviate;

3 (b) A description of the specific services and activities, for both 4 the parents and child, that are needed in order to prevent serious harm 5 to the child; the reasons why such services and activities are likely 6 to be useful; the availability of any proposed services; and the 7 agency's overall plan for ensuring that the services will be delivered. 8 The description shall identify the services chosen and approved by the 9 parent;

(c) If removal is recommended, a full description of the reasons 10 11 why the child cannot be protected adequately in the home, including a description of any previous efforts to work with the parents and the 12 child in the home; the in-home treatment programs that have been 13 considered and rejected; the preventive services, including housing 14 assistance, that have been offered or provided and have failed to 15 16 prevent the need for out-of-home placement, unless the health, safety, 17 and welfare of the child cannot be protected adequately in the home; 18 and the parents' attitude toward placement of the child;

(d) A statement of the likely harms the child will suffer as aresult of removal;

(e) A description of the steps that will be taken to minimize the harm to the child that may result if separation occurs including an assessment of the child's relationship and emotional bond with any siblings, and the agency's plan to provide ongoing contact between the child and the child's siblings if appropriate; and

26 (f) Behavior that will be expected before determination that 27 supervision of the family or placement is no longer necessary.

(18) "Supervising agency" means an agency licensed by the state under RCW 74.15.090 or an Indian tribe under RCW 74.15.190 with whom the department has entered into a performance-based contract to provide child welfare services as defined in RCW 74.13.020.

32 **Sec. 7.** RCW 26.26.220 and 1989 c 404 s 2 are each amended to read 33 as follows:

A person shall not enter into, induce, arrange, procure, or otherwise assist in the formation of a surrogate parentage contract under which an unemancipated minor female or a female diagnosed as

1 ((being mentally retarded or as)) having an intellectual disability, a

2 mental illness, or developmental disability is the surrogate mother.

3 Sec. 8. RCW 28B.20.410 and 1969 ex.s. c 223 s 28B.20.410 are each 4 amended to read as follows:

5 There is hereby established at the University of Washington a 6 ((children's)) center for research and training in ((mental retardation 7 and-other-handicapping-conditions)) intellectual and developmental 8 disabilities.

9 Sec. 9. RCW 28B.20.414 and 1969 ex.s. c 223 s 28B.20.414 are each 10 amended to read as follows:

11 The general purposes of the center shall be:

(1) To provide clinical and laboratory facilities for research on the causes, diagnosis, prevention, and treatment of ((mental retardation — and — other — handicapping — conditions — in — children)) intellectual and developmental disabilities;

16 (2) To develop improved professional and in-service training 17 programs in the various disciplines concerned with ((handicapped 18 children)) persons with disabilities;

19 (3) To provide diagnostic and consultative services to various 20 state programs and to regional and local centers, to an extent 21 compatible with the primary research and teaching objectives of the 22 center.

23 **Sec. 10.** RCW 39.32.010 and 1995 c 137 s 2 are each amended to read 24 as follows:

25 For the purposes of RCW 39.32.010 through 39.32.060:

26 The term "eligible donee" means any public agency carrying out or promoting for the residents of a given political area one or more 27 28 public purposes, such as conservation, economic development, education, 29 parks and recreation, public health, and public safety; or nonprofit educational or public health institutions or organizations, such as 30 medical institutions, hospitals, clinics, health centers, schools, 31 colleges, universities, schools for ((the mentally retarded)) persons 32 with intellectual disabilities, schools for ((the - physically 33 34 handicapped)) persons with physical disabilities, child care centers, 35 radio and television stations licensed by the federal communications

1 commission as educational radio or educational television stations, 2 museums attended by the public, and public libraries serving all 3 residents of a community, district, state, or region, and which are 4 exempt from taxation under Section 501 of the Internal Revenue Code of 5 1954, for purposes of education or public health, including research 6 for any such purpose.

7 The term "public agency" means the state or any subdivision 8 thereof, including any unit of local government, economic development 9 district, emergency services organization, or any instrumentality 10 created by compact or other agreement between the state and a political 11 subdivision, or any Indian tribe, band, group, or community located on 12 a state reservation.

13 The term "surplus property" means any property, title to which is 14 in the federal, state, or local government or any department or agency 15 thereof, and which property is to be disposed of as surplus under any 16 act of congress or the legislature or local statute, heretofore or 17 hereafter enacted providing for such disposition.

18 Sec. 11. RCW 41.05.095 and 2007 c 259 s 18 are each amended to 19 read as follows:

(1) Any plan offered to employees under this chapter must offer each employee the option of covering any unmarried dependent of the employee under the age of twenty-five.

(2) Any employee choosing under subsection (1) of this section to
cover a dependent who is: (a) Age twenty through twenty-three and not
a registered student at an accredited secondary school, college,
university, vocational school, or school of nursing; or (b) age twentyfour, shall be required to pay the full cost of such coverage.

(3) Any employee choosing under subsection (1) of this section to cover a dependent with disabilities, ((developmental-disabilities,)) mental illness, or ((mental-retardation)) intellectual or other developmental_disabilities, who is incapable of self-support, may continue covering that dependent under the same premium and payment structure as for dependents under the age of twenty, irrespective of age.

35 **Sec. 12.** RCW 43.20B.080 and 2008 c 6 s 302 are each amended to 36 read as follows:

HB 2490.SL

1 (1) The department shall file liens, seek adjustment, or otherwise 2 effect recovery for medical assistance correctly paid on behalf of an 3 individual consistent with 42 U.S.C. Sec. 1396p. The department shall 4 adopt a rule providing for prior notice and hearing rights to the 5 record title holder or purchaser under a land sale contract.

6 (2) Liens may be adjusted by foreclosure in accordance with chapter7 61.12 RCW.

(3) In the case of an individual who was fifty-five years of age or 8 older when the individual received medical assistance, the department 9 shall seek adjustment or recovery from the individual's estate, and 10 from nonprobate assets of the individual as defined by RCW 11.02.005, 11 but only for medical assistance consisting of nursing facility 12 services, home and community-based services, other services that the 13 department determines to be appropriate, and related hospital and 14 prescription drug services. Recovery from the individual's estate, 15 16 including foreclosure of liens imposed under this section, shall be 17 undertaken as soon as practicable, consistent with 42 U.S.C. Sec. 1396p. 18

19 (4) The department shall apply the medical assistance estate 20 recovery law as it existed on the date that benefits were received when 21 calculating an estate's liability to reimburse the department for those 22 benefits.

23 (5)(a) The department shall establish procedures consistent with 24 standards established by the federal department of health and human 25 services and pursuant to 42 U.S.C. Sec. 1396p to waive recovery when such recovery would work an undue hardship. The department shall 26 27 recognize an undue hardship for a surviving domestic partner whenever recovery would not have been permitted if he or she had been a 28 29 surviving spouse. The department is not authorized to pursue recovery 30 under such circumstances.

(b) Recovery of medical assistance from a recipient's estate shall not include property made exempt from claims by federal law or treaty, including exemption for tribal artifacts that may be held by individual Native Americans.

35 (6) A lien authorized under this section relates back to attach to 36 any real property that the decedent had an ownership interest in 37 immediately before death and is effective as of that date or date of 38 recording, whichever is earlier.

1 (7) The department may enforce a lien authorized under this section 2 against a decedent's life estate or joint tenancy interest in real 3 property held by the decedent immediately prior to his or her death. 4 Such a lien enforced under this subsection shall not end and shall 5 continue as provided in this subsection until the department's lien has 6 been satisfied.

7 (a) The value of the life estate subject to the lien shall be the
8 value of the decedent's interest in the property subject to the life
9 estate immediately prior to the decedent's death.

10 (b) The value of the joint tenancy interest subject to the lien 11 shall be the value of the decedent's fractional interest the recipient 12 would have owned in the jointly held interest in the property had the 13 recipient and the surviving joint tenants held title to the property as 14 tenants in common on the date of the recipient's death.

15 (c) The department may not enforce the lien provided by this 16 subsection against a bona fide purchaser or encumbrancer that obtains 17 an interest in the property after the death of the recipient and before 18 the department records either its lien or the request for notice of 19 transfer or encumbrance as provided by RCW 43.20B.750.

(d) The department may not enforce a lien provided by this
subsection against any property right that vested prior to July 1,
2005.

(8)(a) Subject to the requirements of 42 U.S.C. Sec. 1396p(a) and the conditions of this subsection (8), the department is authorized to file a lien against the property of an individual prior to his or her death, and to seek adjustment and recovery from the individual's estate or sale of the property subject to the lien, if:

(i) The individual is an inpatient in a nursing facility, intermediate care facility for ((individuals with mental retardation)) persons with intellectual disabilities, or other medical institution; and

(ii) The department has determined after notice and opportunity for
 a hearing that the individual cannot reasonably be expected to be
 discharged from the medical institution and to return home.

35 (b) If the individual is discharged from the medical facility and 36 returns home, the department shall dissolve the lien.

37 (9) The department is authorized to adopt rules to effect recovery

under this section. The department may adopt by rule later enactments
 of the federal laws referenced in this section.

3 (10) It is the responsibility of the department to fully disclose 4 in advance verbally and in writing, in easy to understand language, the 5 terms and conditions of estate recovery to all persons offered long-6 term care services subject to recovery of payments.

(11) In disclosing estate recovery costs to potential clients, and
to family members at the consent of the client, the department shall
provide a written description of the community service options.

10 **Sec. 13.** RCW 43.190.020 and 1995 1st sp.s. c 18 s 32 are each 11 amended to read as follows:

12 As used in this chapter, "long-term care facility" means any of the 13 following:

14 (1) A facility which:

15 (a) Maintains and operates twenty-four hour skilled nursing 16 services for the care and treatment of chronically ill or convalescent 17 patients, including mental, emotional, or behavioral problems, ((mental 18 retardation)) intellectual disabilities, or alcoholism;

19 (b) Provides supportive, restorative, and preventive health services in conjunction with a socially oriented program to its 20 21 residents, and which maintains and operates twenty-four hour services including board, room, personal care, and intermittent nursing care. 22 "Long-term health care facility" includes nursing homes and nursing 23 facilities, but does not include acute care hospital or other licensed 24 25 facilities except for that distinct part of the hospital or facility 26 which provides nursing facility services.

(2) Any family home, group care facility, or similar facility determined by the secretary, for twenty-four hour nonmedical care of persons in need of personal services, supervision, or assistance essential for sustaining the activities of daily living or for the protection of the individual.

(3) Any swing bed in an acute care facility.

33 Sec. 14. RCW 48.01.035 and 1985 c 264 s 1 are each amended to read 34 as follows:

The term "developmental disability" as used in this title means a disability attributable to ((mental - retardation)) <u>intellectual</u>

disability, cerebral palsy, epilepsy, autism, or another neurological 1 2 condition closely related to ((mental-retardation)) an_intellectual disability or to require treatment similar to that required for 3 ((mentally — retarded — individuals)) persons __with __intellectual 4 5 disabilities, which disability originates before such individual attains age eighteen, which has continued or can be expected to 6 7 continue indefinitely, and which constitutes a substantial ((handicap)) 8 limitation to such individual.

Such services include, but are not limited to, extraordinary
