25 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

26 **PART I**

27 **Sec. 1001.** RCW 10.01.050 and Code 1881 s 770 are each amended to
28 read as follows:

29 No person charged with any offense against the law shall be
30 punished for such offense, unless he or she shall have been duly and
31 legally convicted thereof in a court having competent jurisdiction of
32 the case and of the person.

33 **Sec. 1002.** RCW 10.01.060 and 1951 c 52 s 1 are each amended to
34 read as follows:

1 No person informed against or indicted for a crime shall be
2 convicted thereof, unless by admitting the truth of the charge in his
3 or her plea, by confession in open court, or by the verdict of a jury,
4 accepted and recorded by the court: PROVIDED HOWEVER, That except in
5 capital cases, where the person informed against or indicted for a
6 crime is represented by counsel, such person may, with the assent of
7 the court, waive trial by jury and submit to trial by the court.

8 **Sec. 1003.** RCW 10.01.120 and Code 1881 s 1136 are each amended to
9 read as follows:

10 Whenever a prisoner has been sentenced to death, the governor shall
11 have power to commute such sentence to imprisonment for life at hard
12 labor; and in all cases in which the governor is authorized to grant
13 pardons or commute sentence of death, he or she may, upon the petition
14 of the person convicted, commute a sentence or grant a pardon, upon
15 such conditions, and with such restrictions, and under such limitations
16 as he or she may think proper; and he or she may issue his or her
17 warrant to all proper officers to carry into effect such pardon or
18 commutation, which warrant shall be obeyed and executed, instead of the
19 sentence, if any, which was originally given. The governor may also,
20 on good cause shown, grant respites or reprieves from time to time as
21 he or she may think proper.

22 **Sec. 1004.** RCW 10.01.140 and 1895 c 10 s 2 are each amended to
23 read as follows:

24 No allowance of mileage shall be made to a juror or witness who has
25 not verified his or her claim of mileage under oath before the clerk of
26 the court on which he or she is in attendance.

27 **Sec. 1005.** RCW 10.01.150 and 1999 c 163 s 6 are each amended to
28 read as follows:

29 Whenever a state officer or employee is charged with a criminal
30 offense arising out of the performance of an official act which was
31 fully in conformity with established written rules, policies, and
32 guidelines of the state or state agency, the employing agency may
33 request the attorney general to defend the officer or employee. If the
34 agency finds, and the attorney general concurs, that the officer's or
35 employee's conduct was fully in accordance with established written

1 rules, policies, and guidelines of the state or a state agency and the
2 act performed was within the scope of employment, then the request
3 shall be granted and the costs of defense shall be paid by the
4 requesting agency: PROVIDED, HOWEVER, If the agency head is the person
5 charged, then approval must be obtained from both the attorney general
6 and the state auditor. If the court finds that the officer or employee
7 was performing an official act, or was within the scope of employment,
8 and that his or her actions were in conformity with the established
9 rules, regulations, policies, and guidelines of the state and the state
10 agency, the cost of any monetary fine assessed shall be paid from the
11 liability account.

12 **Sec. 1006.** RCW 10.01.180 and 1989 c 373 s 13 are each amended to
13 read as follows:

14 (1) A defendant sentenced to pay a fine or costs who defaults in
15 the payment thereof or of any installment is in contempt of court as
16 provided in chapter 7.21 RCW. The court may issue a warrant of arrest
17 for his or her appearance.

18 (2) When a fine or assessment of costs is imposed on a corporation
19 or unincorporated association, it is the duty of the person authorized
20 to make disbursement from the assets of the corporation or association
21 to pay the fine or costs from those assets, and his or her failure to
22 do so may be held to be contempt.

23 (3) If a term of imprisonment for contempt for nonpayment of a fine
24 or costs is ordered, the term of imprisonment shall be set forth in the
25 commitment order, and shall not exceed one day for each twenty-five
26 dollars of the fine or costs, thirty days if the fine or assessment of
27 costs was imposed upon conviction of a violation or misdemeanor, or one
28 year in any other case, whichever is the shorter period. A person
29 committed for nonpayment of a fine or costs shall be given credit
30 toward payment for each day of imprisonment at the rate specified in
31 the commitment order.

32 (4) If it appears to the satisfaction of the court that the default
33 in the payment of a fine or costs is not contempt, the court may enter
34 an order allowing the defendant additional time for payment, reducing
35 the amount thereof or of each installment or revoking the fine or costs
36 or the unpaid portion thereof in whole or in part.

1 (5) A default in the payment of a fine or costs or any installment
2 thereof may be collected by any means authorized by law for the
3 enforcement of a judgment. The levy of execution for the collection of
4 a fine or costs shall not discharge a defendant committed to
5 imprisonment for contempt until the amount of the fine or costs has
6 actually been collected.

7 **Sec. 1007.** RCW 10.04.110 and 1987 c 202 s 153 are each amended to
8 read as follows:

9 In all cases of conviction, unless otherwise provided in this
10 chapter, the judge shall enter judgment for the fine and costs against
11 the defendant, and may commit him or her to jail until the amount of
12 such fine and costs owing are paid, or the payment thereof be secured
13 as provided by RCW 10.04.120. The amount of such fine and costs owing
14 shall be computed as provided for superior court cases in RCW 10.82.030
15 and 10.82.040. Further proceedings therein shall be had as in like
16 cases in the superior court: PROVIDED, That all fees, fines,
17 forfeitures and penalties collected or assessed by a district court
18 because of the violation of a state law shall be remitted as provided
19 in chapter 3.62 RCW as now exists or is later amended.

20 **Sec. 1008.** RCW 10.10.060 and 1891 c 29 s 7 are each amended to
21 read as follows:

22 The appellant in a criminal action shall not be required to advance
23 any fees in claiming his or her appeal nor in prosecuting the same; but
24 if convicted in the appellate court, or if sentenced for failing to
25 prosecute his or her appeal, he or she may be required as a part of the
26 sentence to pay the costs of the prosecution. If the appellant shall
27 fail to enter and prosecute his or her appeal he or she shall be
28 defaulted of his or her recognizance, if any was taken, and the
29 superior court may award sentence against him or her for the offense
30 whereof he or she was convicted in like manner as if he or she had been
31 convicted thereof in that court; and if he or she be not then in
32 custody process may be issued to bring him or her into court to receive
33 sentence.

34 **Sec. 1009.** RCW 10.16.080 and Code 1881 s 1925 are each amended to
35 read as follows:

1 If it should appear upon the whole examination that no offense has
2 been committed, or that there is not probable cause for charging the
3 defendant with an offense, he or she shall be discharged, and if in the
4 opinion of the magistrate, the complaint was malicious, or without
5 probable cause, and there was no reasonable ground therefor, the costs
6 shall be taxed against the party making the complaint.

7 **Sec. 1010.** RCW 10.16.110 and 1890 p 102 s 6 are each amended to
8 read as follows:

9 It shall be the duty of the prosecuting attorney of the proper
10 county to inquire into and make full examination of all the facts and
11 circumstances connected with any case of preliminary examination, as
12 provided by law, touching the commission of any offense wherein the
13 offender shall be committed to jail, or become recognized or held to
14 bail; and if the prosecuting attorney shall determine in any such case
15 that an information ought not to be filed, he or she shall make,
16 subscribe, and file with the clerk of the court a statement in writing
17 containing his or her reasons, in fact and in law, for not filing an
18 information in such case, and such statement shall be filed at and
19 during the session of court at which the offender shall be held for his
20 or her appearance: PROVIDED, That in such case such court may examine
21 such statement, together with the evidence filed in the case, and if
22 upon such examination the court shall not be satisfied with such
23 statement, the prosecuting attorney shall be directed by the court to
24 file the proper information and bring the case to trial.

25 **Sec. 1011.** RCW 10.16.145 and Code 1881 s 1930 are each amended to
26 read as follows:

27 If the magistrate shall be satisfied that there is good cause to
28 believe that any such witness will not perform the condition of his or
29 her recognizance unless other security be given, such magistrate may
30 order the witness to enter into recognizance with such sureties as may
31 be deemed necessary for his or her appearance at court.

32 **Sec. 1012.** RCW 10.16.150 and 1973 1st ex.s. c 154 s 19 are each
33 amended to read as follows:

34 When any minor is a material witness, any other person may be
35 allowed to recognize for the appearance of such witness, or the

1 magistrate may, in his or her discretion, take the recognizance of such
2 minor in a sum not exceeding fifty dollars which shall be valid and
3 binding in law, notwithstanding the disability of minority.

4 **Sec. 1013.** RCW 10.19.040 and Code 1881 s 1034 are each amended to
5 read as follows:

6 Any officer authorized to execute a warrant in a criminal action,
7 may take the recognizance and justify and approve the bail; he or she
8 may administer an oath and examine the bail as to its sufficiency.

9 **Sec. 1014.** RCW 10.19.060 and Code 1881 s 1035 are each amended to
10 read as follows:

11 Every recognizance taken by any peace officer must be certified by
12 him or her forthwith to the clerk of the court to which the defendant
13 is recognized. The clerk must thereupon record the recognizance in the
14 order book, and, from the time of filing, it has the same effect as if
15 taken in open court.

16 **Sec. 1015.** RCW 10.22.010 and 2008 c 276 s 308 are each amended to
17 read as follows:

18 When a defendant is prosecuted in a criminal action for a
19 misdemeanor, other than a violation of RCW 9A.48.105, for which the
20 person injured by the act constituting the offense has a remedy by a
21 civil action, the offense may be compromised as provided in RCW
22 10.22.020, except when it was committed:

23 (1) By or upon an officer while in the execution of the duties of
24 his or her office;

25 (2) Riotously;

26 (3) With an intent to commit a felony; or

27 (4) By one family or household member against another as defined in
28 RCW 10.99.020 and was a crime of domestic violence as defined in RCW
29 10.99.020.

30 **Sec. 1016.** RCW 10.22.020 and 1891 c 28 s 63 are each amended to
31 read as follows:

32 In such case, if the party injured appear in the court in which the
33 cause is pending at any time before the final judgment therein, and
34 acknowledge, in writing, that he or she has received satisfaction for

1 the injury, the court may, in its discretion, on payment of the costs
2 incurred, order all proceedings to be discontinued and the defendant to
3 be discharged. The reasons for making the order must be set forth
4 therein and entered in the minutes. Such order is a bar to another
5 prosecution for the same offense.

6 **Sec. 1017.** RCW 10.25.070 and 1891 c 28 s 7 are each amended to
7 read as follows:

8 The defendant may show to the court, by affidavit, that he or she
9 believes he or she cannot receive a fair trial in the county where the
10 action is pending, owing to the prejudice of the judge, or to
11 excitement or prejudice against the defendant in the county or some
12 part thereof, and may thereupon demand to be tried in another county.
13 The application shall not be granted on the ground of excitement or
14 prejudice other than prejudice of the judge, unless the affidavit of
15 the defendant be supported by other evidence, nor in any case unless
16 the judge is satisfied the ground upon which the application is made
17 does exist.

18 **Sec. 1018.** RCW 10.27.060 and 1971 ex.s. c 67 s 6 are each amended
19 to read as follows:

20 Neither the grand jury panel nor any individual grand juror may be
21 challenged, but the court may:

22 (1) At any time before a grand jury is sworn discharge the panel
23 and summon another if it finds that the original panel does not
24 substantially conform to the requirements of chapter 2.36 RCW; or

25 (2) At any time after a grand juror is drawn, refuse to swear him
26 or her, or discharge him or her after he or she has been sworn, upon a
27 finding that he or she is disqualified from service pursuant to chapter
28 2.36 RCW, or incapable of performing his or her duties because of bias
29 or prejudice, or guilty of misconduct in the performance of his or her
30 duties such as to impair the proper functioning of the grand jury.

31 **Sec. 1019.** RCW 10.27.070 and 1971 ex.s. c 67 s 7 are each amended
32 to read as follows:

33 (1) When the grand jury is impaneled, the court shall appoint one
34 of the jurors to be (~~foreman~~) foreperson, and also another of the

1 jurors to act as ((foreman)) foreperson in case of the absence of the
2 ((foreman)) foreperson.

3 (2) The grand jurors must be sworn pursuant to the following oath:
4 "You, as grand jurors for the county of, do solemnly swear
5 (or affirm) that you will diligently inquire into and true presentment
6 make of all such matters and things as shall come to your knowledge and
7 you will submit things truly as they come to your knowledge, according
8 to your charge the laws of this state and your understanding; you shall
9 indict no person through envy, hatred, malice or political
10 consideration; neither will you leave any person unindicted through

12 consideration. The counsel of the state, his or her advice, and that
13 of your fellows you shall keep secret."

14 (3) After a grand jury has been sworn, the court must deliver or
15 cause to be delivered to each grand juror a printed copy of all the
16 provisions of this chapter, and the court may give the grand jurors any
17 oral or written instructions, or both, relating to the proper
18 performance of their duties at any time it deems necessary or
19 appropriate.

20 (4) The court shall appoint a reporter to record the proceedings
21 before the grand jury or special inquiry judge, and shall swear him or
22 her not to disclose any testimony or the name of any witness except as
23 provided in RCW 10.27.090. In addition, the ((foreman)) foreperson of
24 the grand jury may, in his or her discretion, select one of the grand
25 jurors to act as secretary to keep records of the grand jury's
26 business.

27 (5) The court, whenever necessary, shall appoint an interpreter,
28 and shall swear him or her not to disclose any testimony or the name of
29 any witness except as provided in RCW 10.27.090.

30 (6) When a person held in official custody is a witness before a
31 grand jury or special inquiry judge, a public servant, assigned to
32 guard him or her during his or her appearance may accompany him or her.
33 The court shall swear such public servant not to disclose any testimony
34 or the name of any witness except as provided in RCW 10.27.090.

35 (7) Proceedings of a grand jury shall not be valid unless at least
36 twelve of its members are present. The ((foreman)) foreperson or
37 acting ((foreman)) foreperson of the grand jury shall conduct

1 proceedings in an orderly manner and shall administer an oath or
2 affirmation in the manner prescribed by law to any witness who shall
3 testify before the grand jury.

4 (8) The legal advisers of a grand jury are the court and public
5 attorneys, and a grand jury may not seek or receive legal advice from
6 any other source. When necessary or appropriate, the court or public
7 attorneys or both must instruct the grand jury concerning the law with
8 respect to its duties or any matter before it, and such instructions
9 shall be recorded by the reporter.

10 (9)(a) Upon request of the prosecuting attorney of the county in
11 which a grand jury or special inquiry judge is impaneled, the attorney
12 general shall assist such prosecuting attorney in attending such grand
13 jury or special inquiry judge.

14 (b) Whenever directed by the court, the attorney general shall
15 supersede the prosecuting attorney in attending the grand jury and in
16 which event the attorney general shall be responsible for the
17 prosecution of any indictment returned by the grand jury.

18 (c) When the attorney general is conducting a criminal
19 investigation pursuant to powers otherwise granted to him or her, he or
20 she shall attend all grand juries or special inquiry judges in relation
21 thereto and shall prosecute any indictments returned by a grand jury.

22 (10) After consulting with the court and receiving its approval,
23 the grand jury may request the governor to appoint a special prosecutor
24 to attend the grand jury. The grand jury shall in the request nominate
25 three persons approved by the court. From those nominated, the
26 governor shall appoint a special prosecutor, who shall supersede the
27 prosecuting attorney and the attorney general and who shall be
28 responsible for the prosecution of any indictments returned by the
29 grand jury attended by him or her.

30 (11) A public attorney shall attend the grand jurors when requested
31 by them, and he or she may do so on his or her own motion within the
32 limitations of RCW 10.27.020(2), 10.27.070(9) and 10.27.070(10) hereof,
33 for the purpose of examining witnesses in their presence, or of giving
34 the grand jurors legal advice regarding any matter cognizable by them.
35 He or she shall also, when requested by them, draft indictments and
36 issue process for the attendance of witnesses.

37 (12) Subject to the approval of the court, the corporation counsel
38 or city attorney for any city or town in the county where any grand

1 jury has been convened may appear as a witness before the grand jury to
2 advise the grand jury of any criminal activity or corruption within his
3 or her jurisdiction.

4 **Sec. 1020.** RCW 10.27.080 and 1971 ex.s. c 67 s 8 are each amended
5 to read as follows:

6 No person shall be present at sessions of the grand jury or special
7 inquiry judge except the witness under examination and his or her
8 attorney, public attorneys, the reporter, an interpreter, a public
9 servant guarding a witness who has been held in custody, if any, and,
10 for the purposes provided for in RCW 10.27.170, any corporation counsel
11 or city attorney. The attorney advising the witness shall only advise
12 such witness concerning his or her right to answer or not answer any
13 questions and the form of his or her answer and shall not otherwise
14 engage in the proceedings. No person other than grand jurors shall be
15 present while the grand jurors are deliberating or voting. Any person
16 violating either of the above provisions may be held in contempt of
17 court.

18 **Sec. 1021.** RCW 10.27.090 and 1971 ex.s. c 67 s 9 are each amended
19 to read as follows:

20 (1) Every member of the grand jury shall keep secret whatever he,
21 she, or any other grand juror has said, and how he, she, or any other
22 grand juror has voted, except for disclosure of indictments, if any, as
23 provided in RCW 10.27.150.

24 (2) No grand juror shall be permitted to state or testify in any
25 court how he, she, or any other grand juror voted on any question
26 before them or what opinion was expressed by himself, herself, or any
27 other grand juror regarding such question.

28 (3) No grand juror, public or private attorney, city attorney or
29 corporation counsel, reporter, interpreter or public servant who held
30 a witness in custody before a grand jury or special inquiry judge, or
31 witness, principal or other person shall disclose the testimony of a
32 witness examined before the grand jury or special inquiry judge or
33 other evidence received by it, except when required by the court to
34 disclose the testimony of the witness examined before the grand jury or
35 special inquiry judge for the purpose of ascertaining whether it is
36 consistent with that of the witness given before the court, or to

1 disclose his or her testimony given before the grand jury or special
2 inquiry judge by any person upon a charge against such person for
3 perjury in giving his or her testimony or upon trial therefor, or when
4 permitted by the court in furtherance of justice.

5 (4) The public attorney shall have access to all grand jury and
6 special inquiry judge evidence and may introduce such evidence before
7 any other grand jury or any trial in which the same may be relevant.

8 (5) The court upon a showing of good cause may make any or all
9 grand jury or special inquiry judge evidence available to any other
10 public attorney, prosecuting attorney, city attorney or corporation
11 counsel upon proper application and with the concurrence of the public
12 attorney attending such grand jury. Any witness' testimony, given
13 before a grand jury or a special inquiry judge and relevant to any
14 subsequent proceeding against the witness, shall be made available to
15 the witness upon proper application to the court. The court may also,
16 upon proper application and upon a showing of good cause, make
17 available to a defendant in a subsequent criminal proceeding other
18 testimony or evidence:

19 (a) When given or presented before a special inquiry judge, if
20 doing so is in the furtherance of justice; or

21 (b) When given or presented before a grand jury, if the court finds
22 that doing so is necessary to prevent an injustice and that there is no
23 reason to believe that doing so would endanger the life or safety of
24 any witness or his or her family. The cost of any such transcript made
25 available shall be borne by the applicant.

26 **Sec. 1022.** RCW 10.27.100 and 1971 ex.s. c 67 s 10 are each amended
27 to read as follows:

28 The grand jurors shall inquire into every offense triable within
29 the county for which any person has been held to answer, if an
30 indictment has not been found or an information filed in such case, and
31 all other indictable offenses within the county which are presented to
32 them by a public attorney or otherwise come to their knowledge. If a
33 grand juror knows or has reason to believe that an indictable offense,
34 triable within the county, has been committed, he or she shall declare
35 such a fact to his or her fellow jurors who may begin an investigation.
36 In such investigation the grand juror may be sworn as a witness.

1 **Sec. 1023.** RCW 10.27.120 and 1971 ex.s. c 67 s 12 are each amended
2 to read as follows:

3 Any individual called to testify before a grand jury or special
4 inquiry judge, whether as a witness or principal, if not represented by
5 an attorney appearing with the witness before the grand jury or special
6 inquiry judge, must be told of his or her privilege against self-
7 incrimination. Such an individual has a right to representation by an
8 attorney to advise him or her as to his or her rights, obligations, and
9 duties before the grand jury or special inquiry judge, and must be
10 informed of this right. The attorney may be present during all
11 proceedings attended by his or her client unless immunity has been
12 granted pursuant to RCW 10.27.130. After immunity has been granted,
13 such an individual may leave the grand jury room to confer with his or
14 her attorney.

17 If in any proceedings before a grand jury or special inquiry judge,
18 a person refuses, or indicates in advance a refusal, to testify or
19 provide evidence of any other kind on the ground that he or she may be
20 incriminated thereby, and if a public attorney requests the court to
21 order that person to testify or provide the evidence, the court shall
22 then hold a hearing and shall so order unless it finds that to do so
23 would be clearly contrary to the public interest, and that person shall
24 comply with the order. The hearing shall be subject to the provisions
25 of RCW 10.27.080 and 10.27.090, unless the witness shall request that
26 the hearing be public.

27 If, but for this section, he or she would have been privileged to
28 withhold the answer given or the evidence produced by him or her, the

30 her privilege against self-incrimination; but he or she shall not be
31 prosecuted or subjected to criminal penalty or forfeiture for or on
32 account of any transaction, matter, or fact concerning which he or she

34 nevertheless be prosecuted for failing to comply with the order to
35 answer, or for perjury or for offering false evidence to the grand
36 jury.

1 **Sec. 1025.** RCW 10.27.140 and 1971 ex.s. c 67 s 14 are each amended
2 to read as follows:

3 (1) Except as provided in this section, no person has the right to
4 appear as a witness in a grand jury or special inquiry judge
5 proceeding.

6 (2) A public attorney may call as a witness in a grand jury or
7 special inquiry judge proceeding any person believed by him or her to
8 possess information or knowledge relevant thereto and may issue legal
9 process and subpoena to compel his or her attendance and the production
10 of evidence.

11 (3) The grand jury or special inquiry judge may cause to be called
12 as a witness any person believed by it to possess relevant information
13 or knowledge. If the grand jury or special inquiry judge desires to
14 hear any such witness who was not called by a public attorney, it may

24 (4) The proceedings to summon a person and compel him or her to
25 testify or provide evidence shall as far as possible be the same as
26 proceedings to summon witnesses and compel their attendance. Such
27 persons shall receive only those fees paid witnesses in superior court
28 criminal trials.

29 **Sec. 1026.** RCW 10.27.150 and 1971 ex.s. c 67 s 15 are each amended
30 to read as follows:

31 After hearing, examining, and investigating the evidence before it,
32 a grand jury may, in its discretion, issue an indictment against a
33 principal. A grand jury shall find an indictment only when from all
34 the evidence at least three-fourths of the jurors are convinced that
35 there is probable cause to believe a principal is guilty of a criminal
36 offense. When an indictment is found by a grand jury the (~~foreman~~)

1 foreperson or acting (~~foreman~~) foreperson shall present it to the
2 court.

3 **Sec. 1027.** RCW 10.29.050 and 1980 c 146 s 5 are each amended to
4 read as follows:

5 A statewide special inquiry judge shall have the following powers
6 and duties:

7 (1) To hear and receive evidence of crime and corruption.

8 (2) To appoint a reporter to record the proceedings; and to swear
9 the reporter not to disclose any testimony or the name of any witness
10 except as provided in RCW 10.27.090.

11 (3) Whenever necessary, to appoint an interpreter, and to swear him
12 or her not to disclose any testimony or the name of any witness except
13 as provided in RCW 10.27.090.

14 (4) When a person held in official custody is a witness before a
15 statewide special inquiry judge, a public servant, assigned to guard
16 him or her during his or her appearance may accompany him or her. The
17 statewide special inquiry judge shall swear such public servant not to

19 RCW 10.27.090.

20 (5) To cause to be called as a witness any person believed by him
21 or her to possess relevant information or knowledge. If the statewide
22 special inquiry judge desires to hear any such witness who was not
23 called by the special prosecutor, it may direct the special prosecutor
24 to issue and serve a subpoena upon such witness and the special
25 prosecutor must comply with such direction. At any time after service
26 of such subpoena and before the return date thereof, however, the
27 special prosecutor may apply to the statewide special inquiry judge for
28 an order vacating or modifying the subpoena on the grounds that such is
29 in the public interest. Upon such application, the statewide special
30 inquiry judge may in its discretion vacate the subpoena, extend its
31 return date, attach reasonable conditions to directions, or make such
32 other qualification thereof as is appropriate.

33 (6) Upon a showing of good cause may make available any or all
34 evidence obtained to any other public attorney, prosecuting attorney,
35 city attorney, or corporation counsel upon proper application and with
36 the concurrence of the special prosecutor. Any witness' testimony,
37 given before a statewide special inquiry judge and relevant to any

1 subsequent proceeding against the witness, shall be made available to
2 the witness upon proper application to the statewide special inquiry
3 judge. The statewide special inquiry judge may also, upon proper
4 application and upon a showing of good cause, make available to a
5 defendant in a subsequent criminal proceeding other testimony or
6 evidence when given or presented before a special inquiry judge, if
7 doing so is in the furtherance of justice.

8 (7) Have authority to perform such other duties as may be required
9 to effectively implement this chapter, in accord with rules adopted by
10 the supreme court relating to these proceedings.

11 (8) Have authority to hold in contempt of court any person who
12 shall disclose the name or testimony of a witness examined before a
13 statewide special inquiry judge except when required by a court to
14 disclose the testimony given before such statewide special inquiry
15 judge in a subsequent criminal proceeding.

16 **Sec. 1028.** RCW 10.29.110 and 1980 c 146 s 11 are each amended to
17 read as follows:

18 The special prosecutor or his or her designee shall:

- 19 (1) Attend all proceedings of the statewide special inquiry judge;
20 (2) Have the authority to issue subpoenas for witnesses statewide;
21 (3) Examine witnesses, present evidence, draft reports as directed
22 by the statewide special inquiry judge, and draft and file informations
23 under RCW 10.29.120.

24 **Sec. 1029.** RCW 10.31.030 and 1970 ex.s. c 49 s 3 are each amended
25 to read as follows:

26 The officer making an arrest must inform the defendant that he or
27 she acts under authority of a warrant, and must also show the warrant:
28 PROVIDED, That if the officer does not have the warrant in his or her
29 possession at the time of arrest he or she shall declare that the
30 warrant does presently exist and will be shown to the defendant as soon
31 as possible on arrival at the place of intended confinement: PROVIDED,
32 FURTHER, That any officer making an arrest under this section shall, if
33 the person arrested wishes to deposit bail, take such person directly
34 and without delay before a judge or before an officer authorized to
35 take the recognizance and justify and approve the bail, including the
36 deposit of a sum of money equal to bail. Bail shall be the amount

1 fixed by the warrant. Such judge or authorized officer shall hold bail
2 for the legal authority within this state which issued such warrant if
3 other than such arresting authority.

4 **Sec. 1030.** RCW 10.31.040 and Code 1881 s 1170 are each amended to
5 read as follows:

6 To make an arrest in criminal actions, the officer may break open
7 any outer or inner door, or windows of a dwelling house or other
8 building, or any other inclosure, if, after notice of his or her office
9 and purpose, he or she be refused admittance.

10 **Sec. 1031.** RCW 10.31.050 and Code 1881 s 1031 are each amended to
11 read as follows:

12 If after notice of the intention to arrest the defendant, he or she
13 either flee or forcibly resist, the officer may use all necessary means
14 to effect the arrest.

15 **Sec. 1032.** RCW 10.31.060 and 1971 c 81 s 48 are each amended to
16 read as follows:

17 Whenever any person or persons shall have been indicted or accused
18 on oath of any public offense, or thereof convicted, and a warrant of
19 arrest shall have been issued, the magistrate issuing such warrant, or
20 any justice of the supreme court, or any judge of either the court of
21 appeals or superior court may indorse thereon an order signed by him or
22 her and authorizing the service thereof by telegraph or teletype, and
23 thereupon such warrant and order may be sent by telegraph or teletype
24 to any marshal, sheriff, constable or (~~police man~~) police officer, and
25 on the receipt of the telegraphic or teletype copy thereof by any such
26 officer, he or she shall have the same authority and be under the same

35 said accused person or persons guilty of the offense charged:

1 PROVIDED, That the making of such order by any officer aforesaid, shall
2 be prima facie evidence of the regularity thereof, and of all the
3 proceedings prior thereto. The original warrant and order, or a copy
4 thereof, certified by the officer making the order, shall be preserved
5 in the telegraph office or police agency from which the same is sent,
6 and in telegraphing or teletyping the same, the original or the said
7 certified copy may be used.

8 **Sec. 1033.** RCW 10.34.010 and Code 1881 s 1922 are each amended to
9 read as follows:

10 If any person against whom a warrant may be issued for an alleged
11 offense, committed in any county, shall either before or after the
12 issuing of such warrant, escape from, or be out of the county, the
13 sheriff or other officer to whom such warrant may be directed, may
14 pursue and apprehend the party charged, in any county in this state,
15 and for that purpose may command aid, and exercise the same authority
16 as in his or her own county.

17 **Sec. 1034.** RCW 10.34.020 and Code 1881 s 1032 are each amended to
18 read as follows:

19 If a person arrested escape or be rescued, the person from whose
20 custody he or she made his or her escape, or was rescued, may
21 immediately pursue and retake him or her at any time, and within any
22 place in the state. To retake the person escaping or rescued, the
23 person pursuing has the same power to command assistance as given in
24 cases of arrest.

25 **Sec. 1035.** RCW 10.34.030 and 1993 c 442 s 1 are each amended to
26 read as follows:

27 The governor may appoint agents to make a demand upon the executive
28 authority of any state or territory for the surrender of any fugitive
29 from justice, or any other person charged with a felony or any other
30 crime in this state. Whenever an application shall be made to the
31 governor for the appointment of an agent he or she may require the
32 official submitting the same to provide whatever information is
33 necessary prior to approval of the application.

1 (4) That the crime was committed within the jurisdiction of the
2 court, except where, as provided by law, the act, though done without
3 the county in which the court is held, is triable therein;

4 (5) That the crime was committed at some time previous to the
5 finding of the indictment or filing of the information, and within the
6 time limited by law for the commencement of an action therefor;

7 (6) That the act or omission charged as the crime is clearly and
8 distinctly set forth in ordinary and concise language, without
9 repetition, and in such a manner as to enable a person of common
10 understanding to know what is intended;

11 (7) The act or omission charged as the crime is stated with such a
12 degree of certainty as to enable the court to pronounce judgment upon
13 a conviction according to the right of the case.

14 **Sec. 1038.** RCW 10.40.050 and 1891 c 28 s 49 are each amended to
15 read as follows:

16 If he or she alleges that another name is his or her true name it
17 must be entered in the minutes of the court, and the subsequent
18 proceedings on the indictment or information may be had against him or
19 her by that name, referring also to the name by which he or she is
20 indicted or informed against.

21 **Sec. 1039.** RCW 10.40.060 and 1891 c 28 s 50 are each amended to
22 read as follows:

23 In answer to the arraignment, the defendant may move to set aside
24 the indictment or information, or he or she may demur or plead to it,
25 and is entitled to one day after arraignment in which to answer thereto
26 if he or she demands it.

27 **Sec. 1040.** RCW 10.40.140 and Code 1881 s 1053 are each amended to
28 read as follows:

29 If the demurrer is overruled the defendant has a right to put in a
30 plea. If he or she fails to do so, judgment may be rendered against
31 him or her on the demurrer, and, if necessary, a jury may be impaneled
32 to inquire and ascertain the degree of the offense.

33 **Sec. 1041.** RCW 10.40.170 and Code 1881 s 1056 are each amended to
34 read as follows:

1 The plea of guilty can only be put in by the defendant himself or
2 herself in open court.

3 **Sec. 1042.** RCW 10.43.040 and 1999 c 141 s 1 are each amended to
4 read as follows:

5 Whenever, upon the trial of any person for a crime, it appears that
6 the offense was committed in another state or country, under such
7 circumstances that the courts of this state had jurisdiction thereof,
8 and that the defendant has already been acquitted or convicted upon the
9 merits, in a judicial proceeding conducted under the criminal laws of
10 such state or country, founded upon the act or omission with respect to
11 which he or she is upon trial, such former acquittal or conviction is
12 a sufficient defense. Nothing in this section affects or prevents a
13 prosecution in a court of this state of any person who has received
14 administrative or nonjudicial punishment, civilian or military, in
15 another state or country based upon the same act or omission.

16 **Sec. 1043.** RCW 10.43.050 and 1909 c 249 s 64 are each amended to
17 read as follows:

18 No order of dismissal or directed verdict of not guilty on the
19 ground of a variance between the indictment or information and the
20 proof, or on the ground of any defect in such indictment or
21 information, shall bar another prosecution for the same offense.
22 Whenever a defendant shall be acquitted or convicted upon an indictment
23 or information charging a crime consisting of different degrees, he or
24 she cannot be proceeded against or tried for the same crime in another
25 degree, nor for an attempt to commit such crime, or any degree thereof.

26 **Sec. 1044.** RCW 10.46.060 and 1891 c 28 s 23 are each amended to
27 read as follows:

28 When a defendant is designated in the indictment or information by
29 a fictitious or erroneous name, and in any stage of the proceedings his
30 or her true name is discovered, it may be inserted in the subsequent
31 proceedings, referring to the fact of his or her being indicted or
32 informed against by the name mentioned in the indictment or
33 information.

1 **Sec. 1045.** RCW 10.46.110 and Code 1881 s 1092 are each amended to
2 read as follows:

3 When two or more persons are included in one prosecution, the court
4 may, at any time before the defendant has gone into his or her defense,
5 direct any defendant to be discharged, that he or she may be a witness
6 for the state. A defendant may also, when there is not sufficient
7 evidence to put him or her on his or her defense, at any time before
8 the evidence is closed, be discharged by the court, for the purpose of
9 giving evidence for a codefendant. The order of discharge is a bar to
10 another prosecution for the same offense.

3 (1) The arrest of a person may be lawfully made also by any peace

28 been committed and reasonable cause to believe that the person to be
29 arrested has committed it; or

30 (v) The officer has received positive information by written,
31 telegraphic, teletypic, telephonic, radio, or other authoritative
32 source that a peace officer holds a warrant for the person's arrest;
33 and

34 (c) The regional commissioner of customs certifies to the state of
35 Washington that the customs officer has received proper training within
36 the agency to enable that officer to enforce or administer this
37 subsection.

1 **Sec. 1077.** RCW 10.88.340 and 1971 ex.s. c 46 s 15 are each amended
2 to read as follows:

3 If from the examination before the judge or magistrate it appears
4 that the person held is the person charged with having committed the
5 crime alleged and, except in cases arising under RCW 10.88.250, that he

7 warrant reciting the accusation, commit him or_her to the county jail
8 for such a time not exceeding thirty days and specified in the warrant,

32 of the indictment returned, or information and affidavit filed, or of
33 the complaint made to the judge or magistrate, stating the offense with
34 which the accused is charged, or of the judgment of conviction or of
35 the sentence. The prosecuting officer, parole board, warden, or
36 sheriff may also attach such further affidavits and other documents in
37 duplicate as he or she shall deem proper to be submitted with such

1 application. One copy of the application, with the action of the
2 governor indicated by endorsement thereon, and one of the certified
3 copies of the indictment, complaint, information, and affidavits, or of
4 the judgment of conviction or of the sentence shall be filed in the
5 office of the secretary of state to remain of record in that office.
6 The other copies of all papers shall be forwarded with the governor's
7 requisition.

2 on hand or anticipated and the income to be received and disbursements

7 shall faithfully discharge the office and trust of such guardian or

22 and for the use and benefit of any person entitled by the breach
23 thereof, until the whole penalty is recovered thereon. The court may
24 require an additional bond whenever for any reason it appears to the
25 court that an additional bond should be given.

26 In all guardianships or limited guardianships of the person, and in
27 all guardianship or limited guardianships of the estate, in which the
28 petition alleges that the alleged incapacitated person has total assets
29 of a value of less than three thousand dollars, the court may dispense
30 with the requirement of a bond pending filing of an inventory

33 to report to the court any changes in the total assets of the

37 person if said monthly income, excluding moneys from state or federal

1 benefits, is over the sum of five hundred dollars per month for any

5 (1) Upon the death of an incapacitated person, a guardian or
6 limited guardian of the estate shall have authority to disburse or

25 under his or her letters of guardianship or limited guardianship, he or
26 she shall petition the court for an order transferring the guardianship
27 or limited guardianship proceeding to a probate proceeding, and upon
28 court approval, the clerk of the court shall re-index the cause as a
29 decedent's estate, using the same file number which was assigned to the
30 guardianship or limited guardianship proceeding. The guardian or
31 limited guardian shall then be authorized to continue administration of
32 the estate without the necessity for any further petition or hearing.
33 Notice to creditors and other persons interested in the estate shall be
34 published and may be combined with the notice of the guardian's or
35 limited guardian's final account. This notice shall be given and

37 hearing, the account may be allowed and the balance distributed to the

1 persons entitled thereto, after the payment of such claims as may be

6 administration are granted upon petition filed within forty days after
7 the death of the incapacitated person, the personal representative
8 shall supersede the guardian or limited guardian in the administration
9 of the estate and the estate shall be administered as a decedent's
10 estate as provided in this title, including the publication of notice
11 to creditors and other interested persons and the barring of creditors
12 claims.

13 **Sec. 2090.** RCW 11.92.115 and 1990 c 122 s 30 are each amended to

15 The guardian or limited guardian making any sale of real estate,
16 either at public or private sale or sale by negotiation, shall within
17 ten days after making such sale file with the clerk of the court his or

20 court may, without notice, approve and confirm such sale and direct

1 authority otherwise given by law, have discretionary power to acquire,

4 by law, and in so doing may:

5 (1) Receive property from any source as additions to the trust or
6 any fund of the trust to be held and administered under the provisions
7 of the trust;

10 (4) Sell or exercise subscriptions to stock or other corporate
11 securities and to exercise conversion rights;

12 (5) Deposit stock or other corporate securities with any protective
13 or other similar committee;

14 (6) Assent to corporate sales, leases, and encumbrances;

15 (7) Vote trust securities in person or by proxy with power of
16 substitution; and enter into voting trusts;

17 (8) Register and hold any stocks, securities, or other property in
18 the name of a nominee or nominees without mention of the trust
19 relationship, provided the trustee or trustees are liable for any loss
20 occasioned by the acts of any nominee, except that this subsection
21 shall not apply to situations covered by subsection (31) of this
22 section;

23 (9) Grant leases of trust property, with or without options to
24 purchase or renew, to begin within a reasonable period and for terms
25 within or extending beyond the duration of the trust, for any purpose
26 including exploration for and removal of oil, gas and other minerals;
27 enter into community oil leases, pooling and unitization agreements;

28 (10) Subdivide, develop, dedicate to public use, make or obtain the
29 vacation of public plats, adjust boundaries, partition real property,
30 and on exchange or partition to adjust differences in valuation by
31 giving or receiving money or money's worth;

32 (11) Compromise or submit claims to arbitration;

33 (12) Borrow money, secured or unsecured, from any source, including
34 a corporate trustee's banking department, or from the individual
35 trustee's own funds;

36 (13) Make loans, either secured or unsecured, at such interest as
37 the trustee may determine to any person, including any beneficiary of
38 a trust, except that no trustee who is a beneficiary of a trust may

1 participate in decisions regarding loans to such beneficiary from the
2 trust, unless the loan is as described in RCW 83.110.020(2), and then
3 only to the extent of the loan, and also except that if a beneficiary
4 or the grantor of a trust has the power to change a trustee of the
5 trust, the power to loan shall be limited to loans at a reasonable rate
6 of interest and for adequate security;

7 (14) Determine the hazards to be insured against and maintain
8 insurance for them;

9 (15) Select any part of the trust estate in satisfaction of any
10 partition or distribution, in kind, in money or both; make nonpro rata
11 distributions of property in kind; allocate particular assets or
12 portions of them or undivided interests in them to any one or more of
13 the beneficiaries without regard to the income tax basis of specific
14 property allocated to any beneficiary and without any obligation to
15 make an equitable adjustment;

16 (16) Pay any income or principal distributable to or for the use of
17 any beneficiary, whether that beneficiary is under legal disability, to
18 the beneficiary or for the beneficiary's use to the beneficiary's
19 parent, guardian, custodian under the uniform gifts to minors act of
20 any state, person with whom he or she resides, or third person;

21 (17) Change the character of or abandon a trust asset or any
22 interest in it;

23 (18) Mortgage, pledge the assets or the credit of the trust estate,
24 or otherwise encumber trust property, including future income, whether
25 an initial encumbrance or a renewal or extension of it, for a term
26 within or extending beyond the term of the trust, in connection with
27 the exercise of any power vested in the trustee;

28 (19) Make ordinary or extraordinary repairs or alterations in
29 buildings or other trust property, demolish any improvements, raze
30 existing structures, and make any improvements to trust property;

31 (20) Create restrictions, easements, including easements to public
32 use without consideration, and other servitudes;

33 (21) Manage any business interest, including any farm or ranch
34 interest, regardless of form, received by the trustee from the trustor
35 of the trust, as a result of the death of a person, or by gratuitous
36 transfer from any other transferor, and with respect to the business
37 interest, have the following powers:

1 (a) To hold, retain, and continue to operate that business interest
2 solely at the risk of the trust, without need to diversify and without
3 liability on the part of the trustee for any resulting losses;

4 (b) To enlarge or diminish the scope or nature or the activities of
5 any business;

6 (c) To authorize the participation and contribution by the business
7 to any employee benefit plan, whether or not qualified as being tax
8 deductible, as may be desirable from time to time;

9 (d) To use the general assets of the trust for the purpose of the
10 business and to invest additional capital in or make loans to such
11 business;

12 (e) To endorse or guarantee on behalf of the trust any loan made to
13 the business and to secure the loan by the trust's interest in the
14 business or any other property of the trust;

15 (f) To leave to the discretion of the trustee the manner and degree
16 of the trustee's active participation in the management of the
17 business, and the trustee is authorized to delegate all or any part of
18 the trustee's power to supervise, manage, or operate to such persons as
19 the trustee may select, including any partner, associate, director,
20 officer, or employee of the business; and also including electing or
21 employing directors, officers, or employees of the trustee to take part
22 in the management of the business as directors or officers or
23 otherwise, and to pay that person reasonable compensation for services
24 without regard to the fees payable to the trustee;

25 (g) To engage, compensate, and discharge or to vote for the
26 engaging, compensating, and discharging of managers, employees, agents,
27 lawyers, accountants, consultants, or other representatives, including
28 anyone who may be a beneficiary of the trust or any trustee;

29 (h) To cause or agree that surplus be accumulated or that dividends
30 be paid;

31 (i) To accept as correct financial or other statements rendered by
32 any accountant for any sole proprietorship or by any partnership or
33 corporation as to matters pertaining to the business except upon actual
34 notice to the contrary;

35 (j) To treat the business as an entity separate from the trust, and
36 in any accounting by the trustee it is sufficient if the trustee
37 reports the earning and condition of the business in a manner
38 conforming to standard business accounting practice;

1 (k) To exercise with respect to the retention, continuance, or
2 disposition of any such business all the rights and powers that the
3 trustor of the trust would have if alive at the time of the exercise,
4 including all powers as are conferred on the trustee by law or as are
5 necessary to enable the trustee to administer the trust in accordance
6 with the instrument governing the trust, subject to any limitations
7 provided for in the instrument; and

8 (l) To satisfy contractual and tort liabilities arising out of an
9 unincorporated business, including any partnership, first out of the
10 business and second out of the estate or trust, but in no event may
11 there be a liability of the trustee, except as provided in RCW
12 11.98.110 (2) and (4), and if the trustee is liable, the trustee is
13 entitled to indemnification from the business and the trust,
14 respectively;

15 (22) Participate in the establishment of, and thereafter in the
16 operation of, any business or other enterprise according to subsection
17 (21) of this section except that the trustee shall not be relieved of
18 the duty to diversify;

19 (23) Cause or participate in, directly or indirectly, the
20 formation, reorganization, merger, consolidation, dissolution, or other
21 change in the form of any corporate or other business undertaking where
22 trust property may be affected and retain any property received
23 pursuant to the change;

24 (24) Limit participation in the management of any partnership and
25 act as a limited or general partner;

26 (25) Charge profits and losses of any business operation, including
27 farm or ranch operation, to the trust estate as a whole and not to the
28 trustee; make available to or invest in any business or farm operation
29 additional moneys from the trust estate or other sources;

30 (26) Pay reasonable compensation to the trustee or co-trustees
31 considering all circumstances including the time, effort, skill, and
32 responsibility involved in the performance of services by the trustee;

33 (27) Employ persons, including lawyers, accountants, investment
34 advisors, or agents, even if they are associated with the trustee, to
35 advise or assist the trustee in the performance of the trustee's duties
36 or to perform any act, regardless of whether the act is discretionary,
37 and to act without independent investigation upon their
38 recommendations, except that:

1 (a) A trustee may not delegate all of the trustee's duties and
2 responsibilities;

3 (b) This power to employ and to delegate duties does not relieve
4 the trustee of liability for such person's discretionary acts, that, if
5 done by the trustee, would result in liability to the trustee;

6 (c) This power to employ and to delegate duties does not relieve
7 the trustee of the duty to select and retain a person with reasonable
8 care;

9 (d) The trustee, or a successor trustee, may sue the person to
10 collect any damages suffered by the trust estate even though the
11 trustee might not be personally liable for those damages, subject to
12 the statutes of limitation that would have applied had the claim been
13 one against the trustee who was serving when the act or failure to act
14 occurred;

15 (28) Appoint an ancillary trustee or agent to facilitate management
16 of assets located in another state or foreign country;

17 (29) Retain and store such items of tangible personal property as
18 the trustee selects and pay reasonable storage charges thereon from the
19 trust estate;

20 (30) Issue proxies to any adult beneficiary of a trust for the
21 purpose of voting stock of a corporation acting as the trustee of the
22 trust;

23 (31) Place all or any part of the securities at any time held by
24 the trustee in the care and custody of any bank, trust company, or
25 member firm of the New York Stock Exchange with no obligation while the
26 securities are so deposited to inspect or verify the same and with no
27 responsibility for any loss or misapplication by the bank, trust
28 company, or firm, so long as the bank, trust company, or firm was
29 selected and retained with reasonable care, and have all stocks and
30 registered securities placed in the name of the bank, trust company, or
31 firm, or in the name of its nominee, and to appoint such bank, trust
32 company, or firm agent as attorney to collect, receive, receipt for,
33 and disburse any income, and generally may perform, but is under no
34 requirement to perform, the duties and services incident to a so-called
35 "custodian" account;

36 (32) Determine at any time that the corpus of any trust is
37 insufficient to implement the intent of the trust, and upon this
38 determination by the trustee, terminate the trust by distribution of

1 the trust to the current income beneficiary or beneficiaries of the
2 trust or their legal representatives, except that this determination
3 may only be made by the trustee if the trustee is neither the grantor
4 nor the beneficiary of the trust, and if the trust has no charitable
5 beneficiary;

6 (33) Continue to be a party to any existing voting trust agreement
7 or enter into any new voting trust agreement or renew an existing
8 voting trust agreement with respect to any assets contained in trust;
9 and

10 (34)(a) Donate a qualified conservation easement, as defined by
11 section 2031(c) of the internal revenue code, on any real property, or
12 consent to the donation of a qualified conservation easement on any
13 real property by a personal representative of an estate of which the
14 trustee is a devisee, to obtain the benefit of the estate tax exclusion
15 allowed under section 2031(c) of the internal revenue code or the
16 deduction allowed under section 2055(f) of the internal revenue code as
17 long as:

18 (i)(A) The governing instrument authorizes the donation of a
19 qualified conservation easement on the real property; or

20 (B) Each beneficiary that may be affected by the qualified
21 conservation easement consents to the donation under the provisions of
22 chapter 11.96A RCW; and

23 (ii) The donation of a qualified conservation easement will not
24 result in the insolvency of the decedent's estate.

25 (b) The authority granted under this subsection includes the
26 authority to amend a previously donated qualified conservation
27 easement, as defined under section 2031(c)(8)(B) of the internal
28 revenue code, and to amend a previously donated unqualified
29 conservation easement for the purpose of making the easement a
30 qualified conservation easement under section 2031(c)(8)(B).

31 **Sec. 2092.** RCW 11.106.030 and 1985 c 30 s 97 are each amended to

20 check the names, residence, and registration of the signers with the
21 records of his or her office and shall, as soon as possible, certify to
22 said board the number of qualified signers. If the requisite number of
23 signers is so certified, the board shall thereupon place the
24 proposition: "Shall a county airport district be established in the
25 following area: (describing the proposed district)?," upon the ballot
26 for vote of the people of the proposed district at the next election,
27 general or special. If a majority of the voters on such proposition
28 shall vote in favor of the proposition, the board, shall, by
29 resolution, declare the district established. If the requisite number
30 of qualified persons have not signed the application, further
31 signatures may be added and certified until the requisite number have
32 signed and the above procedure shall be thereafter followed.

33 The area of such district may be the area of the county including
34 incorporated cities and towns, or such portion or portions thereof as
35 the board may determine to be the most feasible for establishing an

1 airport. When established, an airport district shall be a municipality
2 as defined in this chapter and entitled to all the powers conferred by
3 this chapter and exercised by municipal corporations in this state.
4 The airport district is hereby empowered to levy not more than
5 seventy-five cents per thousand dollars of assessed value of the
6 property lying within the said airport district: PROVIDED, HOWEVER,
7 Such levy shall not be made unless first approved at any election
8 called for the purpose of voting on such levy.

9 **Sec. 5002.** RCW 14.08.112 and 1983 c 167 s 16 are each amended to
10 read as follows:

11 (1) Municipalities, including any governmental subdivision which
12 may be hereafter authorized by law to own, control, and operate an
13 airport or other air navigation facility, are hereby authorized to
14 issue revenue bonds to provide part or all of the funds required to
15 accomplish the powers granted them by chapter 14.08 RCW, and to
16 construct, acquire by purchase or condemnation, equip, add to, extend,
17 enlarge, improve, replace and repair airports, facilities and
18 structures thereon including but not being limited to facilities for
19 the servicing of aircraft and for the comfort and accommodation of air
20 travelers, and other properties incidental to the operation of airports
21 and to pay all costs incidental thereto.

22 The legislative body of the municipality shall create a special
23 fund for the sole purpose of paying the principal of and interest on
24 the bonds of each issue, into which fund the legislative body shall
25 obligate the municipality to pay an amount of the gross revenue derived
26 from its ownership, control, use, and operation of the airport and all
27 airport facilities and structures thereon and used and operated in
28 connection therewith, including but not being limited to fees charged
29 for all uses of the airport and facilities, rentals derived from leases
30 of part or all of the airport, buildings and any or all air navigation
31 facilities thereon, fees derived from concessions granted, and proceeds
32 of sales of part or all of the airport and any or all buildings and
33 structures thereon or equipment therefor, sufficient to pay the
34 principal and interest as the same shall become due, and to maintain
35 adequate reserves therefor if necessary. Revenue bonds and the
36 interest thereon shall be payable only out of and shall be a valid

1 claim of the owner thereof only as against the special fund and the
2 revenue pledged to it, and shall not constitute a general indebtedness
3 of the municipality.

4 Each revenue bond and any interest coupon attached thereto shall
5 name the fund from which it is payable and state upon its face that it
6 is only payable therefrom; however, all revenue bonds and any interest
7 coupons issued under RCW 14.08.112 and 14.08.114 shall be negotiable
8 instruments within the provisions and intent of the negotiable
9 instruments law of this state. Each issue of revenue bonds may be
10 bearer coupon bonds or may be registered either as to principal only or
11 as to principal and interest as provided in RCW 39.46.030; shall be in
12 the denomination or denominations the legislative body of the
13 municipality shall deem proper; shall be payable at the time or times
14 and at the place or places as shall be determined by the legislative
15 body; shall bear interest at such rate or rates as authorized by the
16 legislative body; shall be signed on behalf of the municipality by the
17 (~~chairman~~) chair of the county legislative authority, mayor of the
18 city or town, president of the port commission, and similar officer of
19 any other municipality, shall be attested by the county auditor, the
20 clerk or comptroller of the city or town, the secretary of the port
21 commission, and similar officer of any other municipality, one of which
22 signatures may be a facsimile signature, and shall have the seal of the
23 municipality impressed thereon; any interest coupons attached thereto
24 shall be signed by the facsimile signatures of said officials. Revenue
25 bonds shall be sold in the manner as the legislative body of the
26 municipality shall deem best, either at public or private sale.

27 The municipality at the time of the issuance of revenue bonds may
28 provide covenants as it may deem necessary to secure and guarantee the
29 payment of the principal thereof and interest thereon, including but
30 not being limited to covenants to create a reserve fund or account and
31 to authorize the payment or deposit of certain moneys therein for the
32 purpose of securing or guaranteeing the payment of the principal and
33 interest, to establish and maintain rates, charges, fees, rentals, and
34 sales prices sufficient to pay the principal and interest and to
35 maintain an adequate coverage over annual debt service, to appoint a
36 trustee for the bond owners and a trustee for the safeguarding and
37 disbursing of the proceeds of sale of the bonds and to fix the powers
38 and duties of the trustee or trustees, and to make any and all other

1 covenants as the legislative body may deem necessary to its best
2 interest and that of its inhabitants to accomplish the most
3 advantageous sale possible of the bonds. The legislative body may also
4 provide that revenue bonds payable out of the same source or sources
5 may later be issued on a parity with revenue bonds being issued and
6 sold.

7 The legislative body of the municipality may include an amount for
8 working capital and an amount necessary for interest during the period
9 of construction of the airport or any facilities plus six months, in
10 the principal amount of any revenue bond issue; if it deems it to the
11 best interest of the municipality and its inhabitants, it may provide
12 in any contract for the construction or acquisition of an airport or
13 facilities that payment therefor shall be made only in revenue bonds at
14 the par value thereof.

15 If the municipality or any of its officers shall fail to carry out
16 any of its or their obligations, pledges or covenants made in the
17 authorization, issuance and sale of bonds, the owner of any bond or the
18 trustee may bring action against the municipality and/or said officers
19 to compel the performance of any or all of the covenants.

20 (2) Notwithstanding subsection (1) of this section, such bonds may
21 be issued and sold in accordance with chapter 39.46 RCW.

22 **Sec. 5003.** RCW 14.12.030 and 1945 c 174 s 3 are each amended to
23 read as follows:

24 (1) In order to prevent the creation or establishment of airport
25 hazards, every political subdivision having an airport hazard area
26 within its territorial limits may adopt, administer, and enforce, under
27 the police power and in the manner and upon the conditions hereinafter
28 prescribed, airport zoning regulations for such airport hazard area,
29 which regulations may divide such area into zones, and, within such
30 zones, specify the land uses permitted and regulate and restrict the
31 height to which structures and trees may be erected or allowed to grow.

32 (2) Where an airport is owned or controlled by a political
33 subdivision and any airport hazard area appertaining to such airport is
34 located outside the territorial limits of said political subdivision,
35 the political subdivision owning or controlling the airport and the
36 political subdivision within which the airport hazard area is located
37 may, by ordinance or resolution duly adopted, create a joint airport

1 zoning board, which board shall have the same power to adopt,
2 administer, and enforce airport zoning regulations applicable to the
3 airport hazard area in question as that vested by subsection (1) of
4 this section in the political subdivision within which such area is
5 located. Each such joint board shall have as members two
6 representatives appointed by each political subdivision participating
7 in its creation and in addition a (~~chairman~~) chair elected by a
8 majority of the members so appointed.

9 **Sec. 5004.** RCW 14.12.110 and 1945 c 174 s 7 are each amended to
10 read as follows:

11 (1) Permits. Any airport zoning regulations adopted under this
12 chapter may require that a permit be obtained before any new structure
13 or use may be constructed or established and before any existing use or
14 structure may be substantially changed or substantially altered or
15 repaired. In any event, however, all such regulations shall provide
16 that before any nonconforming structure or tree may be replaced,
17 substantially altered or repaired, rebuilt, allowed to grow higher, or
18 replanted, a permit must be secured from the administrative agency
19 authorized to administer and enforce the regulations, authorizing such
20 replacement, change, or repair. No permit shall be granted that would
21 allow the establishment or creation of an airport hazard or permit a
22 nonconforming structure or tree or nonconforming use to be made or
23 become higher or become a greater hazard to air navigation than it was
24 when the applicable regulation was adopted or than it is when the
25 application for a permit is made. Except as provided herein, all
26 applications for permits shall be granted.

27 (2) Variances. Any person desiring to erect any structure, or
28 increase the height of any structure, or permit the growth of any tree,
29 or otherwise use his or her property in violation of airport zoning
30 regulations adopted under this chapter, may apply to the board of
31 adjustment for a variance from the zoning regulations in question.
32 Such variances shall be allowed where a literal application or
33 enforcement of the regulations would result in practical difficulty or
34 unnecessary hardship and the relief granted would not be contrary to
35 the public interest but do substantial justice and be in accordance
36 with the spirit of the regulations and this chapter: PROVIDED, That

1 any variance may be allowed subject to any reasonable conditions that
2 the board of adjustment may deem necessary to effectuate the purposes
3 of this chapter.

4 (3) Hazard marking and lighting. In granting any permit or
5 variance under this section, the administrative agency or board of
6 adjustment may, if it deems such action advisable to effectuate the
7 purposes of this chapter and reasonable in the circumstances, so
8 condition such permit or variance as to require the owner of the
9 structure or tree in question to permit the political subdivision, at
10 its own expense, to install, operate, and maintain thereon such markers
11 and lights as may be necessary to indicate to flyers the presence of an
12 airport hazard.

13 **Sec. 5005.** RCW 14.12.140 and 1945 c 174 s 10 are each amended to
14 read as follows:

15 (1) All airport zoning regulations adopted under this chapter shall
16 provide for a board of adjustment to have and exercise the following
17 powers:

18 (a) To hear and decide appeals from any order, requirement,
19 decision, or determination made by the administrative agency in the
20 enforcement of the airport zoning regulations, as provided in RCW
21 14.12.190.

22 (b) To hear and decide any special exceptions to the terms of the
23 airport zoning regulations upon which such board may be required to
24 pass under such regulations.

25 (c) To hear and decide specific variances under RCW 14.12.110(2).

26 (2) Where a zoning board of appeals or adjustment already exists,
27 it may be appointed as the board of adjustment. Otherwise, the board
28 of adjustment shall consist of five members, each to be appointed for
29 a term of three years by the authority adopting the regulations and to
30 be removable by the appointing authority for cause, upon written
31 charges and after public hearing.

32 (3) The concurring vote of a majority of the members of the board
33 of adjustment shall be sufficient to reverse any order, requirement,
34 decision, or determination of the administrative agency, or to decide
35 in favor of the applicant on any matter upon which it is required to
36 pass under the airport zoning regulations, or to effect any variation
37 in such regulations.

1 (4) The board shall adopt rules in accordance with the provisions
2 of the ordinance or resolution by which it was created. Meetings of
3 the board shall be held at the call of the ((~~chairman~~)) chair and at
4 such other times as the board may determine. The ((~~chairman~~)) chair,
5 or in his or her absence the acting ((~~chairman~~)) chair, may administer
6 oaths and compel the attendance of witnesses. All hearings of the
7 board shall be public. The board shall keep minutes of its
8 proceedings, showing the vote of each member upon each question, or, if
9 absent or failing to vote, indicating such fact, and shall keep records
10 of its examinations and other official actions, all of which shall
11 immediately be filed in the office of the board and shall be a public
12 record.

13 **Sec. 5006.** RCW 14.16.010 and 1984 c 7 s 8 are each amended to read
14 as follows:

15 In this chapter "aircraft" means any contrivance now known or
16 hereafter invented, used, or designed for navigation of or flight in
17 the air, except a parachute or other contrivance designed for such
18 navigation but used primarily as safety equipment. The term "airman"
19 or "airwoman" means any individual (including the person in command and
20 any pilot, mechanic, or member of the crew) who engages in the
21 navigation of aircraft while under way and any individual who is in
22 charge of the inspection, overhauling, or repairing of aircraft.
23 "Operating aircraft" means performing the services of aircraft pilot.
24 "Person" means any individual, proprietorship, partnership,
25 corporation, or trust. "Downed aircraft rescue transmitter" means a
26 transmitter of a type approved by the state department of
27 transportation or the federal aviation administration with sufficient
28 transmission power and reliability that it will be automatically
29 activated upon the crash of an aircraft so as to transmit a signal on
30 a preset frequency so that it will be effective to assist in the
31 location of the downed aircraft. "Air school" means air school as
32 defined in RCW 47.68.020(11).

33 **Sec. 5007.** RCW 14.16.030 and 1929 c 157 s 3 are each amended to
34 read as follows:

35 The public safety requiring and the advantages of uniform
36 regulation making it desirable in the interest of aeronautical progress

1 that a person serving as an airman or airwoman within this state should
2 have the qualifications necessary for obtaining and holding the class
3 of license required by the United States government with respect to
4 such an airman or airwoman subject to its jurisdiction, it shall be
5 unlawful for any person to serve as an airman or airwoman within this
6 state unless he (~~have~~) or she has such a license: PROVIDED, HOWEVER,
7 That for the first thirty days after entrance into this state this
8 section shall not apply to nonresidents of this state operating
9 aircraft within this state, other than aircraft carrying persons or
10 property for hire, if such person shall have fully complied with the
11 laws of the state, territory or foreign country of his or her residence
12 respecting the licensing of airmen or airwomen.

13 **Sec. 5008.** RCW 14.16.040 and 1929 c 157 s 4 are each amended to
14 read as follows:

15 The certificate of the license herein required shall be kept in the
16 personal possession of the licensee when he or she is serving as an
17 airman or airwoman within this state, and must be presented for
18 inspection upon the demand of any passenger, any peace officer of this
19 state, or any official, manager, or person in charge of any airport or
20 landing field in this state upon which he or she shall land.

21 **Sec. 5009.** RCW 14.20.030 and 1984 c 7 s 11 are each amended to
22 read as follows:

23 Applications for an aircraft dealer's license shall contain:

24 (1) The name under which the dealer's business is conducted and the
25 address of the dealer's established place of business;

26 (2) The residence address of each owner, director, or principal
27 officer of the aircraft dealer, and, if a foreign corporation, the
28 state of incorporation and names of its resident officers or managers;

29 (3) The make or makes of aircraft for which franchised, if any;

30 (4) Whether or not used aircraft are dealt in;

31 (5) A certificate that the applicant is a dealer having an
32 established place of business at the address shown on the application,
33 which place of business is open during regular business hours to
34 inspection by the secretary or his or her representatives; and

35 (6) Whether or not the applicant has ever been denied an aircraft

1 dealer's license or has had one which has been denied, suspended, or
2 revoked.

3 **Sec. 5010.** RCW 14.20.050 and 1998 c 187 s 1 are each amended to
4 read as follows:

5 The fee for original aircraft dealer's license for each calendar
6 year or fraction thereof is seventy-five dollars, which includes one
7 aircraft dealer's certificate and which must be renewed annually for a
8 fee of seventy-five dollars. Additional aircraft dealer certificates
9 may be obtained for ten dollars each per year. If any dealer fails or
10 neglects to apply for renewal of his or her license prior to February
11 1st in each year, his or her license shall be declared canceled by the
12 secretary, in which case any such dealer desiring a license shall
13 reapply and pay a fee of seventy-five dollars.

14 **Sec. 5011.** RCW 14.20.070 and 1984 c 7 s 15 are each amended to
15 read as follows:

16 Before issuing an aircraft dealer license, the secretary shall
17 require the applicant to file with the secretary a surety bond in the
18 amount of twenty-five thousand dollars running to the state, and
19 executed by a surety company authorized to do business in the state.
20 The bond shall be approved by the attorney general as to form and
21 conditioned that the dealer shall conduct his or her business in
22 conformity with the provisions of this chapter, RCW 47.68.250, and
23 82.48.100. Any person who has suffered any loss or damage by reason of
24 any act by a dealer which constitutes ground for refusal, suspension,
25 or revocation of license under RCW 14.20.090 has a right of action
26 against the aircraft dealer and the surety upon the bond. Successive

28 liability of the surety to all persons shall in no event exceed the
29 amount of the bond.

32 The secretary shall refuse to issue an aircraft dealer's license or
33 shall suspend or revoke an aircraft dealer's license whenever he or she
34 has reasonable grounds to believe that the dealer has:

1 (1) Forged or altered any federal certificate, permit, rating, or
2 license relating to ownership and airworthiness of an aircraft;

3 (2) Sold or disposed of an aircraft which he or she knows or has
4 reason to know has been stolen or appropriated without the consent of
5 the owner;

6 (3) Wilfully misrepresented any material fact in the application
7 for an aircraft dealer's license, aircraft dealer's certificate, or
8 registration certificate;

9 (4) Wilfully withheld or caused to be withheld from a purchaser of
10 an aircraft any document referred to in subsection (1) of this section
11 if applicable, or an affidavit to the effect that there are no liens,
12 mortgages, or encumbrances of any type on the aircraft other than noted
13 thereon, if the document or affidavit has been requested by the
14 purchaser;

15 (5) Suffered or permitted the cancellation of his or her bond or
16 the exhaustion of the penalty thereof;

17 (6) Used an aircraft dealer's certificate for any purpose other
18 than those permitted by this chapter or RCW 47.68.250 and 82.48.100;

19 (7) Been adjudged guilty of a crime that directly relates to the
20 business of an aircraft dealer and the time elapsed since the
21 conviction is less than ten years, or had a judgment entered against
22 the dealer within the preceding five years in any civil action
23 involving fraud, misrepresentation, or conversion. For the purpose of
24 this section, the term "adjudged guilty" means, in addition to a final
25 conviction in either a state or municipal court, an unvacated
26 forfeiture of bail or collateral deposited to secure a defendant's
27 appearance in court, the payment of a fine, a plea of guilty, or a
28 finding of guilt regardless of whether the imposition of the sentence
29 is deferred or the penalty is suspended.

31 **Sec. 6001.** RCW 14.20.100 and 1984 c 7 s 17 are each amended to
32 read as follows:

33 If the secretary issues an order that any person is not entitled to
34 an aircraft dealer's license or that an existing license should be
35 suspended or revoked, he or she shall forthwith notify the applicant or
36 dealer in writing. The applicant has thirty days from the date of the

1 secretary's order to appeal therefrom to the superior court of Thurston
2 county, which he or she may do by filing a notice of the appeal with
3 the clerk of the superior court and at the same time filing a copy of
4 the notice with the secretary.

5 **Sec. 6002.** RCW 15.04.090 and 1998 c 345 s 1 are each amended to
6 read as follows:

7 The director of agriculture may, at his or her discretion, for a
8 period of not to exceed ten years, lease state lands which are now or

11 needs, to any nonprofit group or organization having educational,
12 agricultural, or youth development purposes. Such leases shall be upon

15 shall be deposited in the fair fund created under RCW 15.76.115.

16 **Sec. 6003.** RCW 15.04.110 and 1961 c 247 s 1 are each amended to
17 read as follows:

18 The director of the state department of agriculture may control
19 birds which he or she determines to be injurious to agriculture, and
20 for this purpose enter into written agreements with the federal and
21 state governments, political subdivisions and agencies of such
22 governments, political subdivisions and agencies of this state
23 including counties, municipal corporations and associations and
24 individuals, when such cooperation will implement the control of
25 predatory birds injurious to agriculture.

26 **Sec. 6004.** RCW 15.04.160 and 1975 1st ex.s. c 238 s 2 are each
27 amended to read as follows:

28 (1) An employee engaged to pick berries in this state outside of
29 school hours for the school district where such employee is living
30 while so employed may be less than twelve years of age: PROVIDED, That
31 (a) the employee is employed with the consent of his or her parent or
32 person standing in the place of his or her parent, (b) the berries are
33 for sale within the state only, and are not to be shipped out of the
34 state in any form; (c) the secretary of agriculture or his or her
35 designated representative has certified that there are not sufficient

1 workers available in the immediate area to harvest the crop without
2 such youthful employees, and (d) all employees of any employer engaging
3 youthful employees are paid at the same rate for picking berries.

4 (2) Each basket, package, or other container containing berries or
5 berry products picked by an employee under twelve years of age shall be
6 distinctively marked so as to insure that the berries do not enter
7 interstate commerce: PROVIDED HOWEVER, That nothing in RCW 15.04.150
8 and 15.04.160 shall apply to employers who are exempt from the federal
9 fair labor standards act.

10 **Sec. 6005.** RCW 15.08.010 and 1981 c 296 s 4 are each amended to
11 read as follows:

12 As used in this chapter:

13 (1) "Supervisor" means an assistant director known as the
14 supervisor of plant industry.

15 (2) "Horticultural premises" includes orchards, vineyards,
16 nurseries, berry farms, vegetable farms, cultivated cranberry marshes,
17 packing houses, dryhouses, warehouses, depots, docks, cars, vessels and
18 other places where nursery stock, fruits, vegetables and other
19 horticultural products are grown, stored, packed, shipped, held for
20 shipment or delivery, sold or otherwise disposed of.

21 (3) "Nursery stock" includes, but is not limited to, any
22 horticultural, floricultural, viticultural, and vegetable plant, for
23 planting, propagation or ornamentation, growing or otherwise, including
24 cut plant material.

25 (4) "Pests and diseases" means, but is not limited to, any living
26 stage of any insect, mite, nematode, slug, snail, protozoa, or other
27 invertebrate animal, bacteria, fungus, other parasitic plant, weed, or
28 reproductive part thereof, virus or any organism similar to or allied
29 with any of the foregoing, or any infectious substance, which can
30 directly or indirectly injure or cause disease or damage in or to any
31 plant or parts thereof, or any processed, manufactured, or other
32 products of plants.

33 (5) "Nuisance" means any plant, produce or property found in any
34 commercial area upon which is found any pest or disease that is or may
35 be a source of infestation of other properties.

36 (6) "Commercial area" means a district where any horticultural

1 product is being produced to the extent that a producer is dependent
2 thereon, in whole or in part, for his or her livelihood.

3 (7) "Infect," and its derivatives "infected," "infecting," and
4 "infection," means affected by or infested with pests or diseases as
5 above defined.

6 (8) "Disinfect," and its derivatives, means the control, cure, or
7 eradication of such pests or diseases by cutting or destroying infected
8 parts or the application of effective pesticides.

9 **Sec. 6006.** RCW 15.08.040 and 1961 c 11 s 15.08.040 are each
10 amended to read as follows:

11 The director, supervisor, and horticultural inspectors are
12 authorized to at any time enter horticultural premises and any
13 structure where fruit, vegetables, nursery stock, or horticultural
14 products are grown or situated for any purpose, to inspect the same for
15 infection.

16 No person shall hinder or interfere with any such officer in
17 entering or inspecting or performing any duty imposed upon him or her.

18 **Sec. 6007.** RCW 15.08.080 and 1961 c 11 s 15.08.080 are each
19 amended to read as follows:

20 Personal service of said notice shall be made upon the person in
21 possession or in charge of said premises or property if possible. If
22 such person is not the owner, or personal service cannot be made on
23 such person, then a copy of the notice shall be mailed or telegraphed
24 to the owner at his or her home or post office address if known or can
25 with reasonable diligence be ascertained. If personal service cannot
26 be made upon any person in possession or charge of the premises or
27 property and the name and address of the owner thereof are not known or
28 cannot be so ascertained, then the notice shall be served by posting
29 the same in some conspicuous place on the premises where the property
30 to be disinfected or destroyed is situated, which service by posting
31 shall be construed to be constructive personal service upon such owner.
32 If the name and address of the owner are not known or cannot be so
33 ascertained, service upon the person in possession or charge of the
34 premises or property shall constitute substituted personal service upon
35 the owner, in the absence of fraud or gross neglect.

3 Except as hereinabove provided, upon service of said notice the
4 owner or person in possession or charge of the premises or property
5 shall comply with its terms within the time specified. In case of
6 their failure so to do, the inspector may enter the premises and
7 perform or cause to be performed the services required in the notice.
8 He or she shall keep an accurate account of the expense of performing
9 said services, which shall become a lien on the premises or property
10 which may be foreclosed in the manner herein provided. The lien on
11 personal property shall have preference over all other liens.

12 If the inspector has not disinfected or destroyed the property it
13 may be declared a nuisance as herein provided and treated as such.

16 The officer disinfecting personal property may enforce the lien
17 thereon provided for in RCW 15.08.090 by impounding and selling the
18 property. He or she shall give notice of the impounding and proposed
19 sale by posting a written notice in a conspicuous place upon the
20 premises where the property is impounded and serve said notice upon the
21 owner or person in charge of the property in the manner provided for
22 service of notice to disinfect in RCW 15.08.080. Said notice shall
23 state that the property, describing it with reasonable certainty, has
24 been impounded, where it is situated, the amount of costs and expenses
25 charged against it, and that unless same are paid within a specified
26 time the property will be sold to satisfy said charges, accrued
27 transportation and storage charges, if any, and costs of sale. Said
28 specified time shall not be less than ten days after giving of the
29 notice, except that immediate sale may be made of perishable fruits or
30 vegetables.

31 **Sec. 6010.** RCW 15.08.120 and 1961 c 11 s 15.08.120 are each
32 amended to read as follows:

33 The inspector shall make and sign a record of the proceedings,
34 stating the name of the owner or reputed owner of the property, if
35 known; location of the property, date of inspection and the results
36 thereof; date and manner of giving notice to disinfect; failure to

1 disinfect; disinfection by the inspector; the cost thereof in detail;
2 date and manner of giving notice of impounding and sale; date, place,
3 and manner of sale; name of the purchaser; and amount of the proceeds
4 and disposition thereof.

5 Upon demand of the owner or person in charge of the property, the
6 inspector shall furnish him or her with a verified copy of the record,
7 and tender him or her the balance of the proceeds. If no demand is

10 balance of the proceeds to the director, and if it is not claimed by
11 the owner within six months, it shall be deposited in the state
12 treasury.

13 The record or a verified copy thereof shall be admissible in
14 evidence as prima facie evidence of the truth of its contents.

17 The county auditor shall forthwith issue warrants in payment of the
18 labor employed in the work, and thereupon the county shall be

8 expense. The order to show cause and petition shall be served on the
9 owner not less than five days before the hearing date specified in the
10 order in the same manner as a summons and complaint. In the event the
11 owner fails to appear or fails to show by competent evidence that the
12 horticultural pest or disease has been controlled, then the court shall
13 authorize the county horticultural pest and disease board to remove the
14 plants at the owner's expense, to be collected as provided by this
15 chapter. If the procedure provided herein is followed, no action for
16 damages for removal of the plants shall lie against the county
17 horticultural pest and disease board, its officers or agents, or the
18 county in which it is situated.

19 **Sec. 6020.** RCW 15.09.100 and 1969 c 113 s 10 are each amended to

21 Any amount charged to the owner of land in accordance with the
22 provisions of RCW 15.09.080 and 15.09.090 shall be paid by such owner

9 one year, an additional fee of ten dollars shall be assessed and added
10 to the original fee and shall be paid by the applicant before the
11 license shall be issued: PROVIDED, That such additional fee shall not
12 apply if the applicant furnishes an affidavit that he or she has not
13 labeled seed for distribution in this state subsequent to the
14 expiration of his or her prior permit.

15 **Sec. 6066.** RCW 15.58.100 and 1979 c 146 s 2 are each amended to

17 (1) The director shall require the information required under RCW
18 15.58.060 and shall register the label or labeling for such pesticide
19 if he or she determines that:

36 criterion for denying registration of any pesticide.

1 **Sec. 6067.** RCW 15.58.280 and 1989 c 380 s 24 are each amended to
2 read as follows:

3 The sampling and examination of pesticides or devices shall be made
4 under the direction of the director for the purpose of determining
5 whether or not they comply with the requirements of this chapter. The
6 director is authorized, upon presentation of proper identification, to
7 enter any distributor's premises, including any vehicle of transport,
8 at all reasonable times in order to have access to pesticides or
9 devices. If it appears from such examination that a pesticide or
10 device fails to comply with the provisions of this chapter or rules
11 adopted under this chapter, and the director contemplates instituting
12 criminal proceedings against any person, the director shall cause
13 notice to be given to such person. Any person so notified shall be
14 given an opportunity to present his or her views, either orally or in

22 be made upon every material point controverted at the hearing and/or

6 the equally low legal price of any competitor within any one trading
7 area during any one trading period and the director may define in said
8 marketing agreement or order said trading area and said trading period
9 in accordance with generally accepted industry practices; but in any

11 low legal price of a competitor or to liquidate said excess inventory
12 shall be upon the person who sells below cost as above defined. Any
13 marketing agreement or order may authorize use of any money received
14 and of any persons employed thereunder for legal proceedings, of any
15 type and in the name of any person, directed to enforcement of this or
16 any other law in force in the state of Washington relating to the
17 prevention of unfair trade practices.

18 **Sec. 6080.** RCW 15.65.390 and 1987 c 393 s 9 are each amended to
19 read as follows:

20 There is hereby levied, and the director or his or her designee
21 shall collect, upon each and every affected unit of any agricultural
22 commodity specified in any marketing agreement or order an annual
23 assessment which shall be paid by the producer thereof upon each and
24 every such affected unit stored in frozen condition or sold or marketed
25 or delivered for sale or marketed by him or her, and which shall be
26 paid by the handler thereof upon each and every such unit purchased or

6 In every marketing agreement and order the director shall prescribe
7 the rate of such assessment. Such assessment shall be expressed as a

13 until the facility has been notified by the commission that the
14 commodity owner has paid the commission for any assessments imposed by
15 the marketing order.

16 Unless the director has otherwise provided in any marketing order
17 or agreement, assessments payable by producers shall be paid prior to
18 the time when the affected unit is shipped off the farm, and
19 assessments payable to handlers shall be paid prior to the time when
20 the affected units are received by or for the account of the first
21 handler. No affected units shall be transported, carried, shipped,
22 sold, marketed, or otherwise handled or disposed of until every due and
23 payable assessment herein provided for has been paid by the producer or
24 first handler and the receipt issued.

27 Moneys collected by the director or his or her designee pursuant to
28 any marketing order or agreement from any assessment or as an advance

32 enforcement of such order or agreement and carrying out its provisions

8 director or his or her designee when payment is called for by him or

19 **Sec. 7001.** RCW 43.21A.405 and 1973 2nd ex.s. c 30 s 1 are each
20 amended to read as follows:

21 The legislature recognizes that there exists a great risk of
22 potential damage from oil pollution of the waters of the state of
23 Washington and further declares that immediate steps must be undertaken
24 to reduce this risk. The legislature also is aware that such danger is
25 expected to increase in future years in proportion to the increase in
26 the size and cargo capacity of ships, barges, and other waterborne
27 carriers, the construction and operational characteristics of these
28 carriers, the density of waterborne traffic, and the need for a greater
29 supply of petroleum products.

30 A program of systematic baseline studies to be conducted by the
31 department of ecology has been recognized as a vital part of the
32 efforts to reduce the risk of oil pollution of marine waters, and the
33 legislature recognizes that many factors combine to make this effort

3 (d) Prior to making any detailed statement, the responsible
4 official shall consult with and obtain the comments of any public
5 agency which has jurisdiction by law or special expertise with respect
6 to any environmental impact involved. Copies of such statement and the
7 comments and views of the appropriate federal, province, state, and
8 local agencies, which are authorized to develop and enforce
9 environmental standards, shall be made available to the governor, the
10 department of ecology, the ecological commission, and the public, and
11 shall accompany the proposal through the existing agency review
12 processes;

13 (e) Study, develop, and describe appropriate alternatives to
14 recommended courses of action in any proposal which involves unresolved
15 conflicts concerning alternative uses of available resources;

29 read as follows:

30 In the discharge of any duty imposed by this chapter, the committee
31 or any personnel acting under its direction shall have the authority to
32 examine and inspect all properties, equipment, facilities, files,
33 records, and accounts of any state office, department, institution,
34 board, committee, commission, or agency; to administer oaths; and to
35 issue subpoenas, upon approval of a majority of the members of the
36 house or senate rules committee, to compel the attendance of witnesses

1 and the production of any papers, books, accounts, documents, and

25 except those for confidential use only. The director shall charge and
26 collect therefor the actual cost to the department. Any funds accruing
27 to the director of licensing under this section shall be certified and
28 sent to the state treasurer and by him or her deposited to the credit
29 of the highway safety fund.

30 **Sec. 9002.** RCW 46.09.080 and 1990 c 250 s 24 are each amended to
31 read as follows:

32 (1) Each dealer of off-road vehicles in this state who does not
33 have a current "dealer's plate" for vehicle use pursuant to chapter

21 Certificates of ownership when assigned and returned to the
22 department, together with subsequently assigned reissues thereof, shall
23 be retained by the department and appropriately filed and indexed so
24 that at all times it will be possible to trace ownership to the vehicle
25 designated therein:

26 (1) If the interest of an owner in a vehicle passes to another,
27 other than by voluntary transfer, the transferee shall, except as
28 provided in subsection (3) of this section, promptly mail or deliver to
29 the department the last certificate of ownership if available, proof of
30 transfer, and his or her application for a new certificate in the form
31 the department prescribes.

32 (2) If the interest of the owner is terminated or the vehicle is
33 sold under a security agreement by a secured party named in the
34 certificate of ownership, the transferee shall promptly mail or deliver
35 to the department the last certificate of ownership, his or her
36 application for a new certificate in the form the department
37 prescribes, and an affidavit made by or on the behalf of the secured

1 party that the vehicle was repossessed and that the interest of the
2 owner was lawfully terminated or sold pursuant to the terms of the

12 (1) The suspension, revocation, cancellation, or refusal by the

22 highest bidder, or by holding the article or articles for the official
23 use of the agency, when:

10 Before any "farm vehicle", as defined in RCW 46.04.181, shall

29 application by the director; and
30 (5) Place where farm vehicle is principally used or garaged.

31 A fee of five dollars shall be charged for and submitted with such
32 application for an identification decal as in this section provided as
33 to each farm vehicle which fee shall be deposited in the motor vehicle
34 fund and distributed proportionately as otherwise provided for vehicle
35 license fees under RCW 46.68.030. Only one application need be made as
36 to each such vehicle, and the status as an exempt vehicle shall

1 continue until suspended or revoked for misuse, or when such vehicle no
2 longer is used as a farm vehicle.

5 Forms for such temporary permits shall be prescribed and furnished

5 person is then duly licensed as a vehicle driver for the kind of motor
6 vehicle being rented in this state or, in case of a nonresident, then
7 that he or she is duly licensed as a driver under the laws of the state

1 within this state has no driver's license in this state, then such
2 driver shall not be allowed a driver's license until he or she has
3 complied with the requirements of this chapter to the same extent that
4 would be necessary if, at the time of the accident, he or she had held
5 a license or been the owner of a vehicle registered in this state.

6 (2) When a nonresident's driving privilege is suspended pursuant to
7 RCW 46.29.110, the department shall transmit a certified copy of the
8 record or abstract of such action to the official in charge of the
9 issuance of licenses and registration certificates in the state in
10 which such nonresident resides, if the law of such other state provided
11 for action in relation thereto similar to that provided for in
12 subsection (3) of this section.

13 (3) Upon receipt of such certification that the driving privilege
14 of a resident of this state has been suspended or revoked in any such
15 other state pursuant to a law providing for its suspension or
16 revocation for failure to deposit security for the payment of judgments
17 arising out of a motor vehicle accident, under circumstances which
18 would require the department to suspend a nonresident's driving
19 privilege had the accident occurred in this state, the department shall
20 suspend the license of such resident. Such suspension shall continue
21 until such resident furnishes evidence of his or her compliance with
22 the law of such other state relating to the deposit of such security.

7 limit the return of any deposit of security under any other provision
8 of this chapter authorizing such return.

12 convicted of or forfeits any bail or collateral deposited to secure an

13 of liability as are set forth above with respect to an owner's policy
14 of liability insurance.

16 policy shall state the name and address of the named insured, the
17 coverage afforded by the policy, the premium charged therefor, the
18 policy period, and the limits of liability, and shall contain an
19 agreement or be endorsed that insurance is provided under the policy in
20 accordance with the coverage defined in this chapter as respects bodily
21 injury and death or property damage, or both, and is subject to all the

24 vehicle liability policy need not insure any liability under any
25 workers' compensation law nor any liability on account of bodily injury
26 or death of an employee of the insured while engaged in the employment,

29 to property owned by, rented to, in charge of, or transported by the

34 (a) The liability of the insurance carrier with respect to the
35 insurance required by this chapter becomes absolute whenever injury or
36 damage covered by said motor vehicle liability policy occurs; said
37 policy may not be canceled or annulled as to such liability by any
38 agreement between the insurance carrier and the insured after the

1 occurrence of the injury or damage; no statement made by the insured or
2 on his or her behalf and no violation of said policy defeats or voids
3 said policy.

4 (b) The satisfaction by the insured of a judgment for such injury
5 or damage shall not be a condition precedent to the right or duty of
6 the insurance carrier to make payment on account of such injury or
7 damage.

8 (c) The insurance carrier may settle any claim covered by the
9 policy, and if such settlement is made in good faith, the amount
10 thereof is deductible from the limits of liability specified in
11 (~~subdivision (b) of~~) subsection (2)(b) of this section.

12 (d) The policy, the written application therefor, if any, and any
13 rider or endorsement which does not conflict with the provisions of
14 this chapter constitutes the entire contract between the parties.

15 (7) Excess or additional coverage. Any policy which grants the
16 coverage required for a motor vehicle liability policy may also grant
17 any lawful coverage in excess of or in addition to the coverage
18 specified for a motor vehicle liability policy, and such excess or
19 additional coverage is not subject to the provisions of this chapter.
20 With respect to a policy which grants such excess or additional
21 coverage the term "motor vehicle liability policy" applies only to that
22 part of the coverage which is required by this section.

23 (8) Reimbursement provision permitted. Any motor vehicle liability
24 policy may provide that the insured shall reimburse the insurance
25 carrier for any payment the insurance carrier would not have been
26 obligated to make under the terms of the policy except for the
27 provisions of this chapter.

28 (9) Proration of insurance permitted. Any motor vehicle liability
29 policy may provide for the prorating of the insurance thereunder with
30 other valid and collectible insurance.

31 (10) Multiple policies. The requirements for a motor vehicle
32 liability policy may be fulfilled by the policies of one or more
33 insurance carrier which policies together meet such requirements.

34 (11) Binders. Any binder issued pending the issuance of a motor
35 vehicle liability policy is deemed to fulfill the requirements for such
36 a policy.

1 **Sec. 9044.** RCW 46.29.510 and 1963 c 169 s 51 are each amended to
2 read as follows:

3 (1) This chapter shall not be held to apply to or affect policies
4 of automobile insurance against liability which may now or hereafter be
5 required by any other law of this state, and such policies, if they
6 contain an agreement or are endorsed to conform with the requirements
7 of this chapter, may be certified as proof of financial responsibility
8 under this chapter.

9 (2) This chapter shall not be held to apply to or affect policies
10 insuring solely the insured named in the policy against liability
11 resulting from the maintenance or use by persons in the insured's
12 employ or on his or her behalf of vehicles not owned by the insured.

13 **Sec. 9045.** RCW 46.29.540 and 1963 c 169 s 54 are each amended to
14 read as follows:

15 If a judgment, rendered against the principal on any bond described
16 in RCW 46.29.520, shall not be satisfied within thirty days after it
17 has become final, the judgment creditor may, for his or her own use and
18 benefit and at his or her sole expense, bring an action or actions in
19 the name of the state against the company or persons executing such
20 bond, including an action or proceeding to foreclose any lien that may
21 exist upon the real estate of a person who has executed such bond.

35 (7) It is a traffic infraction for any person to perform false or
36 improvised repairs, or repairs in any manner not in accordance with
37 acceptable and customary repair practices, upon a motor vehicle.

1 **Sec. 9051.** RCW 46.32.020 and 2007 c 419 s 8 are each amended to
2 read as follows:

3 (1)(a) The chief of the Washington state patrol may adopt
4 reasonable rules regarding types of vehicles to be inspected,
5 inspection criteria, times for the inspection of vehicle equipment,
6 drivers' qualifications, hours of service, and all other matters with
7 respect to the conduct of vehicle equipment and driver inspections.

8 (b) The chief of the Washington state patrol shall prepare and
9 furnish such stickers, tags, record and report forms, stationery, and

12 assistants as he or she may consider necessary and to fix hours of

20 sell or offer for sale any new pneumatic passenger car tire which does
21 not meet the standards prescribed in this section unless such tires are
22 sold for off-highway use, as evidenced by a statement signed by the
23 purchaser at the time of sale certifying that he or_she is not
24 purchasing such tires for use on the public highways of this state.

25 **Sec. 9054.** RCW 46.37.424 and 1979 ex.s. c 136 s 72 are each
26 amended to read as follows:

27 No person, firm, or corporation shall sell or offer for sale any
28 regrooved tire or shall regroove any tire for use on the public
29 highways of this state which does not meet the standard established by
30 federal motor vehicle standard part 569--regrooved tires, as
31 promulgated by the United States department of transportation under
32 authority of the National Traffic and Motor Vehicle Safety Act of 1966

1 It is a traffic infraction for any person, firm, or corporation to
2 sell or offer for sale any regrooved tire or shall regroove any tire

4 such tires are sold or regrooved for off-highway use, as evidenced by
5 a statement signed by the purchaser or regroover at the time of sale or
6 regrooving certifying that he or she is not purchasing or regrooving
7 such tires for use on the public highways of this state.

8 **Sec. 9055.** RCW 46.37.550 and 1969 c 112 s 3 are each amended to
9 read as follows:

10 It shall be unlawful for any person to sell a motor vehicle in this
11 state if such person has knowledge that the odometer on such motor
12 vehicle has been turned back and if such person fails to notify the
13 buyer, prior to the time of sale, that the odometer has been turned
14 back or that he or she had reason to believe that the odometer has been
15 turned back.

16 **Sec. 9056.** RCW 46.37.560 and 1969 c 112 s 4 are each amended to

18 It shall be unlawful for any person to sell a motor vehicle in this
19 state if such person has knowledge that the odometer on such motor
20 vehicle has been replaced with another odometer and if such person

23 replaced.

27 seller of such vehicle, the purchaser shall be entitled to recover his

30 allegation that the odometer on such vehicle has been tampered with
31 contrary to RCW 46.37.540 and 46.37.550 or replaced contrary to RCW

34 know that the odometer on such vehicle had been so tampered with or

1 replaced and failed to disclose such knowledge to the purchaser prior
2 to the time of sale.

3 **Sec. 9058.** RCW 46.44.047 and 1994 c 172 s 1 are each amended to
4 read as follows:

5 A three axle truck tractor and a two axle pole trailer combination
6 engaged in the operation of hauling logs may exceed by not more than
7 six thousand eight hundred pounds the legal gross weight of the
8 combination of vehicles when licensed, as permitted by law, for sixty-
9 eight thousand pounds: PROVIDED, That the distance between the first
10 and last axle of the vehicles in combination shall have a total
11 wheelbase of not less than thirty-seven feet, and the weight upon two
12 axles spaced less than seven feet apart shall not exceed thirty-three
13 thousand six hundred pounds.

14 Such additional allowances shall be permitted by a special permit
15 to be issued by the department of transportation valid only on state
16 primary or secondary highways authorized by the department and under
17 such rules, regulations, terms, and conditions prescribed by the
18 department. The fee for such special permit shall be fifty dollars for
19 a twelve-month period beginning and ending on April 1st of each
20 calendar year. Permits may be issued at any time, but if issued after
21 July 1st of any year the fee shall be thirty-seven dollars and fifty
22 cents. If issued on or after October 1st the fee shall be twenty-five
23 dollars, and if issued on or after January 1st the fee shall be twelve
24 dollars and fifty cents. A copy of such special permit covering the
25 vehicle involved shall be carried in the cab of the vehicle at all
26 times. Upon the third offense within the duration of the permit for
27 violation of the terms and conditions of the special permit, the
28 special permit shall be canceled. The vehicle covered by such canceled
29 special permit shall not be eligible for a new special permit until
30 thirty days after the cancellation of the special permit issued to said
31 vehicle. The fee for such renewal shall be at the same rate as set
32 forth in this section which covers the original issuance of such
33 special permit. Each special permit shall be assigned to a three-axle
34 truck tractor in combination with a two-axle pole trailer. When the
35 department issues a duplicate permit to replace a lost or destroyed
36 permit and where the department transfers a permit, a fee of fourteen

1 dollars shall be charged for each such duplicate issued or each such
2 transfer.

3 All fees collected hereinabove shall be deposited with the state
4 treasurer and credited to the motor vehicle fund.

5 Permits involving city streets or county roads or using city
6 streets or county roads to reach or leave state highways, authorized
7 for permit by the department may be issued by the city or county or
8 counties involved. A fee of five dollars for such city or county
9 permit may be assessed by the city or by the county legislative
10 authority which shall be deposited in the city or county road fund.
11 The special permit provided for herein shall be known as a "log
12 tolerance permit" and shall designate the route or routes to be used,
13 which shall first be approved by the city or county engineer involved.
14 Authorization of additional route or routes may be made at the
15 discretion of the city or county by amending the original permit or by
16 issuing a new permit. Said permits shall be issued on a yearly basis
17 expiring on March 31st of each calendar year. Any person, firm, or
18 corporation who uses any city street or county road for the purpose of
19 transporting logs with weights authorized by state highway log
20 tolerance permits, to reach or leave a state highway route, without
21 first obtaining a city or county permit when required by the city or
22 the county legislative authority shall be subject to the penalties
23 prescribed by RCW 46.44.105. For the purpose of determining gross
24 weight the actual scale weight taken by the officer shall be prima
25 facie evidence of such total gross weight. In the event the gross
26 weight is in excess of the weight permitted by law, the officer may,
27 within his or her discretion, permit the operator to proceed with his
28 or her vehicles in combination.

29 The chief of the state patrol, with the advice of the department,
30 may make reasonable rules and regulations to aid in the enforcement of
31 the provisions of this section.

32 **Sec. 9059.** RCW 46.52.050 and 1961 c 12 s 46.52.050 are each
33 amended to read as follows:

34 Every coroner or other official performing like functions shall on
35 or before the tenth day of each month, report in writing to the sheriff
36 of the county in which he or she holds office and to the chief of the
37 Washington state patrol the death of any person within his or her

1 jurisdiction during the preceding calendar month as a result of an
2 accident involving any vehicle, together with the circumstances of such
3 accident.

4 **Sec. 9060.** RCW 46.52.070 and 1999 c 351 s 2 are each amended to
5 read as follows:

6 (1) Any police officer of the state of Washington or of any county,
7 city, town, or other political subdivision, present at the scene of any
8 accident or in possession of any facts concerning any accident whether
9 by way of official investigation or otherwise shall make report thereof
10 in the same manner as required of the parties to such accident and as
11 fully as the facts in his or her possession concerning such accident
12 will permit.

13 (2) The police officer shall report to the department, on a form
14 prescribed by the director: (a) When a collision has occurred that
15 results in a fatality; and (b) the identity of the operator of a
16 vehicle involved in the collision when the officer has reasonable
17 grounds to believe the operator caused the collision.

18 (3) The police officer shall report to the department, on a form
19 prescribed by the director: (a) When a collision has occurred that
20 results in a serious injury; (b) the identity of the operator of a
21 vehicle involved in the collision when the officer has reasonable
22 grounds to believe the operator who caused the serious injury may not
23 be competent to operate a motor vehicle; and (c) the reason or reasons
24 for the officer's belief.

25 **Sec. 9061.** RCW 46.55.030 and 1989 c 111 s 3 are each amended to
26 read as follows:

27 (1) Application for licensing as a registered tow truck operator
28 shall be made on forms furnished by the department, shall be
29 accompanied by an inspection certification from the Washington state
30 patrol, shall be signed by the applicant or an agent, and shall include
31 the following information:

32 (a) The name and address of the person, firm, partnership,
33 association, or corporation under whose name the business is to be
34 conducted;

35 (b) The names and addresses of all persons having an interest in

1 the business, or if the owner is a corporation, the names and addresses
2 of the officers of the corporation;

3 (c) The names and addresses of all employees who serve as tow truck
4 drivers;

5 (d) Proof of minimum insurance required by subsection (3) of this
6 section;

7 (e) The vehicle license and vehicle identification numbers of all
8 tow trucks of which the applicant is the registered owner;

9 (f) Any other information the department may require; and

10 (g) A certificate of approval from the Washington state patrol
11 certifying that:

12 (i) The applicant has an established place of business and that
13 mail is received at the address shown on the application;

14 (ii) The address of any storage locations where vehicles may be
15 stored is correctly stated on the application;

16 (iii) The place of business has an office area that is accessible
17 to the public without entering the storage area; and

18 (iv) The place of business has adequate and secure storage
19 facilities, as defined in this chapter and the rules of the department,
20 where vehicles and their contents can be properly stored and protected.

21 (2) Before issuing a registration certificate to an applicant the
22 department shall require the applicant to file with the department a
23 surety bond in the amount of five thousand dollars running to the state
24 and executed by a surety company authorized to do business in this
25 state. The bond shall be approved as to form by the attorney general
26 and conditioned that the operator shall conduct his or her business in
27 conformity with the provisions of this chapter pertaining to abandoned
28 or unauthorized vehicles, and to compensate any person, company, or the
29 state for failure to comply with this chapter or the rules adopted
30 hereunder, or for fraud, negligence, or misrepresentation in the
31 handling of these vehicles. Any person injured by the tow truck
32 operator's failure to fully perform duties imposed by this chapter and
33 the rules adopted hereunder, or an ordinance or resolution adopted by
34 a city, town, or county is entitled to recover actual damages,
35 including reasonable attorney's fees against the surety and the tow
36 truck operator. Successive recoveries against the bond shall be
37 permitted, but the aggregate liability of the surety to all persons
38 shall not exceed the amount of the bond. As a condition of authority

1 to do business, the operator shall keep the bond in full force and
2 effect. Failure to maintain the penalty value of the bond or
3 cancellation of the bond by the surety automatically cancels the
4 operator's registration.

5 (3) Before the department may issue a registration certificate to
6 an applicant, the applicant shall provide proof of minimum insurance
7 requirements of:

8 (a) One hundred thousand dollars for liability for bodily injury or
9 property damage per occurrence; and

10 (b) Fifty thousand dollars of legal liability per occurrence, to
11 protect against vehicle damage, including but not limited to fire and
12 theft, from the time a vehicle comes into the custody of an operator
13 until it is redeemed or sold.

14 Cancellation of or failure to maintain the insurance required by
15 (a) and (b) of this subsection automatically cancels the operator's
16 registration.

17 (4) The fee for each original registration and annual renewal is
18 one hundred dollars per company, plus fifty dollars per truck. The
19 department shall forward the registration fee to the state treasurer
20 for deposit in the motor vehicle fund.

21 (5) The applicant must submit an inspection certificate from the
22 state patrol before the department may issue or renew an operator's
23 registration certificate or tow truck permits.

24 (6) Upon approval of the application, the department shall issue a
25 registration certificate to the registered operator to be displayed
26 prominently at the operator's place of business.

27 **Sec. 9062.** RCW 46.55.085 and 2002 c 279 s 6 are each amended to
28 read as follows:

29 (1) A law enforcement officer discovering an unauthorized vehicle
30 left within a highway right-of-way shall attach to the vehicle a
31 readily visible notification sticker. The sticker shall contain the
32 following information:

33 (a) The date and time the sticker was attached;

34 (b) The identity of the officer;

35 (c) A statement that if the vehicle is not removed within twenty-
36 four hours from the time the sticker is attached, the vehicle may be
37 taken into custody and stored at the owner's expense;

1 (d) A statement that if the vehicle is not redeemed as provided in
2 RCW 46.55.120, the registered owner will have committed the traffic
3 infraction of littering--abandoned vehicle; and

4 (e) The address and telephone number where additional information
5 may be obtained.

6 (2) If the vehicle has current Washington registration plates, the
7 officer shall check the records to learn the identity of the last owner
8 of record. The officer or his or_her department shall make a
9 reasonable effort to contact the owner by telephone in order to give
10 the owner the information on the notification sticker.

11 (3) If the vehicle is not removed within twenty-four hours from the
12 time the notification sticker is attached, the law enforcement officer
13 may take custody of the vehicle and provide for the vehicle's removal
14 to a place of safety. A vehicle that does not pose a safety hazard may
15 remain on the roadside for more than twenty-four hours if the owner or
16 operator is unable to remove it from the place where it is located and
17 so notifies law enforcement officials and requests assistance.

18 (4) For the purposes of this section a place of safety includes the
19 business location of a registered tow truck operator.

20 **Sec. 9063.** RCW 46.55.200 and 1989 c 111 s 16 are each amended to
21 read as follows:

22 A registered tow truck operator's license may be denied, suspended,
23 or revoked, or the licensee may be ordered to pay a monetary penalty of
24 a civil nature, not to exceed one thousand dollars per violation, or
25 the licensee may be subjected to any combination of license and
26 monetary penalty, whenever the director has reason to believe the
27 licensee has committed, or is at the time committing, a violation of
28 this chapter or rules adopted under it or any other statute or rule
29 relating to the title or disposition of vehicles or vehicle hulks,
30 including but not limited to:

31 (1) Towing any abandoned vehicle without first obtaining and having
32 in the operator's possession at all times while transporting it,
33 appropriate evidence of ownership or an impound authorization properly
34 executed by the private person or public official having control over
35 the property on which the unauthorized vehicle was found;

36 (2) Forging the signature of the registered or legal owner on a

1 certificate of title, or forging the signature of any authorized person
2 on documents pertaining to unauthorized or abandoned vehicles or
3 automobile hulks;

4 (3) Failing to comply with the statutes and rules relating to the
5 processing and sale of abandoned vehicles;

6 (4) Failing to accept bids on any abandoned vehicle offered at
7 public sale;

8 (5) Failing to transmit to the state surplus funds derived from the
9 sale of an abandoned vehicle;

10 (6) Selling, disposing of, or having in his or her possession,
11 without notifying law enforcement officials, a vehicle that he or she
12 knows or has reason to know has been stolen or illegally appropriated
13 without the consent of the owner;

14 (7) Failing to comply with the statutes and rules relating to the
15 transfer of ownership of vehicles or other procedures after public
16 sale; or

17 (8) Failing to pay any civil monetary penalty assessed by the
18 director pursuant to this section within ten days after the assessment
19 becomes final.

20 All orders by the director made under this chapter are subject to
21 the Administrative Procedure Act, chapter 34.05 RCW.

22 **Sec. 9064.** RCW 46.55.240 and 1994 c 176 s 2 are each amended to
23 read as follows:

24 (1) A city, town, or county that adopts an ordinance or resolution
25 concerning unauthorized, abandoned, or impounded vehicles shall include
26 the applicable provisions of this chapter.

27 (a) A city, town, or county may, by ordinance, authorize other
28 impound situations that may arise locally upon the public right-of-way
29 or other publicly owned or controlled property.

30 (b) A city, town, or county ordinance shall contain language that
31 establishes a written form of authorization to impound, which may
32 include a law enforcement notice of infraction or citation, clearly
33 denoting the agency's authorization to impound.

34 (c) A city, town, or county may, by ordinance, provide for release
35 of an impounded vehicle by means of a promissory note in lieu of
36 immediate payment, if at the time of redemption the legal or registered
37 owner requests a hearing on the validity of the impoundment. If the

1 municipal ordinance directs the release of an impounded vehicle before
2 the payment of the impoundment charges, the municipality is responsible
3 for the payment of those charges to the registered tow truck operator
4 within thirty days of the hearing date.

5 (d) The hearing specified in RCW 46.55.120(2) and in this section
6 may be conducted by an administrative hearings officer instead of in
7 the district court. A decision made by an administrative hearing
8 officer may be appealed to the district court for final judgment.

9 (2) A city, town, or county may adopt an ordinance establishing
10 procedures for the abatement and removal as public nuisances of junk
11 vehicles or parts thereof from private property. Costs of removal may
12 be assessed against the registered owner of the vehicle if the identity
13 of the owner can be determined, unless the owner in the transfer of
14 ownership of the vehicle has complied with RCW 46.12.101, or the costs
15 may be assessed against the owner of the property on which the vehicle
16 is stored. A city, town, or county may also provide for the payment to
17 the tow truck operator or wrecker as a part of a neighborhood
18 revitalization program.

19 (3) Ordinances pertaining to public nuisances shall contain:

20 (a) A provision requiring notice to the last registered owner of
21 record and the property owner of record that a hearing may be requested
22 and that if no hearing is requested, the vehicle will be removed;

23 (b) A provision requiring that if a request for a hearing is
24 received, a notice giving the time, location, and date of the hearing
25 on the question of abatement and removal of the vehicle or part thereof
26 as a public nuisance shall be mailed, by certified mail, with a five-
27 day return receipt requested, to the owner of the land as shown on the
28 last equalized assessment roll and to the last registered and legal
29 owner of record unless the vehicle is in such condition that
30 identification numbers are not available to determine ownership;

31 (c) A provision that the ordinance shall not apply to (i) a vehicle
32 or part thereof that is completely enclosed within a building in a
33 lawful manner where it is not visible from the street or other public
34 or private property or (ii) a vehicle or part thereof that is stored or
35 parked in a lawful manner on private property in connection with the
36 business of a licensed dismantler or licensed vehicle dealer and is
37 fenced according to RCW 46.80.130;

1 (d) A provision that the owner of the land on which the vehicle is
2 located may appear in person at the hearing or present a written
3 statement in time for consideration at the hearing, and deny
4 responsibility for the presence of the vehicle on the land, with his or
5 her reasons for the denial. If it is determined at the hearing that
6 the vehicle was placed on the land without the consent of the landowner
7 and that he or she has not subsequently acquiesced in its presence,
8 then the local agency shall not assess costs of administration or
9 removal of the vehicle against the property upon which the vehicle is
10 located or otherwise attempt to collect the cost from the owner;

11 (e) A provision that after notice has been given of the intent of
12 the city, town, or county to dispose of the vehicle and after a
13 hearing, if requested, has been held, the vehicle or part thereof shall
14 be removed at the request of a law enforcement officer with notice to
15 the Washington state patrol and the department of licensing that the
16 vehicle has been wrecked. The city, town, or county may operate such
17 a disposal site when its governing body determines that commercial
18 channels of disposition are not available or are inadequate, and it may
19 make final disposition of such vehicles or parts, or may transfer such
20 vehicle or parts to another governmental body provided such disposal
21 shall be only as scrap.

22 (4) A registered disposer under contract to a city or county for
23 the impounding of vehicles shall comply with any administrative
24 regulations adopted by the city or county on the handling and disposing
25 of vehicles.

26 **Sec. 9065.** RCW 46.61.024 and 2003 c 101 s 1 are each amended to
27 read as follows:

28 (1) Any driver of a motor vehicle who willfully fails or refuses to
29 immediately bring his or her vehicle to a stop and who drives his or
30 her vehicle in a reckless manner while attempting to elude a pursuing
31 police vehicle, after being given a visual or audible signal to bring
32 the vehicle to a stop, shall be guilty of a class C felony. The signal
33 given by the police officer may be by hand, voice, emergency light, or
34 siren. The officer giving such a signal shall be in uniform and the
35 vehicle shall be equipped with lights and sirens.

36 (2) It is an affirmative defense to this section which must be
37 established by a preponderance of the evidence that: (a) A reasonable

1 person would not believe that the signal to stop was given by a police
2 officer; and (b) driving after the signal to stop was reasonable under
3 the circumstances.

4 (3) The license or permit to drive or any nonresident driving
5 privilege of a person convicted of a violation of this section shall be
6 revoked by the department of licensing.

7 **Sec. 9066.** RCW 46.61.035 and 1969 c 23 s 1 are each amended to
8 read as follows:

9 (1) The driver of an authorized emergency vehicle, when responding
10 to an emergency call or when in the pursuit of an actual or suspected
11 violator of the law or when responding to but not upon returning from
12 a fire alarm, may exercise the privileges set forth in this section,
13 but subject to the conditions herein stated.

14 (2) The driver of an authorized emergency vehicle may:

15 (a) Park or stand, irrespective of the provisions of this chapter;

16 (b) Proceed past a red or stop signal or stop sign, but only after
17 slowing down as may be necessary for safe operation;

18 (c) Exceed the maximum speed limits so long as he or she does not
19 endanger life or property;

20 (d) Disregard regulations governing direction of movement or
21 turning in specified directions.

22 (3) The exemptions herein granted to an authorized emergency
23 vehicle shall apply only when such vehicle is making use of visual
24 signals meeting the requirements of RCW 46.37.190, except that: (a) An
25 authorized emergency vehicle operated as a police vehicle need not be
26 equipped with or display a red light visible from in front of the
27 vehicle; (b) authorized emergency vehicles shall use audible signals
28 when necessary to warn others of the emergency nature of the situation
29 but in no case shall they be required to use audible signals while
30 parked or standing.

31 (4) The foregoing provisions shall not relieve the driver of an
32 authorized emergency vehicle from the duty to drive with due regard for
33 the safety of all persons, nor shall such provisions protect the driver
34 from the consequences of his or her reckless disregard for the safety
35 of others.

1 **Sec. 9067.** RCW 46.61.202 and 1975 c 62 s 48 are each amended to
2 read as follows:

3 No driver shall enter an intersection or a marked crosswalk or
4 drive onto any railroad grade crossing unless there is sufficient space
5 on the other side of the intersection, crosswalk, or railroad grade
6 crossing to accommodate the vehicle he or_she is operating without
7 obstructing the passage of other vehicles, pedestrians, or railroad
8 trains notwithstanding any traffic control signal indications to
9 proceed.

10 **Sec. 9068.** RCW 46.61.255 and 1989 c 288 s 1 are each amended to
11 read as follows:

12 (1) No person shall stand in or on a public roadway or alongside
13 thereof at any place where a motor vehicle cannot safely stop off the
14 main traveled portion thereof for the purpose of soliciting a ride for
15 himself or_herself or for another from the occupant of any vehicle.

16 (2) It shall be unlawful for any person to solicit a ride for
17 himself or_herself or another from within the right-of-way of any
18 limited access facility except in such areas where permission to do so
19 is given and posted by the highway authority of the state, county,
20 city, or town having jurisdiction over the highway.

21 (3) The provisions of subsections (1) and (2) above shall not be
22 construed to prevent a person upon a public highway from soliciting, or
23 a driver of a vehicle from giving a ride where an emergency actually
24 exists, nor to prevent a person from signaling or requesting
25 transportation from a passenger carrier for the purpose of becoming a
26 passenger thereon for hire.

27 (4) No person shall stand in a roadway for the purpose of
28 soliciting employment or business from the occupant of any vehicle.

29 (5) No person shall stand on or in proximity to a street or highway
30 for the purpose of soliciting the watching or guarding of any vehicle
31 while parked or about to be parked on a street or highway.

32 (6)(a) Except as provided in (b) of this subsection, the state
33 preempts the field of the regulation of hitchhiking in any form, and no
34 county, city, or town shall take any action in conflict with the
35 provisions of this section.

36 (b) A county, city, or town may regulate or prohibit hitchhiking in

1 an area in which it has determined that prostitution is occurring and
2 that regulating or prohibiting hitchhiking will help to reduce
3 prostitution in the area.

4 **Sec. 9069.** RCW 46.61.350 and 1977 c 78 s 1 are each amended to
5 read as follows:

6 (1) The driver of any motor vehicle carrying passengers for hire,
7 other than a passenger car, or of any school bus or private carrier bus
8 carrying any school child or other passenger, or of any vehicle
9 carrying explosive substances or flammable liquids as a cargo or part
10 of a cargo, before crossing at grade any track or tracks of a railroad,
11 shall stop such vehicle within fifty feet but not less than fifteen
12 feet from the nearest rail of such railroad and while so stopped shall
13 listen and look in both directions along such track for any approaching
14 train, and for signals indicating the approach of a train, except as
15 hereinafter provided, and shall not proceed until he or she can do so
16 safely. After stopping as required herein and upon proceeding when it
17 is safe to do so the driver of any said vehicle shall cross only in
18 such gear of the vehicle that there will be no necessity for changing
19 gears while traversing such crossing, and the driver shall not shift
20 gears while crossing the track or tracks.

21 (2) This section shall not apply at:

22 (a) Any railroad grade crossing at which traffic is controlled by
23 a police officer or a duly authorized (~~flagman~~) flagger;

24 (b) Any railroad grade crossing at which traffic is regulated by a
25 traffic control signal;

26 (c) Any railroad grade crossing protected by crossing gates or an
27 alternately flashing light signal intended to give warning of the
28 approach of a railroad train;

29 (d) Any railroad grade crossing at which an official traffic
30 control device as designated by the utilities and transportation
31 commission pursuant to RCW 81.53.060 gives notice that the stopping
32 requirement imposed by this section does not apply.

33 **Sec. 9070.** RCW 46.61.385 and 1990 c 33 s 585 are each amended to
34 read as follows:

35 The superintendent of public instruction, through the
36 superintendent of schools of any school district, or other officer or

1 board performing like functions with respect to the schools of any
2 other educational administrative district, may cause to be appointed
3 voluntary adult recruits as supervisors and, from the student body of
4 any public or private school or institution of learning, students, who
5 shall be known as members of the "school patrol" and who shall serve
6 without compensation and at the pleasure of the authority making the
7 appointment.

8 The members of such school patrol shall wear an appropriate
9 designation or insignia identifying them as members of the school
10 patrol when in performance of their duties, and they may display "stop"
11 or other proper traffic directional signs or signals at school
12 crossings or other points where school children are crossing or about
13 to cross a public highway, but members of the school patrol and their
14 supervisors shall be subordinate to and obey the orders of any peace
15 officer present and having jurisdiction.

16 School districts, at their discretion, may hire sufficient numbers
17 of adults to serve as supervisors. Such adults shall be subordinate to
18 and obey the orders of any peace officer present and having
19 jurisdiction.

20 Any school district having a school patrol may purchase uniforms
21 and other appropriate insignia, traffic signs and other appropriate
22 materials, all to be used by members of such school patrol while in
23 performance of their duties, and may pay for the same out of the
24 general fund of the district.

25 It shall be unlawful for the operator of any vehicle to fail to
26 stop his or her vehicle when directed to do so by a school patrol sign
27 or signal displayed by a member of the school patrol engaged in the
28 performance of his or her duty and wearing or displaying appropriate
29 insignia, and it shall further be unlawful for the operator of a
30 vehicle to disregard any other reasonable directions of a member of the
31 school patrol when acting in performance of his or her duties as such.

32 School districts may expend funds from the general fund of the
33 district to pay premiums for life and accident policies covering the
34 members of the school patrol in their district while engaged in the
35 performance of their school patrol duties.

36 Members of the school patrol shall be considered as employees for
37 the purposes of RCW 28A.400.370.

1 **Sec. 9071.** RCW 46.61.519 and 1989 c 178 s 26 are each amended to
2 read as follows:

3 (1) It is a traffic infraction to drink any alcoholic beverage in
4 a motor vehicle when the vehicle is upon a highway.

24 any person other than the assured, with a good and sufficient surety

27 the principal of said bond with the provisions of this chapter, and to
28 pay all damages which may be sustained by any person injured by reason
29 of any careless negligence or unlawful act on the part of said
30 principal, his or her agents or employees in the conduct of said
31 business or in the operation of any motor propelled vehicle used in
32 transporting passengers for compensation on any public highway of this
33 state.

34 **Sec. 9090.** RCW 46.72.060 and 1961 c 12 s 46.72.060 are each
35 amended to read as follows:

1 Every person having a cause of action for damages against any
2 person, firm, or corporation receiving a permit under the provisions of
3 this chapter, for injury, damages, or wrongful death caused by any
4 careless, negligent, or unlawful act of any such person, firm, or
5 corporation or his(~~their~~) or her or its agents or employees in
6 conducting or carrying on said business or in operating any motor

19 value plus cost to repair exceeds its fair market value, if repaired;

16 with an immediate right of possession vested in the conditional vendee,

34 vehicle dealer, then the provisions of this section and RCW 46.96.170
35 relating to hearings by an administrative law judge do not apply, and
36 a dispute regarding the establishment of an additional new motor
37 vehicle dealer or the relocation of an existing new motor vehicle

1 dealer shall be determined in an arbitration proceeding conducted in
2 accordance with the Uniform Arbitration Act, chapter 7.04A RCW. The
3 thirty-day period for filing a protest under this section still applies
4 except that the protesting dealer shall file his or her protest with
5 the manufacturer within thirty days after receipt of the notice under
6 RCW 46.96.140.

7 (3) The dispute shall be referred for arbitration to such
8 arbitrator as may be agreed upon by the parties to the dispute. If the
9 parties cannot agree upon a single arbitrator within thirty days from
10 the date the protest is filed, the protesting dealer will select an
11 arbitrator, the manufacturer will select an arbitrator, and the two
12 arbitrators will then select a third. If a third arbitrator is not
13 agreed upon within thirty days, any party may apply to the superior
14 court, and the judge of the superior court having jurisdiction will
15 appoint the third arbitrator. The protesting dealer will pay the
16 arbitrator selected by him or her, and the manufacturer will pay the
17 arbitrator it selected. The expense of the third arbitrator and all
18 other expenses of arbitration will be shared equally by the parties.
19 Attorneys' fees and fees paid to expert witnesses are not expenses of
20 arbitration and will be paid by the person incurring them.

21 (4) Notwithstanding the terms of a franchise or written statement
22 of the manufacturer and notwithstanding the terms of a waiver, the
23 arbitration will take place in the state of Washington in the county
24 where the protesting dealer has his or her principal place of business.
25 RCW 46.96.160 applies to a determination made by the arbitrator or
26 arbitrators in determining whether good cause exists for permitting the
27 proposed establishment or relocation of a new motor vehicle dealer, and
28 the manufacturer has the burden of proof to establish that good cause
29 exists for permitting the proposed establishment or relocation. After
30 a hearing has been held, the arbitrator or arbitrators shall render a
31 decision as expeditiously as possible, but in any event not later than
32 one hundred twenty days from the date the arbitrator or arbitrators are
33 selected or appointed. The manufacturer shall not establish or
34 relocate the new motor vehicle dealer until the arbitration hearing has
35 been held and the arbitrator or arbitrators have determined that there
36 is good cause for permitting the proposed establishment or relocation.
37 The written decision of the arbitrator is binding upon the parties

1 unless modified, corrected, or vacated under the Washington Arbitration
2 Act. Any party may appeal the decision of the arbitrator under the
3 Uniform Arbitration Act, chapter 7.04A RCW.

4 (5) If the franchise agreement or the manufacturer's written
5 statement distributed and provided to its dealers does not provide for
6 arbitration under the Uniform Arbitration Act as a mechanism for
7 resolving disputes relating to the establishment of an additional new
8 motor vehicle dealer or the relocation of a new motor vehicle dealer,
9 then the hearing provisions of this section and RCW 46.96.170 apply.
10 Nothing in this section is intended to preclude a new motor vehicle
11 dealer from electing to use any other dispute resolution mechanism
12 offered by a manufacturer.

14 **Sec. 10001.** RCW 47.01.070 and 1977 ex.s. c 151 s 27 are each
15 amended to read as follows:

16 In all situations wherein the director of highways, the director of
17 aeronautics, or any one of their designees, or any member of the
18 highway commission, the toll bridge authority, the aeronautics
19 commission, or the canal commission, or any one of their designees was
20 on September 21, 1977, designated or serving as a member of any board,
21 commission, committee, or authority, the (~~chairman~~) chair of the
22 transportation commission or the (~~chairman~~) chair's designee who
23 shall be an employee of the department of transportation, shall
24 hereafter determine who shall serve as such member.

25 **Sec. 10002.** RCW 47.10.150 and 1961 c 13 s 47.10.150 are each
26 amended to read as follows:

27 Increased construction costs for highway and bridge construction
28 since the enactment of a highway bond issue by the 1951 legislature
29 makes necessary additional money with which to complete the sections of
30 primary state highway No. 1 planned from funds allocated under RCW
31 47.10.010 through 47.10.140 and it is vital to the economy of the state
32 and the safety of the traffic that these sections shall be completed to
33 relieve traffic congestions, to add capacity in event of war, and to
34 presently insure greater safety to highway users; the rapid increase of
35 traffic across Snoqualmie Pass necessitates continued improvement of

1 primary state highway No. 2 to provide four-lane paving contiguous to
2 Snoqualmie Pass as the funds will permit; the rapid increase of traffic
3 and the facilitation of movement of military forces and equipment from
4 the military centers of the state makes imperative the construction of
5 a highway from primary state highway No. 2 beginning approximately four
6 miles west of North Bend thence southwesterly by the most feasible
7 route by the way of Auburn to a junction with primary state highway No.
8 1 in the vicinity of Milton; said highway to follow approximately the
9 route surveyed by the director of highways and covered in the report
10 filed by him or her with the 1951 legislature commonly known as the
11 "Echo Lake Route," as the funds provided for herein will permit; the
12 construction of secondary state highways in to the Columbia Basin area
13 is immediately necessary to provide needed state arterial highways for
14 the irrigated lands of the Columbia Basin areas to market centers and
15 thereby encourage the full development of the basin project. The
16 construction of such projects is required in the interest of the public
17 safety and for the orderly development of the state. The threat of war
18 makes acceleration of construction a vital necessity at this time.

19 **Sec. 10003.** RCW 47.12.023 and 1984 c 7 s 115 are each amended to
20 read as follows:

21 (1) Except as provided in RCW 47.12.026 and 47.12.029, whenever it
22 is necessary to secure any lands or interests in lands for any highway
23 purpose mentioned in RCW 47.12.010, or for the construction of any toll
24 facility or ferry terminal or docking facility, the title to which is
25 in the state of Washington and under the jurisdiction of the department
26 of natural resources, the department of transportation may acquire
27 jurisdiction over the lands or interests in lands, or acquire rights to
28 remove materials from the lands in the manner set forth in this
29 section.

30 (2) At any time after the final adoption of a right-of-way plan or
31 other plan requiring the acquisition of lands or interests in lands for
32 any purpose as authorized in subsection (1) of this section, the
33 department of transportation may file with the department of natural
34 resources a notice setting forth its intent to acquire jurisdiction of
35 the lands or interests in lands under the jurisdiction of the
36 department of natural resources required for right-of-way or other

1 highway purposes related to the construction or improvement of such
2 state highway, toll facility, or ferry terminal or docking facility.

3 (3) The department of transportation at the time of filing its
4 notice of intent as provided in subsection (2) of this section shall
5 file therewith a written statement showing the total amount of just
6 compensation to be paid for the property in the event of settlement.
7 The offer shall be based upon the department of transportation approved
8 appraisal of the fair market value of the property to be acquired. In
9 no event may the offer of settlement be referred to or used during any
10 arbitration proceeding or trial conducted for the purpose of
11 determining the amount of just compensation.

12 (4) Just compensation and/or fair market value for the purposes of
13 this section shall be determined in accordance with applicable federal
14 and state constitutional, statutory, and case law relating to the
15 condemnation of private and public property for public purposes.

16 (5) If the department of natural resources does not accept the
17 offer of the department of transportation, the department of
18 transportation may nonetheless pay to the department of natural
19 resources the amount of its offer and obtain immediate possession and
20 use of the property pending the determination of just compensation in
21 the manner hereinafter provided.

22 (6) If the amount of just compensation is not agreed to, either the
23 department of natural resources or the department of transportation may
24 request in writing the appointment of an arbitrator for the purpose of
25 determining the amount of compensation to be paid by the department of
26 transportation for the acquisition of jurisdiction over the lands or
27 interests in lands or rights therein. In that event the department of
28 natural resources and the department of transportation may jointly
29 agree on an arbitrator to determine the compensation, and his or her
30 determination shall be final and conclusive upon both departments. The
31 costs of the arbitrator shall be borne equally by the parties. If the
32 department of natural resources and the department of transportation
33 are unable to agree on the selection of an arbitrator within thirty
34 days after a request therefor is made, either the department of
35 transportation or the department of natural resources may file a
36 petition with the superior court for Thurston county for the purpose of
37 determining the amount of just compensation to be paid. The matter

1 shall be tried by the court pursuant to the procedures set forth in RCW
2 8.04.080.

3 (7) Whenever the department of transportation has acquired
4 immediate possession and use of property by payment of the amount of
5 its offer to the department of natural resources, and the arbitration
6 award or judgment of the court for the acquisition exceeds the payment
7 for immediate possession and use, the department of transportation
8 shall forthwith pay the amount of such excess to the department of
9 natural resources with interest thereon from the date it obtained
10 immediate possession. If the arbitration or court award is less than
11 the amount previously paid by the department of transportation for
12 immediate possession and use, the department of natural resources shall
13 forthwith pay the amount of the difference to the department of
14 transportation.

15 (8) Upon the payment of just compensation, as agreed to by the
16 department of transportation and the department of natural resources,
17 or as determined by arbitration or by judgment of the court, and other
18 costs or fees as provided by statute, the department of natural
19 resources shall cause to be executed and delivered to the department of
20 transportation an instrument transferring jurisdiction over the lands
21 or interests in lands, or rights to remove material from the lands, to
22 the department of transportation.

23 (9) Except as provided in RCW 47.12.026, whenever the department of
24 transportation ceases to use any lands or interests in lands acquired
25 in the manner set forth in this section for the purposes mentioned
26 herein, the department of natural resources may reacquire jurisdiction
27 over the lands or interests in land by paying the fair market value
28 thereof to the department of transportation. If the two departments
29 are unable to agree on the fair market value of the lands or interests
30 in lands, the market value shall be determined and the interests
31 therein shall be transferred in accordance with the provisions and
32 procedures set forth in subsections (4) through (8) of this section.

33 **Sec. 10004.** RCW 47.12.160 and 1984 c 7 s 122 are each amended to
34 read as follows:

35 Whenever a part of a parcel of land is to be acquired for state
36 highway purposes and the remainder lying outside of the right-of-way is
37 to be left in such shape or condition as to be of little value to its

1 owner or to give rise to claims or litigation concerning severance or
2 other damage, and its value does not exceed the probable amount of the
3 severance claims or damages, the department may acquire by gift,
4 purchase, or condemnation the whole parcel and may sell that portion
5 lying outside of the highway right-of-way or may exchange the same for
6 other property needed for highway purposes. The provisions of this
7 section do not apply if the taking of that portion of the land lying
8 outside of the highway right-of-way would deprive any adjacent owner of
9 an existing right of ingress and egress to his or her property.

10 **Sec. 10005.** RCW 47.12.230 and 1969 ex.s. c 197 s 5 are each
11 amended to read as follows:

12 Warrants issued for payment of property and engineering costs as
13 provided herein shall be of a distinctive design and shall contain the
14 words "for purchase by the state finance committee from fund"
15 (indicating the proper investing fund as provided by the agreement).
16 Such warrants shall be approved by the secretary of the state finance
17 committee prior to their issuance by the state treasurer. Upon
18 presentation of such warrants to the state treasurer for payment, he or
19 she shall pay the par value thereof from the fund for which the state
20 finance committee agreed to purchase such warrants whether or not there
21 are then funds in the motor vehicle fund. The state treasurer shall
22 deposit such warrants in the treasury for the investing fund.

23 **Sec. 10006.** RCW 47.12.283 and 1979 ex.s. c 189 s 1 are each
24 amended to read as follows:

25 (1) Whenever the department of transportation determines that any
26 real property owned by the state of Washington and under the
27 jurisdiction of the department is no longer required for highway
28 purposes and that it is in the public interest to do so, the department
29 may, in its discretion, sell the property under RCW 47.12.063 or under
30 subsections (2) through (6) of this section.

31 (2) Whenever the department determines to sell real property under
32 its jurisdiction at public auction, the department shall first give
33 notice thereof by publication on the same day of the week for two
34 consecutive weeks, with the first publication at least two weeks prior
35 to the date of the auction, in a legal newspaper of general circulation
36 in the area where the property to be sold is located. The notice shall

1 be placed in both the legal notices section and the real estate
2 classified section of the newspaper. The notice shall contain a
3 description of the property, the time and place of the auction, and the
4 terms of the sale. The sale may be for cash or by real estate
5 contract.

6 (3) The department shall sell the property at the public auction,
7 in accordance with the terms set forth in the notice, to the highest
8 and best bidder providing the bid is equal to or higher than the

12 negotiations for the sale of the property or may list the property with
13 a licensed real estate broker. No property shall be sold by
14 negotiations or through a broker for less than the property's appraised
15 fair market value. Any offer to purchase real property pursuant to
16 this subsection shall be in writing and may be rejected at any time
17 prior to written acceptance by the department.

18 (5) Before the department shall approve any offer for the purchase
19 of real property having an appraised value of more than ten thousand
20 dollars, pursuant to subsection (4) of this section, the department
21 shall first publish a notice of the proposed sale in a local newspaper
22 of general circulation in the area where the property is located. The
23 notice shall include a description of the property, the selling price,
24 the terms of the sale, including the price and interest rate if sold by

36 offeror fails to complete the sale if the offeror's offer is accepted.
37 If a subsequent offer is received, the first offeror shall be informed
38 by registered or certified mail sent to the address stated in his or

1 her offer. The first offeror shall then have ten days, from the date
2 of mailing the notice of the increased offer, in which to file with the
3 designated state employee or real estate broker a higher offer than
4 that of the subsequent offeror. After the expiration of the ten-day
5 period, the department shall approve in writing the highest and best
6 offer which the department then has on file.

7 (6) All moneys received pursuant to this section, less any real
8 estate broker's commissions paid pursuant to RCW 47.12.320, shall be
9 deposited in the motor vehicle fund.

10 **Sec. 10007.** RCW 47.26.150 and 1988 c 167 s 17 are each amended to
11 read as follows:

12 The transportation improvement board shall meet at least once
13 quarterly and upon the call of its (~~chairman~~) chair and shall from
14 time to time adopt rules and regulations for its own government and as
15 may be necessary for it to discharge its duties and exercise its powers
16 under this chapter.

17 **Sec. 10008.** RCW 47.26.4254 and 1999 sp.s. c 1 s 611 are each
18 amended to read as follows:

19 (1) Any funds required to repay series III bonds authorized by RCW
20 47.26.420, or the interest thereon, when due shall first be taken from
21 that portion of the motor vehicle fund that results from the imposition
22 of excise taxes on motor vehicle and special fuels imposed by chapters
23 82.36 and 82.38 RCW and that is distributed to the urban arterial trust
24 account in the motor vehicle fund pursuant to RCW 46.68.090(~~(1)(g)~~)
25 (2)(e), subject, however, to the prior lien of the first authorization
26 of bonds authorized by RCW 47.26.420. If the moneys so distributed to
27 the urban arterial trust account, after first being applied to
28 administrative expenses of the transportation improvement board and to

7 from that portion of the motor vehicle fund that results from the
8 imposition of excise taxes on motor vehicle and special fuels and that
9 is distributed to the state. The remaining forty percent shall first
10 be taken from that portion of the motor vehicle fund that results from
11 the imposition of excise taxes on motor vehicle and special fuels and
12 that is distributed to the cities and towns pursuant to RCW

20 series III bonds, for the period through the first eleven months of the
21 prior fiscal year as determined by the (~~(chairman)~~) chair of the
22 transportation improvement board and reported to the state finance
23 committee and the state treasurer not later than the first working day
24 of June.

25 (3) Any payments on such bonds or interest thereon taken from motor
26 vehicle or special fuel tax revenues that are distributable to the
27 state, counties, cities, and towns shall be repaid from the first
28 moneys distributed to the urban arterial trust account not required for
29 redemption of the first authorization bonds, series II bonds, or series
30 III bonds or interest on these bonds.

31 **Sec. 10009.** RCW 47.28.080 and 1985 c 242 s 2 are each amended to
32 read as follows:

33 Any person, firm, or corporation proposing a bid for the
34 construction or improvement of any state highway in response to a call
35 for bids published therefor may withdraw the bid proposal without
36 forfeiture and without prejudice to the right of the bidder to file a
37 new bid proposal before the time fixed for the opening of the bid

1 proposals. The request for the withdrawal shall be made in writing,
2 signed by the person proposing the bid or his or her duly authorized
3 agent, and filed at the place and before the time fixed in the call for
4 bids for receipt of the bid proposals. No bid proposal may be
5 considered that has not been filed with the department before the time
6 fixed for the receipt of bid proposals. In any provisions regarding
7 the filing or withdrawing of bid proposals the time fixed for the
8 receipt of bid proposals in the call for bid proposals as published
9 shall control without regard for the time when the bid proposals are
10 actually opened.

11 **Sec. 10010.** RCW 47.32.060 and 1988 c 202 s 45 are each amended to
12 read as follows:

13 At the time and place appointed for hearing upon the complaint,
14 which hearing shall be by summary proceedings, if the court or judge
15 thereof finds that due notice has been given by posting and publication
16 and that the order of the department was duly made, and is further
17 satisfied and finds that the state highway or portion thereof described
18 is legally a state highway having the width of right-of-way specified
19 in the order and that the structure, buildings, improvements, or other
20 means of occupancy of the state highway or portion thereof as stated in
21 the certificate of the department do in fact encroach, or that any
22 portion thereof encroach, upon the state highway right-of-way, the
23 court or judge thereof shall thereupon make and enter an order
24 establishing that each of the structures, buildings, improvements, and
25 other means of occupancy specified in the order is unlawfully

27 sale and that they be forthwith confiscated, removed from the right-of-
28 way, and sold, and providing that six days after the entry of the

32 other means of occupancy specified in the order forthwith on receipt of
33 a writ based on the order and to take and hold the property in his or

35 provided for by law, and if not then so redelivered to sell the
36 property at public or private sale and to pay the proceeds thereof into
37 the registry of the court within sixty days after the issuance of the

1 writ, and further in such action, including costs of posting original
2 notices of the department, the costs of posting and publishing notices
3 of hearing as part thereof and any cost of removal, be paid by the
4 clerk to the state treasurer and credited to the motor vehicle fund.
5 The order shall be filed with the clerk of the court and recorded in
6 the minutes of the court, and is final unless appellate review thereof
7 is sought within five days after filing of the order.

8 **Sec. 10011.** RCW 47.32.070 and 1971 c 81 s 115 are each amended to
9 read as follows:

10 Six days after filing of the order above provided for, if no review
11 thereof be taken to the supreme court or the court of appeals of the
12 state, the clerk of the court shall issue under seal of such court a
13 writ directed to the sheriff of the county in which such court is held
14 commanding him or her to remove, take into custody and dispose of the
15 property described in such order and make returns thereof as provided
16 for such writ by said order. On receipt of such writ it shall be the
17 duty of such sheriff to obey the command thereof, proceed as therein
18 directed and make return within the time fixed by such writ; and said
19 sheriff shall be liable upon his or her official bond for the faithful
20 discharge of such duties. Upon filing of such return the clerk of
21 court shall make payments as provided for in the order of court. If by

31 The sureties on such bond shall justify as in other cases if the
32 sheriff requires it and in case they do not so justify when required,
33 the sheriff shall retain and sell or dispose of the property; and if
34 the sheriff does not require the sureties to justify, he or she shall
35 stand good for their sufficiency. He or she shall date and indorse his
36 or her acceptance upon the bond, and shall return the affidavit, bond

1 and justification, if any, to the office of the clerk of such superior
2 court, whereupon such clerk shall set the hearing thereof as a separate

13 state department of transportation's "Manual on Uniform Traffic Control
14 Devices for Streets and Highways." All persons traveling upon the
15 highway shall come to a complete stop at such a sign, and the
16 appearance of any sign so located is sufficient warning to a person
17 that he or she is required to stop. A person stopping at such a sign
18 shall proceed through that portion of the highway in a careful manner
19 and at a reasonable rate of speed not to exceed twenty miles per hour.
20 It is unlawful to fail to comply with the directions of any such stop
21 sign. When the findings of a traffic engineering study show that the
22 condition of an intersection is such that vehicles may safely enter the
23 major artery without stopping, the department or local authorities in
24 their respective jurisdictions shall install and maintain a "Yield"
25 sign.

26 **Sec. 10014.** RCW 47.36.200 and 2006 c 331 s 1 are each amended to
27 read as follows:

28 (1) When construction, repair, or maintenance work is conducted on
29 or adjacent to a public highway, county road, street, bridge, or other
30 thoroughfare commonly traveled and when the work interferes with the
31 normal and established mode of travel on the highway, county road,
32 street, bridge, or thoroughfare, the location shall be properly posted
33 by prominently displayed signs or (~~flagmen~~) flaggers or both. Signs
34 used for posting in such an area shall be consistent with the
35 provisions found in the state of Washington "Manual on Uniform Traffic

1 Control Devices for Streets and Highways" obtainable from the
2 department of transportation.

3 (2) If the construction, repair, or maintenance work includes or
4 uses grooved pavement, abrupt lane edges, steel plates, or gravel or
5 earth surfaces, the construction, repair, or maintenance zone must be
6 posted with signs stating the condition, as required by current law,
7 and in addition, must warn motorcyclists of the potential hazard only
8 if the hazard or condition exists on a paved public highway, county
9 road, street, bridge, or other thoroughfare commonly traveled. For the
10 purposes of this subsection, the department shall adopt by rule a
11 uniform sign or signs for this purpose, including at least the
12 following language, "MOTORCYCLES USE EXTREME CAUTION."

13 (3) Any contractor, firm, corporation, political subdivision, or
14 other agency performing such work shall comply with this section.

15 (4) Each driver of a motor vehicle used in connection with such
16 construction, repair, or maintenance work shall obey traffic signs
17 posted for, and flaggers stationed at such location in the same manner
18 and under the same restrictions as is required for the driver of any
19 other vehicle.

20 (5) A violation of or a failure to comply with this section is a
21 misdemeanor. Each day upon which there is a violation, or there is a
22 failure to comply, constitutes a separate violation.

23 **Sec. 10015.** RCW 47.41.040 and 1984 c 7 s 218 are each amended to
24 read as follows:

25 Before July 1, 1971, the department shall determine whether or not
26 the topography of the land adjoining the highway will permit adequate
27 screening of any junkyard lawfully in existence located outside of a
28 zoned industrial area or an unzoned industrial area as defined under
29 RCW 47.41.030 on August 9, 1971, that is within one thousand feet of
30 the nearest edge of the right-of-way and visible from the main traveled
31 way of any highway on the interstate and primary system and whether
32 screening of the junkyard would be economically feasible. Within
33 thirty days thereafter the department shall notify by certified mail
34 the record owner of the land upon which the junkyard is located, or the
35 operator thereof, of its determination.

36 If it is economically feasible to screen the junkyard, the
37 department shall screen the junkyard so that it will not be visible

1 from the main-traveled way of the highway. The department is
2 authorized to acquire by gift, purchase, exchange, or condemnation such
3 lands or interest in lands as may be required for these purposes.

4 If it is not economically feasible to screen the junkyard, the
5 department shall acquire by purchase, gift, or condemnation an interest
6 in the real property used for junkyard purposes that is visible from
7 the main traveled way of the highway, restricting any owner of the
8 remaining interest to use of the real estate for purposes other than a
9 junkyard. In addition to compensation for the real property interest,
10 the operator of a junkyard shall receive the actual reasonable expenses
11 in moving his or her business personal property to a location within
12 the same general area where a junkyard may be lawfully established,
13 operated, and maintained. This section shall be interpreted as being
14 in addition to all other rights and remedies of a junkyard owner or
15 operator and shall not be interpreted as a limitation on or alteration
16 of the law of compensation in eminent domain.

17 **Sec. 10016.** RCW 47.42.080 and 1985 c 376 s 6 are each amended to
18 read as follows:

19 (1) Any sign erected or maintained contrary to the provisions of
20 this chapter or rules adopted hereunder that is designed to be viewed
21 from the interstate system, the primary system, or the scenic system is
22 a public nuisance, and the department, the chief of the Washington
23 state patrol, the county sheriff, or the chief of police of any city or
24 town shall notify the permittee or, if there is no permittee, the owner
25 of the property on which the sign is located, by certified mail at his
26 or her last known address, that it constitutes a public nuisance and
27 must comply with the chapter or be removed.

28 (2) If the permittee or owner, as the case may be, fails to comply
29 with the chapter or remove any such sign within fifteen days after
30 being notified to remove the sign he or she is guilty of a misdemeanor.
31 In addition to the penalties imposed by law upon conviction, an order
32 may be entered compelling removal of the sign. Each day the sign is
33 maintained constitutes a separate offense.

34 (3) If the permittee or the owner of the property upon which it is
35 located, as the case may be, is not found or refuses receipt of the
36 notice, the department, the chief of the Washington state patrol, the
37 county sheriff, or the chief of police of any city or town shall post

1 the sign and property upon which it is located with a notice that the
2 sign constitutes a public nuisance and must be removed. If the sign is
3 not removed within fifteen days after such posting, the department, the
4 chief of the Washington state patrol, the county sheriff, or the chief
5 of police of any city or town shall abate the nuisance and destroy the
6 sign, and for that purpose may enter upon private property without
7 incurring liability for doing so.

8 (4) Nothing in this section may be construed to affect the
9 provisions contained in RCW 47.42.102 requiring the payment of
10 compensation upon the removal of any signs compensable under state law.

11 (5) Any sign erected or maintained on state highway right-of-way
12 contrary to this chapter or rules adopted under it is a public
13 nuisance, and the department is authorized to remove any such sign
14 without notice.

15 **Sec. 10017.** RCW 47.42.103 and 1984 c 7 s 229 are each amended to
16 read as follows:

17 (1) Compensation as required by RCW 47.42.102 shall be paid to the
18 person or persons entitled thereto for the removal of such signs. If
19 no agreement is reached on the amount of compensation to be paid, the
20 department may institute an action by summons and complaint in the
21 superior court for the county in which the sign is located to obtain a
22 determination of the compensation to be paid. If the owner of the sign
23 is unknown and cannot be ascertained after diligent efforts to do so,
24 the department may remove the sign upon the payment of compensation
25 only to the owner of the real property on which the sign is located.
26 Thereafter the owner of the sign may file an action at any time within
27 one year after the removal of the sign to obtain a determination of the
28 amount of compensation he or she should receive for the loss of the
29 sign. If either the owner of the sign or the owner of the real
30 property on which the sign is located cannot be found within the state,
31 service of the summons and complaint on such person for the purpose of
32 obtaining a determination of the amount of compensation to be paid may
33 be by publication in the manner provided by RCW 4.28.100.

34 (2) If compensation is determined by judicial proceedings, the sum
35 so determined shall be paid into the registry of the court to be
36 disbursed upon removal of the sign by its owner or by the owner of the
37 real property on which the sign is located. If the amount of

1 compensation is agreed upon, the department may pay the agreed sum into
2 escrow to be released upon the removal of the sign by its owner or the
3 owner of the real property on which the sign is located.

4 (3) The state's share of compensation shall be paid from the motor
5 vehicle fund, or if a court having jurisdiction enters a final judgment
6 declaring that motor vehicle funds may not be used, then from the
7 general fund.

8 **Sec. 10018.** RCW 47.52.150 and 1977 ex.s. c 151 s 64 are each
9 amended to read as follows:

10 Upon request for a hearing before the board by any county, city, or
11 town, a board consisting of five members shall be appointed as follows:
12 The mayor or the county commissioners, as the case may be shall appoint
13 two members of the board, of which one shall be a duly elected official
14 of the city, county, or legislative district, except that of the
15 legislative body of the county, city, or town requesting the hearing,
16 subject to confirmation by the legislative body of the city or town;
17 the secretary of transportation shall appoint two members of the board;
18 and one member shall be selected by the four members thus appointed.
19 Such fifth member shall be a licensed civil engineer or a recognized
20 professional city or town planner, who shall be (~~chairman~~) chair of
21 the board. In the case both the county and an included city or town
22 request a hearing, the board shall consist of nine members appointed as
23 follows: The mayor and the county commission shall each appoint two
24 members from the elective officials of their respective jurisdictions,
25 and of the four thus selected no more than two thereof may be members
26 of a legislative body of the county, city, or town. The secretary of
27 transportation shall appoint four members of the board. One member
28 shall be selected by the members thus selected, and such ninth member
29 shall be a licensed civil engineer or a recognized city or town
30 planner, who shall be (~~chairman~~) chair of the board. Such boards as
31 are provided by this section shall be appointed within thirty days
32 after the receipt of such a request by the secretary. In the event the
33 secretary or a county, city, or town shall not appoint members of the
34 board or members thus appointed fail to appoint a fifth or ninth member
35 of the board, as the case may be, either the secretary or the county,
36 city, or town may apply to the superior court of the county in which

1 the county, city, or town is situated to appoint the member or members
2 of the board in accordance with the provisions of this chapter.

3 **Sec. 10019.** RCW 47.52.170 and 1961 c 13 s 47.52.170 are each
4 amended to read as follows:

5 No witness's testimony shall be received unless he or she shall
6 have been duly sworn, and the board may cause all oral testimony to be
7 stenographically reported. Members of the board, its duly authorized
8 representatives, and all persons duly commissioned by it for the
9 purpose of taking depositions, shall have power to administer oaths; to
10 preserve and enforce order during such hearings; to issue subpoenas
11 for, and to compel the attendance and testimony of witnesses, or the
12 production of books, papers, documents and other evidence, or the
13 taking of depositions before any designated individual competent to
14 administer oaths, and it shall be their duty so to do; to examine
15 witnesses; and to do all things conformable to law which may be
16 necessary to enable them, or any of them, effectively to discharge the
17 duties of their office.

18 **Sec. 10020.** RCW 47.60.310 and 1988 c 100 s 1 are each amended to
19 read as follows:

20 (1) The department is further directed to conduct such review by
21 soliciting and obtaining expressions from local community groups in
22 order to be properly informed as to problems being experienced within
23 the area served by the Washington state ferries. In order that local
24 representation may be established, the department shall give prior
25 notice of the review to the ferry advisory committees.

26 (2) The legislative authorities of San Juan, Skagit, Clallam, and
27 Jefferson counties shall each appoint a committee to consist of five
28 members to serve as an advisory committee to the department or its
29 designated representative in such review. The legislative authorities

30 (b) To cause or attempt to cause an employer to discriminate
31 against an employee in violation of subsection (1)(c) of this section;

32 (c) To refuse to bargain collectively with an employer.

33 (3) The expression of any view, argument, or opinion, or the
34 dissemination thereof to the public, whether in written, printed,
35 graphic, or visual form, shall not constitute or be evidence of an
36 unfair labor practice under any of the provisions of this chapter, if
37 the expression contains no threat of reprisal or force or promise of
38 benefit.

11 employment free from recognized hazards that are causing or likely to

14 employer solely under the authority of this subsection except where no
15 applicable rule or regulation has been adopted by the department
16 covering the unsafe or unhealthful condition of employment at the work

19 promulgated under this chapter.

20 **Sec. 12008.** RCW 49.17.080 and 1973 c 80 s 8 are each amended to
21 read as follows:

22 (1) Any employer may apply to the director for a temporary order
23 granting a variance from any safety and health standard promulgated by
24 rule or regulation under the authority of this chapter. Such temporary
25 order shall be granted only if the employer files an application which
26 meets the requirements of subsection (2) of this section and
27 establishes that the employer is unable to comply with a safety or
28 health standard because of the unavailability of professional or
29 technical personnel or of materials and equipment needed to come into
30 compliance with the safety and health standard or because necessary
31 construction or alteration of facilities cannot be completed by the
32 effective date of such safety and health standard, that he or she is
33 taking all available steps to safeguard his or her employees against
34 the hazards covered by the safety and health standard, and he or she

36 and health standard as quickly as practicable. Any temporary order

2 practices, means, methods, operations, and processes which the employer

7 or any affected employee. The name of any affected employee requesting

11 determination is made or a decision rendered if a hearing is demanded.
12 No temporary order may be in effect for longer than the period needed
13 by the employer to achieve compliance with the standard, or one year,
14 whichever is shorter, except that such an order may be renewed not more
15 than twice, so long as the requirements of this subsection are met and
16 if an application for renewal is filed at least ninety days prior to
17 the expiration date of the order. No renewal of a temporary order may
18 remain in effect for longer than one hundred eighty days.

22 thereof from which the employer seeks a variance;

38 employees or their authorized representative by posting a copy of such

2 or by other appropriate means of notification and by mailing a copy to
3 the authorized representative of such employees; the application shall
4 set forth the manner in which the employees have been so informed. The
5 application shall also advise employees and their employee
6 representatives of their right to apply to the director to conduct a
7 hearing upon the application for a variance.

8 **Sec. 12009.** RCW 49.17.090 and 1973 c 80 s 9 are each amended to
9 read as follows:

10 Any employer may apply to the director for an order for a variance
11 from any rule or regulation establishing a safety and health standard
12 promulgated under this chapter. Affected employees shall be given
13 notice of each such application and in the manner prescribed by RCW
14 49.17.080 shall be informed of their right to request a hearing on any
15 such application. The director shall issue such order granting a
16 variance, after opportunity for an inspection, if he or she determines
17 or decides after a hearing has been held, if request for hearing has

36 A representative of the employer and an employee representative

1 authorized by the employees of such employer shall be given an
2 opportunity to accompany the director, or his or_her authorized

22 of employees who in good faith believes that a violation of a safety or
23 health standard, promulgated by rule under the authority of this
24 chapter exists that threatens physical harm to employees, or that an

26 the work place by giving notice to the director or his or_her
27 authorized representative of such violation or danger. Any such notice

5 employee, and an order of immediate restraint of the use of such
6 machine or equipment has been issued under this subsection, the use of
7 such machine or equipment is prohibited, and a notice to that effect

9 representative.

10 (2) Whenever the director, or his or her authorized representative,
11 concludes that a condition of employment described in subsection (1) of
12 this section exists in any work place, he or she shall promptly inform
13 the affected employees and employers of the danger.

14 (3) At any time that a citation or a citation and order restraining
15 any condition of employment or practice described in subsection (1) of
16 this section is issued by the director, or his or her authorized
17 representative, he or she may in addition request the attorney general
18 to make an application to the superior court of the county wherein such

20 probability that death or serious physical harm could result to any
21 employee immediately or before the imminence of such danger can be

34 relief or temporary restraining order pending the outcome of

36 temporary restraining order issued without notice shall be effective
37 for a period longer than five working days.

1 (3) Whenever and as soon as any authorized representative of the
2 director concludes that a condition or practice described in subsection
3 (1) exists in any work place, he or_she shall inform the affected
4 employees and employers of the danger and may recommend to the director
5 that relief be sought under this section.

6 (4) If the director arbitrarily or capriciously fails to invoke his
7 or_her restraining authority under RCW 49.17.130 or fails to seek
8 relief under this section, any employee who may be injured by reason of

11 which the danger is alleged to exist for a writ of mandamus to compel
12 the director to seek such an order and for such further relief as may
13 be appropriate or seek the director to exercise his or_her restraining
14 authority under RCW 49.17.130.

15 **Sec. 12015.** RCW 49.17.180 and 1995 c 403 s 629 are each amended to
16 read as follows:

17 (1) Except as provided in RCW 43.05.090, any employer who willfully
18 or repeatedly violates the requirements of RCW 49.17.060, of any safety
19 or health standard promulgated under the authority of this chapter, of
20 any existing rule or regulation governing the conditions of employment
21 promulgated by the department, or of any order issued granting a
22 variance under RCW 49.17.080 or 49.17.090 may be assessed a civil
23 penalty not to exceed seventy thousand dollars for each violation. A
24 minimum penalty of five thousand dollars shall be assessed for a
25 willful violation.

26 (2) Any employer who has received a citation for a serious
27 violation of the requirements of RCW 49.17.060, of any safety or health

17 than six months, or by both.

18 (2) Whoever knowingly makes any false statement, representation, or

19 provision of this section defining a crime has been violated by an
20 employer, the director shall cause a record of such alleged violation
21 to be prepared, a copy of which shall be referred to the prosecuting
22 attorney of the county wherein such alleged violation occurred, and the
23 prosecuting attorney of such county shall in writing advise the
24 director of the disposition he or_she shall make of the alleged
25 violation.

28 All information reported to or otherwise obtained by the director,
29 or his or_her authorized representative, in connection with any
30 inspection or proceeding under the authority of this chapter, which
31 contains or which might reveal a trade secret shall be considered
32 confidential, except that such information may be disclosed to other
33 officers or employees concerned with carrying out this chapter, or when
34 relevant in any proceeding under this chapter. In any such proceeding
35 the director, the board of industrial insurance appeals, or the court
36 shall issue such orders as may be appropriate to protect the
37 confidentiality of trade secrets.

1 **Sec. 12018.** RCW 49.17.220 and 1973 c 80 s 22 are each amended to
2 read as follows:

3 (1) Each employer shall make, keep, and preserve, and make
4 available to the director such records regarding his or her activities
5 relating to this chapter as the director may prescribe by regulation as
6 necessary or appropriate for the enforcement of this chapter or for
7 developing information regarding the causes and prevention of
8 occupational accidents and illnesses. In order to carry out the
9 provisions of this section such regulations may include provisions
10 requiring employers to conduct periodic inspections. The director
11 shall also issue regulations requiring that employers, through posting
12 of notices or other appropriate means, keep their employees informed of
13 their protections and obligations under this chapter, including the
14 provisions of applicable safety and health standards.

37 read as follows:

1 (1) The director in the promulgation of rules under the authority
2 of this chapter shall establish safety and health standards for
3 conditions of employment of general and/or specific applicability for
4 all industries, businesses, occupations, crafts, trades, and
5 employments subject to the provisions of this chapter, or those that
6 are a national or accepted federal standard. In adopting safety and
7 health standards for conditions of employment, the director shall
8 solicit and give due regard to all recommendations by any employer,

25 such exposure. In the event that such medical examinations are in the
26 nature of research, as determined by the director, such examinations
27 may be furnished at the expense of the department. The results of such
28 examinations or tests shall be furnished only to the director, other
29 appropriate agencies of government, and at the request of the employee
30 to his or her physician.

31 (3) Whenever the director adopts by rule any safety and health
32 standard he or she may at the same time provide by rule the effective
33 date of such standard which shall not be less than thirty days,
34 excepting emergency rules, but may be made effective at such time in
35 excess of thirty days from the date of adoption as specified in any
36 rule adopting a safety and health standard. Any rule not made
37 effective thirty days after adoption, having a delayed effectiveness in

1 Every employer of persons for work in compressed air shall:

2 (1) Connect at least two air pipes with the working chamber and
3 keep such pipes in perfect working condition;

6 charge of competent persons, with a period of duty for each such person
7 not exceeding six hours in any twenty-four;

32 agreement which regulates hours of work and overtime pay;

35 et seq. and 49 U.S.C. Sec. 10101 et seq.), if the compensation system
36 under which the truck or bus driver is paid includes overtime pay,

3 (g) Any individual employed (i) on a farm, in the employ of any
4 person, in connection with the cultivation of the soil, or in
5 connection with raising or harvesting any agricultural or horticultural
6 commodity, including raising, shearing, feeding, caring for, training,
7 and management of livestock, bees, poultry, and furbearing animals and
8 wildlife, or in the employ of the owner or tenant or other operator of
9 a farm in connection with the operation, management, conservation,
10 improvement, or maintenance of such farm and its tools and equipment;
11 or (ii) in packing, packaging, grading, storing or delivering to
12 storage, or to market or to a carrier for transportation to market, any
13 agricultural or horticultural commodity; or (iii) commercial canning,
14 commercial freezing, or any other commercial processing, or with
15 respect to services performed in connection with the cultivation,
16 raising, harvesting, and processing of oysters or in connection with
17 any agricultural or horticultural commodity after its delivery to a
18 terminal market for distribution for consumption;

19 (h) Any industry in which federal law provides for an overtime
20 payment based on a work week other than forty hours. However, the
21 provisions of the federal law regarding overtime payment based on a
22 work week other than forty hours shall nevertheless apply to employees
23 covered by this section without regard to the existence of actual
24 federal jurisdiction over the industrial activity of the particular
25 employer within this state. For the purposes of this subsection,
26 "industry" means a trade, business, industry, or other activity, or
27 branch, or group thereof, in which individuals are gainfully employed
28 (section 3(h) of the Fair Labor Standards Act of 1938, as amended
29 (Public Law 93-259));

30 (i) Any hours worked by an employee of a carrier by air subject to
31 the provisions of subchapter II of the Railway Labor Act (45 U.S.C.
32 Sec. 181 et seq.), when such hours are voluntarily worked by the
33 employee pursuant to a shift-trading practice under which the employee
34 has the opportunity in the same or in other work weeks to reduce hours
35 worked by voluntarily offering a shift for trade or reassignment.

36 (3) No employer shall be deemed to have violated subsection (1) of
37 this section by employing any employee of a retail or service

1 establishment for a work week in excess of the applicable work week
2 specified in subsection (1) of this section if:

3 (a) The regular rate of pay of the employee is in excess of one and
4 one-half times the minimum hourly rate required under RCW 49.46.020;
5 and

6 (b) More than half of the employee's compensation for a
7 representative period, of not less than one month, represents
8 commissions on goods or services.

9 In determining the proportion of compensation representing
10 commissions, all earnings resulting from the application of a bona fide
11 commission rate is to be deemed commissions on goods or services
12 without regard to whether the computed commissions exceed the draw or
13 guarantee.

14 (4) No employer of commissioned salespeople primarily engaged in
15 the business of selling automobiles, trucks, recreational vessels,

24 rate for all hours worked over forty hours in one week; or

25 (b) A straight commission, a salary plus commission, or a salary
26 plus bonus applied to gross salary.

29 fire protection activities or any employee in law enforcement
30 activities (including security personnel in correctional institutions)
31 if: (a) In a work period of twenty-eight consecutive days the employee
32 receives for tours of duty which in the aggregate exceed two hundred
33 forty hours; or (b) in the case of such an employee to whom a work
34 period of at least seven but less than twenty-eight days applies, in
35 his or her work period the employee receives for tours of duty which in
36 the aggregate exceed a number of hours which bears the same ratio to
37 the number of consecutive days in his or her work period as two hundred

1 forty hours bears to twenty-eight days; compensation at a rate not less
2 than one and one-half times the regular rate at which he or she is
3 employed.

6 (1) An employer that imposes an automatic service charge related to

11 (2) For purposes of this section:

19 openly, clearly, and in due course recorded in the employer's books and
20 records.

21 Paragraph three of this section shall not be construed to affect
22 the right of any employer or former employer to sue upon or collect any
23 debt owed to said employer or former employer by his or her employees
24 or former employees.

27 In any action in which any person is successful in recovering
28 judgment for wages or salary owed to him or her, reasonable attorney's

20 circumstances, whether arising out of a recognition dispute, bargaining

24 employer, unless an effect of such picketing or other publicity is (a)

32 The director shall have the power to make such rules and
33 regulations not inconsistent with this chapter, including the

2 she shall determine are necessary to effectuate its purpose and to
3 enable him or her to carry out its provisions.

3 Whereas, economic insecurity due to unemployment is a serious
4 menace to the health, morals, and welfare of the people of this state;
5 involuntary unemployment is, therefore, a subject of general interest
6 and concern which requires appropriate action by the legislature to
7 prevent its spread and to lighten its burden which now so often falls
8 with crushing force upon the unemployed worker and his or her family.
9 Social security requires protection against this greatest hazard of our
10 economic life. This can be provided only by application of the
11 insurance principle of sharing the risks, and by the systematic
12 accumulation of funds during periods of employment to provide benefits
13 for periods of unemployment, thus maintaining purchasing powers and
14 limiting the serious social consequences of relief assistance. The
15 state of Washington, therefore, exercising herein its police and
16 sovereign power endeavors by this title to remedy any widespread
17 unemployment situation which may occur and to set up safeguards to
18 prevent its recurrence in the years to come. The legislature,
19 therefore, declares that in its considered judgment the public good,
20 and the general welfare of the citizens of this state require the
21 enactment of this measure, under the police powers of the state, for
22 the compulsory setting aside of unemployment reserves to be used for
23 the benefit of persons unemployed through no fault of their own, and
24 that this title shall be liberally construed for the purpose of
25 reducing involuntary unemployment and the suffering caused thereby to
26 the minimum.

29 "Benefits" means the compensation payable to an individual, as

8 The term "employment" shall not include services as an outside

13 **Sec. 13005.** RCW 50.04.290 and 1945 c 35 s 30 are each amended to
14 read as follows:

21 registrations for employment, and all job or placement referrals

4 remuneration paid by one employer during any calendar year to an
5 individual in its employment under this title or the unemployment
6 compensation law of any other state in the amount specified in RCW
7 50.24.010. If an employer (hereinafter referred to as a successor
8 employer) during any calendar year acquires substantially all the
9 operating assets of another employer (hereinafter referred to as a
10 predecessor employer) or assets used in a separate unit of a trade or

11 the compensation serves to make the individual eligible for all regular

28 department will employ supervisory and investigative personnel for the
29 program, who must be qualified by training and experience.

30 (3) The commissioner or the commissioner's duly authorized designee
31 is authorized to receive criminal history record information that
32 includes nonconviction data for any purpose associated with the
33 investigation for abuse or fraud under chapter 50.20 RCW.
34 Dissemination or use of nonconviction data for purposes other than that
35 authorized in this section is prohibited.

1 The commissioner is hereby authorized to enter into arrangements
2 with the appropriate agencies of other states, foreign governments, or

6 within any one of the states (1) in which any part of such individual's

31 The sheriff of any county, upon request of the commissioner or his
32 or her duly authorized representative, or upon request of the attorney

35 is granted to the commissioner or his or her duly authorized

1 representative. No bond shall be required by the sheriff of any county
2 for services rendered for the commissioner, his or her duly authorized
3 representative, or the attorney general. The sheriff shall be allowed
4 such fees as may be prescribed for like or similar official services.

31 collection of contributions.

32 **Sec. 13029.** RCW 50.24.080 and 1979 ex.s. c 190 s 4 are each
33 amended to read as follows:

34 If the commissioner shall have reason to believe that an employer
35 is insolvent or if any reason exists why the collection of any
36 contributions accrued will be jeopardized by delaying collection, he or

1 she may make an immediate assessment thereof and may proceed to enforce
2 collection immediately, but interest and penalties shall not begin to
3 accrue upon any contributions until the date when such contributions
4 would normally have become delinquent.

5 **Sec. 13030.** RCW 50.24.090 and 1979 ex.s. c 190 s 5 are each
6 amended to read as follows:

7 If the amount of contributions, interest, or penalties assessed by
8 the commissioner by order and notice of assessment provided in this
9 title is not paid within ten days after the service or mailing of the

12 assessment by the distraint, seizure, and sale of the property, goods,

9 proceeding in making the sale, and shall transfer to the purchaser all
10 right, title, and interest of the delinquent employer in said property.
11 The proceeds of any such sale, except in those cases wherein the
12 property has been acquired by the employment security department, shall
13 be first applied by the commissioner in satisfaction of the delinquent
14 account, and out of any sum received in excess of the amount of
15 delinquent contributions, interest, and penalties the administration
16 fund shall be reimbursed for the costs of distraint and sale. Any
17 excess which shall thereafter remain in the hands of the commissioner
18 shall be refunded to the delinquent employer. Sums so refundable to a
19 delinquent employer may be subject to seizure or distraint in the hands
20 of the commissioner by any other taxing authority of the state or its
21 political subdivisions.

24 Whenever any order and notice of assessment or jeopardy assessment
25 shall have become final in accordance with the provisions of this title

29 county wherein the warrant is filed shall immediately designate a

7 commissioner to the employer or employing unit. A copy of the warrant
8 shall be mailed to the employer or employing unit by certified mail to
9 his or her last known address within five days of filing with the
10 clerk.

12 amended to read as follows:

13 Remedies given to the state under this title for the collection of
14 contributions, interest, or penalties shall be cumulative and no action
15 taken by the commissioner or his or her duly authorized representative,
16 the attorney general, or any other officer shall be construed to be an
17 election on the part of the state or any of its officers to pursue any
18 remedy to the exclusion of any other.

19 **Sec. 13034.** RCW 50.24.150 and 1979 ex.s. c 190 s 13 are each
20 amended to read as follows:

21 No later than three years after the date on which any
22 contributions, interest, or penalties have been paid, an employer who
23 has paid such contributions, interest, or penalties may file with the
24 commissioner a petition in writing for an adjustment thereof in
25 connection with subsequent contribution payments or for a refund
26 thereof when such adjustment cannot be made. If the commissioner upon
27 an ex parte consideration shall determine that such contributions,

30 tribunals, each of which shall consist of an administrative law judge

33 disputed claim in any case in which he or_she is an interested party.
34 Wherever the term "appeal tribunal" or "the appeal tribunal" is used in
35 this title the same refers to an appeal tribunal established under the
36 provisions of this section. Notice of any appeal or petition for

1 hearing taken to an appeal tribunal in any proceeding under this title
2 may be filed with such agency as the commissioner may by regulation
3 prescribe.

5 amended to read as follows:

6 After having acquired jurisdiction for review, the commissioner
7 shall review the proceedings in question. Prior to rendering his or

10 case. Upon the basis of evidence submitted to the appeal tribunal and
11 such additional evidence as the commissioner may order to be taken, the
12 commissioner shall render his or her decision in writing affirming,
13 modifying, or setting aside the decision of the appeal tribunal.
14 Alternatively, the commissioner may order further proceedings to be
15 held before the appeal tribunal, upon completion of which the appeal
16 tribunal shall issue a decision in writing affirming, modifying, or
17 setting aside its previous decision. The new decision may be appealed
18 under RCW 50.32.070. The commissioner shall mail his or her decision
19 to the interested parties at their last known addresses.

22 No individual shall be charged fees of any kind in any proceeding
23 involving the individual's application for initial determination, or
24 claim for waiting period credit, or claim for benefits, under this
25 title by the commissioner or his or her representatives, or by an
26 appeal tribunal, or any court, or any officer thereof. Any individual
27 in any such proceeding before the commissioner or any appeal tribunal
28 may be represented by counsel or other duly authorized agent who shall
29 neither charge nor receive a fee for such services in excess of an
30 amount found reasonable by the officer conducting such proceeding.

13 religious order in the exercise of duties required by such order; or

14 (3) In a facility conducted for the purpose of carrying out a
15 program of (a) rehabilitation for individuals whose earning capacity is
16 impaired by age or physical or mental deficiency or injury, or (b)
17 providing remunerative work for individuals who because of their
18 impaired physical or mental capacity cannot be readily absorbed in the
19 competitive labor market, by an individual receiving such
20 rehabilitation or remunerative work; or

21 (4) As part of an unemployment work-relief or work-training program
22 assisted or financed in whole or in part by a federal agency or an
23 agency of a state or political subdivision thereof, by an individual
24 receiving such work-relief or work-training; or

25 (5) For a custodial or penal institution by an inmate of the
26 custodial or penal institution; or

27 (6) In the employ of a hospital, if such service is performed by a
28 patient of such hospital; or

29 (7) In the employ of a school, college, or university, if such
30 service is performed (a) by a student who is enrolled and is regularly
31 attending classes at such school, college, or university, or (b) by the
32 spouse of such a student, if such spouse is advised, at the time such
33 spouse commences to perform such service, that (i) the employment of
34 such spouse to perform such service is provided under a program to
35 provide financial assistance to such student by such school, college,
36 or university, and (ii) such employment will not be covered by any
37 program of unemployment insurance; or

1 (8) By an individual under the age of twenty-two who is enrolled at
2 a nonprofit or public educational institution which normally maintains
3 a regular faculty and curriculum and normally has a regularly organized
4 body of students in attendance at the place where its educational
5 activities are carried on as a student in a full time program, taken
6 for credit at such institution, which combines academic instruction
7 with work experience, if such service is an integral part of such
8 program, and such institution has so certified to the employee, except
9 that this subsection shall not apply to service performed in a program
10 established for or on behalf of an employer or group of employers; or

12 exclusively to the area of child development training of preschool age
13 children through an established curriculum of formal classroom or

17 (10) In the employ of the state or any of its instrumentalities or
18 political subdivisions of this state in any of its instrumentalities by

22 (c) In a policymaking position the performance of the duties of
23 which ordinarily do not require more than eight hours per week.

26 Benefits paid to employees of "nonprofit organizations" shall be
27 financed in accordance with the provisions of this section. For the
28 purpose of this section and RCW 50.44.070, the term "nonprofit

31 organizations.

32 (1) Any nonprofit organization which is, or becomes subject to this
33 title on or after January 1, 1972, shall pay contributions under the

35 accordance with this subsection, to pay to the commissioner for the
36 unemployment compensation fund an amount equal to the full amount of

8 with the date on which such subjectivity begins by filing a written
9 notice of its election with the commissioner not later than thirty days
10 immediately following the date of the determination of such
11 subjectivity.

12 (b) Any nonprofit organization which makes an election in
13 accordance with ((paragraph)) (a) of this subsection will continue to
14 be liable for payments in lieu of contributions until it files with the
15 commissioner a written notice terminating its election not later than
16 thirty days prior to the beginning of the taxable year for which such
17 termination shall first be effective.

18 (c) Any nonprofit organization which has been paying contributions
19 under this title for a period subsequent to January 1, 1972, may change

35 determine whether the total of payments for such year made by a
36 nonprofit organization is less than, or in excess of, the total amount
37 of regular and additional benefits plus one-half of the amount of
38 extended benefits paid to individuals during such taxable year based on

1 wages attributable to service in the employ of such organization. Each
2 nonprofit organization whose total payments for such year are less than
3 the amount so determined shall be liable for payment of the unpaid

25 contributions shall pay to the commissioner for the fund the total
26 amount of regular and additional benefits plus the amount of one-half
27 of extended benefits paid that are attributable to service in the
28 employ of such employer. If benefits paid to an individual are based
29 on wages paid by more than one employer and one or more of such
30 employers are liable for payments in lieu of contributions, the amount
31 payable to the fund by each employer that is liable for such payments
32 shall be determined in accordance with the provisions of ~~((paragraphs))~~
33 (a) and (b) of this subsection.

34 (a) If benefits paid to an individual are based on wages paid by
35 one or more employers that are liable for payments in lieu of
36 contributions and on wages paid by one or more employers who are liable
37 for contributions, the amount of benefits payable by each employer that
38 is liable for payments in lieu of contributions shall be an amount

1 which bears the same ratio to the total benefits paid to the individual
2 as the total base-period wages paid to the individual by such employer
3 bear to the total base-period wages paid to the individual by all of
4 his or her base-period employers.

5 (b) If benefits paid to an individual are based on wages paid by
6 two or more employers that are liable for payments in lieu of
7 contributions, the amount of benefits payable by each such employer
8 shall be an amount which bears the same ratio to the total benefits

11 the individual by all of his or her base-period employers.

12 **Sec. 13044.** RCW 50.44.070 and 1973 c 73 s 11 are each amended to

14 In the discretion of the commissioner, any nonprofit organization
15 that elects to become liable for payments in lieu of contributions
16 shall be required within thirty days after the effective date of its
17 election, to execute and file with the commissioner a surety bond
18 approved by the commissioner or it may elect instead to deposit with
19 the commissioner money or securities. The amount of such bond or
20 deposit shall be determined in accordance with the provisions of this

20 **Sec. 14001.** RCW 51.04.110 and 1982 c 109 s 2 are each amended to
21 read as follows:

22 The director shall appoint a workers' compensation advisory
23 committee composed of ten members: Three representing subject workers,
24 three representing subject employers, one representing self-insurers,
25 one representing workers of self-insurers, and two ex officio members,
26 without a vote, one of whom shall be the ((chairman)) chair of the
27 board of industrial appeals and the other the representative of the
28 department. The member representing the department shall be
29 ((chairman)) chair. This committee shall conduct a continuing study of
30 any aspects of workers' compensation as the committee shall determine
31 require their consideration. The committee shall report its findings
32 to the department or the board of industrial insurance appeals for such
33 action as deemed appropriate. The members of the committee shall be
34 appointed for a term of three years commencing on July 1, 1971 and the
35 terms of the members representing the workers and employers shall be
36 staggered so that the director shall designate one member from each

1 such group initially appointed whose term shall expire on June 30, 1972
2 and one member from each such group whose term shall expire on June 30,
3 1973. The members shall serve without compensation, but shall be
4 entitled to travel expenses as provided in RCW 43.03.050 and 43.03.060
5 as now existing or hereafter amended. The committee may hire such
6 experts, if any, as it shall require to discharge its duties, and may
7 utilize such personnel and facilities of the department and board of
8 industrial insurance appeals as it shall need without charge. All
9 expenses of this committee shall be paid by the department.

10 **Sec. 14002.** RCW 51.12.080 and 1973 1st ex.s. c 154 s 92 are each
11 amended to read as follows:

12 Inasmuch as it has proved impossible in the case of employees of
13 common carriers by railroad, engaged in maintenance and operation of
14 railways doing interstate, foreign, and intrastate commerce, and in
15 maintenance and construction of their equipment, to separate and
16 distinguish the connection of such employees with interstate or foreign
17 commerce from their connection with intrastate commerce, and such
18 employees have, in fact, received no compensation under this title, the
19 provisions of this title shall not apply to work performed by such
20 employees in the maintenance and operation of such railroads or
21 performed in the maintenance or construction of their equipment, or to
22 the employees of such common carriers by railroad engaged therein, but
23 nothing herein shall be construed as excluding from the operation of
24 this title railroad construction work, or the employees engaged
25 thereon: PROVIDED, That common carriers by railroad engaged in such
26 interstate or foreign commerce and in intrastate commerce shall, in all
27 cases where liability does not exist under the laws of the United
28 States, be liable in damages to any person suffering injury while
29 employed by such carrier, or in case of the death of such employee, to
30 the surviving spouse and child, or children, and if no surviving spouse
31 or child or children, then to the parents, minor sisters, or minor
32 brothers, residents of the United States at the time of such death, and
33 who were dependent upon such deceased for support, to the same extent
34 and subject to the same limitations as the liability now existing, or
35 hereafter created, by the laws of the United States governing
36 recoveries by railroad employees injured while engaged in interstate
37 commerce: PROVIDED FURTHER, That if any interstate common carrier by

1 railroad shall also be engaged in one or more intrastate enterprises or
2 industries (including street railways and power plants) other than its
3 railroad, the foregoing provisions of this section shall not exclude
4 from the operation of the other sections of this title or bring under
5 the foregoing proviso of this section any work of such other enterprise
6 or industry, the payroll of which may be clearly separable and
7 distinguishable from the payroll of the maintenance or operation of
8 such railroad, or of the maintenance or construction of its equipment:
9 PROVIDED FURTHER, That nothing in this section shall be construed as
10 relieving an independent contractor engaged through or by his or her
11 employees in performing work for a common carrier by railroad, from the
12 duty of complying with the terms of this title, nor as depriving any
13 employee of such independent contractor of the benefits of this title.

14 **Sec. 14003.** RCW 51.14.040 and 1971 ex.s. c 289 s 29 are each
15 amended to read as follows:

16 (1) The surety on a bond filed by a self-insurer pursuant to this
17 title may terminate its liability thereon by giving the director
18 written notice stating when, not less than thirty days thereafter, such
19 termination shall be effective.

20 (2) In case of such termination, the surety shall remain liable, in
21 accordance with the terms of the bond, with respect to future
22 compensation for injuries to employees of the self-insurer occurring
23 prior to the termination of the surety's liability.

24 (3) If the bond is terminated for any reason other than the
25 employer's terminating his or her status as a self-insurer, the
26 employer shall, prior to the date of termination of the surety's
27 liability, otherwise comply with the requirements of this title.

28 (4) The liability of a surety on any bond filed pursuant to this
29 section shall be released and extinguished and the bond returned to the
30 employer or surety provided either such liability is secured by another
31 bond filed, or money or securities deposited as required by this title.

35 self-insurer by giving the director written notice stating when, not

14 all past delinquencies are made good, and such bond furnished.

15 **Sec. 14007.** RCW 51.16.170 and 1986 c 9 s 5 are each amended to
16 read as follows:

17 Separate and apart from and in addition to the foregoing provisions
18 in this chapter, the claims of the state for payments and penalties due
19 under this title shall be a lien prior to all other liens or claims and
20 on a parity with prior tax liens not only against the interest of any
21 employer, in real estate, plant, works, equipment, and buildings
22 improved, operated, or constructed by any employer, and also upon any
23 products or articles manufactured by such employer.

24 The lien created by this section shall attach from the date of the
25 commencement of the labor upon such property for which such premiums
26 are due. In order to avail itself of the lien hereby created, the
27 department shall, within four months after the employer has made report
28 of his or her payroll and has defaulted in the payment of his or her
29 premiums thereupon, file with the county auditor of the county within
30 which such property is then situated, a statement in writing describing
31 in general terms the property upon which a lien is claimed and stating
32 the amount of the lien claimed by the department. If any employer
33 fails or refuses to make report of his or her payroll, the lien hereby

35 thereof is undetermined and the four months' time within which the
36 department shall file its claim of lien shall not begin to run until

23 emergency medical apparatus and all other necessary or proper
24 facilities, machinery, and equipment for the prevention and suppression
25 of fires, the providing of emergency medical services and the
26 protection of life and property;

27 (2) Lease, acquire, own, maintain, and operate real property,
28 improvements, and fixtures for housing, repairing, and maintaining the
29 apparatus, facilities, machinery, and equipment described in subsection

13 The secretary of the district shall keep a record of the

25 (1) The purchaser shall enter into a contract with the district in
26 which the purchaser shall covenant that he or she will make the
27 payments of principal and interest when due, and that he or she will
28 pay all taxes and assessments on such property. Upon failure to make
29 payments of principal, interest, assessments, or taxes when due all
30 rights of the purchaser under said contract may, at the election of the
31 district, after notice to said purchaser, be declared to be forfeited.
32 When the rights of the purchaser are declared forfeited, the district
33 shall be released from all obligation to convey land covered by the
34 contract, and in the case of personal property, the district shall have
35 all rights granted to a secured party under chapter 62A.9 RCW;

1 (2) The district may, as it deems advisable, extend the time for
2 payment of principal and interest due or to become due;

3 (3) The district shall notify the purchaser in each instance when
4 payment is overdue, and that the purchaser is liable to forfeiture if
5 payment is not made within thirty days from the time the same became
6 due, unless the time be extended by the district;

7 (4) Not less than four percent of the total purchase price shall be
8 paid on the date of execution of the contract for sale and not less
9 than four percent shall be paid annually thereafter until the full
10 purchase price has been paid, but any purchaser may make full payment
11 at any time. All unpaid deferred payments shall draw interest at a
12 rate not less than six percent per annum.

13 Nothing in this section shall be deemed to supersede other

3 (1) Persons employed to perform the pilotage service of a port
4 district must be licensed under chapter 88.16 RCW to provide pilotage.

5 (2) Before establishing pilotage service, a port district shall
6 give at least sixty days' written notice to the ((~~chairman~~)) chair of
7 the board of pilotage commissioners to provide pilotage.

8 (3) A port district providing pilotage service under this section
9 requiring additional pilots may petition the board of pilotage

12 independently resolve jurisdictional disputes: PROVIDED, That when no
13 other procedure is available the procedures of RCW 49.08.010 shall be
14 followed in resolving such disputes. In such case the ((~~chairman~~)
15 chair of the public employment relations commission shall, at the
16 request of any employee organization, arbitrate any dispute between
17 employee organizations and enter a binding award in such dispute.

18 **Sec. 16006.** RCW 53.25.020 and 1955 c 73 s 2 are each amended to
19 read as follows:

20 It is further found and declared that:

21 (1) The existence of such marginal lands characterized by any or
22 all of such conditions constitutes a serious and growing menace which
23 is condemned as injurious and inimical to the public health, safety,
24 and welfare of the people of the communities in which they exist and of
25 the people of the state.

26 (2) Such marginal lands present difficulties and handicaps which
27 are beyond remedy and control solely by regulatory processes in the
28 exercise of the police power.

29 (3) They contribute substantially and increasingly to the problems
30 of, and necessitate excessive and disproportionate expenditures for,
31 crime prevention, correction, prosecution, and punishment, the
32 treatment of juvenile delinquency, the preservation of the public
33 health and safety, and the maintaining of adequate police, fire and
34 accident protection, and other public services and facilities.

35 (4) This menace is becoming increasingly direct and substantial in
36 its significance and effect.

1 (5) The benefits which will result from the remedying of such
2 conditions and the redevelopment of such marginal lands will accrue to
3 all the inhabitants and property owners of the communities in which
4 they exist.

5 (6) Such conditions of marginal lands tend to further obsolescence,
6 deterioration, and disuse because of the lack of incentive to the
7 individual landowner and his or her inability to improve, modernize, or
8 rehabilitate his or her property while the condition of the neighboring
9 properties remains unchanged.

10 (7) As a consequence the process of deterioration of such marginal
11 lands frequently cannot be halted or corrected except by redeveloping
12 the entire area, or substantial portions of it.

13 (8) Such conditions of marginal lands are chiefly found in areas
14 subdivided into small parcels, held in divided and widely scattered
15 ownerships, frequently under defective titles, and in many such
16 instances the private assembly of the land areas for redevelopment is
17 so difficult and costly that it is uneconomic and as a practical matter
18 impossible for owners to undertake because of lack of the legal power
19 and excessive costs.

21 acquisition at fair prices of adequate areas, the redevelopment of the
22 areas suffering from such conditions under proper supervision, with

26 governmental functions, and that the sale or leasing of such land after

29 the condition which caused said property to be marginal property as in
30 this chapter defined.

31 **Sec. 16007.** RCW 53.25.150 and 1984 c 195 s 2 are each amended to
32 read as follows:

33 If the commission chooses to sell the property through competitive
34 bidding under RCW 53.25.140:

35 (1) Bids may be submitted for the property or any part of it, shall
36 state the use which the bidder intends to make of it, and the

1 commission may require the successful bidder to file additional
2 information as to the intended use, and may require of him or her
3 security as assurance that the property will be used for that purpose;

4 (2) All sales shall be made to the best bidder, and in determining
5 the best bid, the commission may also consider the nature of the
6 proposed use and the relation thereof to the improvement of the harbor
7 and the business and facilities thereof;

8 (3) Within thirty days after the last day for submitting bids, the
9 commission shall decide which if any bids it accepts. All sales shall
10 be made upon such terms and conditions as the commission may prescribe.

11 **Sec. 16008.** RCW 53.25.160 and 1955 c 73 s 16 are each amended to
12 read as follows:

13 The purchaser shall, within one year from the date of purchase,
14 devote the property to its intended use, or shall commence work on the
15 improvements thereon to devote it to such use, and if he or she fails
16 to do so, the port commission may cancel the sale and return the money
17 paid on the purchase price, and title to the property shall revert to
18 the district. This remedy shall be in addition to any other remedy
19 under the terms of the sale. No purchaser shall transfer title to such
20 property within one year from the date of purchase.

21 **Sec. 16009.** RCW 53.34.020 and 1959 c 236 s 2 are each amended to
22 read as follows:

23 The district shall have the power to enter into a contract or
24 contracts for the use of said projects, their approaches and equipment
25 and from time to time to amend such contracts, with persons and with
26 private and public corporations, and by said contracts to give such
27 persons or corporations the right to use said projects, their
28 approaches and equipment for the transmission of power for telephone
29 and telegraph lines, for the transportation of water, gas, petroleum,
30 and other products, for railroad and railway purposes, and for any
31 other purpose to which the same may be adapted: PROVIDED, That no such
32 contract shall be for a period longer than ninety-nine years, and that
33 the projects shall be put to the largest possible number of uses
34 consistent with the purposes for which such projects are constructed.

35 In making such contract or contracts and providing for payments and
36 rentals thereunder the port district shall determine the value of the

1 separate and different uses to which the projects are to be put and
2 shall apportion the annual rentals and charges as nearly as possible
3 according to the respective values of such uses. No such contract
4 shall be made with any person or corporation unless and until such
5 person or corporation shall bind himself or herself or itself to pay as
6 rental therefor an amount determined by the port district and specified
7 in the contract which shall be a fair and just proportion of the total
8 amount required to pay interest on the bonds provided for in this
9 chapter, plus a just proportion of the amount necessary for their
10 retirement, and plus the cost of maintenance of the projects, their
11 approaches and equipment.

12 The port district may require any of such contracts to be entered
13 into before beginning the construction of said projects or before the
14 expenditure of funds under the provisions of this chapter if in its
15 judgment it is deemed expedient.

16 There shall be no monopoly of the use of said projects, and their
17 approaches by any one use, or by any person or corporation, private or
18 public, in respect to the several uses, and the port district may
19 continue to make separate, additional, and supplemental contracts for
20 one or more uses until in the judgment of said port district the
21 capacity of the projects and approaches for any such use has been
22 reached. When such capacity has been reached contracts for the use of
23 said projects shall be given preference in regard to such uses
24 according to the public interest as determined by the port district,
25 and subsequent contracts shall be subject to all existing and prior
26 contracts. The port district shall have the power to prescribe
27 regulations for the use of such facilities by the parties to contracts
28 for such use, or any of them, and to hear and determine all
29 controversies which may arise between such parties, under such rules as
30 the port district may from time to time promulgate; and all contracts
31 shall expressly reserve such power to the port district.

32 **Sec. 16010.** RCW 53.34.140 and 1959 c 236 s 14 are each amended to
33 read as follows:

34 Prior to the issuance and delivery of revenue bonds or notes under
35 the authority of this chapter, such revenue bonds or notes and a
36 certified copy of the resolution, resolutions, or trust agreements
37 authorizing such revenue bonds or notes shall be forwarded by the port

1 commission to the state auditor together with any additional
2 information requested by him or her, and when such revenue bonds or
3 notes have been examined they shall be registered by the auditor in
4 books to be kept by him or her for that purpose, and a certificate of
5 registration shall be endorsed upon each such revenue bond or note and
6 signed by the auditor or a deputy appointed by him or her for that
7 purpose.

8 Revenue bonds or notes so registered shall then be prima facie
9 valid and binding obligations of the port district in accordance with
10 the terms thereof, notwithstanding any defect or irregularity in the
11 proceedings for the authorization and issuance of such revenue bonds or
12 notes or in the sale, execution or delivery thereof or in the
13 application of the proceeds thereof.

14 **Sec. 16011.** RCW 53.36.010 and 1983 c 250 s 1 are each amended to
15 read as follows:

16 The treasurer of the county in which a port district is located
17 shall be treasurer of the district unless the commission of a port
18 district which has for the last three consecutive years received annual
19 gross operating revenues of one hundred thousand dollars or more,
20 excluding tax revenues and grants for capital purposes, designates by
21 resolution some other person having experience in financial or fiscal
22 matters as treasurer of the port district to act with the same powers
23 and under the same restrictions as provided by law for a county
24 treasurer acting on behalf of a port district: PROVIDED, That any port
25 district which was authorized by the county treasurer to appoint its
26 own treasurer prior to July 24, 1983, may continue to appoint its own

1 **Sec. 16012.** RCW 53.36.050 and 1997 c 393 s 10 are each amended to
2 read as follows:

3 The county treasurer acting as port treasurer shall create a fund
4 to be known as the "Port of Fund," into which shall be paid
5 all money received by him or her from the collection of taxes in behalf
6 of such port district, and shall also maintain such other special funds
7 as may be created by the port commission into which shall be placed
8 such moneys as the port commission may by its resolution direct. All
9 such port funds shall be deposited with the county depositories under
10 the same restrictions, contracts, and security as is provided by
11 statute for county depositories and all interest collected on such port

12 favor of consolidation, the board of county commissioners shall so
13 declare, and the port district resulting from the consolidation shall
14 then be and become a municipal corporation of the state of Washington.
15 The county auditor shall in such event issue a certificate of election

8 commission of such consolidated port district shall certify to the
9 principal county auditor the budget and the levies to be assessed for

8 be inactive and which is sought to be dissolved;

9 (2) Allege with particularity that the port district sought to be
10 dissolved is inactive within the purview of any of the several
11 particulars set forth in RCW 53.47.020; and

12 (3) Request that the court find the port district inactive and
13 declare it dissolved upon such terms and conditions as the court may
14 impose and declare.

15 **Sec. 16018.** RCW 53.47.040 and 1973 1st ex.s. c 195 s 59 are each
16 amended to read as follows:

17 The superior court, upon the filing of such petition, shall set
18 such petition for hearing not less than one hundred twenty days and not
19 more than one hundred eighty days after the date of filing said
20 petition. Further, the court shall order the clerk of said court to
21 give notice of the time and place fixed for the hearing by publication
22 of notice in a newspaper of general circulation within such district,
23 such publication to be once each week for three consecutive weeks, the

7 The court upon hearing the petition shall fix and determine all
8 such claims subject to proof being properly filed as provided in this
9 section; shall fix and determine the financial condition of the
10 district as to its assets and liabilities, and if it finds the port
11 district to be inactive in respect of any standard of inactivity set
12 forth by this chapter, shall order the port district to be dissolved
13 upon the following terms and conditions:

14 (1) If there be no outstanding debts, or if the debts be less than
15 the existing assets, the court shall appoint the auditor of the county
16 in which the port district is located to be trustee of the port's
17 assets and shall empower such person to wind up and liquidate the
18 affairs of such district in such manner as the court shall provide and
19 to file his or her accounting with the court within ninety days from
20 the date of his or her appointment. Upon the filing of such account,
21 the court shall fix a date for hearing upon the same and upon approval

32 the court to continue to make such annual levies as are required for
33 the purpose of debt service upon said bonded debt.

34 **Sec. 16019.** RCW 53.49.020 and 1943 c 282 s 2 are each amended to
35 read as follows:

36 The superior court of any such county shall enter his or her order
37 authorizing such transfer of funds if he or she is satisfied, after

1 hearing the petition therefor, that the port district is dissolved and
2 disestablished or is about to be dissolved and disestablished and that
3 no obligations of the port district remain unpaid. The court shall
4 equitably divide such sums of money between school districts if there
5 be more than one district involved.

7 **Sec. 17001.** RCW 54.04.060 and 1951 c 207 s 1 are each amended to
8 read as follows:

9 The supervisor of elections or other proper officer of the county
10 shall give notice of all elections held under this title, for the time
11 and in the manner and form provided for city, town, school district,
12 and port district elections. When the supervisor or other officer
13 deems an emergency exists, and is requested so to do by a resolution of
14 the district commission, he or she may call a special election at any
15 time in the district, and he or she may combine or divide precincts for
16 the purpose of holding special elections, and special elections shall
17 be conducted and notice thereof given in the manner provided by law.

18 The supervisor or other officer shall provide polling places,
19 appoint the election officers, provide their compensation, provide
20 ballot boxes, and ballots or voting machines, poll books and tally
21 sheets, and deliver them to the election officers at the polling
22 places, publish and post notices of the elections in the manner
23 provided by law, and apportion to the district its share of the expense
24 of the election.

25 The manner of conducting and voting at the elections, opening and
26 closing of polls, keeping of poll lists, canvassing the votes,

29 provided herein.

30 The district commission shall certify to the supervisor a list of
31 offices to be filled at a district election and the commission, if it
32 desires to submit to the voters of the district a proposition, shall
33 require the secretary of the commission to certify it at the time and
34 in the manner and form provided for certifying propositions by the
35 governing board of cities, towns, and port districts.

1 **Sec. 17002.** RCW 54.04.120 and 1985 c 95 s 1 are each amended to
2 read as follows:

3 In order that the commissioners of a public utility district may be
4 better able to plan for the marketing of power and for the development
5 of resources pertaining thereto, they shall have the same powers as are
6 vested in a board of county commissioners as provided in chapter 44,
7 Laws of 1935 (sections 9322-2 to 9322-4, both inclusive, and 9322-10 to
8 9322-11 inclusive, Remington's Revised Statutes, also Pierce's
9 Perpetual Code 776-3 to -7, 776-19 and -21), entitled: "An Act
10 relating to city, town, county and regional planning and the creation,
11 organization, duties and powers of planning commissions." For the
12 purposes of such act, the president of a public utility district shall
13 have the powers of the (~~chairman~~) chair of the board of county

21 read as follows:

22 Any person affected by RCW 54.04.130 who was employed by the
23 private utility at the time of acquisition may, at his or her option,
24 apply to the district and/or appropriate officers, for admission to any
25 plan available to other employees of the district. Every such person
26 who was covered at the time of acquisition by a plan with the private
27 utility shall have added and accredited to his or her period of
28 employment his or her period of immediately preceding continuous
29 service with such private utility if he or she remains in the service
30 of the municipal corporation until such plan for which he or she seeks
31 admission becomes applicable to him or her.

32 No such person shall have added and accredited to his or her period
33 of employment his or her period of service with said private utility
34 unless he or she or a third party shall pay to the appropriate officer
35 or fund of the plan to which he or she requests admission his or her
36 contribution for the period of such service with the private utility at

1 admission, or if he or she shall be entitled to any private benefits,
2 as a result of such private service, unless he or she agrees at the
3 time of his or her employment with the district to accept a reduction

6 accredited service by the amount of benefits received. For the
7 purposes of contributions, the date of entry of service shall be deemed
8 the date of entry into service with the private utility, which service
9 is accredited by this section, and the amount of contributions for the
10 period of accredited service shall be based on the wages or salary of
11 such person during that added and accredited period of service with the
12 private utility.

13 The district may receive such payments from a third party and shall
14 make from such payments contributions with respect to such prior
15 service as may be necessary to enable it to assume its obligations.

16 After such contributions have been made and such service added and
17 accredited such employee shall be established in the plan to which he
18 or she seeks admission with all rights, benefits, and privileges that
19 he or she would have been entitled to had he or she been a member of
20 the plan from the beginning of his or her immediately preceding
21 continuous employment with the private utility or of his or her
22 eligibility.

23 **Sec. 17004.** RCW 54.08.010 and 2006 c 344 s 36 are each amended to
24 read as follows:

25 At any general election held in an even-numbered year, the county
26 legislative authority of any county in this state may, or, on petition
27 of ten percent of the qualified electors of the county based on the
28 total vote cast in the last general county election held in an even-
29 numbered year, shall, by resolution, submit to the voters of the county
30 the proposition of creating a public utility district which shall be
31 coextensive with the limits of the county as now or hereafter
32 established. A form of petition for the creation of a public utility
33 district shall be submitted to the county auditor within ten months
34 prior to the election at which the proposition is to be submitted to
35 the voters. Petitions shall be filed with the county auditor not less
36 than four months before the election and the county auditor shall
37 within thirty days examine the signatures thereof and certify to the

2 insufficient, it shall be returned to the persons filing the same, who
3 may amend or add names thereto for ten days, when the same shall be
4 returned to the county auditor, who shall have an additional fifteen
5 days to examine the same and attach his or her certificate thereto. No
6 person having signed the petition shall be allowed to withdraw his or
7 her name therefrom after the filing of the same with the county
8 auditor: PROVIDED, That each signature shall be dated and that no
9 signature dated prior to the date on which the form of petition was
10 submitted to the county auditor shall be valid. Whenever the petition
11 shall be certified to as sufficient, the county auditor shall forthwith
12 transmit the same, together with his or her certificate of sufficiency
13 attached thereto, to the county legislative authority which shall
14 submit the proposition to the voters of the county at the next general
15 election in an even-numbered year according to RCW 29A.04.330. The
16 notice of the election shall state the boundaries of the proposed
17 public utility district and the object of such election, and shall in
18 other respects conform to the requirements of the general laws of the
19 state of Washington, governing the time and manner of holding
20 elections. In submitting the question to the voters for their approval
21 or rejection, the proposition shall be expressed on the ballot
22 substantially in the following terms:

- 23 Public Utility District No. YES
24 Public Utility District No. NO

25 Any petition for the formation of a public utility district may
26 describe a less area than the entire county in which the petition is
27 filed, the boundaries of which shall follow the then existing precinct
28 boundaries and not divide any voting precinct; and in the event that
29 such a petition is filed the county legislative authority shall fix a
30 date for a hearing on such petition, and shall publish the petition,
31 without the signatures thereto appended, for two weeks prior to the
32 date of the hearing, together with a notice stating the time of the
33 meeting when the petition will be heard. The publication, and all
34 other publications required by chapter 1, Laws of 1931, shall be in a
35 newspaper of general circulation in the county in which the district is
36 situated. The hearing on the petition may be adjourned from time to
37 time, not exceeding four weeks in all. If upon the final hearing the
38 county legislative authority shall find that any lands have been

1 unjustly or improperly included within the proposed public utility
2 district and will not be benefited by inclusion therein, it shall
3 change and fix the boundary lines in such manner as it shall deem
4 reasonable and just and conducive to the public welfare and
5 convenience, and make and enter an order establishing and defining the
6 boundary lines of the proposed public utility district: PROVIDED, That
7 no lands shall be included within the boundaries so fixed lying outside
8 the boundaries described in the petition, except upon the written
9 request of the owners of those lands. Thereafter the same procedure
10 shall be followed as prescribed in this chapter for the formation of a
11 public utility district including an entire county, except that the
12 petition and election shall be confined solely to the lesser public
13 utility district.

14 No public utility district created after September 1, 1979, shall
15 include any other public utility district within its boundaries:
16 PROVIDED, That this paragraph shall not alter, amend, or modify
17 provisions of chapter 54.32 RCW.

18 **Sec. 17005.** RCW 54.08.070 and 2006 c 344 s 37 are each amended to
19 read as follows:

20 Any district which does not own or operate electric facilities for
21 the generation, transmission, or distribution of electric power on
22 March 25, 1969, or any district which hereafter does not construct or
23 acquire such electric facilities within ten years of its creation,
24 shall not construct or acquire any such electric facilities without the
25 approval of such proposal by the voters of such district: PROVIDED,
26 That a district shall have the power to construct or acquire electric
27 facilities within ten years following its creation by action of its
28 commission without voter approval of such action.

29 At any general election held in an even-numbered year, the proposal
30 to construct or acquire electric facilities may be submitted to the
31 voters of the district by resolution of the public utility district
32 commission or shall be submitted to the voters of the district by the
33 county legislative authority on petition of ten percent of the
34 qualified electors of such district, based on the total vote cast in
35 the last general county election held in an even-numbered year. A form
36 of petition for the construction or acquisition of electric facilities
37 by the public utility district shall be submitted to the county auditor

1 within ten months prior to the election at which such proposition is to
2 be submitted to the voters. Petitions shall be filed with the county
3 auditor not less than four months before such election and the county
4 auditor shall within thirty days examine the signatures thereof and
5 certify to the sufficiency or insufficiency thereof. If such petition
6 is found to be insufficient, it shall be returned to the persons filing
7 the same, who may amend and add names thereto for ten days, when the
8 same shall be returned to the county auditor, who shall have an
9 additional fifteen days to examine the same and attach his or her
10 certificate thereto. No person having signed such petition shall be
11 allowed to withdraw his or her name therefrom after the filing of the
12 same with the county auditor: PROVIDED, That each signature shall be
13 dated and that no signature dated prior to the date on which the form
14 of petition was submitted to the county auditor shall be valid.
15 Whenever such petition shall be certified to as sufficient, the county
16 auditor shall forthwith transmit the same, together with his or her
17 certificate of sufficiency attached thereto, to the county legislative
18 authority which shall submit such proposition to the voters of said
19 district at the next general election in an even-numbered year
20 according to RCW 29A.04.330. The notice of the election shall state
21 the object of such election, and shall in other respects conform to the
22 requirements of the general laws of Washington, governing the time and
23 manner of holding elections.

24 The proposal submitted to the voters for their approval or
25 rejection, shall be expressed on the ballot substantially in the
26 following terms:

27 Shall Public Utility District No. of County
28 construct or acquire electric facilities for the generation,
29 transmission or distribution of electric power?

- 30 Yes
- 31 No

32 Within ten days after such election, the election board of the
33 county shall canvass the returns, and if at such election a majority of
34 the voters voting on such proposition shall vote in favor of such
35 construction or acquisition of electric facilities, the district shall
36 be authorized to construct or acquire electric facilities.

1 **Sec. 17006.** RCW 54.12.100 and 1986 c 167 s 23 are each amended to
2 read as follows:

3 Each commissioner before he or she enters upon the duties of his or
4 her office shall take and subscribe an oath or affirmation that he or
5 she will faithfully and impartially discharge the duties of his or her
6 office to the best of his or her ability. This oath, or affirmation,
7 shall be administered and certified by an officer of the county in
8 which the district is situated, who is authorized to administer oaths,
9 without charge therefor. The oath or affirmation shall be filed with
10 the county auditor.

11 **Sec. 17007.** RCW 54.16.097 and 1975 c 60 s 2 are each amended to
12 read as follows:

13 Whenever any action, claim, or proceeding is instituted against any

22 defense and/or judgment or settlement against such person shall not be
23 paid in any case where the court has found that such person was not
24 acting in good faith or within the scope of his or her employment with
25 or duties for the district.

28 When a petition signed by a majority of the landowners in a

21 person shall withdraw his or her name from the petition after the same

26 exceed one month's rent of the unit.

27 (4) The provisions of this section shall not:

28 (a) Create a relationship of employer and employee between landlord
29 and tenant; or

30 (b) Create liability under the workers' compensation act; or

31 (c) Constitute the tenant as an agent of the landlord for the
32 purposes of RCW 60.04.010 and 60.04.040.

33 (5) Any repair work performed under the provisions of this section
34 shall comply with the requirements imposed by any applicable code,
35 statute, ordinance, or regulation. A landlord whose property is
36 damaged because of repairs performed in a negligent manner may recover
37 the actual damages in an action against the tenant.

1 (6) Nothing in this section shall prevent the tenant from agreeing
2 with the landlord to undertake the repairs himself or herself in return
3 for cash payment or a reasonable reduction in rent, the agreement
4 thereof to be agreed upon between the parties, and such agreement does
5 not alter the landlord's obligations under this chapter.

6 **Sec. 19022.** RCW 59.18.140 and 1989 c 342 s 6 are each amended to
7 read as follows:

8 The tenant shall conform to all reasonable obligations or
9 restrictions, whether denominated by the landlord as rules, rental
10 agreement, rent, or otherwise, concerning the use, occupation, and
11 maintenance of his or her dwelling unit, appurtenances thereto, and the
12 property of which the dwelling unit is a part if such obligations and
13 restrictions are not in violation of any of the terms of this chapter
14 and are not otherwise contrary to law, and if such obligations and
15 restrictions are brought to the attention of the tenant at the time of
16 his or her initial occupancy of the dwelling unit and thus become part
17 of the rental agreement. Except for termination of tenancy, after
18 thirty days written notice to each affected tenant, a new rule of
19 tenancy including a change in the amount of rent may become effective
20 upon completion of the term of the rental agreement or sooner upon
21 mutual consent.

22 **Sec. 19023.** RCW 59.18.190 and 1973 1st ex.s. c 207 s 19 are each

24 Whenever the landlord learns of a breach of RCW 59.18.130 or has
25 accepted performance by the tenant which is at variance with the terms
26 of the rental agreement or rules enforceable after the commencement of
27 the tenancy, he or she may immediately give notice to the tenant to
28 remedy the nonconformance. Said notice shall expire after sixty days
29 unless the landlord pursues any remedy under this chapter.

30 **Sec. 19024.** RCW 59.18.230 and 1989 c 342 s 8 are each amended to
31 read as follows:

32 (1) Any provision of a lease or other agreement, whether oral or
33 written, whereby any section or subsection of this chapter is waived
34 except as provided in RCW 59.18.360 and shall be deemed against public

1 policy and shall be unenforceable. Such unenforceability shall not
2 affect other provisions of the agreement which can be given effect
3 without them.

4 (2) No rental agreement may provide that the tenant:

5 (a) Agrees to waive or to forego rights or remedies under this

8 out of the rental agreement; or

9 (c) Agrees to pay the landlord's attorney's fees, except as
10 authorized in this chapter; or

22 hereby abolished for property covered by this chapter. Any provision
23 in a rental agreement creating a lien upon the personal property of the
24 tenant or authorizing a distress for rent is null and void and of no
25 force and effect. Any landlord who takes or detains the personal
26 property of a tenant without the specific written consent of the tenant
27 to such incident of taking or detention, and who, after written demand
28 by the tenant for the return of his or her personal property, refuses
29 to return the same promptly shall be liable to the tenant for the value

31 intentional, may also be liable for damages of up to one hundred
32 dollars per day but not to exceed one thousand dollars, for each day or
33 part of a day that the tenant is deprived of his or her property. The
34 prevailing party may recover his or her costs of suit and a reasonable
35 attorney's fee.

36 In any action, including actions pursuant to chapters 7.64 or 12.28
37 RCW, brought by a tenant or other person to recover possession of his
38 or her personal property taken or detained by a landlord in violation

1 of this section, the court, upon motion and after notice to the
2 opposing parties, may waive or reduce any bond requirements where it
3 appears to be to the satisfaction of the court that the moving party is
4 proceeding in good faith and has, prima facie, a meritorious claim for
5 immediate delivery or redelivery of said property.

6 **Sec. 19025.** RCW 59.18.240 and 1983 c 264 s 9 are each amended to
7 read as follows:

8 So long as the tenant is in compliance with this chapter, the
9 landlord shall not take or threaten to take reprisals or retaliatory
10 action against the tenant because of any good faith and lawful:

11 (1) Complaints or reports by the tenant to a governmental authority
12 concerning the failure of the landlord to substantially comply with any
13 code, statute, ordinance, or regulation governing the maintenance or
14 operation of the premises, if such condition may endanger or impair the
15 health or safety of the tenant; or

16 (2) Assertions or enforcement by the tenant of his or her rights
17 and remedies under this chapter.

18 "Reprisal or retaliatory action" shall mean and include but not be
19 limited to any of the following actions by the landlord when such
20 actions are intended primarily to retaliate against a tenant because of
21 the tenant's good faith and lawful act:

- 22 (a) Eviction of the tenant;
23 (b) Increasing the rent required of the tenant;
24 (c) Reduction of services to the tenant; and
25 (d) Increasing the obligations of the tenant.

28 Initiation by the landlord of any action listed in RCW 59.18.240
29 within ninety days after a good faith and lawful act by the tenant as
30 enumerated in RCW 59.18.240, or within ninety days after any inspection
31 or proceeding of a governmental agency resulting from such act, shall
32 create a rebuttable presumption affecting the burden of proof, that the
33 action is a reprisal or retaliatory action against the tenant:

36 rent or in breach of any other lease or rental obligation, there is a

13 That the presumption of retaliation, with respect to an eviction, may
14 be rebutted by evidence that it is not practical to make necessary
15 repairs while the tenant remains in occupancy. In any action or
16 eviction proceeding where the tenant prevails upon his or her claim or
17 defense that the landlord has violated this section, the tenant shall
18 be entitled to recover his or her costs of suit or arbitration,
19 including a reasonable attorney's fee, and where the landlord prevails
20 upon his or her claim he or she shall be entitled to recover his or her
21 costs of suit or arbitration, including a reasonable attorney's fee:
22 PROVIDED FURTHER, That neither party may recover attorney's fees to the
23 extent that their legal services are provided at no cost to them.

24 **Sec. 19027.** RCW 59.18.280 and 1989 c 342 s 9 are each amended to
25 read as follows:

26 Within fourteen days after the termination of the rental agreement
27 and vacation of the premises or, if the tenant abandons the premises as
28 defined in RCW 59.18.310, within fourteen days after the landlord
29 learns of the abandonment, the landlord shall give a full and specific
30 statement of the basis for retaining any of the deposit together with
31 the payment of any refund due the tenant under the terms and conditions
32 of the rental agreement. No portion of any deposit shall be withheld
33 on account of wear resulting from ordinary use of the premises. The
34 landlord complies with this section if the required statement or
35 payment, or both, are deposited in the United States mail properly
36 addressed with first-class postage prepaid within the fourteen days.

1 The notice shall be delivered to the tenant personally or by mail

4 limits specified above he or she shall be liable to the tenant for the
5 full amount of the deposit. The landlord is also barred in any action
6 brought by the tenant to recover the deposit from asserting any claim
7 or raising any defense for retaining any of the deposit unless the
8 landlord shows that circumstances beyond the landlord's control
9 prevented the landlord from providing the statement within the fourteen
10 days or that the tenant abandoned the premises as defined in RCW
11 59.18.310. The court may in its discretion award up to two times the
12 amount of the deposit for the intentional refusal of the landlord to
13 give the statement or refund due. In any action brought by the tenant
14 to recover the deposit, the prevailing party shall additionally be
15 entitled to the cost of suit or arbitration including a reasonable
16 attorney's fee.

17 Nothing in this chapter shall preclude the landlord from proceeding
18 against, and the landlord shall have the right to proceed against a
19 tenant to recover sums exceeding the amount of the tenant's damage or
20 security deposit for damage to the property for which the tenant is
21 responsible together with reasonable attorney's fees.

22 **Sec. 19028.** RCW 59.18.290 and 1973 1st ex.s. c 207 s 29 are each

24 (1) It shall be unlawful for the landlord to remove or exclude from
25 the premises the tenant thereof except under a court order so

37 suit or arbitration and reasonable attorney's fees.

1 **Sec. 19029.** RCW 59.18.300 and 1973 1st ex.s. c 207 s 30 are each
2 amended to read as follows:

3 It shall be unlawful for a landlord to intentionally cause
4 termination of any of his or her tenant's utility services, including
5 water, heat, electricity, or gas, except for an interruption of utility
6 services for a reasonable time in order to make necessary repairs. Any
7 landlord who violates this section may be liable to such tenant for his
8 or her actual damages sustained by him or her, and up to one hundred
9 dollars for each day or part thereof the tenant is thereby deprived of
10 any utility service, and the prevailing party may recover his or her
11 costs of suit or arbitration and a reasonable attorney's fee. It shall
12 be unlawful for a tenant to intentionally cause the loss of utility
13 services provided by the landlord, including water, heat, electricity,
14 or gas, excepting as resulting from the normal occupancy of the
15 premises.

16 **Sec. 19030.** RCW 59.18.340 and 1983 c 264 s 12 are each amended to
17 read as follows:

18 The administrative fee for this arbitration procedure shall be
19 established by agreement of the parties and the arbitrator and, unless
20 otherwise allocated by the arbitrator, shall be shared equally by the
21 parties: PROVIDED, That upon either party signing an affidavit to the
22 effect that he or she is unable to pay his or her share of the fee,
23 that portion of the fee may be waived or deferred.

24 **Sec. 19031.** RCW 59.18.350 and 1973 1st ex.s. c 207 s 35 are each
25 amended to read as follows:

26 When a party gives notice pursuant to (~~subsection (2) of~~) RCW
27 59.18.320(2), he or she must, at the same time, arrange for arbitration
28 of the grievance in the manner provided for in this chapter. The
29 arbitration shall be completed before the rental due date next
30 occurring after the giving of notice pursuant to RCW 59.18.320:
31 PROVIDED, That in no event shall the arbitrator have less than ten days
32 to complete the arbitration process.

35 At the time and place fixed for the hearing of plaintiff's motion

1 for a writ of restitution, the defendant, or any person in possession

4 out of the tenancy. If the answer is oral the substance thereof shall
5 be endorsed on the complaint by the court. The court shall examine the

3 plaintiff's motion for a writ of restitution and enter an order
4 directing the parties to proceed to trial within thirty days on the
5 complaint and answer. If it appears to the court that there is a
6 substantial issue of material fact as to whether or not the plaintiff
7 is entitled to other relief as is prayed for in plaintiff's complaint
8 and provided for in this chapter, or that there is a genuine issue of
9 a material fact pertaining to a legal or equitable defense or set-off
10 raised in the defendant's answer, the court shall grant or deny so much
11 of plaintiff's other relief sought and so much of defendant's defenses
12 or set-off claimed, as may be proper.

15 If upon the trial the verdict of the jury or, if the case be tried

4 provided, be not made within five days the judgment may be enforced for
5 its full amount and for the possession of the premises. In all other
