

HB 1009-S - DIGEST

(SUBSTITUTED FOR - SEE 2ND SUB)

Extends the sales and use tax exemption for eligible renewable energy and fuel cell machinery and equipment.

Specifies that the exemption is available to a qualifying utility under the energy independence act, or to a person contracting with a qualifying utility for the sale of electric power generated by eligible renewable energy and fuel cell machinery and equipment.
