

HB 1078 - DIGEST

(SUBSTITUTED FOR - SEE 2ND SUB)

Finds that there are no statutory requirements for persons who facilitate like-kind exchanges pursuant to section 1031 of the internal revenue code and associated treasury regulations.

Declares an intent to create a statutory framework that provides consumer protections to those who entrust money or property to persons acting as exchange facilitators.
