# **House Bills**

HB 1021-S by House Committee on Health Care & Wellness (originally sponsored by Representatives Campbell, Morrell, and Moeller)

Concerning notice of hospital audits.

# (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the department of social and health services to make unannounced inspections of all hospitals.

Prohibits the department of social and health services from issuing its final report regarding an unannounced inspection until: (1) The hospital is given at least two weeks following the inspection to provide any information or documentation requested by the department during the unannounced inspection that was not available at the time of the request; and

(2) At least one person from the department conducting the inspection meets personally with the chief administrator or executive officer of the hospital following the inspection or the chief administrator or executive officer declines such a meeting.

HB 1033-S by House Committee on Environmental Health (originally sponsored by Representatives Campbell, Morrell, Hudgins, Hunt, Chase, Wood, and Dickerson)

Requiring the use of alternatives to lead wheel weights.
(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Finds that: (1) Environmental health hazards associated with lead wheel weights are a preventable problem. People are exposed to lead fragments and dust when lead wheel weights fall from vehicles on Washington roadways and are then abraded and pulverized by traffic. Lead wheel weights on and alongside roadways can contribute to soil, surface, and groundwater contamination and pose a hazard to downstream aquatic life;

- (2) Lead negatively affects every bodily system. While injurious to individuals of all ages, it is especially harmful to children, fetuses, and adults of childbearing age. Effects of lead on a child's cognitive, behavioral, and developmental abilities may necessitate large expenditures of public funds for health care and special education. Irreversible damage to children and subsequent expenditures could be avoided if exposure to lead is reduced; and
- (3) There are no federal regulatory controls governing use of lead wheel weights. The legislature recognizes the state's need to protect the public from exposure to lead hazards.

Requires the department of ecology to: (1) Prepare and distribute information to persons in the tire and wheel weight manufacturing, distribution, wholesale, retail, an auto manufacturing industries, to the maximum extent practicable, to assist them in identifying environmentally preferred wheel weights;

- (2) Issue a warning letter to a person in the tire distribution, wholesale, retail, auto manufacturing, or associated industry who violates the requirements of the act; and
- (3) Offer information or other appropriate assistance to the person in (2) above.

Requiring notification to property owners of emergency responses to property titled in their name.

Requires a municipal agency, a county agency, the Washington state patrol, and a fire protection district to notify a property owner of its response to an emergency on property titled in the owner's name within twenty-four hours of the response.

Directs the Washington state institute for public policy, with the assistance and support of the office of the state actuary, to study, during the 2009 legislative interim, the options available to the legislature for addressing the needs of members of the public employees' retirement system plan 2 and plan 3, the teachers' retirement system plan 2 and plan 3, and the school employees' retirement system plan 2 and plan 3, to have adequate disability benefit coverage through disability benefits under the public pension systems, through access to long-term disability insurance coverage, or a combination of both.

Prohibits a governing body of a public agency from adopting any ordinance, resolution, rule, regulation, order, or directive, before a formal public testimony period has been allowed.

Authorizing the department of labor and industries to issue stop work orders for violations of certain workers' compensation provisions.

Authorizes the director of the department of labor and industries to issue a stop work order against an employer requiring the cessation of all business operations of the employer if the employer is found to be in violation of certain worker's compensation provisions.

Addressing the recommendations of the joint legislative task force on the underground economy in the construction industry.

Requires the department of labor and industries to: (1) Approve training on state law for applicants for contractor registration;

- (2) Work with representatives of the business community to explore the need for continuing education for contractors;
- (3) Conduct education and outreach to employers on workers' compensation requirements and premium responsibilities, including independent contractor issues; and
- (4) Work with new employers on an individual basis and also establish mass education campaigns.

Requires a contractor to maintain and have available for inspection by the department of labor and industries a list of all direct subcontractors and a copy of their certificate of registration.

Prohibits a local government from issuing a business license to a person required to be registered under chapter 18.27 RCW (registration of contractors) without verifying that the person is registered under that chapter and meets other requirements.

Provides that any employer who fails to keep and preserve certain work records required by RCW 50.12.070 is subject to a penalty determined by the commissioner of the employment security department but not to exceed two hundred fifty dollars or two hundred percent of the quarterly tax for each offense, whichever is greater.

Creates an interagency advisory committee on the underground economy to conduct a continuing study of the underground economy of the construction industry with the goal of reducing or eliminating the underground economy in this state.

Regarding the installation and maintenance of a dock on state-owned aquatic lands.

Permits an abutting residential owner to state-owned aquatic lands, who has installed a dock on the area, to install and maintain a boat lift, or other construction primarily used to provide safe moorage for a boat or to safely remove and store a boat above the water level, that is intended to operate in conjunction or association with the dock.

Finds that Oregon does not charge any fees for their farm structures and there is a need for farmers in Washington to have competitive parity with our neighboring state.

Declares an intent that first-year taxes paid on a new farm structure be used to offset any permit and inspection fees the county planning department would charge.

Prohibits a county from imposing permit fees or inspection charges for the construction or remodel of agricultural structures.

Provides that an amount equal to any reduction in revenue resulting from the agricultural structure permit fee and inspection charge exemptions must be allocated from the county general levy imposed on the agricultural structure to the county planning department.

Requiring annuities sold in Washington to be suitable to the age and financial situation of the purchaser.

Finds that consumers rely heavily on the insurance producers and insurers selling annuities for accurate, descriptive information when purchasing annuities and may be easily misled about the risks and benefits of the product being purchased.

Requires an annuity sold in Washington to be suitable to the age and financial situation of the owner. Purchasers are entitled to a clear written description of the annuity at the time of solicitation on a summary disclosure form adopted by rule of the insurance commissioner. Prior to issuing an annuity, the insurer must obtain sufficient information from the purchaser to verify the suitability of the proposed sale and to enable the prospective owner to make an informed purchase.

Requires every insurer to provide written notice at policy issuance and annually thereafter to homeowner, condominium unit owner, residential tenant, and residential fire insurance policyholders that clearly and conspicuously discloses that the policy does not cover damage caused by flooding.

Expanding the scope of business continuity plans for domestic insurers.

Requires each domestic insurer to create and maintain a written business continuity plan identifying procedures relating to a local, state, or national emergency or significant business disruption.

HB 1566 by Representatives Kirby, Williams, and Simpson; by request of Insurance Commissioner

Granting the insurance commissioner certain authority when the governor declares a state of emergency.

Authorizes the insurance commissioner to, when the governor declares a state of emergency, issue an order that addresses any or all of the following matters related to insurance policies issued in this state: (1) Reporting requirements for claims;

- (2) Grace periods for payment of insurance premiums and performance of other duties by insureds;
- (3) Temporary postponement of cancellations and renewals; and
  - (4) Medical coverage to ensure access to care.

Addressing insurance, generally.

Removes the legislature's authority to transfer money from the insurance commissioner's regulatory account to the Washington state heritage center account.

Requires, for tax purposes, premiums to be reported on a written basis or a paid-for basis consistent with the annual statement.

Sets forth the conditions under which medicare supplement insurance coverage must be offered without evidence of insurability.

HB 1569 by Representatives Liias, O'Brien, Hope, Sells, Dunshee, Kagi, McCoy, Morrell, and Ormsby

Establishing local public works assistance funds.

Authorizes a county legislative authority to establish local public works assistance funds for the purpose of funding public works projects located wholly or partially within the county.

Authorizes a county, in consultation with cities and towns within the county, to make loans to local governments from funds established under the act for the purpose of assisting local governments in funding public works projects.

Requires a county legislative authority to: (1) Using or providing money under the act, develop a prioritization process for funding public works projects that gives priority to projects necessary to address public health needs, substantial environmental degradation, or increases existing capacity necessary to accommodate projected population and employment growth;

- (2) Providing funding to other local governments under the act, consider, through a competitive application process, certain factors in assigning a priority to and funding a project; and
- (3) Providing funding for public works projects under the act, keep proper records of accounts.

HB 1570 by Representatives Liias, Hope, and O'Brien

Concerning the conservation of forest lands.

Reduces the county population from one million to six hundred thousand as a qualifier for certain transfers resulting in exemption from compensating taxes due to the removal of designated forest land from the current use valuation tax program.

HB 1571 by Representatives Blake and Chandler; by request of Department of Ecology

Regarding the adjudication of water rights.

Modifies provisions regarding the adjudication of water rights.

HB 1572 by Representatives Hunt, Liias, Appleton, Miloscia, and Williams

Adopting all mail voting.

Establishes all-mail elections, but allows for designated in-person voting centers.

Jan 23 First reading, referred to State Government & Tribal Affairs.

HB 1573 by Representatives Appleton, Newhouse, Conway, Hunt, Green, Armstrong, Condotta, and Kelley; by request of State Board of Accountancy

Protecting financial and medical information presented to the board of accountancy.

Provides that the financial records of certified public accountants and clients that are provided to the board of accountancy in the course of an investigation or in conjunction with an application for licensure under chapter 18.04 RCW are not subject to disclosure under the public records act, chapter 42.56 RCW, are privileged, and are not subject to discovery, subpoena, or other means of legal process or introduction into evidence in any civil action or arbitration.

HB 1574 by Representatives Kagi and Rodne; by request of Washington State Patrol

Addressing motor carrier compliance review.

Revises penalties for motor carriers.

Doubles the penalty amount for high-risk carriers that have repeat violations of the same violation during a follow-up compliance review.

Authorizes motor carriers, except for high-risk carriers, to request penalty mitigation.

HB 1575 by Representatives Sells, McCoy, Kristiansen, Hope, Pearson, Dunshee, and Liias

Requiring a state route number 2 route development plan.

Requires the department of transportation to conduct a state route number 2 route development plan to identify essential improvements needed between the port of Everett/Naval Station and approaching the state route number 9 interchange near the city of Snohomish.

Makes an appropriation. Expires July 1, 2011.

HB 1576 by Representatives Clibborn, Liias, Roach, and

Determining the amount of motor vehicle fuel tax moneys derived from tax on marine fuel.

Requesting congress take action to maintain and develop a highly-skilled workforce in Washington.

Requests the President of the United States Senate, the Speaker of the United States House of Representatives, and the United States Senate and House of Representatives to actively support legislation: (1) Increasing the number of available H-1B visas; and

(2) Mandating that companies hiring highly skilled workers through the H-1B visa program pay the sum of ten thousand dollars per foreign worker, to go toward training domestic workers for highly skilled jobs.
