House Bills

HB 2315-S by House Committee on Agriculture & Natural Resources (originally sponsored by Representatives Takko and Darneille)

Regarding forest fire protection assessment refunds.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Directs the department of natural resources to: (1) Develop a revised forest fire protection assessment rate structure as recommended by the 2008 forest fire protection and prevention work group in order to more closely align assessments with actual forest wildfire protection costs;

(2) Consider reducing the rate paid by owners of unimproved parcels while adding a surcharge or applying a higher rate to parcels that include improvements such as homes and other structures to achieve the same value of assessment collection derived under the current rate structure; and

(3) Develop a definition of the term "improvement" as used for the purposes of the forest fire protection assessment rate structure.

HB 2326 by Representatives Clibborn and Williams

Authorizing bonds for the financing of eligible toll facilities. Requires, upon the request of the department of transportation, a total of one billion two hundred million dollars of general obligation bonds of the state of Washington to be issued and sold in order to provide funds necessary for the location, design, right-of-way, and construction of selected projects or improvements on the state route number 520 corridor.

Requires the state finance committee, upon request of the department of transportation, as appropriate, to supervise and provide for the issuance, sale, and retirement of the bonds in accordance with chapter 39.42 RCW.

Authorizing the siting of a master planned location for major auctioneering activity.

Authorizes a county planning under RCW 36.70A.040 that meets certain criteria, in addition to the major industrial development allowed under RCW 36.70A.365 and 36.70A. 367, to establish, in consultation with cities consistent with RCW 36.70A.210 (county-wide planning policies), a process for designating a master planned location for major auctioneering activity outside urban growth areas, and regardless of any underlying land use designation.
