House Bills

HB 2344-S by House Committee on Ways & Means (originally sponsored by Representative Haigh)

Regarding resident undergraduate tuition.

(AS OF HOUSE 2ND READING 4/22/2009)

Authorizes the legislature to increase tuition above the statutory seven percent cap for 2009-2010 and 2010-2011.

Requires institutions of higher education to include information on their billing statements notifying students of tax credits available through the American opportunity tax credit provided in the American recovery and reinvestment act of 2009.

Requires the higher education coordinating board, in coordination with higher education stakeholders, to review options and make recommendations on a tuition policy that allows flexibility, accessibility, and differentiation among Washington's various public baccalaureate tuition rates.

Requires the joint legislative audit and review committee, within existing resources, to complete a systemic performance audit of the state universities, regional universities, and The Evergreen State College to create a transparent link between revenues, expenditures, and performance outcomes as outlined in the performance agreements developed under RCW 28B.10.920 and the strategic master plan for higher education as adopted by the legislature.

HB 2383 by Representatives Simpson and Van De Wege

Adopting the international wildland urban interface code. Adopts the international wildland urban interface code.

HB 2384 by Representative Quall

Providing salary bonuses for nationally certified educational staff associates.

Provides annual salary bonuses for nationally certified educational staff associates beginning in the 2011-2012 school year.

Provides additional bonuses if the nationally certified educational staff associate is in an assignment in a school where at least seventy percent of the students qualify for the free and reduced-price lunch program.

HB 2385 by Representatives Williams, Green, Appleton, Ormsby, Nelson, Sells, Chase, Dunshee, and

Simpson

Improving unemployment benefits.

Improves unemployment benefits by: (1) Modifying provisions relating to disqualification for leaving work voluntarily without good cause and the calculation of unemployment benefits;

(2) Removing a provision regarding part-time workers in reference to suitable work; and

(3) Revising the definition of "part-time work."

Senate Bills

SB 6160-S by Senate Committee on Ways & Means (originally sponsored by Senator Prentice)

Concerning criminal justice sentencing.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Revises criminal justice sentencing provisions by: (1) Amending the sentencing grid to allow judges greater discretion; and

(2) Addressing mitigating and aggravating circumstances that may allow the imposition of a sentence above or below the standard sentence range.

Minority; without recommendation.
Passed to Rules Committee for second reading.

SB 6188 by Senator Carrell

Imposing a minimum bail bond premium fee of ten percent.

Requires a bail bond agent to charge and collect for his or her premium, commission, or fee an amount of ten percent of the amount of the corporate surety bail bond posted by him or her.

Authorizes the director of the department of licensing to impose a civil penalty for a violation of chapter 18.185 RCW (bail bond agents).

Authorizes the attorney general, at the request of the director of the department of licensing, to bring an action in the name of the state.
