Revises current statutes governing depictions of a minor engaged in sexually explicit conduct to ensure that intentional viewing of and trading in child pornography over the internet is subject to a criminal penalty without limiting the scope of existing prohibitions on the possession of or dealing in child pornography, including the possession of electronic depictions of a minor engaged in sexually explicit conduct.

Clarifies that each individual item of visual or printed matter constitutes a separate violation for purposes of determining the unit of prosecution under the statutes governing possession of and trading in depictions of a minor engaged in sexually explicit conduct.

Creates a new crime of intentionally viewing over the internet a visual or printed matter depicting a minor engaged in sexually explicit conduct and sets a different unit of prosecution for the crime such that each separate internet session of intentionally viewing over the internet of a visual or printed matter depicting a minor engaged in sexually explicit conduct constitutes a separate offense.

HB 3123 by Representative Hope

Providing a business and occupation tax credit for employers who pay livable wage rates.

Allows a business and occupation tax credit for wages paid to one or more employees at a rate that equals or exceeds the livable wage rate for the county in which the employee or employees are employed.

Requires the Washington state institute for public policy to conduct a study to determine the livable wage rate for 2009 for each county.

# HB 3124 by Representatives Roberts, Kagi, Simpson, and Kenney

Requiring a report to child protective services when a child is present in the vehicle of a person arrested for driving or being in control of a vehicle while under the influence of alcohol or drugs.

Requires a law enforcement officer to promptly notify child protective services if a child is present in a vehicle being driven by, or under the control of, a person being arrested on probable cause for driving, or being in physical control of, a vehicle while under the influence of alcohol or drugs.

Prohibits, beginning July 1, 2011, the department of social and health services from paying certain home care agencies for in-home personal care or respite services if the home care agency does not verify agency employee hours by electronic timekeeping.

(2) Work cooperatively with the tribal comanagers for all fish resources in implementing and enforcing these requirements.

#### Concerning human trafficking.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Modifies human trafficking provisions relating to the definition of foreign worker, furnishing disclosure statements and informational pamphlets, and liability of an international labor recruitment agency.

Requires the department of labor and industries to integrate into existing posters and brochures, information on assisting victims of human trafficking.

Concerning forest fire prevention and suppression.

Modifies forest fire prevention and suppression provisions regarding: (1) The department of natural resources' obligation to protect certain forest land and state and privately owned unimproved lands located outside of fire protection districts;

(2) Forest fire protection assessments; and

(3) The legislature's acknowledgment that the department of natural resources may use discretionary authority to take actions that may prevent approaching wildfire from destroying or damaging homes and other improvements, although this is not the primary mission of the department.
